Councilman Dotson Organizes, Inglewood Supports Christmas Food, Toy Drive

On Saturday Dec. 13 from 10 a.m. to Noon Inglewood's District No. 1 Councilman George Dotson will be distributing food and toys to selected families in need during the 2014 Annual District 1 Christmas Food and Toy Drive.

"The reason I did it and called it a food and toy drive is because there are a lot of toy drives and toys only last a couple of months and then they're gone," Councilman Dotson said. "I wanted to do something that would help families so I am not only doing a doing toys but this is a chance to go out an buy clothes, food or whatever they [families] need."

With the help and support of his colleagues on the city council, Councilman Dotson has been able to organize this effort to reach out to needy families within his district. Again, this year many families in District No. 1 will benefit from the generosity of community members donating food or toys. In past years individuals and organizations have joined efforts in order to support children and families in need during the Christmas season.

"Some of the people might not even have a home and live in their car in some cases, so we are really are trying to reach people in need within the first district," Councilman Dotson said. "The first year we only did a few families but this year we are helping twenty families and we are actually going to their homes."

The councilman is made aware of the families in need within his district through the Inglewood Police Department and the Inglewood Housing Division. The families selected have children up to age 15 and the Councilman requested assistance from

several individuals, block clubs and local businesses to donate unwrapped toys, food gift cards and gift certificates.

"The whole idea is to help each other. "That is my goal for my district and my constituents: to help those that are in need."

After being elected to the city council, Councilman Dotson a resident of Inglewood for more than 44 years has shared with his colleagues his passion for safer neighborhoods and communities. The Christmas Food and Toy Drive is one of his efforts in assisting

the less fortunate in District No. 1. The good working relationship with council colleagues has facilitated these efforts by the councilman.

"We kind of go hands-on, on anything: if there is anything that they need that I can help them with, I will," Councilman Dotson said. "A couple of the members have been very good in helping me reach out to people and showing me how to reach out to people and get the donations we need for the drive. That has been a wonderful experience with me."

The initial donations collected will be used to help families in District No. 1; however, any leftover donation items will be donated to the Salvation Army or some other nonprofit to help in the city.

"I like serving with a council that has a purpose and our purpose is to serve the public and that's what we've been doing," Councilman Dotson said. "I just feel that this is my gift to my community and my constituents; top help those that are in need."

People interested can donate food gift cards or gift certificates from local stores or any place that persons in need can obtain food for Christmas. For persons interested in donating toys, it is asked that they donate such items but that they remain unwrapped.

Donations can be made at the Police Community Center on the corner of 7th Avenue and Manchester Avenue, at Darby Park located at 3400 W. Arbor Vitae as well as at Holly Knolls on Crenshaw [apartment house complex]. Each location has boxes set up for people to leave donations. •

Simple Steps That Help People With Diabetes Keep Their Feet Healthy

(BPT) - A diabetes diagnosis can be daunting, but a simple attitude adjustment can make a world of difference in how well you fare while living with the disease. By proactively taking steps to monitor key health indicators, experts agree that it's possible to prevent some of the most severe risks of diabetes, including lower limb amputation. People ages 20 and older who are living with diabetes account for about 60 percent of non-traumatic lower-limb amputations, according to the Centers for Disease Control and Prevention's 2014 National Diabetes Statistics Report.

"The CDC says the occurrence of diabetes-related foot and lower-leg amputation has decreased by 65 percent since 1996," says American Podiatric Medical Association (APMA) President Dr. Frank Spinosa. "Working together, podiatrists and their patients with diabetes can reduce the number of amputations even more."

People with diabetes may be less aware of cuts or wounds on their feet due to the nerve damage related to their disease, Spinosa points out. "Regular and vigilant foot care can help catch problems before they develop



into a health crisis." The APMA offers advice to help people with diabetes protect their foot health:

- Inspect your feet daily, checking the entire foot and all 10 toes for cuts, bruises, sores or changes to the toenails, such as thickening or discoloration. Treat wounds immediately and see your podiatrist if a

problem persists or infection is apparent.

- Exercise by walking, which can help you maintain a healthy weight and improve circulation. Be sure to wear appropriate athletic shoes appropriate for the type of exercise you're doing.

- When you buy new shoes, have them properly measured and fitted. Foot size and

shape can change over time, and ill-fitting shoes are a leading cause of foot pain and lesions. Certain types of shoes, socks and custom orthotics are available for people with diabetes, and they may be covered under Medicare. You can find a list of podiatrist-approved footwear and products for people with diabetes on the APMA website.

- Keep your feet covered and never go barefoot even at home. The risk of cuts and infection is too great.

- See a podiatrist to remove calluses, corns or warts - don't tackle them yourself and don't ask a unlicensed non-professional to do it. Over-the-counter products can burn your skin and injure your foot. Podiatrists are specially trained to address all aspects of foot health for people with diabetes.

- Get checkups twice a year. An exam by your podiatrist is the best way to ensure your feet stay healthy.

"For people with diabetes, taking charge of your own foot health can help you avoid foot-related complications like amputation," Spinosa says. "Work with today's podiatrist to help you safeguard your foot health." •

Inglewood Tops Lawndale; Both Find it Tough Going at Shores

Inglewood High's boys' basketball team began its season with a 70-58 win over Lawndale in the first round of the highly regarded Redondo Pacific Shores Tournament on November 24, but both squads found the classic tough going. After the win over the Cardinals, the Sentinels, who many feel that will be a top contender for the Bay League championship and were last year's CIF-Southern Section Division IAA semifinalist before a one-point loss at eventual champion Long Beach Poly last season, lost their next three games, including 79-57 in the championship quarterfinals to the eventual tournament champion Jackrabbits on November 26.

Lawndale went on to lose in the championship quarterfinals to Woodland Hills Taft 68-56 before coming back after Thanksgiving for two straight consolation wins over last year's PAC Shores runner-up (behind host Redondo) Lakewood Mayfair on Friday and Newhall Hart on Saturday for a 13th place finish in the 16-team classic.

In Inglewood's win over the Cardinals, returning all-CIF Southern Section Division IAA junior guard Terrell Gomez led with 22 points, six rebounds and six assists. Darae Elliot added 18 points and eight rebounds and Tyree Jones chipped in nine points. Joshua Conley gathered 10 rebounds. Leading 46-44 after three quarters, the Sents (1-3) pulled away by outscoring Lawndale 24-14.

Leading the Cardinals (2-2) was six-foot-10 center-forward Chimeze Metu with 15 points. D'lano Beckles was close behind with 14. Deandre Snedecor and Chris White each had nine points. Poly proved too much for Inglewood as it built a 44-30 halftime lead and the Jackrabbits, who are expected to again be one of the top contenders for the Southern Section Division IAA or even the title in the prestigious Open Division, continued to have command in the second half.

Gomez led Inglewood with 22 points in the loss. The Sentinels went on to lose to Calabasas 61-54 on Friday and Compton 53-52 Saturday for an eighth place finish.

Lawndale struggled in the games before Thanksgiving with the consolation quarterfinal loss to Taft but the Cardinals, who should contend for the Ocean League crown, returned from their turkey feasts to win the final two games. The Cardinals rolled over Mayfair 70-51 on Friday, then finished with a 59-51 victory over the Indians.

The Sentinels resume play with a home

non-league game against a tough St. John Bosco team from Bellflower next Tuesday at 7 p.m. The Braves were among the teams in the Redondo Tournament as they placed third with a 60-55 win over CIF-Los Angeles City power and last season's Southern California Regional finalist Westchester last Saturday. St. John Bosco (3-1) had wins over Hart (58-55) and Compton before falling short of host and tournament runner-up Redondo 58-56 in the championship semifinals last Friday. Poly edged the Sea Hawks 63-61 in overtime for the title. Lawndale will travel to Sacramento to play in the St. Hope Elite Classic beginning on Tuesday. The Cardinals open against El Dorado Hills Oakridge at 6 p.m.

MORNINGSIDE ROUTS VERBUM DEI

Last Friday's non-league match-up between host Inglewood Morningside and southeast L.A. Verbum Dei could remind older prep boys' basketball fans of the 1970's when they were two of the top powers in Southern California.

Neither squad has quite the lust that they had some 40 years ago. The Monarchs, though, brought back more their glory days than the Eagles with an 82-57 win. Morningside (1-0) wasted little time in jumping out to a 23-5 first quarter lead and had command throughout the rest of the contest. Looking Up

Best View Yet of Jupiter's Moon Europa

Scientists have produced a new version of what is perhaps NASA's best view of Jupiter's ice-covered moon, Europa. The mosaic of color images was obtained in the late 1990s by NASA's Galileo spacecraft. This is the first time that NASA is publishing a version of the scene produced using modern image processing techniques.

The image features many long, curving and linear fractures in the moon's bright ice shell. Scientists are eager to learn if the reddish-brown fractures, and other markings spattered across the surface, contain clues about the geological history of Europa and the chemistry of the global ocean that is thought to exist beneath the ice.

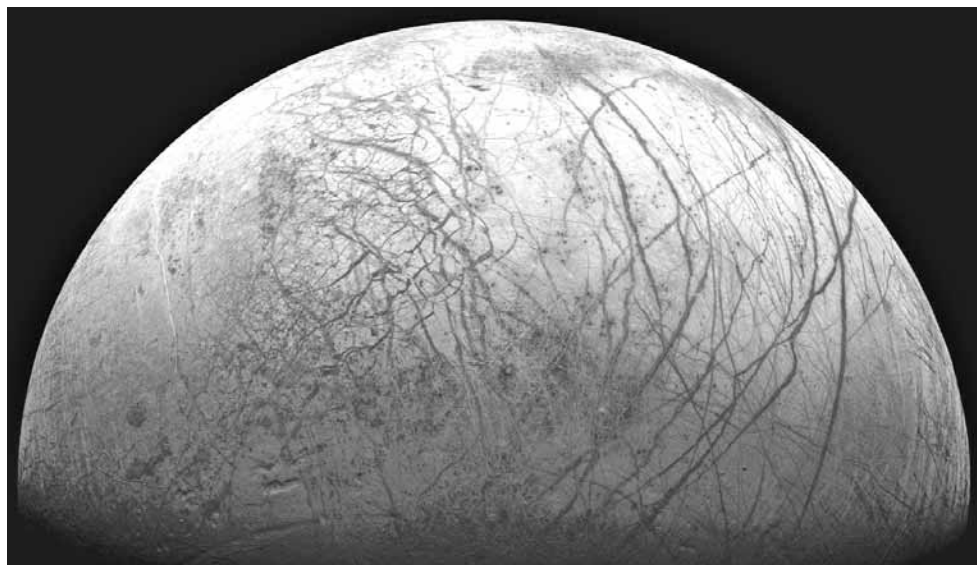
In addition to the newly processed image, a new video (<http://youtu.be/kz9VhCQbPAk>)

found that the rotation axes of these quasars tend to be aligned with the vast structures in the cosmic web in which they reside.

Quasars are galaxies with very active supermassive black holes at their centers. These black holes are surrounded by spinning discs of extremely hot material that is often spewed out in long jets along their axes of rotation. Quasars can shine more brightly than all the stars in the rest of their host galaxies put together.

A team led by Damien Hutsemékers from the University of Liège in Belgium used the VLT to study 93 quasars that were known to form huge groupings spread over billions of light-years, seen at a time when the universe was about one-third of its current age.

"The first odd thing we noticed was that some of the quasars' rotation axes were aligned with each other—despite the fact that these quasars

details why this likely ocean world is a high priority for future exploration.

Hidden beneath Europa's icy surface is perhaps the most promising place in our solar system beyond Earth to look for present-day environments that are suitable for life. The Galileo mission found strong evidence that a subsurface ocean of salty water is in contact with a rocky seafloor. The cycling of material between the ocean and ice shell could potentially provide sources of chemical energy that could sustain simple life forms.

"Spooky" Alignment of Distant Quasars

New observations with ESO's Very Large Telescope (VLT) in Chile have revealed alignments over the largest structures ever discovered in the universe. A European research team has found that the rotation axes of the central supermassive black holes in a sample of quasars are parallel to each other over distances of billions of light-years. The team has also

are separated by billions of light-years," said Hutsemékers.

The team then went further and looked to see if the rotation axes were linked, not just to each other, but also to the structure of the universe on large scales at that time.

When astronomers look at the distribution of galaxies on scales of billions of light-years they find that they are not evenly distributed. They form a cosmic web of filaments and clumps around huge voids where galaxies are scarce. This intriguing and beautiful arrangement of material is known as large-scale structure.

The new VLT results indicate that the rotation axes of the quasars tend to be parallel to the large-scale structures in which they find themselves. So, if the quasars are in a long filament then the spins of the central black holes will point along the filament. The researchers estimate that the probability that these alignments are simply the result of chance is less than 1%. •

Kabocha Squash



Serves 4 or 16 tasting portions

Ingredients

- 1/2 grated garlic
- 1/4 cup extra virgin olive oil
- 1/2 bunch chopped sage
- Handful of thyme
- 2 tablespoons maple syrup
- 1 medium Kabocha squash skin on, seeded and cut into 4 wedges
- Salt
- Pepper
- 1/2 tablespoon Ras el Hanout spice
- Orange zest
- 1 cup whole milk
- 1/2 clove of grated garlic
- 1/4 cup of Arbequina olive oil
- Zest and juice from one lemon
- 1/2 tablespoon ground pink peppercorn
- Seeds of 1 fresh pomegranate
- 2 tablespoons fresh mint, coarsely chopped

Preparation

Preheat oven to 400 degrees. Combine grated garlic, olive oil, sage and thyme into a food processor and process until smooth. Whisk in maple syrup. Spread half the Kabocha squash in a 1.5 quart CW by CorningWare Medium Baker. Using a pastry brush, thoroughly brush all the squash with the olive oil/maple syrup mixture. Season with salt, pepper, Ras el Hanout and orange zest and roast, covered with foil, for 35 minutes or until the flesh and skin are tender.

Meanwhile combine the milk, Arbequina olive oil, lemon zest and juice, peppercorn, pomegranate seeds, mint and salt and pepper to taste in a 20-ounce CW by CorningWare Small Baker.

Remove the squash from oven and cut each piece into bite-size pieces. Place them in a clean, cool dish. Top each piece of squash with a dollop of the yogurt and serve immediately. •
