# Hawthorne City Council Bans Medical Marijuana, Expands Parking in City

With the candidate selection for the vacant City Council seat taking a break until Thursday, the City Council spent their regular meeting tackling city issues such as construction, parking amendments, and banning marijuana dispensaries.

In terms of parking, the Council discussed a resolution that would authorize Interim City Manager Arnie Shadbehr to execute a parking license agreement between the city and Space X for non-exclusive use of 40 parking spaces at the Memorial Center.

The location under discussion was the parking lot between Costco Wholesale and Memorial Park. The number of parking spots was determined by an area survey and historical aerial photos that the city has on hand.

"The 160 parking spaces in that particular parking lot is underutilized except for some weekend events," Shadbehr said. "After some conversations with the Recreation Committee Services Director and based on the survey that engineering had conducted, we decided that we can come up with a number."

Shadbehr says that Space X was asking for more parking spaces even though their new parking structure was due to be open by the end of the week.

"They're growing and they are still in need of more parking spaces," Shadbehr said. "They have been talking to us and we have examined some other plans for them to redesign and restripe it for angled parking to accommodate more cars," Sahdbehr said.

Shadbehr said that they had 160 parking spaces available in the lot and said that while the city could have given Space X 100 of those spaces, there are last minute events that the city is notified about and would need those spots for cars to park.

"We think that it is harmless and not going to impact us in any way," Sahdbehr said. "It is also for a six month period initially as well and as far as security, Space X is going to take care of that."

Councilmember Angie Reyes English raised concern that the liability factor of vehicles entering and exiting the lot as well as the foot traffic in the area was addressed.

Shadbehr said the liability issue has been addressed and that the agreement can be terminated at any time.

"The purpose of having it for six months is to have it as a pilot study to see if it works," Shadbehr said.

In terms of construction, the Council adopted an ordinance that regulates exterior colors of commercials and multi-family structures.

While the Planning Commission would ultimately have final say on whether a business or multi-family building could proceed with painting their structure a desired color, the amendment would also allow property owners the opportunity to paint their buildings however they saw fit.

"It would have to be delayed until we write the ordinance that creates the Design and Review Board," Gregg McClain, Planning and Economic Development Director said.

McClain added that appeals would be vetted out once the Design and Review Board is created. One method is to have appeals go to the Planning Commission and then the City Council while an alternate path sends appeals directly to the Council.

The Council approved the ordinance and then moved on to the marijuana ordinance.

Residents who addressed the council were split on the ban. Those against the dispensaries claimed that it would bring a blight to the community while those in favor said that they were necessary because some people need them for legitimate medical reasons.

Beginning this month, the state passed on the decision of whether to allow or ban

marijuana dispensaries to city councils. The law was signed on November last year and went in to effect on January 1.

"I know our ordinance is saying to ban all together but there is a sensitive issue to the matter as well," Councilmember English after introducing a statement from a medical marijuana company that provides goods to more than 1,000 Hawthorne residents for medical purposes.

"When we're talking about banning marijuana cultivation and dispensaries and delivery, it's debate-able but at the end of the day, the council needs to make their own decision," English said.

The issue became even murkier when the issue of transporting marijuana in from other cities or through a delivery service such as the UPS, FedEx, or the postal service was mentioned.

"There's another issue here," English said. "They're not asking us to look at the total ban, they're asking for us to look at the fact that they do delivery. Do we have a way of finding out if these licensed businesses are in fact coming in and out of Hawthorne?"

McClain said that the ordinance was a landuse ordinance and does not concern delivery. Recipients would not be affected by delivery unless it originated in Hawthorne.

"When you look at the ordinance and the changes we are proposing, every single one of them is in a zone chapter," McClain said as he looked to clarify the matter of marijuana delivery. "These use are not permitted as land uses in these zones."

The Council ultimately voted to approve the ban.

The City Council will meet again on Thursday in a special meeting to hopefully fill their vacated seat. If no one is selected on Thursday, the chances of a special election this June increase exponentially. •

### Life, Animated

Director Roger Ross Williams shed

The resulting drama is about being true to yourself and following your passions while keeping relationships in your life. While the film meanders at times, it thankfully finds enough of a storyline to finish extremely strong and leave the audience emotionally moved. These performances will

light on the African evangelical invasion in God Loves Uganda. Openly admitting he needed to do something a little more light-hearted for his next film, his latest documentary, Life, Animated, is an entirely different project.

At the age of 3, Owen Suskind completely shut off from the world and became unable to communicate. His parents soon discovered that he had autism and may never be able to speak again, and were heartbroken at the thought of how the relationship they had dreamed of may never fully exist. After trying many tactics with professional help, eventually Owen learned how to communicate by watching scenes from Disney animated movies such as Aladdin, The Jungle Book, and The Little Mermaid. The exaggerated character movements and expressions became a tool for Owen to learn his language skills, describe his emotions, and gain an understanding of how to express himself in situations he will experience. Life, Animated is not only a touching film, it also successfully widens the understanding of an often mysterious mental state that so many people are affected by.

### Viva

While the film is Ireland's official Oscar submission due to director Paddy Breathnach's home country (and source of financing), Viva is a film set entirely in Havana, Cuba, and serves as a window into the unique world of Cuban drag performers at a local nightclub.

Our protagonist, Jesus (Héctor Medina), barely survives off meager wages and temporary work, but dreams of being a drag star like his mentor Mama (Luis Alberto García). His road to local stardom starts out extremely well as he has plenty of potential, but hits a major hurdle when his father, a convict, comes home unexpectedly from prison. As a former be the film's calling card and what makes it so memorable. As both a father-son drama and an introduction into a world foreign to many of us, Viva is a success all around.

### Belgica

There is rich enough texture in his new film, Belgica, to truly marvel at the craft and storytelling. A festival programmer introduced this film, one of Sundance's opening night selections, with the following statement: "For the last few years, we have been trying to get the World Dramatic category as top-tier as our US Dramatic. This year, thanks in part to this film, I think we finally reached that."

The title comes from the bar in which the film takes place. Two brothers come together to expand what was previously a hole-inthe-wall bar into a full-on destination with a massive remodel. As their dream version of Belgica comes into fruition, so do added layers of conflict that arise with the massive growth: trouble with the new crowds, women, drugs, and differences in opinion on the bar's future. The standout is the photography, which utilizes a broad variety of motifs and themes to display the strife that the two brothers are experiencing. At the beginning when the bar is small, the film carries a red hue with intimacy and fun themes, and as the bar expands beyond their control the color schemes shift toward a harsh and cold blue. That may be the largest visual shift but throughout there are numerous deliberate lighting decisions made to subtly enhance the viewer's understanding of these characters. For the experience of vicariously owning and living at a bar, which includes both raging fun and slamming comedowns, Belgica is a compelling piece that visually stands above the crowd. •

# **Board Approves Agreement to Provide Occupational Therapy Services**

Members of the Hawthorne School Board voted to approve and ratify and Individual Service Agreement between the Hawthorne School District and Gallagher Pediatric Therapy that will provide occupational therapy services.

Gallagher Pediatric Therapy [GPT] is a private pediatric practice that provides services via its multidisciplinary staff of occupational therapists [OTs], certified occupational therapy assistants [COTAs] and physical therapists [PTs].

"Our occupational therapy and physical therapy practitioners specialize in the evaluation, treatment and management of children, including infants, youth and adolescents, with a variety of developmental, sensory, motor, neuromuscular, educational and psychosocial disorders, who may experience functional performance limitations," states GPT's website. "Our mission is to create opportunities for children, including infants, youth and adolescents, to master developmental tasks, increase performance capacity, and achieve independence in their home, school and community."

The agreement with the Hawthorne School District is for GPT to provide occupational therapy services to a kindergarten student, [A.A.], who attends the Special Day Class at Eucalyptus School. The agreed-to services include once-a-week sessions, for 30 minutes a session. The hourly rate for these services is for \$88 and will total cost of \$1,364. The agreement will also include occupational therapy services for a preschool student, [A.D.]; the student attends multiple disabilities program provided through Los Angeles County Office of Education Division of Special Education. This student will also receive once-a-week sessions, for 30 minutes each session, at the same rate and as the previous student but at a total cost of \$1,452.

GPT's therapists provide their services by working in a variety of settings, including clinical environments, schools and homes throughout the Los Angeles, Orange, San Bernardino and Riverside counties.

"We provide direct service as well as consultation with families and educators to serve children with special needs across multiple settings," states the GPT homepage. "These services include structured and unstructured assessment by means of skilled and functional observations or assessment via the administration and careful interpretation of formal [standardized] and informal [non-standardized] tests and measurements."

Other services to be provided through the agreement include occupational therapy services to a kindergarten student, [D.G.], who attends the autism program through Los Angeles County Office of Education Division of Special Education. Services will also be provided once a week in 30-minute sessions. In addition, nine sessions of compensatory services will be provide at an hourly rate of \$88, for a total cost of \$1,496.

Through its clinical and school-based practice, GPT's goal is to provide quality services that include "the evaluation and provision of treatment in collaboration with the child, family or other relevant individuals" as well as to fully develop, enhance, maintain or reestablish sensory, motor, perceptual, neuromuscular or oral-motor functioning skills. The same goal is established for the organization of behavior, adaptive behavior or psychosocial components of performance.

"Our staff is committed to providing services to children in combination with their primary care and specialty care providers, school(s), and other involved community-based service agencies," states the GPT website. "The staff at GPT works closely with the child's family to address the family's needs and concerns, and to incorporate the goals of the family in developing and imple-

menting their child's treatment program."

GPT staff intervenes directly in order to develop, enhance, maintain or reestablish daily living skills such as play or leisure skills, social skills, academic skills, self-help skills and prevocational skills. These efforts include educating the child, the child's family or any other relevant individuals in order to implement adequate interventions.

One preschool student from Prairie Vista South Campus will also receive occupational therapy services once a week, at one-hour sessions, and will include an additional three, one-hour sessions per month. The hourly rate will also be \$88 but the total cost will be \$3,960. Lastly, occupational therapy services will be provided to a kindergarten student, [S.H.], who attends the Resource Specialist Program at Jefferson School. The student will receive services once a week, 30-minute sessions, in addition to consultation services six times a year, 30-minute sessions, at an hourly rate of eighty-eight dollars \$88. The total cost of the student's services will be \$1,232. The agreement for these services will be funded via non-public agency funds.


event on Friday, January 29th from 3:30 to 7:30 p.m. There will be clinics and games for the kids.

# Tough Luck Leuzinger Falls Short to North

Despite youth, Leuzinger High first year head boys' basketball coach Arturo Jones had hopes that the Olympians would be strong contenders for their second consecutive Pioneer League title and, maybe, go far in the CIF-Southern Section playoffs. Instead, the Olympians are 1-3 in league play losing two of those games by one point, including a 68-67 defeat to host North Torrance last Friday.

The game was close all of the way. The Olympians held a slim 19-18 lead after the first quarter. The contest was tied at 36 at halftime and Leuzinger (9-9 overall) took a 51-46 after three periods. The Olympians continued to lead throughout most of the fourth quarter but a big three-point basket from Isaiah Holmes gave the Saxons (3-1 in league) a 64-63 lead with about 1:30 left in the game which proved to be pivotal. From there, North continued to have the edge and held on.

Jones blamed poor free throw shooting and lack of defensive rebounding on the loss. "Poor free throw shooting killed us," Jones said. "We dropped two games by one point and they were on baskets from offensive rebounds in the final seconds." The Olympians' other one-

point league loss was in their opener at West Torrance 52-51 on Jan. 13 when the Warriors pulled it out after an offensive rebound that resulted into their winning basket.

Leuzinger managed to have balanced scoring with four players in double figures. Kavon Fair led the Olympians with 13 points, followed closely by Terrell Williams and Anthony Hamilton with 12 apiece. Damani Washington added 11 points. Despite Fair's team leading scoring effort, he made just one of eight free throw attempts. Leuzinger made 17 of 30 from the charity line. North was led by Holmes and Tyler Johnson with 15 points apiece. Johnson scored 14 of those points in the first half.

At Leuzinger on January 20, the Olympians made just 10 of 35 free throw attempts but managed to defeat South Torrance 53-45. Williams led Leuzinger with 17 points, followed by Washington with 13.

The Olympians visited Lawndale in a cross town rival non-league game last Monday then resumed Pioneer play at Centennial in Compton on Wednesday. Leuzinger hosts West in hope to avenge one of their one-point losses Friday at 7:30 p.m. The Olympians visit league leading Torrance (4-0 in league and 13-7 overall) next Wednesday at the same time.

### MORNINGSIDE WINS TWO

After losing its first two Bay League games on the road to Rolling Hills Estates Peninsula and Redondo two weeks ago, Morningside High's boys' basketball team got on the right track returning home to defeat Palos Verdes and Mira Costa last week. The Monarchs held off the Sea Kings 65-59 on January 20, then slipped past the Mustangs 70-66 last Friday.

Against Mira Costa, Patrick Jeune sparked Morningside with 21 points and 10 rebounds. Brandon Anyanwu added 16 points and 10 rebounds. Kameron Khalbeer and Charles Wright chipped in 14 and 10 points, in order.

Two days earlier, Anyanwu led the Monarchs (13-7 overall and 2-2 in league) with 19 points and 10 rebounds. Jeune contributed 17 points, eight rebounds and five steals. Arkel Lord had 10 points. Khabeer dished out eight assists.

With the victories, Morningside moved into a four-way tie with Inglewood, Mira Costa and Peninsula for second place at 2-2. Redondo, one of the top teams in California, leads at 4-0 and Palos Verdes is 0-4 in league.

The Monarchs were at cross town rival Inglewood last Tuesday and host Peninsula Friday at 7:30 p.m. Morningside also has a home game against Redondo next Tuesday at the same time. The Panthers helped force the four-way deadlock for second place with a come-from-behind 68-62 victory over the Sentinels last Friday. The Sea Hawks had little trouble at Palos Verdes with a 77-28 victory on Friday.

### **INGLEWOOD SPLITS**

Inglewood High's boys' basketball team played two away Bay League games last week. The Sentinels started out by topping Mira Costa 55-47, but fell to Peninsula 68-62 on Friday.

Last Friday, Inglewood had trouble containing the Panthers' leading scorer Mickey Bebeck who scored a game-high 33 points. The Sentinels held a 51-47 edge after three quarters before Peninsula outscored Inglewood 21-11 in the final period. Terrell Gomez led Inglewood (14-6 overall and 2-2 in league) with 21 points.

Gomez sparked the Sents with 15 points, seven assists and five rebounds in their win at Mira Costa on January 19. Jordan Bell finished with 14 points and nine rebounds and Chance Hunter tallied 11 points and nine rebounds.

# **Grilled Butterflied American Lamb** Leg with Mint-Pistachio Pesto

Serves: 6-8

### **Ingredients**

• 3 pounds boneless leg of American lamb, butterflied, salt and pepper (to taste)

### FOR MINT-PISTACHIO PESTO

- 1 cup shelled pistachios
- 1 cup fresh mint (leaves only)
- 1/2 cup fresh Italian parsley
- 1/4 cup plus 2 tablespoons extra-virgin olive oil
- 2 tablespoons red wine vinegar
- tablespoon lemon juice (to taste)
- 1 teaspoon lemon zest
- 1/2 teaspoon sea salt (to taste)
- freshly ground black pepper (to taste) pinch red chili pepper flakes

### **Preparation**

- 1. Heat oven to 350 F. Lay lamb leg open on a cutting board. Trim off visible fat. Season lamb generously with salt and pepper; allow to sit at room temperature for 30 minutes prior to grilling.
- 2. Toast pistachios by placing in single layer in shallow dish or pan and baking 8 to 10 minutes.
- 3. In food processor, add pistachios, mint, parsley, oil, vinegar, lemon juice, lemon zest, salt, pepper and chili flakes; blend until somewhat chunky.
- 4. Heat grill to medium-high. Grill lamb leg to medium-rare (remove from heat when thermometer reads between 130 F and 135 F), or to desired doneness. Rest meat, lightly covered, for at least 10 minutes before serving. Slice meat across grain into thin slices.
- 5. Serve lamb with pesto, grilled vegetables and salad. •
