

# Where Rock Fans Head For A Strange Brew

Rock & Brews has leapt from a corner nobody wanted in El Segundo onto a national stage using the KISS principle.

From Southern California to San Antonio, fans of rock music, burgers, buffalo wings and beer have embraced the bar-and-grill concept that co-founder Michael Zislis and his rock-star partners started four years ago in the South Bay. Rock & Brews from the beginning had a simple proposition: Give the people grub, grog and a good time.

Zislis recalls partners - Gene Simmons and Paul Stanley of KISS - having a lukewarm reaction to the original location, which had been a pizza restaurant until the economy tanked in 2008. Dave Furano, a rock promoter and business partner, pushed for the flagship Rock & Brews to start on Main Street in El Segundo. Dave's brother, Dell, also got involved before the concept took off.

Rock & Brews is one of America's fastest-growing small restaurant chains, according to Restaurant Business journal. The 15 locations include Albuquerque, N.M.; Buena Park; Cabo, Mexico; The Colony, Texas; Corona, Calif.; Oklahoma City; Overland Park, Kan.; Oviedo, Fla.; Paia, Maui; and at StubHub Center in Carson and the AT&T Center in San Antonio, Texas.

A Dallas Rock & Brews just opened and will celebrate with a grand opening May 10. It's much bigger than either the El Segundo or Pacific Coast Highway restaurants, and the menu has some regional favorites like fried catfish, sweet heat chicken and Miner's Gold BBQ with a sweet mustard base.

What Dallas, PCH and El Segundo have in common is parking. Some reviewers on Yelp complain about the parking, which is valet. It's not that there's too little in Dallas. Self-parking isn't practical at the newest location, they say.

South Bayans could step into the Dallas restaurant and not skip a beat, Zislis said. The designer kept the open-air seating and the red-barn look and high ceilings, but the picnic benches are pushed apart. It seems, Texans like their personal space.

Gene Simmons is the star attraction in the enterprise, and co-KISS member Paul Stanley

is a close second. Their other two partners, Dell and Dave Furano, are rock promoters with a glitzy client list that includes Led Zeppelin, Rolling Stones, Bob Dylan, Grateful Dead and George Harrison. The musicians and the roadies know how to drink beer. Michael Zislis knows how to make it.

Zislis attained master brewer status while a student at the University of Southern California, and brought to the Rock & Brew concept his expertise and background in craft beer and food service. Zislis opened his Manhattan Beach Brewing Company in the 1980s, before beer was trendy.

Rock & Brews carries locally crafted brews at each of its locations, making a visit to any of the restaurants outside Southern California a chance to sample new beers. The decor screams rock 'n' roll, but beer is celebrated as much as KISS and the legendary bands plastered on the walls.

Before a new restaurant opens, the owners meet with local breweries to sample and decide which up-and-comers the bar staff will promote when they're asked about the hometown selections. He's introduced the El Segundo Brewery and its Mayberry IPA to Southwest and Delta travelers who've grabbed a bar stool waiting for a flight at Los Angeles International Airport.

The Rock & Brews concept features a menu built on American appetites for burgers, wings and beers. People living in New Mexico and Texas don't eat the same way that Southern Californians do, so a regional specialities section was added to the menu once expansion got under way.

A New Mexico diner wants green chiles on his burger, and in Florida they like their barbecue sauce made with mustard, according to Zislis. A kale salad, which is a top seller at the South Bay and Buena Park restaurants, isn't listed on the menus outside of Southern California.

Zislis said as many as eight more restaurants could open this year and a dozen more in 2017. The company doesn't own or operate all of the locations, though the partners want to open more of their own around Southern California. •

# **Mayor and Council Members Installed**

More than 30 visitors and community members lined the standing room only chambers of the Lawndale City Council last week to witness the installation of reelected Council Members Dan Reid and James H. Osborne, alongside re-elected Mayor Robert Pullen-Miles. The special meeting proceeded with a cavalcade of local legislators and community leaders expressing their congratulations and best wishes to the Council.

The Honorable Herb Wesson, president of the Los Angeles City Council was on hand to swear Mayor Pullen in to his second term. Pullen thanked the city for their continued confidence in him and thanked his wife the first lady and his daughters, as his source of inspiration.

Councilman Reid was sworn in by the Reverend Michael Harrison.

Councilman Osborne was sworn in by the City Clerk. The election was certified by a vote of the council and the Oath of Allegiance was sworn by each of the newly elected members.

Jeffrey Prang presented the council with a commendation from the office of the Los Angeles County Tax Assessor. He thanked the council for its leadership and public service. "You should know how highly regarded the city of Lawndale is within the local principalities," said Prang.

In the final action item of the evening, Osborne nominated Pat Kearney to serve as mayor pro tem, to fill the chair of the late Larry Rudolph. The motion was seconded by the mayor. With Kearney abstaining, the vote carried. Kearns will serve the remainder of Rudolph's term, through May 2017. •

# Wiseburn School Board

The Wiseburn School Board Trustees met last week to take action on a host of items regarding ongoing construction at the new Wiseburn High School site. Preceding the regular meeting, the board met in a one-hour closed session to deal with matters of faculty, personnel and potential litigation.

Director of Facilities Planning Vince Madson was on hand to update the board on more than 20 change orders at the Wiseburn site. The campus, at 201 North Douglas Street, is set to open in 2017.

The board granted authority to Madsen and District Superintendent Tom Johnstone to approve change orders, up to \$5000. Madsen said change orders, literally, requests to alter existing plans and equipment or vendors costs, will be brought before the board at the first meeting of each month. Contracts will need to be revisited if the change is more than a three percent increase, said Madsen. After some discussion, the multiple orders were unanimously approved.

Actionable items proceeded with unanimous board approval of a multi-year district arts plan; contract renewal with CSMC (Charter School Management Corporation); payment to law firm Atkinson, Adelson, et al, and approval of various purchase orders, warrants and receipts. Seven routine consent items were acted upon as one motion, with unanimous approval. Four personnel items, including an increase to the daily pay rate for substitute teachers, were passed with full board approval.

The board also honored two district stand-out

students. Superintendent Johnstone presented Clayton Skaggs with the district's certificate of achievement. Skaggs, a 6<sup>th</sup> grader from Dana Middle School, took first place in the district-wide spelling bee. Eighth-grader Katherine Taylor, also from Dana, received an achievement certificate from the superintendent for her 1<sup>st</sup> place win in the Wiseburn Geography Bee.

Next, the board heard presentations from Harmony Project and the district's special education team. Margaret Martin gave an engaging and detailed presentation on Harmony Project's music education initiatives. The program has been featured in several research journals and boasts proven results, particularly in urban school settings, according to Martin. Board members asked for clarification on the data and brain mapping slides in the presentation.

Martin said that while educators may not be reading neurological journals, these studies show in exacting detail the improvements to brain function and learning acquisition that occur when music education is fully supported within the curriculum.

"I can focus better," is what the kids are saying, said Martin, while the hard data points to across the board improvements in academics. The program amounts to a "literary intervention," said Martin. She encouraged the board to consider the positive benefits of bringing Harmony Project to Wiseburn students.

The special education department's annual Accountability and Progress Report showcased positive outcomes of the program and goals for the future. Cathy Waller, director of psychological and child services, said that a recent survey of parents indicates they are highly satisfied with the services their children are receiving through the district.

Waller said contributions from the district's general fund are a concern, adding that nonetheless, Wiseburn's special education budget is in line with comparable programs in the area.

Executive Director Mary Ring said that one goal of her unit is to reduce dependence on the general fund by the end of the school year. Future goals include training of the general education staff and transition planning to enhance continuity as special needs students move between schools and from one grade level to another.

As there were no public comments, the meeting continued with board members reports. Neil Goldman reported on a financial literacy program sponsored by Kinecta. The Bite of Reality workshop assigns participating students a simulated "occupation and salary," debt and expenses and then guides them through financial activities like planning a budget, shopping, buying health insurance and childcare.

Roger Banuelos said that after seeing students' positive responses to a recent trip to Catalina, he was very interested in getting more field trips added to the school calendar. Banuelos was among a group who visited the Orange County School of the Arts. He said he was very impressed with the arts curriculum and overall student enthusiasm. "The student's level of engagement is amazing," said Banuelos. Johnstone also commended the Orange

County arts program. He mentioned a financial contribution that would be coming from an elder member of the Oceangate community and an impressive student variety show he attended at Anza, that can be viewed on You Tube.

Board President Israel Mora expressed future goals for the board, including increasing efforts to focus on parents and early identification of students who are not fully engaged.

Vice President Joanne Kaneda, referring to the wealth of information shared at this meeting, said, "This solidifies to me, that education is changing." Kaneda thanked Superintendent Johnstone for continuing to push the board to excel at its goal areas of enhancing education in the district.

Nelson Martinez reported on a student panel he attended on career readiness and job experience. He was impressed by the poise of Wiseburn students, saying, "It confirmed to me that we're headed in the right direction." Deputy Superintendent Chris Jones reported on "future ready" schools, a national initiative to increase technology equipment and education.

David Wilson, Chief Business Official, advised that the state is anticipating a projected budget short-fall of 1.1 billion dollars. Wilson said the full effect will most likely be unpredictable until the governor's May revision to the budget.

The Wiseburn District budget for 2016-17 will be on agenda at a special meeting, the morning of June 30. The time is yet to be announced. The next scheduled meeting of the Wiseburn Unified School District Board of Trustees will be May 12, 2016 at 5 p.m. •
