City Council to Review Proposed Budget from the Lawndale Finance Committee

The Lawndale Finance Committee delivered on its mandate to bring a balanced budget to the City Council, presenting a special interactive workshop at Monday's meeting. The \$13.3 million proposed budget for 2016-17 is under review by the council, and will be brought forth for action no later than June 30.

City Manager Stephen Mandoki began the briefing, pointing out an operating surplus of \$50,000 not currently obligated. "We have taken many measures," Mandoki said. "To fund reductions and present you a balanced budget, and we have."

Mandoki said savings were realized from a tech position in the sheriff's office being absorbed into a single post. He also pointed out the need to reconsider funding staff, with Rudolph Park and the new teen center coming on line this fiscal year.

Finance Director Kenneth Louie presented the budget overview, noting the city's major revenues remain solid, with general fund revenues at a pace with projected expenditures. Lawndale continues to hold in reserve more than 100 percent of its total budget, as mandated. The city's hefty general fund holds an estimated balance of \$17.7 million, generated through property taxes, sales tax, UUT and motor vehicles fees.

Louie cited a report from the California Policy Center, ranking Lawndale in the 95th percentile of healthiest cities, from a financial standpoint. Other highlights included \$171,000 in storm drain expenditures; an anticipated update of building fees to match county funds; and a significant increase to the sheriff's budget. The total increase to the sheriff's department represents \$309,000, including a base contract increase of 3.7 percent and an increase to 9.5 percent, up from 6 percent last year, to the liability trust fund.

Other detailed reports from city departments followed. Debbie Holland, municipal services manager, pointed out a line item request to purchase a replacement staff vehicle. The \$30,000 purchase of a hybrid vehicle will come from Air Quality Management (AQDM) grant funds.

Tom Strickfadden, cable television supervisor, was excited to report reductions in Lawndale's cable budget. "This year, we're gonna save a lot of money," Strickfadden said.

Lawndale operates two cable stations (channels 3 and 22). Last year's budget support for the department included a one-time \$600,000 contribution for capital upgrades, which won't be needed in this budget.

Reporting on the Community Services department, Manager Mike Estes noted a \$13,000 budget reduction, "with no reduction in services." Estes said his office achieved the savings by adjusting staffing at the three city-owned parks according to community flow on varying days. The council responded, saying that coverage at the parks needs to be assured from 10 a.m. until dusk, to guard against undesirable activity.

"We'll have more activity, if there's no personnel," Councilman Dan Reid said. Staff hours might be diverted from the community centers to provide additional coverage at the parks, Councilman James Osborne said.

Mandoki said the committee could look at the surplus funds and bring a recommendation back to the council.

Estes also reported community services will purchase two new vehicles, using grant monies from Proposition A. "Prop A is strictly for transportation," Estes said. Citing that costs for a multi-use staff vehicle, and an 18-person transit van will not come out of general funds.

Public Works Director Frank Senteno presented a "wish list," a spate of unfunded

projects including a \$10,000 concrete grinder and \$100,000 to replace the marquee over Hawthorne with a new LED system. Senteno noted that the annual street maintenance program is on pace to achieve an 80 percent pavement condition index by 2021. "That's better than most cities," Senteno said. Mentioning several Lawndale neighbors.

Other unfunded public works projects include the City Facilities Assistance Master Plan and ADA transfer plan; railroad storm drain culvert repairs; and replacement of the community centers' HVAC controls. Senteno said he particularly favored funding an additional project--the CNG fueling station replacement, which has a price tag of \$540,000 over 15 years.

Assistant City Clerk Pam Giamario gladly reported a savings of \$55,000. "There's no election," Giamario said. "There's a few changes, but otherwise everything is completely status quo." Reports from the Finance and Information Technology (IT) were reviewed without further comment.

Mandoki recapped the comments, noting the council's requests to discontinue sidewalk sales and associated promotional costs; revisit funding for staffing at the parks; and consider allocations for the four unfunded projects. The council thanked Finance for its work, with Osborne noting how often members hear that Lawndale is the subject of envy for its fiscal responsibility. Mayor Pullen agreed, saying, "Our task is to look at and under every penny. The money is there to serve the people, not just to sit in our coffers."

In other business, the council recessed for a brief closed session regarding labor relations pursuant to government code 54957.6, after which there was no reportable action.

The next meeting of the City Council will be Monday, May 16 at 6:30 p.m. in the Lawndale City Hall council chambers. •

(BPT) - Seniors are one of the five groups most at-risk for identity theft, according to a report from U.S. News & World Report. Because your cellphone or smartphone likely contains personal information about you that may include your name, home address, phone number and financial account information, a lost, stolen or hacked phone can be a treasure trove for criminals.

Consumer Cellular, which specializes in no-contract cellphone service and phones primarily for people 50 and older, offers some advice for securing your cellphone:

- · Always use strong passwords. You may be tempted to use one password for all your accounts because it's easier to remember one rather than multiple. However, if your login information is compromised, a single password makes it easier for crooks to gain access to all your accounts. Use numbers, symbols and capital letters in place of lowercase letters to strengthen your passwords. If you're not sure how to create a strong password, Microsoft offers a helpful free online guide. If you're having trouble remembering passwords, try downloading an app that securely manages all your passwords.
- · Use your phone's built-in security features, such as a lock screen, password protection and data encryption. Many smartphones give you a variety of ways to secure your phone, such as using your fingerprint, entering a PIN or swiping a pattern on the lock screen. A lock and/or encryption ensures that if your phone is

lost or stolen, whoever has it won't be able to easily access data stored on the phone.

- · Back-up your phone's data, especially if you use it to capture photos and videos. If your phone gets damaged, lost or stolen, you can easily restore the data onto another eligible device. In addition, backing-up data can help your phone run more efficiently. Storing data on the device takes up a lot of memory and can slow it down.
- Be cautious about what apps you download to your phone. Carefully review the terms and conditions and privacy disclosures of any app you're considering - before you download it. Some apps may collect data about you and share it with the app developer or others.
- Don't forget to add your cellphone number to the National Do Not Call Registry (www.donotcall.gov) so that you don't receive unwanted solicitation calls. Consider blocking your phone number to further protect your privacy; some businesses you call may collect, store and share your phone number and information unless you block it.
- Accidents happen, and smartphones can be costly to repair or replace. An inexpensive way to protect your phone against drops or spills is using a case. It's also a great way to personalize the appearance of your device. Another option is to purchase a protection plan or warranty for your phone through the manufacturer or your wireless provider. •

Local Tracksters Advance to CIF Prelims

Last week was the CIF-Southern Section League Track and Field Championship Week and several local athletes were able to place high enough with good enough marks or times to advance to this week's Southern Section Prelims to be held at various sites.

In the Ocean League Championships last Thursday at Culver City High, Lawndale had some league champions, behind Jaelin Walker who won the long jump and high jump. Walker captured the long jump with a very good leap of 22 feet, three and a half inches and the high jump at five feet, 10 inches. Walker also placed third in the triple jump at 41-7. Bryant Perkinson was able to defend his league title in the triple jump at 43-9. He also finished second in the long jump with a leap of 22-2 and made the Southern Section Division II Prelims in both events. Erick Willis, along with Walker, had a 5-10 high jump but had to settle for a second place due to Walker

having fewer misses. Both move on to the Southern Section Division II Prelims. Kiyaam Cooksey captured the 110-meter high hurdles clocking 15.03 and took second in the 300 intermediates in 39.94 to qualify for CIF in both events. Jonathan Blackman was second in the 100-meter dash timing 11.13 and finished fourth in the 200 in 21.87 seconds. Lawndale's 4x100-meter and 4x400 relays both recorded second place finshes. Its 400 relay squad of Cooksey, Blackman, Perkinson and Demarjae Gilmore was clocked at 43.89 to finish behind winner Culver City (43.11). Closing the meet, the Cardinals 1,600 relay team of Cooksey, Jona Hian, Willis and Jacob Khu placed second at 3:26.94. Santa Monica, behind nationally ranked 400-meter runner Marcel Espinoza, won the race clocking 3:26.17. Espinoza also won the 200 and 400 in the meet.

For the girls, Lawndale's Destiny Jones advanced after taking third in the high jump,

leaping 4-8. The Lady Cardinals also had a second place finish by Ashley Calloway in the shot put with a toss of 30-4. Teammate Kimberly Romero was third at 29-9. El Segundo's Tatiana Taylor won the event throwing 33-4.

"We're hoping to send athletes in at least four events to the championship meet," Lawndale High assistant coach Demitre Howard said. "We had a few close losses. Our boys took second (behind champion Santa Monica) in league. Honestly our kids excelled. We lost some close dual meets. (The Cardinals took third, behind first place Santa Monica and runner-up Culver City in the Ocean League.)"

Hawthorne High's best showing was by Kishawn Berry in the boys' 100-meter dash where he finished third timing 11.43 but it was not good enough to qualify for the CIF-Southern Section Division II Prelims. Culver City's Chalil Hooper won the 100 in 11.0, followed by Blackman.

The Southern Section Division II Prelims will be at Moorpark High, starting at 8 a.m. Saturday. The finishers in each event move on to the Southern Section Divisional Championships on May 21 at Cerritos College with the field events beginning at 11 a.m. and the running events at 1 p.m.

Morningside's boys and Inglewood's girls had a few top showings in last Friday's Bay League Track and Field Championships at Redondo High. Keying the Monarchs was Adarrus Wilson. Wilson won the 100-meter dash at 11.12 seconds and was a close second behind Redondo's Jerone Jackson clocking 22.66 in the 200. Jackson won the 200 in 22.64. The Monarchs also had a league champion by Darren Morgan in the high jump at 6-4. All move on to the CIF-Southern Section Division IV Prelims at Estancia High in Costa Mesa Saturday, beginning at 8 a.m.

For the Lady Sentinels, sophomore Tajanae Nettles placed second in the 400 timing 59.07. Winning the race was Mira Costa's Jaylah Herron in 57.83. Nettles also helped Inglewood's 4x100-meter relay finish second (also behind Mira Costa) clocking 49.31. The Mustangs won the race at 48.91. Nettles and the relay move on to the CIF-Southern Section Division III Prelims Saturday at 8 a.m. at Trabuco Hills High in Mission Viejo. Planet Nine: A World that Shouldn't Exist


Earlier this year scientists presented evidence for Planet Nine, a Neptune-mass planet in an elliptical orbit 10 times farther from our Sun than Pluto. Since then theorists have puzzled over how this planet could end up in such a distant orbit.

New research by astronomers at the Harvard-Smithsonian Center for Astrophysics (CfA) examines a number of scenarios and finds that most of them have low probabilities. Therefore, the presence of Planet Nine remains a mystery.

"The evidence points to Planet Nine existing, but we can't explain for certain how it was produced," says CfA astronomer Gongjie Li, lead author on a paper accepted for publication in the Astrophysical Journal Letters.

Planet Nine circles our Sun at a distance of about 40 billion to 140 billion miles. This places it far beyond all the other planets in our solar system. The question becomes: did it form there, or did it form elsewhere and land in its unusual orbit later?

Li and her co-author Fred Adams (University of Michigan) conducted millions of computer simulations in order to consider three possibilities. The first and most likely



involves a passing star that tugs Planet Nine outward. Such an interaction would not only nudge the planet into a wider orbit but also make that orbit more elliptical. And since the Sun formed in a star cluster with several thousand neighbors, such stellar encounters were more common in the early history of our solar system.

However, an interloping star is more likely to pull Planet Nine away completely and eject it from the solar system. Li and Adams find only a 10 percent probability, at best, of Planet Nine landing in its current orbit. Moreover, the planet would have had to start at an improbably large distance to begin with.

CfA astronomer Scott Kenyon believes he may have the solution to that difficulty. In two papers submitted to the Astrophysical Journal, Kenyon and his co-author Benjamin Bromley (University of Utah) use computer simulations to construct plausible scenarios for the formation of Planet Nine in a wide orbit.

"The simplest solution is for the solar system to make an extra gas giant," says Kenyon.

They propose that Planet Nine formed much closer to the Sun and then interacted with the other gas giants, particularly Jupiter and Saturn. A series of gravitational kicks then could have boosted the planet into a larger and more elliptical orbit over time.

"Think of it like pushing a kid on a swing. If you give them a shove at the right time, over and over, they'll go higher and higher," explains Kenyon. "Then the challenge becomes not shoving the planet so much that you eject it from the solar system."

That could be avoided by interactions with the solar system's gaseous disk, he suggests.

Kenyon and Bromley also examine the possibility that Planet Nine actually formed at a great distance to begin with. They find that the right combination of initial disk mass and disk lifetime could potentially create Planet Nine in time for it to be nudged by Li's passing star.

"The nice thing about these scenarios is that they're observationally testable," Kenyon points out. "A scattered gas giant will look like a cold Neptune, while a planet that formed in place will resemble a giant Pluto with no gas." •

- 1 slices of Artesano™ Style Bread
- 10 12 red onion slivers
- 2 tbs butter, at room tempurature
- 1 tbs canola oil
- 3 tbs aioli
- 4 oz Fontina, sliced or grated
- 2 oz spicy pickle slices
- red pepper flakes (optional)

Preparation

- 1. Preheat skillet over medium heat, add the oil and allow it to warm. Fry the onion slivers until the tips begin to blacken and the edges char. Lower the heat to medium-low and move the pan to a cool burner for a few moments.
- 2. Butter one side of a slice of bread and place it, butter side down, on the skillet. Place skillet back on the medium-low burner.

- When the bottom slice of bread has reached the desire golden brown color, gently press down on the sandwich with your spatula, and carefully flip over.
- 6. Cook until the second piece of bread has reached the desired color and the interior is heated through and the cheese is melted.
