Diversity Looks A Lot Like Home

When the Lawndale City Council chose Bernadette Suarez to fill a vacant seat earlier this spring, no person of Latin descent and certainly no one that young had ever sat on the Lawndale Council. History was being made, but for Lawndale it just felt like business as usual.

Suarez was already serving the second half of a four-year term as city clerk when Larry Rudolph passed suddenly, leaving the council one vote shy of quorum. To fill that seat, the council simply appointed one of its own, a native Lawndalian with deep roots and strong family ties.

"It was definitely an honor," said Suarez, who was sworn in with her parents in attendance, amidst a council chambers brimming with supporters and well-wishers. "To see that support, I was kind of in awe," she added. Suarez said that being one of the youngest, and the only Mexican-American serving on to the council, represents a lot of things for this community.

Lawndale's population is 65 percent Hispanic, she noted. "It's a pretty small [town] and many of the families have been here a while; It just felt right."

Suarez admits there are big shoes to fill in the wake of Rudolph, who had been on council for close to thirty years. She says it's comforting to think that the most elder member of the council is being replaced by the youngest member.

"From a millennial perspective," said Suarez, "it's exciting to think about being around to see what major developments will take place over the next 30 to 35 years in Lawndale and the rest of the south bay."

The Suarez family settled in the area in the 50s, just before Lawndale incorporated as a city. "I think it must have been an ideal location," Suarez said. "Affordable, close to the beach and perfect weather." It was far away enough from Los Angeles and the commotion of the big city. The Suarez's thought it was nice place to raise a family, and raise they did.

Suarez falls in the middle of ten siblings, all of whom went to Leuzinger, Lawndale's sole high school. In fact, both her mother and father and their many siblings also went to Leuzinger. "My family still has friends from school who live all around the South bay," Suarez said.

Suarez got her first taste of civic engagement watching her mother. "Dad was working full-time," she said, "and Mom took care of us. She was always present, guiding us through school. She decided to get involved." Sandra Suarez was active at her children's' elementary schools; she eventually went on to reactivate the Parent Teachers Association (PTA) at Leuzinger, which had been dormant for years.

By the time her mother had been elected board member at Centinela Valley Union High School District, the younger Suarez was fully engaged. "I guess I was the one to take after her."

She remembers walking her neighborhood while still in elementary school, campaigning for a young man, only 19 years old, who was running for the school board. "It shaped my childhood," she said. "I've always been aware of what's going on, especially at the local level."

Suarez says she is transitioning well into the new post, and admits there is a lot to learn. "I feel like everyone new starts off in that position," she says. "I was lucky to come on council at the time I did, when everything is stable. We have a balanced budget and a lot of major projects completed."

Looking ahead, Suarez will have the opportunity for greater input in two development projects—the proposed Lawndale teen center, which will break ground in 2017, and the already underway development of the lot at Redondo Beach and Hawthorne boulevards.

"We are waiting on those [plans] to finalize," said Suarez, who sees the potential for a space that will accommodate family dining and still be inviting to foot traffic and the fast casual dining attractive to the youth market.

Once the mixed-use space is approved, it will be a draw for commuters passing through and for the traffic expected from the NFL stadium coming to Inglewood in 2018. "It's an ideal location, right next to the freeway, so we'll see," said Suarez, who is very interested

in encouraging foot traffic. "It's one more place to generate revenue," Suarez said. "That could be good for the city"

One of the major challenges Suarez sees is the perennial thorn in the municipal side-parking. "It seems simple," she says, but Lawndale is a high rental area, so space is at a premium.

Other challenges facing Lawndale are common to other south bay cities, like road maintenance, and the California drought. Suarez believes the city is solid enough to take those things in stride.

The Metro project is another thing, though. "It's up in the air," she says. "[LA] is trying to pass the tax measure, so it's on hold." Suarez points out that some local cities are actively opposing the rail cutting through their territory, but Lawndale is taking a more measured approach.

"I think it's inevitable," Suarez said.
"Lawndale's main concern is getting it as noise proof as possible and getting it under our terms."

As a young millennial, Suarez is definitely helping to move the community of Lawndale into the 21st century. When asked if she will run for election when her appointed term expires in 2018, her response is, "Definitely." She thinks Lawndale can grow, and keep its small town feel. "That's what makes it so great." •

South Bay Physician Takes Whole Person Care to New Heights

While serving his internship in Fresno in the late 1970s, young physician in training Ira Byock had an interaction with a patient that would forever change his life. The exchange seems rather nondescript at first glance. "How are you doing this morning, Mr. Rodriguez?" Dr. Byock had asked. "I'm well," Mr. Rodriguez replied. That was it. And yet, the patient was dying and knew very well that his days left on this planet were severely numbered. The moment left Dr. Byock perplexed.

"At first, I didn't know what to do with it," he said. "Was Mr. Rodriguez just being polite, or was he in some euphoric state from painkillers? But then I realized that it is possible to express a sense of well-being even if you know you are dying, may be sad about it, or are physically uncomfortable. The concept fascinated me and I knew then and there that I wanted to help other people achieve that feeling."

Fast forward 37 years or so and Dr. Byock is now one of the nation's foremost figures in the world of palliative medicine (specialized, multi-dimensional care for those with serious illnesses, with the focus on improving quality of life for both patient and family). He is the author of three acclaimed books (Dying Well, The Four Things That Matter Most, and The Best Care Possible) with countless essays under his belt as well as a 10-year directorial stint at the Dartmouth-Hitchcock Medical Center in New Hampshire that paved the way for his 2014 move to the South Bay to head up the Providence Institute for Human Caring at the Torrance-based Providence Health & Services. The Institute's mission (as noted on the website IraByock.org) is to "help people understand how they can be more engaged in

their own care, how to support loved ones who are experiencing medical issues and how best to cope with the strains of caregiving, and later, the strains of grief." The Institute's staff of 16 includes physicians, nurses, educators and data analysts who work closely with doctors, hospital leaders and other health care professionals encompassing a 50-hospital, seven-state system to give them the tools to provide the best possible whole person care.

As Dr. Byock explained, "Individuals are not just defined by their diagnoses and need for treatment, but as people with emotional, interpersonal, social and spiritual components. We want to attend to their needs and maximize their comfort and well-being including during difficult times of illness. There is clear agreement that American mainstream medicine often does more to people who are dying than is in anyone's best interest. We are finding that by focusing on people's well-being and not just their disease that they tend to live longer and feel better—and costs are down because they get their needs met more often at home."

To further elaborate the difference between the old and new models of care, Dr. Byock presented two different versions of a particular patient case study: "Let's say someone has surgery on his heart valve, but has a stroke during the surgery. The family is shocked. The patient is on a ventilator, can't speak, is sedated and on powerful drugs. It's common for the family members to not know what to do and they are unable to speak with any authority about the patient's wishes. By default, the patient stays in ICU. If they don't get better, they transfer to long-term acute care or die in ICU. In contrast-under highly personalized care, the risks are welldiscussed before surgery with the patient and family members on what they would want to have happen if there is a stroke or other complication. The family would have clear authority to speak on the patient's behalf. Every five to seven days in ICU, there would be a formal conversation to see if the treatment is consistent with what was wanted. And the family will also be 'treated' for their own stress to ensure they are getting enough rest, have a place to clean up or shower and ways to communicate with extended family and friends. We would look at this as a personal experience and not just a medical event."

Among the most telling statistics, 70 percent of Americans say they would rather die at home surrounded by loved ones than in a hospital—and yet sure enough, 70 percent die in a hospital, nursing home or long-term care facility. The result in most cases is unnecessary, ineffective, often-unwanted and very costly medical treatments at the end of life that can lead to financial ruin and family discord. To address the situation, Dr. Byock advocates that all patients over 18 have advance health care directives on file. Under the new system, caregivers receive training on how to provide advanced care planning and how to discuss serious illnesses with patients and families while always keeping the patient's specific needs at the forefront.

"If we know anything about illness, people's needs are highly personal—so the best care is not a one-size-fits-all model," Dr. Byock noted. "Before we ask, 'What's the matter with you?"...we ask, 'What matters most to you?' so that we can make sure we're not just doing things *to* people but know what their goals are in order to make decisions about treatment *with* them and not *for* them. Ethnicity, upbringing, religion and individual idiosyncrasies can all play a part."

While it has taken decades to get this far, Dr. Byock reports huge inroads made in moving to a whole person care philosophy. "Through the work the Institute is doing, we are driving a transformation that can be an example to the rest of the country," he said. "The future of health care is in personcentered care and Providence Little Company of Mary is an ardent supporter and major leader in this progression."

Born and raised on the Jersey Shore, Dr. Byock had no clue what he wanted to do for his future living when he started his college studies in the Washington, D.C. area. "In high school, my assumption was whatever I

did in my career shouldn't require that much college," he said. He took a few political science courses, but found himself floundering. "But then when I challenged that assumption and just looked at what truly interested me, it was clear I wanted to help take care of people. It was like the clouds finally cleared." He went on to complete his undergrad work at the University of Colorado with a degree in biology and continued to medical school there with the eventual post-graduate work in Fresno as part of the University of California, San Francisco program.

"I thought I would be a rural family doctor and did that for a short time," Dr. Byock said of his early career. "I was also enamored with emergency medicine and started a hospice. I did a lot of volunteer work and saw many patients at their homes." Spurred by his experience with Mr. Rodriguez and others, he began to serve on committees as an early proponent of palliative care and wrote a number of papers on the subject. In the late 1990s, he accepted an offer to lead a national program to provide grants and technical assistance to health care systems trying to integrate hospice-like care within the mainstream.

Dr. Byock worked with the Robert Wood Johnson Foundation to establish palliative care in ICUs, rural health clinics, pediatric specialty hospitals and even the state penitentiary. "It all worked brilliantly and opened up the doors to expand palliative care across the country," he said. "At Dartmouth, we spent a decade building out palliative care within the medical center and through teaching programs. Now at Providence, we hope to take it to the next level where the whole person model will be the new mainstream."

Married with two grown daughters and a couple of grandkids plus other family in the Los Angeles area, Dr. Byock lives close to the hospital and has quickly grown used to the pleasures of West Coast weather and the South Bay's many amenities. "We are enjoying ourselves a great deal," he confirmed, though he admitted his schedule is packed to the gills. "I rarely get to see patients anymore these days. At this point, I need to do what I can do to support others in this effort..."

Dr. Ira Byock will hold a workshop on advance care planning at the Redondo Beach Library (303 N. Pacific Coast Highway) on Friday, Sept. 23 from 1 to 3 p.m. The event is free, but registration required. The Hawthorne City Council approved the development set for the site of the old police station located across from the city hall. Two Merriott will be going in with approximately 300 rooms. When fully up and running sometime in 2018 they are expected to generate approximately \$2 million in

With Damion Porter at the helm for his third season, he saw his Leuzinger High football team make steps up as it steadily improved. This year, the Olympians return most of their starters from a 5-5 team that narrowly missed making the CIF-Southern Section Western Division playoffs as they are seeking, not only a spot in the newly revamped Southern Section Division X playoffs, but the Pioneer League and even the Southern Section title, something they have not accomplished since 1985. Currently in its first ranking, Leuzinger is ranked ninth in the division.

Last Friday, the Olympians began their season with a stiff non-league game against Lakewood from the always tough Moore League, which is led by powerhouse Long Beach Poly. Elijah Miles ran for 60 yards and scored a touchdown. Wide receiver Tariq Culpepper caught five passes for 98 yards and two touchdowns.

Leuzinger hopes to add on to its good start as it continues its competitive preseason schedule at always tough El Segundo High Friday at 7 p.m. Two years ago, the Eagles captured the Ocean League crown but last season, the Eagles were faced with rebuilding that saw them finish in a three-way tie for second place with Lawndale, the only of the three teams to advance to the Southern Section Western Division playoffs, and Hawthorne. On the next play, Spartans' running back Tyler Breneman scored from 5 yards out to take a 6-0 lead. The 2-point conversion failed.

The Spartans added another score with running back Vince Dioguardi's 3-yard touchdown run. On the ensuing drive, Kalinowski hit wide receiver Carlos Jacobo on a short pass, Jacobo stiff armed a defender and raced 56 yards for the score, to cut La Canada's lead, 13-7.

"We could've done better and worked as a team," Jacobo said, who finished with seven catches for 185 yards. "We have to beat teams off the ball and work hard."

The Spartans added two fourth quarter touchdowns by Dioguardi to put the game away. Hawthorne will have a short week as they host Rivera High School today at 7 p.m. Rivera is coming off a 38-0 loss to Marquez.

"We will watch film and make the corrections," coach Paysinger said. "This game is in the past, now we move forward." •

> • Credit score - Lenders will want to review the credit reports and scores for everyone who is listed as a borrower on the mortgage application. With your written permission, the

credit reporting agency. Generally, the better your credit score is the more likely you will be approved, plus qualify for the best available interest rate from the lender you choose.

• Origination cost - This is the amount the lender charges to process the loan application, which includes gathering and reviewing all loan application documents, underwriting and closing your home loan. This expense typically appears on your loan documents as a "loan origination fee."

"After you apply for a mortgage, the lender should be able to give you an idea of the interest rate you'll likely qualify for," Hamilton says. "With that information, you can use a monthly mortgage payment calculator to estimate just how much the mortgage payment will be each month. 'Almost Famous' Clothing Company Slips Comfortably into America's Malls

Kate Hudson went from being almost famous to a leading actress in Hollywood with just one film, so it's hardly a surprise that her clothing company shot to fame quickly in the fashion industry.

Hudson is the co-owner and celebrity spokes model for the Fabletics line of yoga pants, sports tops and activewear for women and men. She started the El Segundo-based apparel company three years ago with partners Adam Goldenberg and Don Ressler, who made space for Fabletics in their existing headquarters for their online clothing company JustFab.

The partners assembled a team of fashion designers to create activewear to compete with the high-end brands, which Fabletics deemed beyond the price range of many women and working mothers trying to stay fit and look good doing it at the gym and yoga studio. The company personalized online shopping by offering a membership with discounts and a monthly shopping service. Items start at \$25 for members, according to the web site. The "Almost Famous" actress Hudson picks which styles gets shipped to members in the loyalty program.

There's more to Fabletics than meets the eye though. This is an apparel company that had no retail stores until last year and was only selling online. And yet, it attracted 1 million customers who buy off the web site three to four times a year, according to the company. Spokesman Shawn Gold calls its methods for selling active-lifestyle clothing to global consumers a "21st century approach to retail."

The clothier opened for business in fall 2013 and quickly reached milestones that it shared with customers and visitors to its web site. Fashionista Hudson and her partners made 1 million online sale in the first 15 months, and began shipping to Europe, Canada and Australia. Fabletics added a men's line in mid-2015, then reached into Spain and the Netherlands.

Fabletics is still a relatively new brand, yet Gold says it holds a competitive advantage over clothing retailers that have been around for decades. Hudson's company knows what its customers like, based on personal information they provide on the web site. Fabletics uses customer data to manufacture the styles, colors and sizes that it will sell. Getting stuck with unsold clothing is costly to the retailer and reflects in the prices charged to the customer.

"We're using data and personalization to both elevate the customer's experience and take a significant amount of risk out of the fashion industry," Gold said. He referred to the risk of manufacturing and buying clothing that consumers don't want.

By basing its clothing production on customer likes and sizes, Fabletics says it accurately predicts she customers will buy 95 percent of the time. The ability to create products the consumer will buy removes a nagging

inefficiency within the fashion industry. It also lowers return rates on merchandise. The company patterned its production after JustFab, which similarly keeps a personalized customer database.

Though brick-and-mortar retailers, including Nordstroms, offer a personal shopper service, they only have a fraction of their customers enrolled in the popular service. A startup company like JustFab or Fabletics has collected customer information from the beginning, and had dodged the "ship and pray" business model where buyers for retailers and boutiques use a shotgun approach to their inventory. Being an online retailer definitely has its advantages, though lately even Amazon is saying that retail stores might be the next evolution for e-commerce.

Founder and chief executive Jeff Bezos said recently he was toying with an idea of opening Amazon bookstores. Amazon is the world's largest e-commerce company, and dominates online sales in every product category, from gaming to groceries. Walmart is a distant second to Amazon and it's falling further behind in online sales, according to published reports. If Amazon thinks readers want to hold books before buying them, what does that mean for the clothing industry?

Fabletics thinks that retail stores make sense, too, because 80 percent of all clothing is purchased in them. Even if online clothing sales reach 50 percent in five years as expected, that's 50 percent of the market that Fabletics doesn't want to leave on the table, according to Gold. Last fall, the clothier opened its first store in Woodland Hills and it hasn't stopped since.

The company opened six stores a year ago, and the newest Fabletics store is opening this month in the Del Amo Fashion Center. This data-driven clothier is as much a technology company as it is a fashion company, Gold points out. He likens a visit to one of the stores like walking into an Apple store. It's a chance to try out the products first, and maybe go home and purchase online. Fabletics' goal by opening mall stores is to give visitors "a better customer experience," he said.

Again, data and buying patterns determine where the company will open stores because Fabletics plans to stay close to its active customers, according to Gold. By the end of the year, the outfitter will operate stores in Woodland Hills, Mission Viejo, Torrance, Las Vegas, Honolulu, Denver, Salt Lake City, Cincinnati, St. Louis, Charlotte, Newark, Mall of America in Bloomington, Minn., and single stores in Delaware, New Jersey and Maryland.

The El Segundo headquarters employs 400 people, and nearly one-third are involved in media and marketing and not fashion design, according to the company. The JustFab facility on Apollo Drive close to Manhattan Beach includes nearly 40,000 square feet for web and



Film Review

"The Light Between Oceans" is a Darkly Poetic and Affecting Love Story

Director Derek Cianfrance certainly has a knack for portraying "love lost and found." His 2010 indie classic, "Blue Valentine," is a moody and contemporary observation of one couple's dysfunctional relationship while

with the little girl they've come to love and call their own.

It is this impossible choice and the events that follow which makes "The Light Between Oceans" so painstakingly brutal. While author M.L. Stedman takes credit for the story's tragic circumstances, it is the color-

his 2013 indie hit, "The Place Beyond the Pines," deals with familial struggles and the far-reaching repercussions of poor choices. Cianfrance continues to do what he does best, bringing his past experience of showcasing these same themes and questions to his first studio film, based on the acclaimed novel by M.L. Stedman, "The Light Between Oceans." While this film is another romantic drama, written for the screen by Cianfrance, it is a small departure in terms of it being a period film, but that makes it no less relatable to modern audiences.

After four years fighting abroad in World War I, all Tom Sherbourne (Michael Fassbender) craves is isolation and a relatively risk-free routine. When he is offered the position of the lighthouse keeper in a small coastal town in Western Australia, he graciously accepts. After arriving, he meets and quickly falls in love with Isabel (Alicia Vikander) and the two soon marry. Isabel follows Tom to the lighthouse, which stands in seclusion from the rest of the town. They are blissfully in love with each other, domesticating their tiny space on the island they call home and ready to start a family of their own.

Their happiness comes to a sudden halt after two emotionally and physically painful miscarriages. Isabel becomes a shell of her former self, while Tom feels helpless in his efforts to console her. That is until a rowboat washes ashore with a newborn baby girl and her deceased father onboard. Isabel sees this as a sign from God and begs Tom to let her keep the baby instead of reporting the incident per his official protocol. Torn between what he knows is right and his wife's happiness, Tom finally gives in to Isabel's pleas. Life goes on for the couple and their newly acquired baby without consequence until Tom's guilt catches up with him when he sees Hannah Roennfeldt (Rachel Weisz) visiting a grave site. As soon as he realizes that she is the baby girl's birth mother, he knows the awful decision he will have to make. The moral dilemma of whether or not to expose the truth would not only devastate Isabel but ruin the relationship

ful world created by Cianfrance that really drives the story home. Breathtaking visuals cover the screen from start to finish, with the camerawork making the characters seem so small compared to their epic surroundings. These sweeping images of the environment are juxtaposed with extreme closeups as if we are looking at the most intimate details of their relationship through a magnifying glass. In many scenes, the beats between Tom and Isabel's dialogue last longer than a typical film's edit, giving the characters not only a chance to act but react, which is how it achieves its heightened emotional intensity.

Coming off of a strong 2015, Alicia Vikander proves why she, again, deserves to stay on the top this year. Her doe-eyed innocence and warm presence make her a protagonist worth rooting for, despite her flaws. We understand that her heart is in the right place and feel her pain as she finds herself in unspeakable situations. Michael Fassbender taps into his sensitive side as Tom, putting on a brave face for his family despite battling a moral war internally. Rachel Weisz gives a layered performance as Hannah as she experiences a rollercoaster of emotional grief and joy throughout the film. Watching these three powerful lead actors (Vikander and Weisz are Academy-Award winners, Fassbender has been nominated twice), is like truly watching magic on screen.

It would be lazy to call "The Light Between Oceans" this year's "The Notebook," however, there is no denying the strong emotional parallels (plus the fact that Fassbender and Vikander are now dating after meeting on the set a lá Ryan Gosling and Rachel Mc-Adams). "The Light Between Oceans" isn't easy to get through with dry eyes, but this timeless love story is as mesmerizing and beautiful as it is gut-wrenching and powerful, most definitely a top contender in this year's best of lists.

"The Light Between Oceans" is rated PG-13 for thematic material and some sexual content. 132 minutes. In theaters everywhere on Sept. 2. •

Planet Found in Habitable Zone around Nearest Star

Astronomers have found clear evidence of a planet orbiting the closest star to Earth, Proxima Centauri. The long-sought world, designated Proxima b, orbits its cool red parent star every 11 days and has a temperature suitable for liquid water to exist on its surface. This rocky world is a little more massive than the Earth and is the closest exoplanet to us—and it may also be the closest possible abode for life outside the solar system. A paper describing this milestone finding was published in the journal Nature on Aug. 25.

Just over four light-years from the solar system lies a red dwarf star that has been named Proxima Centauri, as it is the closest star to Earth apart from the Sun. This cool star in the southern constellation of Centaurus is too faint to be seen with the unaided eye and lies near to the much brighter pair of stars known as Alpha Centauri AB.

During the first half of 2016, Proxima Centauri was regularly observed with the HARPS spectrograph on the European Southern Observatory (ESO) 3.6-meter telescope at La Silla in Chile, and simultaneously monitored by other telescopes around the world. This was known as the "Pale Red Dot" campaign, in which a team of astronomers led by Guillem Anglada-Escudé, from Queen Mary University of London, was looking for the tiny backand-forth wobble of the star that would be caused by the gravitational pull of a possible orbiting planet.

The Pale Red Dot data, when combined with earlier observations made at ESO observatories and elsewhere, revealed the clear signal of a truly exciting result. At times Proxima Centauri is approaching Earth at about 3 miles per hour-normal human walking pace-and at

times receding at the same speed. This regular pattern of changing radial velocities repeats with a period of 11.2 days. Careful analysis of the resulting tiny Doppler shifts showed that they indicated the presence of a planet with a mass at least 1.3 times that of the Earth, orbiting some 4.5 million miles from Proxima Centauri—only 5 percent of the Earth-Sun distance.

Although Proxima b orbits much closer to its star than Mercury does to the Sun in our solar system, the star itself is far fainter than the Sun. As a result, Proxima b lies well within the habitable zone around the star and has an estimated surface temperature that would allow the presence of liquid water. Despite the temperate orbit of Proxima b, the conditions on the surface may be strongly affected by ultraviolet and X-ray flares from this very active star-far more intense than the Earth experiences from the Sun.

This discovery will be the beginning of extensive further observations, both with current instruments and with the next generation of giant telescopes such as the European Extremely Large Telescope. Proxima b will be a prime target for the hunt for evidence of life elsewhere in the universe. Indeed, the Alpha Centauri system is also the target of humankind's first attempt to travel to another star system, the Starshot (https://breakthroughinitiatives.org/ Initiative/3) project.

Guillem Anglada-Escudé concludes: "Many exoplanets have been found and many more will be found, but searching for the closest potential Earth-analogue and succeeding has been the experience of a lifetime for all of us. Many people's stories and efforts have converged on this discovery. The result is also a tribute to all of them. The search for life on Proxima b comes next." •

WHEREAS, the purpose of this new chapter 8.17B is to establish requirements for the collection and recycling of recyclable materials and collection and

recycling of recyclable materials and collection and organics processing of organic materials generated from commercial facilities, multifamily dwellings, and large events and venues; WHEREAS, these requirements will assist the City of Hawthome ("City") in complying with the Integrated Waste Management Act of 1989 (AB 939 - 1989), Large Events and Venues Recycling Law (AB 2176 - 2004), the Alternative Compliance Act of 2008 (SB 1016 - 2008), the Mandatory Commercial Recycling Act (AB 4341 - 2011) and the Mandatory Commercial Organics Recycling Act (AB 1826 - 2014); WHEREAS, these requirements will also help reduce greenhouse gas emissions associated

8.17.010B Definitions.

'The following words or phrases, whenever used in this Chapter, shall be construed as defined

in this section: Customer' means a generator that contracts for solid waste removal services and enters into a service agreement with a franchised authorized hauler for solid waste collection services.

'Generator' means an owner or responsible party of a commercial property which generates solid waste as a result of its business, commercial activity or other property activity. Generators may include tenants, property managers, and employees and

contractors of generators. contractors of generators. 'Large event' means an event that charges an admission price, or is operated by a local agency, and serves an average of more than 2,000 individuals per day of operation of the event, including, but not limited to, a public, nonprofit, or

privately owned park, parking lot, golf course, street system, or other open space when being used for an event, including, but not limited to, a sporting event or a flea market.

'Large venue' means a permanent venue facility that annually seats or serves an average of more than 2,000 individuals within the grounds of the facility per day of operation of the venue facility. For purposes of this chapter, a venue facility includes, but is not limited to, a public, nonprofit, or privately owned or operated stadium, amphitheater, arena, hall, amusement park, conference or civic center zoo, aquarium, airport, racetrack, horse track, performing arts center, fairground, museum, theater, or other public attraction facility. For purposes of this chapter, a site under common ownership or control that includes more than one large venue

that is configuous with other large venues in the site, is a single large venue. "Organic waste" means food waste, green waste, landscape and pruning waste, nonhazardous wood waste, and food-soiled paper waste that is mixed in with food waste.

in with food waste.

The definitions set forth in Section 8.16.010 and 8.17.010A shall also apply to this chapter. 8.17.020B Commercial generators. Each commercial generator shall be responsible for ensuring and demonstrating its compliance with the requirements of this chapter. Each commercial generator shall:

A. Ensure the segregation of recyclable metricials and organic materials from garbase by pleaning.

A classe the segregation of recyclable miserials and organic materials from garbage by placing each type of material in a separate designated receptacle or container, and ensure that employ-ees, contractors, volunteers, customers, visitors, and other persons on site segregate recyclable materials and employees.

B. Provide an adequate number and type of labeled receptacles needed for segregating and storing recyclable materials and organic materials, and provide adequate access to these receptades C. Post and maintain signs containing informa-tion and instructions on the proper segregation and storage of recyclable materials and organic materials in areas where receptacles are located. D. Ensure that all receptacles used for collecting and storing recyclable materials, organic materials, and garbage are affixed with signs or labels that display the appropriate information to enable users to clearly differentiate which receptacles are used for recyclable materials, organic materials, and garbage to minimize the contamination of material placed in receptacles

placed in receptacles.

E. Provide adequate instructions to employees, contractors, and volunteers of the requirements of this chapter, including (1) the requirement and procedures to ensure the segregation of recyclable materials and organic materials from garbage; (2) the employees, contractor's, and volunteer's responsibilities regarding compliance with this chapter; and (3) the types and location of receptacles and contains for procedules. receptacles and containers for recyclable materials

organic materials, and garbage.

F. Ensure that instructions or training materials provided to employees, contractors, and volunteers are promptly made available to the City upon request. G. Ensure that the contents of receptacles are deposited in the proper container and ensure that the contents of the receptacles for recyclable materials and organic materials are not delivered to garbage containers. Commercial generators shall essed a premium fee based on the size of the container for recyclable materials and organic materials containers that are collected for garbage disposal by the franchisee if the contents of their recyclable materials and organic materials contain-ers contain unacceptable levels of contamination.

8.17.030B Large Events and Large Venues. Large Events and Large Venues shall be responsible for ensuring and demonstrating compliance with the requirements of this chapter. In addition to other requirements in this chapter and the Municipal Code, each Large Event and Large Venue shall: A. Segregate recyclable materials and ensure that employees, contractors, volunteers, customers, visitors, and other persons on site segregate recyclable materials.

B. Ensure the Large Event and Large Venue has access to an adequate number and type of containers needed for collecting and storing

recyclable materials. C. Provide or ensure the provision of adequate receptacles throughout the Large Event and Large Venue location to make the segregation of recyclable materials and organic materials convenient for employees, volunteers, contractors vendors, exhibitors, presenters, visitors, attendees

vendors, exhibitors, presenters, visitors, attendees, customers, and other persons on site.

D. Ensure that all receptacles used for segregating and storing recyclable materials, organic materials, and garbage are affixed with signs or labels that display the appropriate information to enable users to accurately segregate solid waste and to clearly differentiate which receptacles are used for recyclable materials, organic materials, and garbage, to minimize the contamination of materials lagoral in receptacles.

E. Ensure that the contents of the receptacles for recyclable materials and organic materials are not delivered to garbage containers unless they include unacceptable levels of contamination.

8.17.040B Provisions for self haulers.

A. Nothing in this chapter shall preclude any person, solid waste customer, commercial generator, multifamily generator, or Large Event and Large Venue from self hauling recyclable materials or organic materials generated by that entity to a recycling or organics processing facility.

B. Self haulers shall:

1. Comply with the requirements in this chapter by delivering for recycling those items that can be

by delivering for recycling those items that can be recycled by local recycling facilities and establishments and shall comply by delivering for organics processing those items that are accepted by local

organics processing facilities.

2. Provide proof of compliance with this chapter, upon request by the City; proof includes but is not limited to a receipt from a recycling or organics processing facility that clearly identifies the type and quantity of material delivered and an application for Exemption from the Necessity for Refuse Collection. 8.17.050B Authorized Haulers.

A Authorized Haulers shall obtain and maintain a business license with the City. B. Authorized Haulers shall keep separate garbage,

The solid waste customer commercial generator, or Large Event and Large Venue requesting an exemption shall not be granted an exemption from the requirements of this chapter if the City determines that (1) recyclable materials or organic materials are generated on site, (2) it is feasible for containers and receptacles for recyclable teasible for containers and receptacles for recyclable materials and, as necessary, for organic materials to be placed on site, and (3) it is feasible to share recycling containers with an adjacent commercial facility or multifamily dwelling. The City may require the solid waste customer or commercial generator that is granted an exemption from the requirements of this chapter to submit a renewal of its petition for an exemption every two years from the date the exemption was granted by the City.

This chapter shall not create liability on the part of the City, or any of its officers or employees, for any damages that result from reliance on this chapter or any administrative decision lawfully made in accordance with this chapter. All pressons handling solid waste within the chapter. All persons handling solid waste within the boundaries of the City should be and are advised to conduct their own inquiry as to the handling of such materials. In undertaking the implementation of this chapter, the City is assuming an undertaking only to promote the general welfare. It is not assuming, nor is it imposing on its officers and employees, an obligation for breach of which it is liable in money damages to any person who claims that such breach proximately caused injury. 8.17.160B Duties discretionary.

Subject to the limitations of due process and applicable requirements of State or Federal laws, and notwithstanding any other provisions of this chapter, whenever the words "shall" or "must" are used in establishing a responsibility or duty of the City, its

Summary of Proposed Ordinance 2122 On September 13, 2016 at 6:00 p.m., the City Council of the City of Hawthome is considering the adoption of Ordinance No. 2122, a proposed ordinance amending portions of Chapter 17.04 and Sections 17.10.010, 17.32.020 and 17.38.060, and adding Chapter 17.88 to Title 17 of the Hawthome Municipal Code (HMC) to establish the "FREEWAY OVERLAY ZONE" for the purpose of allowing certain off-premises signs (BILLBOARDS) in conjunction with Change of Zone (2016CZ03) that illustrates the boundaries of said overlay zone on the City's Zoning Map.
Pursuant to California Government Code Sec

tion 36933(c)(1), the City Council has directed the preparation and publication of a summary of Ordinance No. 2122 as follows:

Ordinance No. 2122 regulates and governs the conditions and maintenance of all off-site advertising and structures by establishing a policy and providing standards essential to ensure that nonconforming, blighted and intrusive billboards in incompatible locations throughout the City may be removed and relocated to an area that is more compatible and nonintrusive to the community, the "Freeway Overlay Zone," which will be the only location in which new billboards would potentially be permitted. The modifications to Chapter 17 are necessary due to the local degenerative nature of existing billboards in the City. Conditions include closeness to residential structures, deteriorated structures, outdated structures and the overall sporadic placement of advertising structures.

Ordinance No. 2122 requires billboard removal from outside of the Freeway Overlay Zone before a new digital billboard can be built inside of the Freeway Overlay Zone by the billboard owner. Agreements must be approved by the Planning Commission and City Council, after duly noticed public hearings, and must provide the City with a public benefit.

The ordinance also adopts and modifies the

The ordinarios also acopts and modimes the City's Zoning Map by illustrating the physical boundaries of the Freeway Overlay Zone. The aforementioned Freeway Overlay Zone together with certain code amendments, and deletions, generally deal with all aspects of billboard construction, and special requirements dealing with approvals from Caltrans, Planning Department, the Planning Commission and the City Council.
