Wiseburn Full of Optimism As School Year Begins With Positive Forecast On Enrollment, Test Scores

A real sense of accomplishment pervaded the recent meeting of the Wiseburn Unified School District (WUSD) Board of Trustees, as one after another, board members reported exciting news for the coming year.

Superintendent Tom Johnstone confirmed the school year opened with very strong enrollment numbers.

"We're in our third week, and our numbers are coming in strong," Johnstone said. Enrollment at the three elementary schools is on target, he added, with Anza at 585 students; Burnett, 463 and Cabrillo, 457.

At Dana, the district's middle school, enrollment is at 1,027 students in grades six through eight. "We're on target in each grade," Johnstone said. He confirmed, these numbers represent an increase of about 100 new students. Last year the district had 2,490 students; for the 2016-17 academic year, total enrollment is at 2,592.

Johnstone also reported exciting progress on statewide assessment tests. Results of the SBAC (Smarter Balanced Assessment Consortium) showed Wiseburn students made some of the highest gains in the region on Math and English Language Arts. The SBAC rolled out two years ago; in addition to being aligned with the states' Common Core standards, the test is also touted as more accessible to parents. It features year-to-year comparisons and scores are now delivered in the summer, giving teachers a window of opportunity to adjust curriculum and target specific areas for reinforcement.

Wiseburn students in 3rd through 8th grades showed an overall 11 percent increase in ELA scores and an 8 percent increase in math. DaVinci Science scores increased an impressive 14 percent in ELA and 16 percent in math. The all-state average increase was 5 percent in ELA and 4 percent in math.

Deputy Superintendent Chris Jones

reported on technology initiatives, saying, "Our one-to-one technology roll-out is about 99 percent complete." Jones explained that the district's push to have a Chromebook in the hands of every student is, essentially, an innovation in itself.

"We are ahead of the market on this," Jones said. The notebook computers run Google software and the district has beefed up staff to ensure network capabilities are sound and teachers have classroom support for the new technology.

"We've expanded our future-ready advisors," Jones said. "Our teachers are excited about the opportunity this brings to the kids."

The district's numbers guy also had good news to share. Chief Business Official David Wilson noted that since 2015, there has been a 5.8 percent increase in the District's value, from \$7.5 billion to \$8 billion.

Board members Nelson Martinez and Roger Banuelos reported attending Back To School Night at Dana. Martinez expressed great pride in the school's maintenance and upkeep, and acknowledged the districts' staff did a great job over the summer getting the schools ready for fall.

"The schools look like they're new," Banuelos said. "That goes to the culture of our schools."

Board Vice President JoAnne Kaneda acknowledged Member Neil Goldman, who was not present, saying Goldman had taken initiative to help resolve issues plaguing Little League. "I really want to thank him," Kaneda said. "He's put a lot of effort into the Little League situation."

Kaneda reported her sons have all finished in the district, and are now managing college, jobs, and internships, as well as their personal lives. She acknowledged the education they received as students of the Wiseburn community has prepared them well to be

independent adults.

Dr. Mary Ring, executive director of project development for the district, updated the board on Project Optimal, a joint venture with SELPA and the California Teacher Credential (CTC) program. Ring said the project trains special education teachers, allowing them to add additional authorizations to their existing credentials.

Project Optimal, in collaboration with the Special Education Local Plan Area (SELPA), offers an online program to credentialed special education teachers, essentially granting them "added authorization" to work with students who present autism, early childhood traumatic brain injury, emotional disturbances, and other special needs.

"We've trained thousands of teachers," Ring said. "We're really proud of the program." The Wiseburn Board sponsors the innovative program, which is supervised by Ring's office. It is open to special education teachers throughout the state.

Since 1977, all school districts and county school offices in California were required to form geographical regions of sufficient size and scope to provide for all special education service needs of children residing within the region's boundaries. Each region became known as a Special Education Local Plan Area - SELPA. Today, there are over 120 SELPAs in the State.

The SELPA coordinates with school districts and the County Office of Education to provide a continuum of programs and services for disabled individuals from birth through 22 years of age.

Back to School Night programs are scheduled at Dana tonight, and at Cabrillo on Wednesday, Sept. 21. The next regular meeting of the Wiseburn Unified School District Board will be held Thursday, Sept. 22, at 6 p.m. •

Author Spotlight: Lisa Genova

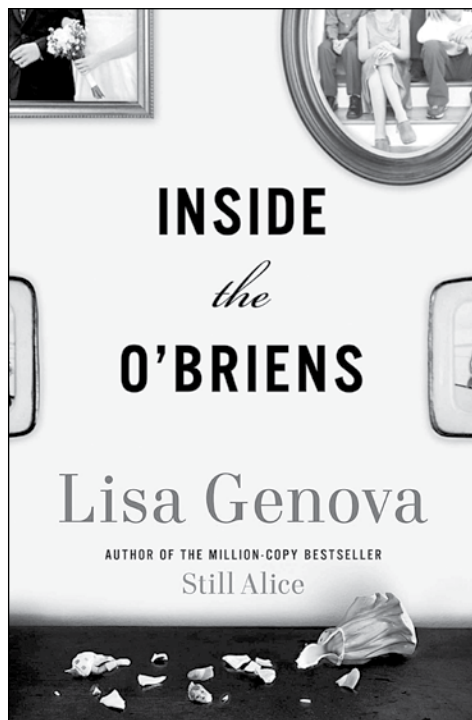

A researcher with a Ph.D. in Neuroscience from Harvard University, Lisa Genova's novels explore how patients and their families cope with and adapt to living with cognitive diseases or injuries. Her novels skillfully weave scientific information about the conditions characters have and how that personally affects them with the larger context of how those changes affects their family bonds, relationships with others and wider perspective of the world.

Genova's best known book, *Still Alice*, chronicles the initial onset, diagnosis and aftermath of a Linguistics professor with early onset Alzheimer's disease. Adapted into a movie starring Julianne Moore, the novel is mostly told from the perspective of Alice, and gives readers a unique perspective of how disorienting it is to slowly lose one's memories.

Similar to *Still Alice*, Genova's latest novel, *Inside the O'Briens*, also gives readers a glimpse of what it's like to live with another incurable, early onset disease, Parkinson's. Unlike Alzheimer's, Parkinson's patients slowly lose physical control of their movements, speech, etc. while their memories

legacy, meaning diagnosed parents have a 50 percent chance of passing these incurable diseases on to their children and grandchildren. Genetic testing can confirm if the



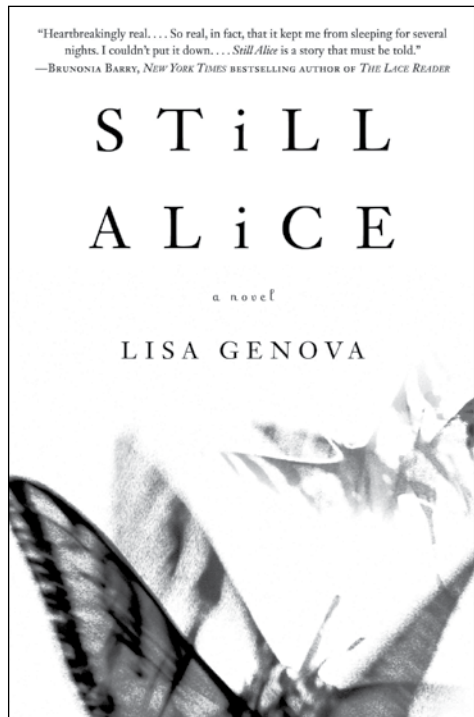

Canadian-set 'Yoga Hosers' is 'Eh'-mazingly Absurd

One of the more wildly talked about movies from this year's Sundance Film Festival that finally hit theaters earlier this month is the flamboyant comedy-meets-fantasy film, "Yoga Hosers," directed by Kevin Smith. Set in a small Canadian town where the accents are as thick as maple syrup, two 15-year-old best friends, both with extremely unhealthy cell phone addictions, discover that horrifying demons are taking over their workplace and threatening to ruin their late night plans. But what are these terrifying little creatures? Turns out that they're Nazi sympathizing sausages from Canada's past, appropriately called "Bratzis."

rewarded. Think "Bad Milo" meets "Sausage Party" in terms of the thematic guideline. However, one of my biggest critiques is how anti-climactic the ending is in comparison to the outlandish storyline. There is no stopping this crazy train and the ending could have followed through with the same emphasis.

Aside from the eccentric storyline, what really makes "Yoga Hosers" great is the familial full-circle connections off-screen. Firstly, and most obviously, director Kevin Smith cast his actors close to the vest with his daughter Harley Quinn as the lead character, Colleen M. Another fun connection is between Lily-Rose Depp, who not only acts alongside one, but both of her parents in the film. Her mother Vanessa Paradis plays Ms. Maurice,

Colleen Collette (Lily-Rose Depp) and Colleen McKenzie (Harley Quinn Smith) are yoga enthusiasts by day and convenience store clerks by night. They work after school dead-end jobs at Eh-2-Zed, the local corner store that sells everything from toilet paper to "Pucky Charms" cereal. Their overall bratty attitude changes to excitement after senior heartthrob Hunter Calloway (Austin Butler) invites the girls to a totally awesome "Grade 12" party. However, things don't go according to plan when they get stuck working a late shift, and discover not only is Hunter not the sweet guy they thought he was, but that they have bigger fish to fry, or in this case, sausages. Enlisting help from legendary man-hunter Guy Lapointe (Johnny Depp), the girls are forced to defeat the meat that is threatening to kill them.

As one can safely assume by this point, "Yoga Hosers" is a wacky and wholly original moviegoing experience. The cheesiness factor is through the roof, but that is one of its biggest charms. Seeing a movie that is technically sophisticated with a top-notch cast (scene stealer Ralph Garman's insanely spot-on impressions of Sylvester Stallone and Adam West draw the biggest laughs), yet not take itself too seriously on screen, is a rare occurrence these days and should be

the school's history teacher who tells the girls of the Nazi origins in Canada. Her father, Johnny Depp, brings his signature Mad Hatter/Inspector Clouseau-kookiness to his character Guy Lapointe, the legendary man-hunter from Montreal whose accent is as wacky as his bushy brows. Finally, a subtle but interesting connection comes from the air-headed yoga instructor Yogi Bayer, played by Justin Long. Not to venture into gossip magazine mode, but until recently, his longtime girlfriend was Amanda Seyfried, who also appears on the cover of the town's hottest magazine.

The biggest misfortune as an audience member would be to walk into "Yoga Hosers" unprepared; not in terms of knowing the plot twists and turns, but in being unable to appreciate this unusual cinematic presentation. It is a film that will provoke you to immediately either love it or hate it. Yet, despite its critics, there is no denying that "Yoga Hosers" is certainly one of the wildest films of the year. Here's a hint— you definitely want to stay through the end credits just to see Johnny Depp shred on the guitar during the closing song.

"Yoga Hosers" is rated PG-13 for crude humor, sexual references, comic violence, and brief drug material. 88 minutes. Coming soon to Video on Demand. •

Cougars Struggle On Offense In Loss To South

Hawthorne struggled offensively and miscues on special teams led to a 14-6 nonconference road loss to South Torrance last Friday. Both teams played a sloppy first quarter. The Cougars took a 6-0 lead in the second quarter after a 12-play, 78 yard drive, capped by a 4-yard touchdown pass from Andrew Kalinowski to wide receiver Carlos Jacobo.

The Spartans got a spark on special teams when Patrick Patterson returned the kickoff 64 yards to the Cougars 27 yard line. With 32 seconds left in the half, South quarterback Anthony Bjazevich scored on a 4-yard keeper. South took a 7-6 lead at halftime.

Both teams went scoreless in the third quarter. Hawthorne's offense couldn't get on track and failed to gain momentum in the game. The Spartans' defense was stout and shut down the Kalinowski to Jacobo connection all game. The running game was held in check.

To win a close, sloppy game, turnovers and special teams are key. The South coaching staff preached playing all three phases of the game. South defensive tackle Jake Fejer broke loose and blocked a Cougars punt, which South recovered deep in Hawthorne territory.

Two plays later, Bjazevich scored on a 5-yard run, giving South a 14-6 lead in the fourth quarter. Hawthorne had a potential game-tying touchdown called back on a chop block penalty with 3:23 remaining in the game. The Cougars went for it on fourth and goal from the Spartans 17-yard line but the pass was broken up by a South defender.

Hawthorne has two more non-league games before conference play begins. Including the

big rivalry game versus Leuzinger on Sept. 23. The Cougars hold a 36-35 record over the Olympians since 2004.

Banning has a three-game winning streak and is coming off a 50-18 win over Millikan last Friday. The Pilots have scored 108 points in three games. The Hawthorne defense will have its hands full.

Lawndale vs. Crespi

Lawndale opened the season with a win over South Torrance. The Cardinals defense struggled in a 49-23 nonconference loss to Crespi last Friday. Lawndale led 16-14 at halftime, however, the defense gave up 35 points in the second half. Lawndale's sophomore running back Jordan Wilmore had two touchdown runs while quarterback Jalen Hamler scored on a 5-yard touchdown run.

The Cardinals are back in action when they travel to Leuzinger for a nonconference matchup Friday. Kickoff is set for 7 p.m. Leuzinger is coming off a 40-26 loss to Sherman Oaks Notre Dame.

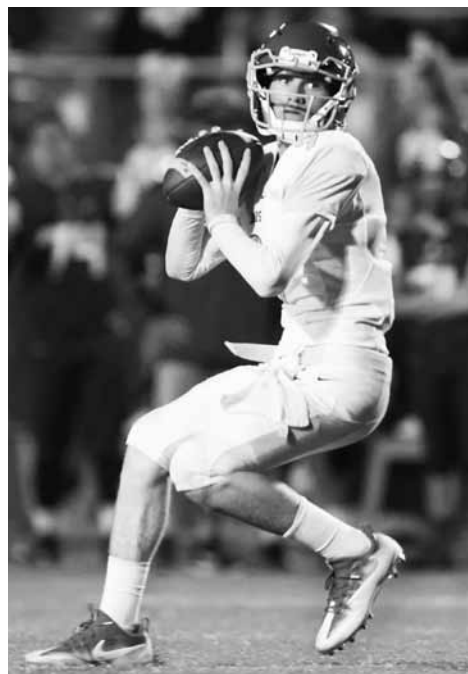
Inglewood vs. Blair

New Grandbaby? Learn How To Help Baby And Mom Thrive



(BPT) - Grandparents play a unique, important role in caring for family members of all ages. Here are some ways that you can help keep babies and moms safe and healthy.

Helping Babies Sleep Safely

Grandparents can help reduce the risk of Sudden Infant Death Syndrome (SIDS) and other sleep-related causes of infant death. To help your grandbaby sleep safely, make sure you:

- Always place your grandbaby on his or her back to sleep, for naps and at night.
- Use a firm sleep surface, such as a mattress in a safety-approved crib, covered by a fitted sheet.
- Keep loose bedding, blankets, quilts, crib

bumpers, soft objects and toys out of your grandbaby's sleep area.

- Do not smoke or allow anyone to smoke around your grandbaby.

"Researchers have learned a lot in the past 20 years about how to keep infants safe while they sleep," said Dr. Catherine Y. Spong, Acting Director of the Eunice Kennedy Shriver National Institute of Child Health and Human Development (NICHD), which leads the Safe to Sleep(R) campaign to educate caregivers about ways to reduce the risk of SIDS and other sleep-related causes of infant death.

"Grandparents often help parents take care of

infants, including during sleep times, but they may not know that the recommendations for safe infant sleep have changed since they had young children," said Dr. Spong. "It is important for grandparents and all caregivers to know how to create a safe sleep environment for baby."

Supporting Moms And Moms-To-Be

In all the excitement over a new baby, sometimes a mother's health, including her mental health, can be overlooked. Research shows that as many as 1 in 10 women experience postpartum depression. However, mood changes and other symptoms of depression can take place anytime during pregnancy, not just after the baby is born. Because of their unique role in the family, grandparents may be among the first to notice that something is wrong.

Moms' Mental Health Matters, another NICHD initiative, describes the signs of depression and anxiety related to pregnancy and birth and offers ways to cope and seek help.

"New mothers may be hesitant to admit they're feeling depressed or anxious, but supportive family members can make all the difference in helping to identify symptoms and encouraging moms to reach out for help when they need it," said Dr. Spong.

For example, during pregnancy and after birth, a mother may:

- Seem to get extremely anxious, sad or angry without warning.
- Seem foggy and have trouble completing tasks.
- Show little interest in things she used to enjoy.
- Seem "robotic," like she is just going through the motions.
- Have trouble sleeping.
- Check things and performs tasks repeatedly.
- Have difficulty caring for herself or the baby.

If you notice any of these signs in a new mom, encourage her to talk with a health care provider - or offer to make an appointment for her. If you need to find a health care provider in her area, call the Substance Abuse and Mental Health Services Administration Treatment Locator at 1-800-662-HELP (4357).
