## Lawndale City Council Approves Cancellation of December 21 Meeting

Even though it is not yet Hallowe'en, thoughts of the December holidays took up one agenda item at Monday's regular City Council meeting when City Manager Stephen Mandoki requested consideration to cancel the regular City Council meeting of Monday, December 21, 2015 since it is the week in which Christmas Eve and Christmas Day will be observed. The City Council voted unanimously to cancel the meeting of Monday, December 21, with the understanding a special meeting for a topic that may need a decision prior to the next meeting on January 4, 2016, will be scheduled.

An ordinance amendment, introduced at the meeting on September 21, was approved as part of the consent calendar, which prohibits parking a vehicle on a public street for the sole purpose of displaying signage on the vehicle. A vehicle may display a removable sign when parked in a parking lot. There are a few exceptions to the new ordinance: if the vehicle is parked within 500 feet of the residence of the owner of the vehicle and if the vehicle is parked in a space on a commercial street for less than four hours. Otherwise, the vehicle will be ticketed. The towing portion of the original ordinance is deleted in its entirety. Signage that is permanently painted on a vehicle or that is wrapped on a vehicle are not subject to this prohibition. Bumper stickers are also exempt. An example of the prohibited signage would be a "For Sale" sign on a parked vehicle on a public street.

Although the City Council approved attendance by Councilman Pat Kearney at the League of California Cities' Convention in San Jose on September 30 to October 2, the councilman did not make the trip, saving the \$1,600 allocated by the City Council. The decision not to send Kearney was made as no topics that were to be part of any referenda at the convention involved issues affecting Lawndale.

As a result of the complaints at the September

21 meeting involving the proliferation of homeless on the streets of Lawndale, especially near and in strip mall areas, the Los Angeles County Sheriff's Department (LASD) conducted an abatement of homeless encampments in two different areas of the city on September 23. Supporting personnel from the Lawndale Public Works Department worked with the Sheriff's Department to clean up debris left behind under the 405 Freeway overpass at Hawthorne Boulevard. The homeless were all counseled by the LASD Mental Evaluation Team and, where it was determined criteria was met, several of the homeless were taken to shelters or other facilities for care. On Tuesday, October 6, the Los Angeles County Board of Supervisors will be considering funding for the Persons Assisting The Homeless (PATH) program throughout the county to coordinate and target outreach in the South Bay, with a goal of connecting homeless persons living on the streets and in encampments to interim residential options and permanent housing and by providing supportive services.

With the observance and reporting by a citizen of all the littering around commercial properties and on the streets of Lawndale, but especially near bus stops, the Sheriff's Department will consider conducting a "Littering Sting" around the city to help with apprehending and fining violators of no littering laws. It was reported that the bulk items continually left on Rosecrans Avenue near Kingsdale Avenue were removed by the Public Works Department. Citizens who see bulky, large items left on curbs should report their findings to the Public Works Department to keep the streets free of this type of litter.

The City Council approved the submittal of an application and agreement with the Lawndale Elementary School District for use of the facilities of the Diane Bollinger Gymnasium on the campus of Will Rogers Middle School for the time period of January 1 to December 31, 2016 in lieu of any renewal of a long-term facility use agreement. The cost of the facility

use agreement is in the 2015-2016 budget in the amount of \$21,000 through June 2016. Any additional cost will be included in the 2016-2017 budgeting.

A street improvement project at Grevillea Avenue (145<sup>th</sup> Street to Marine Avenue) and Avis Avenue (147<sup>th</sup> Street to Marine Avenue) was approved in the amount of \$547,067.20 with Kalban, Inc. Construction is scheduled to begin in November 2015 and conclude by the end of December 2015.

The City Council and City Agency agendas will be combined and each city agency will meet concurrently during a City Council meeting as a result of the approved resolution at this meeting. This resolution amends the procedures of each public agency within the city of Lawndale, such as Housing Authority, for any public meeting held for that agency to adopt the new procedure and be part of a City Council meeting agenda, assuming all normal agenda topics: roll call of members, oral communications, adoption of consent calendar agenda items by title only, and any topics and reports of agency members reporting, as necessary.

The City Manager reported that the paperwork from the Los Angeles County Board of Supervisors is approved and the actual written paperwork must be received, per procedures required by the city and the county, in order to transfer the obligation of funds to be used for the transfer of the modular building adjacent to the County Library building in the Civic Center.

The next City Council meeting is Monday, October 19 at 6:30 p.m. •

## Film Review

### Biopic *Steve Jobs* Captures the Complex Man Behind Apple and the Digital Revolution

The word 'auteur' is generally used to describe a director whose vision is clear enough to be recognizable. The great directors all fit into this category, but most screenwriters tend to play a more anonymous role. The exception is Aaron Sorkin, a screenwriter whose hyper-speed style and wall-to-wall dialogue is immediately recognizable in the best way possible. Five years ago he won an Oscar for his unprecedented script on modern classic *The Social Network*. Although not working with *Network's* director David Fincher, a

using three different eras of cameras/film to match the progression of technology.

Michael Fassbender, easily one of the greatest working actors we have today, tackles the character of Steve Jobs from the immediate get-go. He never feels disguised as the character, but instead embodies the classic approach where he is still very much himself within the spectrum of this incredible character. As is the case with nearly every element of the film, the ensemble of performers all show-up and deliver knockouts. Supporting cast members Kate Winslet, Seth Rogen, Michael Stuhlbarg, and Jeff Daniels

similarly matched level of energy and bold protagonist dares his next project, *Steve Jobs*, to stand confidently alongside his other award winning work.

In the case of both films, Sorkin's writing is met with a director whose style is equally vibrant. *Jobs's* Danny Boyle may not have the fanboy following that Fincher has gathered, but from the film's first moments there is little doubt that this is a "Danny Boyle" film. Boyle utilizes a vibrant array of images, quickly maneuvers between subjects, and manages to feel both macro and micro scale. Boyle has a few tricks up his sleeve as well that add a refreshing enough touch to make the film feel alive. The hybrid of writer from *The Social Network* and director of *Slumdog Millionaire* and *127 Hours* feels like a beautifully matched synthesis.

Perhaps the most daring element of this biography is, rather than telling the entire lifespan like a conventional biopic, the ego-maniac genius of Jobs is distilled into three different chapters, each from different stages of his career. The film wastes no time trying to tell us information that we already know: it is entirely focused on the relationships Jobs had with his closest confidantes. Some fantastic decisions are made to distinguish each chapter, the most prominent being the decision to shoot

each get opportunities to deliver feisty discourse with Fassbender's Jobs, and each is equally compelling. Since the triptych structure of the film allows for a very clear progression of character's relationships, the arcs are more easily recognizable, but nonetheless well executed.

Because of the similarities to predecessor *The Social Network*, Steve Jobs may not feel as enigmatic or fresh as the former film, but its entertainment and gripping narrative are enough to make it a must-see in its own right. It is firing on all cylinders and captures the man behind so much of today's world in a delectable manner. Because of the conscious decision to not cover the entire lifespan of Steve Jobs, but instead explore a series of dramatic relationships he had, the film is one that can stand beautifully beside Walter Isaacson's book in that it only makes you want to learn more about the man instead of trying to encapsulate everything about him. Few influencers were as complex as Steve Jobs, and he is fortunate to have a film that does justice to the fascinatingly complex individual he is. For the numerous reasons listed above, *Steve Jobs*, a film equally attributed to Danny Boyle, Aaron Sorkin, and Michael Fassbender, is one of the must-see films of the year. *Steve Jobs* opens this Friday at the Landmark Theatre. •

The JPL Speakers Bureau Program, provided by the National Aeronautics and Space Administration (NASA), seeks to educate the public by sending speakers out to various events and engagements to provide a blend of historical perspectives, present activities and future visions related to the Jet Propulsion Laboratory. Deirdre (Dee) Terry, Network Operations Control Team Manager and a colleague, focused the presentation on robotics,

engineering, spacecraft communication, and present Mars efforts. Ms. Terry also showed a short video on the NASA Curiosity Mars Rover Mission.

The event was the result of the Career Pathways Program, which is funded by the Advanced Manufacturing & Engineering Technology Linked Learning (AMETLL) Work-Based Learning grant. The South Bay Workforce Investment Board (SBWIB) is the organization tasked to provide work-based learning activities and provide support to local engineering and advanced manufacturing academies to expose them to careers in the industry thereby bridging the gap between schools and companies.

### Whole Kids Foundation Grant Program

United Health Foundation and Whole Kids Foundation will provide \$150,000 in the first round of grants to support innovative projects nationwide that will improve children's health and nutrition. The program is open to educators, individuals and nonprofit organizations seeking to break down barriers to basic, but critical information and resources, such as where food comes from and the importance of eating healthy foods. Letters of intent for the program are due Nov. 30. Applications for the grant program are due Dec. 15, and the grantees will be announced in March 2016. The amount of each grant will range from \$15,000 to \$25,000. ## Leuzinger Captures First Win, Receives Mayor's Cup

In last Friday's Mayor's Cup football cross town rivalry between host Leuzinger and Hawthorne, it was a race between two squads on who would pick up their first victory of the 2015 season. The Olympians (1-4) got off the starting gate well and went on to down the Cougars 34-13. Leuzinger needed just two plays to get on the scoreboard. Quarterback Malik Jackson threw a slant pass to Andre Hunt who sprinted 91 yards for a touchdown and an early 7-0 lead.

Later in the first period, the combination connected, again, from 32 yards out. The Olympians upped their lead to 21-0 early in the second quarter on running back Lionel Smith's 21-yard TD run. Midway in the second

period, Hawthorne scored its first touchdown on a four-yard quarterback keeper from Marte Mapu cutting Leuzinger's lead to 21-7. The score remained that way at halftime.

Desperate to pull off their first victory, Mapu and the Cougars drove to midfield only to see one of his passes fall into the hands of Olympian linebacker Deanthony Jones who ran down the left sideline for a 50-yard TD and Leuzinger brought its lead back up to 21 points at 28-7.

The Cougars (0-5) finally scored their second touchdown when Mapu tossed a 15-yard TD pass to Carlos Jacobo. Kicker Hunter Marquez's point after touchdown attempt was partially blocked as the ball fell short of the goal post, leaving Hawthorne trailing 28-13 with 1:15 left in the third quarter. Leuzinger capped the scoring when Jackson completed a 12-yard touchdown pass to Jones with 8:28 remaining in the game.

"The game was a good outcome for the kids," Leuzinger head coach Damien Porter said. "We made a lot of penalties and mistakes but they didn't cost us. We will need to improve on those to do well in league and beat teams like (Torrance schools), North, South and West."

The Olympians open the Pioneer League at West Torrance Friday at 7 p.m. At West last Friday, the Warriors, who were CIF-Southern Section semifinalists the past two seasons and finalists the year before (in 2012), were upset at home by previously winless Carson 34-27.

Despite the win, Leuzinger was penalized 20 times for 182 yards and had three turnovers. Jackson completed seven of 10 passes for 149 yards and three touchdowns. For Hawthorne, Mapu completed 16 of 34 passes for 149 yards and one TD. He was intercepted once, that going for the score by Jones.

Like the Olympians, the Cougars were plagued with numerous penalties and turnovers.

"Turnovers and other mistakes got to us," Hawthorne head coach Donald Paysinger said. "We got to clean up. Our focus is to get ready for league."

The Cougars begin the Ocean League at home in another "Battle of the Winless" against another 0-5 squad in Santa Monica. The Vikings, who have a long history of football success, are already off to their worst start since their 0-10 1992 squad after getting blanked by last year's

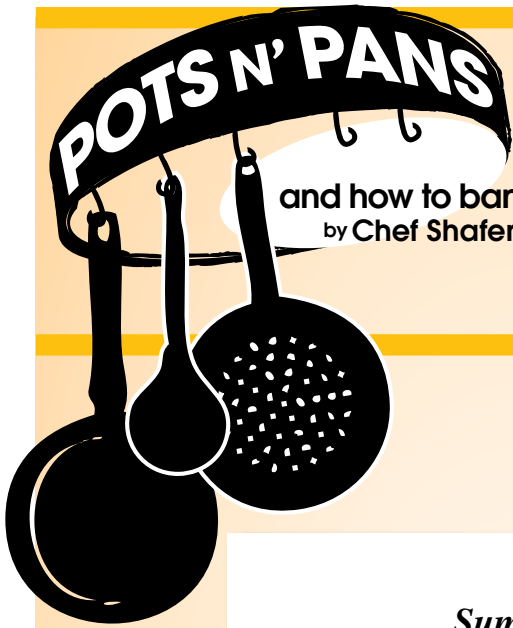
