# Forecast Realty Knows Property in the South Bay

Real estate in the South Bay can be tricky to navigate. Those looking to buy want the perfect home in a great community, a house which meets their price point as well as has the right type of amenities nearby. Each community has its own feel and budgetary concerns, property laws and other quirks. It's always best to find someone to help navigate through the maze: someone who is an expert on local real estate because they know the area by heart. Forecast Realty, owned by Roger Hart, has made local knowledge its bread and butter for decades.

Forecast Realty has been in business for 34 years, having first opened in 1980. Hart kept the business small to midsize through 1991, employing about 50 real estate agents, but in 1991 moved to his current location at 2420 Carson Street and downsized. "In real estate you have about 10-15% of agents making 90% of the money," he said, so it didn't make sense to have so many people in the office who weren't bringing in sales. Currently, he has an operation that is mostly family: he has three sons and they have all joined him in the business, as well as two of his daughters-in-law. He also has four agents who have been with him for many years. Hart values a companionable working environment and highly trained agents, so he has spent time training each agent himself to meet his standards.

Forecast is not a strictly residential or strictly commercial real estate business. Hart says that in the years he's been in business, he's done a little of everything, from avocado groves to apartment buildings to homes to ranch land. He just concluded a "tricky transaction" which sounded very tricky indeed, involving a shopping mall that was built across three separate parcels of land owned by three different sets of people. The mall was built sixty years ago with an original lease agreement, but of course the price of land has gone up just a bit since then. Hart spent two and a

half years dealing with developers, commercial brokers, attorneys, the City of Torrance, the LA City tax assessor, and the title company. "It was a real challenge ... that took a very unique buyer and a sophisticated buyer." The deal was finally concluded successfully and Hart was proud to say that he got the best outcome possible for the families of the owners.

Land and homes in Torrance are in great demand because of the atmosphere in Torrance. Since the early 1990s, developers have spent, according to Hart, about \$70 million rejuvenating the Old Town area making it

more accessible and interesting to residents. All the homes in Old Town are custom-built and not tract homes, which also helps the real estate market to thrive. The area is also considered very safe and the schools are good, which contributes to a thriving community in Torrance and bolsters a small-town feel even though Torrance itself is spread over a large area. Hart says that when people buy, they tend to stay until they are old and have to sell, or they may pass the home along to their children for another generation of residency.

## Neptunians to Make Major Announcement at Upcoming Event

At an event named "Building from the Heart," the Neptunian Woman's Club of Manhattan Beach will be making an important announcement about its 90-year old historical Clubhouse. The event will be held at the Clubhouse located at 920 Highland Avenue from 6:00 to 9:30 p.m. on Saturday, February 7, and will include dinner, wine, entertainment and a raffle. Tickets at \$75 per person are available through www.neptunians.org or by calling 310-283-2266. Proceeds will go to the building fund to help with much-needed repairs and renovations.

The clubhouse was built in 1925 and, during World War II, served as a canteen for soldiers passing through town and as headquarters for the local Red Cross. Today, in addition to being used for Neptunian meetings, it is regularly utilized for civic and public service functions. It serves as an election-day polling station and a donation center for Red Cross blood drives. It is also rented by individuals and organizations as a venue for meetings and events.

The Neptunians, themselves, were founded in 1909, when Manhattan Beach

was home to only 600 people. Ten women, who didn't even have the right to vote, came together with the mission of creating an independent city of Manhattan Beach. They helped achieve not only that but also a local school district and police and fire services. They opened the first library, established the first school, were behind the botanical garden and started the original Boy Scout troop.

Beginning its second century of service, the Neptunians continue to be a force in the South Bay. The 250-plus active members of this non-profit 501(c)3 are dedicated to supporting educational, environmental, and civic projects. It holds an annual chili cook-off to benefit the Manhattan Beach Firefighters' Burn Foundation. Its members can be found selling cookies before the Manhattan Beach Fireworks to benefit the Roundhouse Aquarium or wrapping Christmas gifts at the Manhattan Beach Village Mall to support scholarships for Mira Costa and El Camino students. Other recipients of its donations include the USO, Miller Children's Hospital, Community's Child, and the Mira Costa School choirs. •

#### **Gigantic Ring System around Planet J1407b**

Astronomers at the Leiden Observatory (The Netherlands) and the University of Rochester (USA) have discovered that the ring system that they see eclipse the very young Sun-like star J1407 is of enormous proportions, much larger and heavier than the ring system of Saturn. The ring system—the first of its kind to be found outside our solar system—was discovered in 2012 by a team led by Rochester's Eric

The astronomers analyzed data from the SuperWASP project—a survey designed to detect gas giants that move in front of their parent star. In 2012, Mamajek and colleagues at the University of Rochester reported the discovery of the young star J1407 and the unusual eclipses, and proposed that they were caused by a moon-forming disk around a young giant planet or brown dwarf.

A new analysis of the data, led by Leiden's Matthew Kenworthy, shows that the ring system consists of over 30 rings, each of them tens of millions of kilometers in diameter. Furthermore, they found

gaps in the rings, indicating that satellites ("exomoons") may have formed. The result has been accepted for publication in the Astrophysical Journal.

"The details that we see in the light curve are incredible. The eclipse lasted for several weeks, but you see rapid changes on time scales of tens of minutes as a result of fine structures in the rings," says Kenworthy. "The star is much too far away to observe the rings directly, but we could make a detailed model based on the rapid brightness variations in the starlight passing through the ring system. If we could replace Saturn's rings with the rings around J1407b, they would be easily visible at night and be many times larger than the full Moon."

#### **5** Financial Fitness Habits To Begin In The New Year

(BPT) - While many people focus on personal health goals in the new year, the beginning of the year is also a great time to check your financial fitness. So how can you whip your finances into shape?

South University College of Business, Virginia Beach faculty member Dr. Alan Harper says everyone should adopt these five financial habits in 2015:

#### Establish a Budget

Harper says the first step in taking control of your finances is to establish a budget. "It is extremely important to know how much money is coming in, where it's going, and allocating it appropriately," he says. "Having a budget allows you to gain a broader understanding of your spending habits."

Make sure your budget includes allowances for food, clothing, gas, and even entertainment, Harper advises.

#### **Start Saving**

Your budget should also include money set aside for emergencies. Harper says the old rule-of-thumb that three month's salary is enough to have in your bank account no longer applies in our current economy.

"We found in the last recession that people who lost their jobs tended to stay out of work much longer than three months," he says. "You should have six months to a year's worth of income in savings, just in case."

Harper says you should also try to put away 15 percent of your take-home income toward your retirement. Many retirement savings options are available, including 401(k)s, Roth IRAs and individual retirement accounts. It is important to do your homework before deciding on a long-term investment strategy so that you are aware of terms, conditions and any fees associated with your options.

#### Manage your Credit

The beginning of the year is a perfect time to check your credit history, and to look for any mistakes on your credit report, Harper advises. Mistakes on your credit report can cost you large sums of money in interest rates, or even keep you from being approved

"The law requires the three major credit reporting agencies to provide you with one free credit report a year," Harper says. "Pull those reports and look for discrepancies. If you find one, file a dispute with the credit reporting agency and they will remove the



item if it is incorrect."

Harper also says to check your FICO score on the report, make sure you have an understanding of what the score means, and how to improve it if the score is low.

#### **Shop Smart**

Make it a priority to save money while you shop, Harper says. He encourages clipping coupons, and says purchasing membership cards to discount stores like Sam's Club and Costco can help you save money over time.

"Those stores will save you money in the long run on purchases like food, gas, and even personal care items."

#### **Check your Insurance**

Setting aside time at the beginning of the year to check your insurance policies can also save you money. Harper advises that you should review your auto, home and life insurance to make sure you have the proper coverage.

"You want to make sure you aren't paying for coverage that you may no longer need, but you also want to make sure you have adequate coverage in case there is an accident or you need to make a claim," he says.

Many companies also offer discounted rates if you hold multiple policies with them. So, if your auto, home and life insurance policies are with different companies, you may want to explore the benefits of choosing just one company.

"It's also important to make sure your life insurance policies are sufficient to protect your family from a financial crisis in the event that something happens to you," Harper notes.

"Establishing a budget, saving, staying on top of credit and insurance, and shopping smart all take some work," Harper points out. "But the rewards to your personal and household bottom line are well worth the effort."•


# Councilmember Heidi Ashcraft Looks for Ways to Be Involved

Ashcraft Designs is a spare white building tucked away on Nash Street in El Segundo. Residents might drive by it a hundred times and not know it was there, unless they happened to need a gross of consumer electronics items: the company, founded in 1986, creates beautiful and functional speakers, headphones, and even bathtubs for luxury hotels. But the Ashcraft brand didn't start out in a soaring space full of glass and air; it began with two people who joined forces personally and professionally. One had an artistic vision, and one had the talent for organization and management. They have worked together to ensure not just the company's success, but the successes of their personal lives: childraising, marriage, and religious and personal goals. They are Heidi and Dan Ashcraft, and this year Ms. Ashcraft ran an effective campaign to become Councilmember Ashcraft, the only woman to serve on the Torrance City Council. She has held many positions in the Torrance community because she has always wanted to give back to the city that has meant so much to her.

As the daughter of a machine shop owner and a finishing school graduate, Ashcraft knew that she wanted to go to college, but that she would have to finance it herself. She went to Southwest College and graduated from the medical assisting program, then worked as a medical assistant while attending community college. Then in her early twenties, she married Dan, who was attending school for design. Her first baby came along but she didn't slow down a bit, continuing to work full time.

Ashcraft enjoyed the nursing aspect of being a medical assistant but saw that the "front office" was the place with the higher salary. She became the manager at the doctor's office where she worked, taking care of everything from billing to filing to patient management. Dan would drop her off at 7am with the baby, and pick her up at 7pm after he was done with school. Then at night, Ashcraft would take classes at Citrus College. "You just think of how to get through one day and go to the next one," she said of those long days and long nights.

saying, "I don't join things just to put my name on a list."

For instance: Ashcraft's children went to school in the Torrance Unified School District, so while working part-time at a doctor's office and raising four children full-time, she also began participating in PTA meetings. Her daughter went to Girl Scouts: she became a Girl Scout leader. Her sons played soccer and baseball: she found herself a spot on the AYSO and Little League boards. I

Ashcraft took one look at the manager he had hired and knew she could do better. She had been involved in the business ever since, and she and Dan have desks right across from one another, where they can use their complementary skills for the company's benefit. They have been married 44 years.

Ashcraft's unofficial networking paid off last year, when then-mayor Frank Scotto approached her as a candidate for City Council. Ashcraft had known Scotto's wife

Cindy for many years as part of the PTA and part of the YMCA, where Ashcraft had been elected the first female board president. Mayor Scotto knew of Ashcraft's governing experience and her love of the city, and asked her to run for City Council to give the Council a female perspective. Ashcraft believed she could win a seat, even though there were a total of 16 competitors last June for three seats. She said the best part of the election process was going out and meeting people and knocking on doors, and the worst part was having to fundraise, since she wasn't sure she would win and she didn't like the idea of wasting people's money. She hired Dan as her campaign manager, and her whole family spent nights talking on the phones. The campaign wasn't all fancy social media, because there is still a large bloc of older voters in Torrance who appreciate having things done the old-fashioned way. Ashcraft went onto city cable and talked about herself and her platform, and she was elected to the position.

She believes her perspective can be very helpful to the City Council, and her long experience with other community positions has taught her to make the best decisions without trying to make everyone happy. "I don't feel intimidated stating my position and following through on it," she said. It's her policy to be as courteous and professional as possible at the council meetings. She also encourages her own children who live in the Torrance area to get involved in their city.

Did you think that was all Ashcraft could fit into her schedule? No, indeed. Besides her work as a public affairs specialist for her church community, she is also certified as a Court-Appointed Special Advocate (CASA), which is a volunteer position overseen by Los Angeles County. A CASA oversees medical and educational needs for children in foster positions, and is also involved personally as a mentor who is there for the child while social workers get switched out or foster homes move a child from place to place. Ashcraft's work as a CASA is one more way for her to give back to the city that she loves. "Once you're involved," she said, "there's a special spirit about Torrance." •


"This planet is much larger than Jupiter or Saturn, and its ring system is roughly 200 times larger than Saturn's rings are today," said co-author Mamajek, professor of physics and astronomy at the University of Rochester. "You could think of it as kind of a super Saturn."

In another recent study also led by Kenworthy, adaptive optics and Doppler spectroscopy were used to estimate the mass of the ringed object. Their conclusions based on these and previous papers on the intriguing system J1407 is that the companion is likely to be a giant planet—not yet seen—with a gigantic ring system responsible for the repeated dimming of J1407's light.

The light curve tells astronomers that the diameter of the ring system is nearly 120 million kilometers, more than two hundred times as large as the rings of Saturn. The

ring system likely contains roughly an Earth's worth of mass in light-obscuring dust particles.

Mamajek puts into context how much material is contained in these disks and rings. "If you were to grind up the four large Galilean moons of Jupiter into dust and ice and spread out the material over their orbits in a ring around Jupiter, the ring would be so opaque to light that a distant observer that saw the ring pass in front of the Sun would see a very deep, multi-day eclipse," Mamajek says. "In the case of J1407, we see the rings blocking as much as 95 percent of the light of this young Sun-like star for days, so there is a lot of material there that could then form satellites." Astronomers expect that the rings will become thinner in the next several million years and eventually disappear as satellites form from the material in the disks. •

pass gas than the natural gas industry." (Look out cows, you're next).

There's good news and there's bad news. The good news is that he failed to raise gas prices to \$10 per gallon; but the bad news is that he managed to double the cost of gasoline that had cost \$1.86 a gallon when he took office.

That doubling was a tax on all drivers and home heating. It increased the cost of anything made of plastic. It increased the cost of moving any manufactured and agricultural product to market, and raised the cost of travel. As wages remained stagnant, our

He outlawed oil drilling on both coasts. He stalled for six years, and now appears to deny the construction of the Keystone Pipeline. He has outlawed the coal industry which supplies 40% of the nation's electricity. He signed an agreement with China in which the U.S. agreed to immediately reduce CO2 emissions while the Chinese agreed to begin ten years from now.

Some of his efforts are absolutely comical. In one report, the EPA stated the amount of methane gas released into the air is far less than originally thought. Nevertheless, it issued new regulations requiring escaping methane (the primary component of "natural gas") to be reduced by 45% between 2012 and 2025. Of course, that's the industry's intention also, since they'd rather sell it than allow it to escape into the air. How big a threat is this to the public? The Energy Research Institute says "cows emit more methane when they

standard of living fell in one of the worst economic recoveries on record. Now we are all poorer in dollars and spirit. Paraphrasing Maya Angelou . . . these caged birds dance on the graves of dreams.

Ironically, the private sector may reverse the Obama error in judgment. The science of fracking has made the U.S. number one in the world in oil and natural gas production; and in the last quarter, oil prices have fallen by half causing the economy to grow by over 5%, the fastest rate in nearly 20 years. In fact, the private sector is reversing some of the damage done by bad policy, but the economic harm done will reverberate for decades. In fact, the New York Times declared on January 25, "The Middle Class Shrinks Further as More Fall Out Instead of Climbing Up." So let's reconsider the question: "Green world, healthy economy . . . take your pick." •

## I'm Concerned About Identity Theft, How Do I Protect Myself?

Identity theft for your business is different than identity theft for an individual. Rules governing your business are stricter which could result in greater exposure. Here are a few tips to follow to protect your business:

Review your banking agreements. There are shorter timelines for fraudulent activity on business accounts. In some instances, if you don't notice fraud until you reconcile your checking account at month end, it will be too late. Other activity like wire transfers require reporting almost immediately!

Implement two-factor authentication (two people) for any outgoing wire transfers. Even better, implement multi-factor authentication, using different people and different facilities (email, fax, telephone or special tokens).

Utilize online banking and increase your reconciliation frequency, especially if your transaction volume is high. Along with online banking, implement an electronic alerting system, i.e. email alerts that will notify you of potential fraudulent activity.

Use a different computer, than the one you use for email, when accessing your ac-

count online. The best set-up is to use one computer only for financial transactions and connect it to your network when you need to access online banking. Make sure that this computer has all the latest security patches and virus upgrades.

Enroll in Positive Pay with your financial institution. Positive Pay requires a financial institution to process transactions only if information regarding the payee and amount has been provided by the account holder in advance of each transaction.

Use high security checks and always keep your check stock, deposit slips, and authorization materials in a secured location.

# Toffee and Almond Fudge Cookie Cups



Cookies, cupcakes or candy? How to choose which one to make? Why choose at all? These cookie cups marry the sweetest of all worlds in a single treat sure to win the heart of any loved one.

Servings: Makes 48 servings

#### **Ingredients**

- 2 packages Pillsbury(TM) Ready to Bake!(TM) refrigerated sugar cookies
- 1/4 cup milk chocolate toffee bits (from 8-ounce bag)
- 1 can (14 ounces) Eagle Brand(R) Fat Free Sweetened Condensed Milk

- **2.** While cookies cool, heat sweetened condensed milk and almond butter in a 1-quart heavy saucepan over medium heat for 5-6 minutes, stirring constantly, until mixture begins to bubble. Remove from heat and stir in vanilla. Cool 2 minutes. Spoon one heaping teaspoon of condensed milk mixture into each cookie cup.
- **3.** In small bowl, mix remaining two tablespoons of toffee bits and the almonds. To serve, top each cup with about one tablespoon of whipped cream topping and about 1/4 teaspoon of the almond mixture. •

# <u>Ask the DMV</u>

- O: I just paid my registration online, but forgot to change my address. Can I go back online to make the correction so I can receive my registration tags at my new address?
- A: Unfortunately, it is too late. When you pay for your registration tags online, our system immediately updates your information and your tags are mailed to you in approximately three days. Changing your address takes our system a little longer to update. If you do not receive your new registration tags within 30 days, please apply for duplicate registration tags.
- Q: I heard that select DMV offices will be open on Saturday beginning in January 2015. Which offices will be open and which types of transactions will be handled?
- A: Beginning January 3, 2015, the DMV began offering Saturday hours at 60 select offices statewide from 8 a.m. to 5 p.m. where customer representatives will process ONLY driver license transactions for individuals who have scheduled an appointment.

The DMV has also opened four temporary driver license processing centers in Granada Hills, San Jose, Stanton, and Lompoc where individuals with or without an appointment can receive assistance with driver license transactions only. - Q: When will the Legacy license plate
- A: There is a lot of excitement building for our new Legacy license plate and you

will soon be seeing them on vehicles driving down our roads and highways. It's estimated that production will begin within nine to 12 months. Legislation introduced the California Legacy License Plate program, which offers vehicle owners the opportunity to purchase replicas of California license plates similar to those issued in the 1950s, 1960s, and 1970s. View them at www.dmv.ca.gov.

- **Q**: What happens if applicants, under AB60, cannot provide the primary identification documents necessary to verify their identity and residency to obtain an original driver license?
- A: AB60 applicants may provide additional documentation to verify their identity and residency through the Secondary Review process. An appointment will be scheduled to meet with our specially trained staff in order to review the additional documentation which must be original or certified. The interview may last as long as one hour.

The following documentation may be considered during this appointment: school documents, marriage license or divorce decree, expired foreign passports, foreign driver license, income tax return, and other DMV approved documents. For a full list of DMV approved documents visit ab60. dmv.ca.gov.

If an applicant cannot provide the necessary documentation to verify identity and residency, the AB60 driver license application will not be completed. Individuals can appeal the decision through the DMV Driver Safety Appeal process. •


