



The definition of a park typically refers to a "natural or semi-natural or planted space" that is set aside for enjoyment and recreation. There are varieties of parks – county, national, state, provincial, city, skate, and wildlife for example. One of the earliest discovered parks is from the sixteenth century in Seville, Spain, which at that time was a kind of public mall, urban garden, and park, known as *La Alameda de Hercules*.

Here in America, the very well-known park *Boston Commons* dates from 1634 when the land was purchased for public use; specifically for grazing cows, also as a military parade ground, and (just following the research) a dump. By 1728, the land began to have recreational elements.

has 8.9 acres, which includes picnic tables, a tot lot, a wading pool, basketball courts, two baseball fields, and the adjacent Hawthorne Historical Society.

But what about Zela Davis Park? Research indicates the park covers .74 acres, which is relatively small. The park was originally built in 1978 but has not had many upgrades since. Well, I am glad to say that is definitely going to change!

Bottom line: Parks are good for young people of all ages, for the aesthetic, for a reminder to enjoy things, to play, to take a little downtime, to picnic, perhaps have a birthday or other celebration, and nowadays quite a few parks have exercise equipment.

Hawthorne, our City of Good Neighbors, covers 6.1 square miles but boasts at least eight different parks. Some of these are sizeable, with multiple amenities. For example, Eucalyptus Park is 6.23 acres, with formal picnic shelters and tables, barbecue grills, a tot lot, a wading pool, basketball courts, and a skatepark.

Holly Park is even larger at 10.3 acres, with a picnic shelter, tables, a wading pool, lighted tennis courts, two baseball fields, horseshoes, shuffleboard, basketball courts, and croquet. The unique Jim Thorpe Park shared with me: "The City was able to obtain two grants, one for \$3.4 million from the Clean California local grant program and approximately \$670,000 from the Los Angeles Regional Park and Open Space District.

The upshot is that Zela Davis Park will get a complete renovation. Currently, the park only has a playground and some benches. With this new project, the park will receive a new playground, bathrooms, a basketball half-court, a little walking trail, and seating with a shade structure for picnics. Groundbreaking is scheduled for early Spring 2024, and the ribbon cutting is for late Fall 2024.

Zela Davis, the little park that could and will! You may ask, who is Zela Davis? She started teaching in the Hawthorne School District in 1923. Four years later, she became the first woman principal when she took over Williams School (which later was consolidated with Davis Elementary).

She retired in 1964, and, given her good efforts and commitment throughout that time, the District named the elementary school after

her less than a year later. In addition to her work with the school, Zela was president of a real estate agents' association for a period of time as well. She was outstanding and, indeed, stood out in her own way.

The Zela Davis Elementary School is adjacent to the park and serves over 950 Kindergarten through fifth students. Miguelina Lopez is the Principal. She issued a recent message emphasizing that the school's "mission and commitments are to maximize each student's potential. We are dedicated to ensuring that our school provides a welcoming, safe, and bully-free environment. We want students to be actively involved in learning academics, positive values, and self-discipline."

Zela would be proud. The Zela Davis neighborhood, indeed, is well populated, with renter-occupied housing being dominant. There is a very low vacancy rate. In fact, I See Zela Davis, page 4



Scrambled Is a Fresh Comedy About Female Anxiety and Fertility

In the new comedy, Scrambled, multihyphenate Leah McKendrick takes the taboo out of fertility treatments. Poking fun at the pressure that single women in their mid-30s face from society to get married and start a family, Scrambled is a provocative and confident feminist film that puts the power back into the hands-or wombs-of women.

McKendrick (who also wrote and directed the film) plays Nellie, a single, 34-year-old recurring bridesmaid and aspiring celebrity jewelry designer who struggles with feelings of not-enoughness. She is at the age where all her friends are either getting married or pregnant or reaching some other traditional milestone that comes with a stereotypical relationship. Still wounded from a past breakup, Nellie's prospects in the love department are slim to none.

After a one-night stand goes wrong, Nellie considers freezing her eggs to take some of the pressure off of society's imaginary

timeline for single ladies. Throughout her fertility treatment, which lasts roughly a couple of weeks, Nellie embarks on a chaotic journey through emotional peaks and valleys. What follows is a comically layered personal exploration of being single, including visits from ex-boyfriends of the past, putting on faux smiles during friends' baby showers, and barely surviving family dinners when her dad asks when he can expect grandchildren.

Leah McKendrick has been candid about how the themes of Scrambled were birthed from her real-life experience, which should give audiences an even more delicate lens through which to view the film. Addressing myths, taboos, and the "danger zone" of being a woman in her mid-thirties, McKendrick dodges societal expectations and creates a truly empowering film about developing a newborn sense of ownership over her bodily autonomy.



He is in therapy, enrolled in school and moving forward amongst people but his life is not his own. Time is just passing without any emotional investment from Edward.

I don't want to spoil the book for those who might want to read it, but I was unprepared for how things took off. My heart was broken then it was mended back together.


The pacing of the book, character development and world building was just excellent and had me staying up way past my bedtime for just one more chapter.

It's Tax Time - Don't Procrastinate, Learn Why It's Important To File Early

(BPT) - Whether this year will be your first time filing or you've been doing your taxes for years, it's never too early to prepare for tax season. By knowing ahead of time what documents you'll need, you'll be more likely to make tax prep easier and more efficient - you'll likely need this year. Information and documents you'll need depend on your unique situation, and they include but are not limited to:

• Your Social Security number (as well as your spouse's and children's, if applicable)

Advance preparation can also help you file early to get your refund earlier if you're entitled to one. With an average of 3 out of 4 taxpayers receiving a tax refund, don't wait till tax day.

To get started, create a checklist so you'll know what documents to watch for and collect. Most tax documents like W-2s are made available by employers and other institutions online, although they may also be mailed. You can check with your employer's HR department to find out how and when tax documents are likely to be delivered.

If you've been a gig worker - even part time - or are entirely self-employed, you'll need to gather documents like 1099-Ks, plus all the receipts and records of your self-employment income and expenses throughout the year, including quarterly estimated tax payments you may have already made.

For anyone who has filed before, take out last year's taxes for an idea of what • Records of income received, including interest income

- Mortgage interest statements (1098)
- Payments for tuition (1098-T) or student loan interest (1098-E)
 - Health care and childcare expenses
 - Vehicle or home purchase documents
 - Charitable contribution receipts

"By preparing early, you'll have more time to gather documents, review your tax return and speak with your Tax Pro, helping you feel more confident and less stressed," said Mark Steber, chief tax information officer, Jackson Hewitt Tax Services. "By waiting until the April deadline, you could make a mistake, requiring the filing of an amended tax return or subjecting yourself to avoidable penalties and interest."

Taxes can be confusing, no matter your circumstances, so it's a good idea to consider how you'd like to file this year. It can help to have someone on your side who understands recent changes in tax laws, how to **See Finance, page 5**


