

A Genuine Find Just Rolling Along

Want to go to a comfortable place where there are nice people? Want to go and eat some delicious food, with quite a choice at reasonable prices? Want to pass a little time at a comfortable bar? How about shooting some pool while the kids enjoy video games? Or bowling, want to bowl on really nice lanes and not pay an arm and a leg?

Since the 1960s, the same family has owned and operated Gardena Bowl. The second generation of three brothers, Phil, Vic, and Sam Amenta, have run it since 1983 with ongoing, genuine devotion to the game. I sat down with the "kid", the youngest, Sam. The day starts pretty early in the bowling business, and Sam likes going to the bowling center. Let me put LIKES in caps. This gentleman really does enjoy going to "the office."

One aspect that Sam emphasizes is the importance of Gardena Bowl's employees. "They are the engines of the business. Their knowledge of many aspects of running the daily operation is critical in our continued success and ability to provide a facility we are proud of."

The Amentas own the property, which is almost an acre. They could have sold long before now and, let's be real, made some nice money. Keep in mind that Covid shut down Gardena Bowl for fifteen months. To repeat: For over a year the business was closed. Yet, this did not stop any number of obligations, such as having to pay property taxes and keep current the worker's compensation insurance. Definitely, they had to maintain the place. Fifteen months, no customers, no pool players, no one buying a thing, no one paying a thing, the property just sitting,

"My brothers and I were all raised in this place. Cleaning ashtrays, emptying the beer

bottles, learning machinery repair, and just plain working the family business from top to bottom. You might find this funny, but we all loved it when they banned smoking indoors! Me? I was training to become a commercial pilot. Unfortunately, as fate would have it, I have a stigmatism in one eye. Well, that was the end of my plan to become a professional pilot. In 1983, my brothers and I bought out Dad, and we took over the reins. Amazing, that's forty-two years ago... time flies, even if I don't!"

Gardena Bowl today is a happy place. A friendly place. It has a pro shop if you are looking for equipment. Although I am the opposite of tech-savvy, even I can use computer-scoring without a hitch. There are just 16 lanes; it is not a bowling center posing as an amusement park. Gardena Bowl is dedicated to good, fun bowling, with leagues, times for open bowling, and other engaging activities. So it is that Gardena Bowl operates under the moniker of a family entertainment center. Also, the prices are very reasonable.

The coffee shop may look modest, but it has been known for decades to serve excellent Japanese-Hawaiian food. This includes bacon fried rice, chicken katsu, Portuguese sausage mix, and loco moco. Yum! Like the adjacent bowling alley, the coffee shop at Gardena Bowl is very friendly and inviting. It is run by two fine gentlemen who have rented the space from the Amenta brothers for 20 years.

The billiard room is sizeable and in notably good condition. Next to it are fun video games. The bar is open at 5 p.m., and the prices (like the bowling) are also reasonable.

Bottom line, Gardena Bowl has not changed all that much in 76 years since opening day in December 1948. There is a recent update,

however, which are certified "string pins". There is a bit of controversy about whether string pins are a good thing. My one cents: I have bowled most of my life - I do not have any problem with the string pins at Gardena Bowl. They are durable strings attached to each pin's top. A computer-controlled drawbar raises and lowers the strings; then, after a roll, the system lifts the pins, and the computer determines which pins remain and where. It works well and provides substantial cost savings, which is one reason the prices at Gardena Bowl are so fair.

Another nice aspect of Gardena Bowl is the sound. What I hear is cheerfulness. I hear fun, and I see it, too. Some of the folks are seniors. Sam told me a few have mentioned to him that retiring left a void in their lives. Solution? Bowl in more than one league! Gardena Bowl is more than happy


<u>Film Review</u>

Sly Lives! (aka The Burden of Black Genius) Review: Heavy is the Head that Wears the Crown

Ahmir "Questlove" Thompson's follow-up to his 2022 Oscar-winning documentary Summer of Soul (...Or, When the Revolution Could Not Be Televised) is another timely watch. Sly Lives! (aka The Burden of Black Genius) energetically pays tribute to the life and legacy of the memorable American funk band, Sly & the Family Stone. Using an abundance of archival footage and interviews with key players in the scene, including André 3000, Clive Davis, and Chaka Khan, Sly Lives! is a captivating look at the good times-and bad-of one of pop music's most influential artists. The documentary held its World Premiere at the 2025 Sundance Film Festival and is now available to stream on Hulu.

Bigger than just an homage-filled tribute to the band Sly & the Family Stone, Questlove's thesis is more nuanced and pointed than the average music documentary. Using Sly Stone as his subject, Questlove investigates and interrogates the idea of Black genius and the expectations that come with it. "What is 'Black Genius'" he asks the interviewees at the beginning of the film. The responses range from lighthearted chuckles to introspective contemplation. It's a tricky question

to answer. Even at the end of the film, the question remains fluid and ever-changing.

Those interested in learning how this group from San Francisco came to dominate the music scene will find much to sink their teeth into in this joyous and academic retrospective. Dubbed a "music genius" by those who knew him, Sly Stone-born Sylvester Stewart-was destined to be a game-changer. Equally charismatic and enigmatic, Sly's first foray into the music industry came as a DJ in the Bay Area of California. The documentary expertly tracks how the band became one of the most groundbreaking bands of the 60s. Notably, they were the first major group to have both a multi-racial and mixed-gender roster.

The film covers all of their highlights, including performances of hits "Everyday People" and "Hot Fun in the Summertime". It also covers the not-so-glamorous moments, including the dissolution of the group, friction between band members, and Sly's out-of-control drug use. It's during these moments that Questlove reinserts his original thesis statement: There is an unseen burden that comes with success for Black artists in America.

Sly Lives! doesn't quite live up to the same "must-see" energy as Questlove's former film Summer of Soul. However, what it does provide in its nearly 2-hour runtime is a vivid memory of the legendary contributions from a West Coast rock band that changed the trajectory of rock and funk music forever. •


Check It Out

The Serpent and the Wolf by Rebecca Robinson

This month I am branching out from my regular literary fiction to a new genre for me – fantasy. I have never been particularly interested in fantasy, but the popularity of the Fourth Wing series demanded I finally delve into the genre. I was pleasantly surprised to find engaging characters, superior world building and accomplished prose. Prior to Fourth Wing, Iron Flame, and Onyx Storm, I read an advanced copy of The Serpent and the Wolf by Rebecca Robinson, which is now available in the library. Like Fourth Wing, this book has an intelligent female protagonist who must fight to save herself from a patriarchal society.

Vaasa Kozar grew up at her father's knee, learning the art of political intrigue and ma-

neuvering while mutely observing. Mastering six languages and learning the secrets and machinations of foreign leaders, she was bred to become a dangerous secret weapon. That, however, is not the only secret she is harboring. Vaasa has inherited her mother's magical power. Power she has not yet learned to control. When her father dies and her brother inherits the throne, he marries Vaasa off to a ruthless foreign leader to remove her as a threat to his throne. He knows how dangerous Vaasa can be. So, she becomes a bargaining chip in his unquenchable thirst for power. Can she use her unwanted marriage to protect and free herself? Will she learn to control her dark magic to wield in defense? Or will her life be sacrificed in the quest for dominance?

This book is the first of a duology and is perfect for fans of Rebecca Yarros and Jennifer L. Armentrout. With an enemies to lovers trope, this blend of fantasy and steamy romance provides a welcome escape from the worries of the real world. •



Once you know your risk capacity, set aside the appropriate cash cushion.

A diversified portfolio could potentially help navigate the ups and downs of the economy. And spreading your investments across various asset classes - like stocks, bonds and real estate - may create a cushion against market volatility. Stocks, in particular, have historically outpaced inflation over the long term, helping to preserve your purchasing power. Overall, staying invested through market cycles rather than reacting to short-term fluctuations can be one of the best strategies for maintaining your wealth in retirement.

An emergency fund is crucial at any stage of life, but it becomes especially vital in **See Finance, page 7**

Star Berry Cream Puffs

Ingredients

- 1/2 of a 17.3-ounce package Pepperidge Farm® Puff Pastry Sheets (1 sheet), thawed
- 1 package (12 ounces) frozen mixed berries, thawed and well drained
- 1 egg, beaten
- 1 tablespoon water
- 2 tablespoons all-purpose flour
- 1 tablespoon coarse sugar crystals
- 3/4 cup whipped topping(This is the amount we used, but add as much as you like!)

Directions

- Step 1: Set the pastry and berries out to thaw. Heat the oven to 400°F. Line a baking sheet with parchment paper. Beat the egg and water in a small bowl with a fork.
- Step 2: Sprinkle the work surface with the flour. Unfold the thawed pastry sheet on the work surface. Using a star-shaped cutter, cut the pastry into 6 (about 4-inch) stars. Place the pastry stars onto the baking sheet. Brush with the egg, then sprinkle with the sugar.
- Step 3: Bake for 15 minutes or until the pastries are golden brown. Let the pastries cool on the baking sheet on a wire rack for 10 minutes.
- Step 4: Carefully split each pastry into 2 layers. Just before serving, spoon about 2 tablespoons berries onto each bottom pastry layer, then top with about 2 tablespoons whipped topping and a top pastry layer.

Tips

Keeping berries and puff pastry on hand makes it easy to create simple but beautiful desserts like this one in minutes.

retirement when income is often more fixed. In addition to your cash cushions, aim to keep enough in your emergency fund to cover about a year's worth of expenses, minus any guaranteed income from sources like Social Security or pensions. A high-yield checking or money market account can be a great place to store these funds, allowing for easy access in an emergency without penalties or delays.

One of retirees' biggest worries is the potential cost of health care, especially longterm care. To prepare ask yourself:

- Who will provide care if needed?
- Where do you want that care to be provided?
 - How will you pay for it?

Political shifts, such as a new administration or changes in Congress, can create anxiety about taxes, Medicare, Social Security and the markets. However, it's important to remember that market movements are more often driven by corporate earnings, economic data and central bank policies than by political changes.


