## So Much for a Short Agenda

The agenda for the February 27, 2024, meeting of the Hawthorne City Council looked shorter and more compact than usual. In fact, Mayor Vargas commented that while there are important matters to address, this might well be a briefer meeting than most. Several hours later, his impression did not prove out; there was too much substance to address quickly.

First, the Council recognized the great Veterans in attendance, thanking all of them for their service, and a round of applause erupted. This then led to a Proclamation, quite detailed and read by Council member Alex Monteiro, praising Hawthorne resident and hero James Swain, a fitting tribute to this gentleman as part of Black History Month.

Mr. Swain served in the United States Marine Corps and, over time, received several awards, including for good conduct and the National Defense medal. After his discharge in 1991, he obtained a degree in liberal arts, a bachelor of arts degree in sociology, a social studies credential, and in 2000, a master's in administration of education. He has coached - in fact, Mr. Swain is the first Black track and field coach here -- teaches at Hawthorne High, and is a longstanding, proud member of the American Legion. The Council thanked James for his perseverance, work and determination.

Mr. Swain then spoke briefly, was cordial, and about as humble as someone could possibly be. A reminder that Hawthorne is not just the City of Good Neighbors, but a City of Good People as well.

The focus then turned to the renovation of Hawthorne's Senior Center. This is a \$5.5 million project based on grant funds through

the admirable work of Assemblymember Tina McKinnon. Our Senior Center is outdated and too small.


Access is problematic, and there needs to be more light. As the work goes forward, the Senior Center is being transformed into two stories, with great views, vastly improved access, bigger rooms, a dance studio, a sewing room, a cafeteria, and billiards. Nearby will be pickle ball and bocci courts. The upper level includes a deck looking out at Memorial Park. Council members made some suggestions for the developer to consider, such as enhanced security. Bottomline, this improvement to the Senior Center is much needed and well thought out. Seniors here are going to have a notably better Center.

(My job is to write this column, but if I could have, at that moment, I would have stood up, applauded, and said, "Kudos!".)


More progress: Hawthorne will have new City maintenance and park yards. The current location is very wanting, and dates from over 60 years ago. There will now be new equipment and much more room. The yards will be safer, let alone a morale boost for staff. There will be better parking, and the storage yard will not disrupt current operations.

This, too, is a needed project funded by the grant. The area will be east of the Senior Center, north of the Sports Center, on property that presently is under-utilized. Access will be very convenient, and all to code. Among other tasks, City vehicles can be washed and maintained there. Once again, I thought of saying "Kudos!" but I will just report on the meeting here.




## Film Review

#### The Arc of Oblivion is a Kooky Mediation on Impermanence

Two of the documentary world's most respected filmmakers, Werner Herzog and Kirsten Johnson, give their stamp of approval to Ian Cheney's expansive and rhetorical film The Arc of Oblivion. Lending their astute insights to this cinematic meditation on mindfulness, The Arc of Oblivion playfully explores the human desire for keepsakes amidst an ever-evolving world. Confronted by a question with a myriad

of possible answers, Ian Cheney encourages audiences to ponder what from this world is worth saving or, even more profoundly, "Are we insane to imagine that anything can last?"

Film is a tangible medium that has been around since the Lumière brothers presented the Cinématographe in December 1895. Images are captured and stored on rolls of film or hard drives, accessible when needed. Through the medium of film, we can experience cultures, periods, and places beyond our wildest imagination. The thought of this portal getting erased is terrifying, both from an enjoyment perspective and a historical one. As a filmmaker himself, Ian has always had a fear of losing his life's work from one accidental deletion or natural disaster. In opposition to our need for preserving history, Planet Earth archives it by burying its dead, as seen in limestone layers, tree rings, and fossils. Is that the true order of how we should approach archiving- here one minute, and gone the next?

This train of thought sparks a chain of wild hypothetical theories about memories and the

human desire to want to preserve a legacy. Ian draws comparisons, quite literally, to Noah from the Bible, asking what he would take with him on his arc if he existed in today's modern times. Wanting to experience this scenario from a very method perspective, Ian enlists help from his parents and neighbor to build a 10ft arc in his backyard, using wood he excavates from the neighboring forest. This act of building a backyard arc gets Ian thinking about the fragility of memories, how to cope with their impermanence, and the theory that nothing ever "goes away"- rather, that energy is placed elsewhere.

The Arc of Oblivion has a kookiness to it that feels fresh and unexplored. The incorporation of video art, stop-motion animation, interviews with top subjects (including Johnson and Herzog), and timelapse sequences gives this unconventional thought experiment a sharp edge that is both fun and poignant. Werner Herzog is the film's Executive Producer and he makes an appearance in the last 10 minutes, breaking the fourth wall in a way that feels exciting. He comments on the power of the word "Oblivion" in the film's title, calling it a blessing because we would be miserable if we remembered everything. The human mind needs to be able to forget, he states. He even goes so far as to let us in on a little secret: Herzog discards all of the unused footage that doesn't make it into his films. Never will you see an outtake, director's cut, or extended scene. If it's not in the film, it's deleted from existence.

Acting as a philosophical springboard into the discussion of a desire for permanence, The Arc of Oblivion begs us to question, in the nicest of ways, if we are beautifully insane in our efforts to continue to preserve memories, despite the natural order of disregarding them. It's a fascinating film that I hope remains in the


## Check It Out

#### Prophet Song by Paul Lynch

Prophet Song, the Booker Prize Winner of 2023, is a harrowing account of the descent into authoritarian rule by the fictional National Alliance Party in Dublin, Ireland. Viewed through the lens of one family, mainly matriarch Eilish Stack, the novel is an unrelenting assault on the belief in human decency and democratic rule. Told in running prose with no paragraph breaks, Prophet Song is a frightening look at societal collapse from the ground up.

When the secret police come knocking on the Stack family door, looking for her husband Larry, the deputy general secretary of the Teachers Union of Ireland, Eilish feels the haunting dread of things to come. "This feeling now that something has come into the house, she wants to put the baby down, she wants to stand and think, seeing how it stood with the two men and came into the hallway of its own accord, something formless yet felt."

As Eilish tries to hold her family together through the inexorable slide into fascism, she refuses to see the truth. When Larry is disappeared, as so many are, Eilish continues to cling to the Ireland she knows, not the one that it has become. With four children ranging from nine months to sixteen years and a father sliding into dementia, Eilish rebuffs all arguments to emigrate. Her family begins to unravel; her 16 year old son is enraged with powerlessness, her daughter refuses to eat, and Eilish worries about the effect of toxic stress on the lives of her children while trying to keep tabs on her increasingly erratic father.

Through the mundane daily domesticity of life, we witness the merciless slide of Eilish's world into utter chaos. As Lynch writes, "It is vanity to think the world will end during your lifetime in some sudden event, that what ends is your life and only your life, that what is sung by the prophets is but the same song sung across time."

Eerily prescient, this book reminds us of the horror of civil war and the daily reality of war-torn countries like Gaza and Ukraine, despite being written years before either of these occurrences. Although devastating, this is a powerful novel and a must read. •

And then, at that point, things took an "interesting turn". A gentleman with a Princeton and Oxford background came forward to discuss in great detail how a Charter City works compared to a General Law City. Hawthorne has been a General Law City, so its rules and regulations, to a large degree, emanate from the State.

The speaker (whose name I believe is Scott Rafferty) said General Law may work for some cities, but is a "one size fits all" operation. A Charter City, to an appreciable degree, can tailor things to its own way, including with elections, terms limits, residence requirements, as well as the duties and roles of the Council and Mayor. It may also mean that City Council members be paid far more than they are today. Nearly one-third of California cities are Charter,

including Torrance, Redondo Beach, and Los Angeles. But, in recent memory – in the Fall of 2022 – Hawthorne voters rejected becoming a Charter City by a wide margin. Still, questions arose as to whether becoming a Charter City would provide Hawthorne with greater authority over the presently vacant Hawthorne Plaza Shopping Center, and who doesn't want to finally see something done there of a positive nature?

Some Council members expressed interest in Hawthorne, giving serious thought to becoming a Chater City.

Mayor Vargas would say otherwise.

He used the expression, "Don't fix it if it isn't broken!" He emphasized that, in his view, Hawthorne's general law system has worked, from Space X to great schools to excellent parks. Mayor Vargas said the city is faring

well economically, all things considered, and in his view, it is offensive to the dedicated and hardworking Hawthorne personnel to propose changing the way the City governs. He pointed out Hawthorne has gone from a \$5 million cash balance to some \$85 to \$90 million. He, therefore, adamantly opposes putting the issue on the ballot.

A short while later, local resident Moe Awadallah echoed the mayor's sentiments and made clear that he is running for City Council, so any current member who pushes for Hawthorne to vote yet again on becoming a Charter City will hear from him on the campaign trail.

Next on the Consent Calendar was an item that seemed innocuous, but also involved lively discussion, led by Council member Alex Monteiro. Specifically, there will be criteria in place that the city is to carefully evaluate before providing monies to a nonprofit organization for an event or to support its outreach. The council ultimately voted and approved the item.

Finally, Ken Duran came forward to address the status of a number of business-friendly projects Hawthorne has instituted. These include the Community Gift Card program, which has worked well (and has money still on hand), including grants to improve vacant storefronts and to the now closed-out business rental assistance program.

In sum, not a brief meeting, but to be clear: The Hawthorne City Council is engaged. Hawthorne is governing itself in a manner that, at least in any number of instances, might just convince a member of the public to say "Kudos!" •

## Sausage, Mushroom and Thyme Biscuits

#### Directions

- **Step 1:** Heat the oven to 450°F. While the oven is heating, cook the sausage according to the package directions and finely chop (should make about 1/2 cup). Line a baking sheet with parchment paper.
- Step 2: Stir 2 1/2 cups flour, baking powder and butter in a large bowl (using your fingers, crumble the cold butter into the flour mixture until it forms pea-sized pieces). Add the sausage, soup, honey and thyme and mix just until a slightly sticky dough forms. Shape the dough into a ball.
- Step 3: Sprinkle some additional flour on the work surface. Roll the dough into a 10x7-inch rectangle (should be about 1 inch thick). Cut into 12 (about 2 1/2-inch) squares. Place the dough squares onto the baking sheet. Brush with the egg. Sprinkle with additional chopped fresh thyme, if desired.
- Step 4: Bake for 12 minutes or until the biscuits are golden brown. Serve warm.
