It is unusual that there was only one "Presentation" listed on the Agenda for the March 12, 2024 meeting of the Hawthorne City Council. It carried the interesting description "LAX: Soaring to New Heights". Later in the meeting, Hawthorne's Director of Finance, Felice Lopez, made a detailed presentation about Hawthorne's financial condition.

Given what was discussed about LAX and the financial condition of our City of Good Neighbors, the title of this column is a bit low-key. The word "soaring" could possibly have been included, as both LAX and Hawthorne are soaring in at least several positive respects.

First, regarding LAX: The ongoing \$30 billion capital improvement program is the largest public works program in Los Ange-

and restrooms. There will be inter-terminal connections such that you will be able to literally walk from one to the other (to be clear, to all the other terminals) if you choose to do so, which, at a minimum, will allow greater access to facilities for passengers, such as lounges of choice.

All of this has also meant considerable (very substantial) work for many people and, invariably, more money into the economy. This is why the agenda title was "LAX: Soaring to New Heights."

As to Hawthorne's financial condition, Mayor Vargas remarked that a number of local cities are rather envious. The City of Good Neighbor's cash balance as of December 31, 2023 was \$83,028,36. Compare this to 2018, just five years ago, when the cash

balance was considerably lower, \$14,075.07. Efforts have been made in many departments throughout the City to save dollars and to reduce expenditures, which thereby required that much more dedicated time to make up for not contracting things out to third parties (be this by the City Attorney or City Manager Offices, to name a few). Not at all surprisingly, Hawthorne has a solid bond rating.

Bottom line: Financial discipline is in place in Hawthorne. When Ms. Lopez completed her detailed presentation, there was warm applause.

A case in point as to the "finicky" financial nature of Hawthorne: In this instance, the City Council. The City Attorney made an informative presentation about the modest See City Council, page 4

les's history. Among the improvements is an Automated People Mover, which will consist of 2.25 miles of elevated guideway. There will be six stations-three outside the central terminal area and three inside.

The capacity of each train will be 200 people, with luggage, and the time from start to finish all of ten minutes. The frequency of the trains will be every two minutes during peak hours, and operation will be 24/7, 365 days a year. Wow! Landscaping around LAX also will be greatly enhanced.

In addition, there is CONRAC, the Consolidated Rent-a-Car Facility, which will group all of the rental car operations currently spread across the surrounding area of LAX into one location conveniently located adjacent to the 405 Freeway.


There will be seven terminal vertical cores, with connection points that provide passengers with multi-level travel options, including escalators, elevators and stairs. Light and air will be increased in the terminals, which will better link passengers to concessions, baggage,




# Ryuichi Sakamoto | OPUS is a Stunning Send-Off for a Beloved Virtuoso

It was no surprise that Ryuichi Sakamoto had been sick for some time. The legendary composer and pianist had a semi-public battle with throat cancer in 2014, temporarily hitting pause on work engagements and creative output. The documentary Ryuichi Sakamoto: Coda, directed by Stephen Nomura Schible, elegantly captures Sakamoto's gentle return to music in 2017 after living in remission from cancer. For fans, the film offered a glimmer of hope that our maestro would live cancerfree and continue to bless us with beautiful music. But the happy ending we hoped for wasn't meant to be. The cancer came back in 2021, and Ryuichi Sakamoto died in March 2023. His final performance lives forever in *Ryuichi Sakamoto* | *OPUS*, a feature-length concerto directed by his son, Neo Sora.

It's hard to find the words to convey just how powerful OPUS is. Watching Sakamoto put what energy he had left into this performance is both heartbreaking and devastatingly beautiful. Shot in black and white with practically no spoken words, Neo Sora puts the audience front and center to be immediately swept up in the protruding elegance of the Yamaha grand's ivory keys.

Sora doesn't shy away from close-ups, which is a welcomed sight. Sakamoto's signature eyeglasses are displayed in such stunning detail, as well as his soft, nimble hands and sturdily-constructed jacket.

His career-spanning final performance consists of twenty compositions, including "Lack of Love," "The Last Emperor" "The Wuthering Heights," "Aqua," and "Opus," and ends with Sakamoto's most recognizable song, "Merry Christmas, Mr. Lawrence." Tears were flowing all throughout the film but this finale gutted me. I couldn't help but feel a little selfish watching him play. Here is a 71-year-old man, pushing through visible discomfort to give us, his fans, a final gift. For Sakamoto, the reason he is making this film is clear: it's because he is dying. But instead of surrendering to the illness in self-pity, Sakamoto gracefully and selflessly offers us a lyrical elegy that will withstand time. His legacy is preserved in his music and fortunately, we can revisit this moment in time when Ryuichi Sakamoto graced the world with his stunning compositions through OPUS.

The film ends with Sakamoto's favorite quote, projected on the big screen as a reminder to embrace the world as he did. It simply states, "Ars longa, vita brevis," which translates to "Art is long, life is short."

# Understanding Type 1 Diabetes: Should You Get Screened?

(BPT) - More than 1.4 million Americans have type 1 diabetes - thought to be caused by an autoimmune reaction where the body attacks its own cells that produce insulin. That said, even more surprising is that about 90% of those who develop type 1 diabetes do not have a family history of the disease. So, while having a family history of type 1 diabetes is a common risk factor for developing the disease, it is a condition that truly type 1 diabetes.

While this list does not encompass all potential risk factors - for example, geography and environmental factors can also increase a person's risk for type 1 diabetes - the most important takeaway is that no one should wait for common symptoms of type 1 diabetes to get screened because it is possible to identify type 1 diabetes in its earlier stages, before common symptoms occur. 
#### **Family History**

If you have a first-or-second-degree relative who has type 1 diabetes, your risk of developing it increases quite significantly. In fact, if just one person in your family has type 1 diabetes, the chances of you or someone else in your family developing it are up to 15x does not discriminate.

Age In the U.S., type 1 diabetes is among the most common chronic diseases that impacts children. In fact, type 1 diabetes was once commonly referred to as "juvenile diabetes." That said, we've gotten more knowledgeable about this disease over time - and now we know that although type 1 diabetes usually develops in children and adolescents, individuals at any age can develop it. This means that young adults and adults are still at risk, with recent data showing that more than half the people who are newly diagnosed with type 1 diabetes are being diagnosed as adults.

salary for the City Treasurer and City Clerk, which dates back 20 years.

He explained why an increase could be more readily (and more quickly) handled through a Resolution. An increase does indeed seem to be in order, in part because the City Treasurer and the City Clerk are putting in a lot of hours and effort. It will take more time and is more cumbersome to make the salary change by Ordinance (including that the increase will not go into effect until January 2025). But, as this topic was talked out, the City Council decided to do it the way their salaries are dealt with - as elected officials (which they all are). So, the increase will be done through Ordinance, not Resolution. While very likely the salaries will finally be increased after 20 years, the increase will not go into effect until the beginning of next year.

A particularly nice moment during the meeting arose when a young woman came forward. She is a junior at the Hawthorne Math & Science Academy and was invited to attend the City Council meeting to see


"government in action." She will participate in a summer program addressing Chicano and Latino Politics, and Mayor Pro Tem is mentoring her. She, too, received a warm round of applause, which was all the more tender because her parents accompanied her.

Please note that Southern California Edison is seeking to increase utility charges, at least for many, if not most. Effort is underway to obtain one or two buses to take concerned Hawthorne citizens from City Hall to the meeting on this requested increase, which will



# **Easy Irish Potato Soup**

- Step 2: Stir the broth, water and potatoes in the saucepan and heat to a boil. Reduce the heat to low. Cover and cook for 15 minutes or until the potatoes are tender. Remove the saucepan from the heat (*don't drain off the broth mixture, though*).
- Step 3: Add the milk to the saucepan. Using an immersion blender, blend until the mixture is smooth *(if you don't have an immersion blender, add the milk and blend in a regular blender)*. Season to taste with salt and pepper and heat until hot. Sprinkle with additional sliced green onions before serving, if desired.
