A Very Handy Man in Hawthorne

What if I told you that a gentleman who grew up locally (in Hawthorne, where he still resides) has proven himself to be very adept at fixing drawers, building a bookshelf to fit within a storage space, replacing and installing a toilet, patching and nicely painting an old worn-out wall, restoring the flow of water through a damaged shower head, paving a previously wet area adjacent to an outdoor fireplace with smooth concrete, and repairing stubborn windows that would not stay open? And, what if I said this was simply part of what he can do, and then I looked you square in the eye and insisted, "He charges less than you would probably expect!"

You might say to me: "That's nice, Ron... is there any other snake oil you're selling today?"

Granted, the expression "jack of all trades" is more a slogan than a reality, but Jeff Todd exists. He is very good at all sorts of things, "handyman", and he is likable as well. So, there you have it.

Jeff's dad, back in the day, was the Superintendent of Hawthorne Parks and Recreation. In his spare time, Jeff's father liked doing woodwork. It was a hobby, from carving and making wood bowls to jewelry boxes or, as Jeff puts it: "Just about anything you can make out of wood!" Jeff's dad eventually had a home wood shop, and Jeff became familiar with a lot of tools. He also learned how to approach repair or fix issues, evaluate a construction problem, and focus on what may work in any given instance.

But Jeff did not go from high school to being a handyman. He took a detour in the restaurant business for quite a few years, including as a chef. "The hours were difficult. I would get off work from the restaurant at

1 a.m. but still, be too wide awake to sleep. Also, it seemed like I was always working, particularly on weekends. I had no life to speak of, so when I was offered a job at a thriving sheet metal company, which meant I would often work outside, during daytime hours Monday through Friday, the decision was not really difficult. I got 15 years there and could take what my dad had taught me and what I learned working both in the shop and in the field. It is really cool to take flat metal and turn it into something useful. It's also good to be involved in various aspects of construction projects. Your work can help people."

When the sheet metal business was sold, Jeff "went out on his own." The year was 2009. He handled several repair tasks for a neighbor who was so pleased he put a note in a community newsletter. Jeff got some calls, and from there, the rest has been word of mouth. He has repeat customers among his clientele and is focused in the South Bay.

"I am going on 14 years. I have a buddy and a helper if needed, but most of the work I can do most on my own. I have my own tools. Typically, I ride my bike over to a customer's place. Some jobs are bigger than others. One customer owns several properties. The work there has included fixing a pool leak. That is not typical, but through the years, I have come to understand how to approach a problem and fix it. If I can't fix it, I am clear about it. I chose not to get a contractor's license because I wanted to keep it simple. One reason I can charge less is because I don't have a lot of overhead."

"Have some customers said you don't charge enough?" (He laughs) "Yep. I hear that at times, but what's fair is fair. I do

fine. Remember, I don't have an office that I have to maintain. And it makes me feel good when my time and work are helpful to someone else. Always has..."

Jeff works very hard. Occasionally, some have worried that he does not take breaks when he should. The bottom line, he is dogged. I have seen him on some projects that would sap the enthusiasm of many if not most of us. He has genuine stick-to-it-tiveness; that's a word that fits with Jeff Todd.

Before writing this column, I looked up the definition of a handyman. Wikipedia says: "A handyman, also known as a fixer, handyperson, or handy worker, maintenance worker, repair worker, or repair technician, is a person with skills at a wide range of repairs, typically for keeping buildings, shops or equipment around the home in good repair. These tasks include trade skills, repair work, and maintenance work, both interior and exterior, and are sometimes described as 'side work', 'odd jobs', or 'fix-up tasks.'

Jeff does not advertise and does not have a website. As he says, he has minimal




Film Review

In Paint, Owen Wilson Plays a Bob Ross-like Painter

If you're going to have someone play a Bob Ross-type character in a movie, there's no one better to do it than Owen Wilson. It's this casting alone that made me want to watch Paint, in which Wilson stars as a not uncoincidentally-imagined fictional

basic cable painter known for his serene landscape portraits.

However, Wilson's gimmick of channeling Ross's famous hippie vibes with his trademark chill is only rewarding for so long. While it's an intentionally silly sendup and a mildly funny world to live in, *Paint* isn't nearly as subversive or funny enough to become a new comedy classic.

Wilson plays "Carl Nargle," a hippie host of a live painting program for the local Burlington PBS affiliate TV station. With his good vibes and worldly bits of wisdom, Carl is beloved in his small town. The ladies especially love him, too. They rush him after every show merely for the chance to hold his paintbrushes.

Times are good for ol' Carl Nargle. Exceptpredictably-the times are about to change. Once the station's ratings start to go south, the station manager (Stephen Root) brings in a new painter. Ambrosia (Ciara Renée), a hip younger gal, is to add to Carl's success with another hour of live painting.

Carl and the rest of the station are surprised at the new blood that Ambrosia brings to the show. It's quite the departure from the peaceful mountains and calm creeks painted by Carl for his mostly-senior viewers. But her fresh energy-and new female empowerment-push Carl to the sidelines. Soon enough, he's left alone as an aloof artist and out-of-time man.

If this setup sounds similar to *Anchorman*, it's because it really is. I wonder if this was a conscious or unconscious template that writer-director Brit McAdams had in mind when creating this movie. With his curly blonde perm and woodsman-styled facial hair, even Carl's comically dated '70s appearance channels that of Ron Burgundy's.

I did find an interesting story a few layers underneath Paint, which comes about towards the end of the film. When Carl is sidelined, he finally confronts how his "hotel art" compares to more compelling art of the time, like modernism.

I wish the film followed the blueprint that last year's Weird Al parody-biography Weird: The Al Yankovic Story did so well: weaving biography and wild absurdism together actually drew laughs. While perfectly cast, Owen Wilson is only so watchable as the film drags on. It's enough to make you wonder how much longer it'll take for the paint to finish drying.



A Likely Story by Leigh Abramson

Written from varying points of view, A Likely Story by Leigh Abramson tells the story of Isabelle Manning's struggle to publish in the shadow of her very famous father. All she ever wanted was to be a writer. Entering her

mid-thirties, Isabelle's world is splintering. Her mother just died from a rapidly progressive illness, and her father lives in the rarified world of his own ego. Her first book wasn't accepted and she's wrestling with the expectations of herself and the publishing world as the only child of Ward Manning, the feted and fawned over best-selling author of nineteen novels.

What Isabelle doesn't know is that her father is floundering as well. Ward's agent is pushing him to deliver at least the first chapters as the deadline for his latest book looms. Ward doesn't have any chapters to give. He is so obsessed with his reputation and standing that he spends most of his time reading fan mail and scrolling the internet for mentions. He has no time for anyone or anything that doesn't cater to his monstrous ego. That includes Isabelle. Losing his wife Claire has only made things worse. He is spiraling out of control and there is no one to stop him.

Set in New York City and Sag Harbor, this story of a fractured family coming to terms with loss and failure heats up as Claire leaves a cryptic legacy for Isabelle. Why did her mother insist that her father have no knowledge of what she finds? Why is it so carefully hidden? What she ultimately discovers may destroy them all.

While the characters can be unlikeable, we see how Isabelle's obsession with pleasing her father has shaped her life. Isabelle recognizes her single-minded ambition comes at a terrible cost; one she isn't sure she can live with. This story slowly builds, and the tension thickens as each of our protagonists strive for that publishing pot of gold. Who will win and what will they lose? This book is hard to put down.






