Me: "Granted, I feel a little silly, but there was a packed house at SoFi two nights in a row. This event is in our backyard here in the South Bay. John Cena, one of the most famous, has set a record for granting Make a Wish for kids!" Wife: "Well, I'm glad you had fun. But, when friends come over tonight for dinner, please, if you talk about it, keep it to a minimum, ok?' You see, my son and I went to the second night of Wrestlemania this past Sunday, April 2nd, at Inglewood's So Fi Stadium. The wrestler Roman Reigns (referred to as "The Head of the Table" and "The Tribal Chief") continued his longstanding run as Champion of World Wrestling Entertainment, to the chagrin of many there. It was all very dramatic and ended with quite an array of fireworks. Let me be clear: My son and I are at least somewhat intelligent. We also are from two very different generations. So, we asked ourselves, "Why do we have fun with this?" There was music, including excellent piano playing, a variety of colorful lights, lots and lots of pyrotechnics, and a fair amount of

humor (from, among others, co-host Snoop Dogg). The crowd was noisy, boisterous, and very diverse. There were a fair number of families, lots of excited kids, and the atmosphere at times electric.

The organization itself (the WWE) supports several worthy causes, not the least of which are folks in the military. And SoFi Stadium is indeed one of the pride and joys of the South Bay. Inglewood Mayor James T. Butts spoke before the event began. Wrestlemania was good for our local economy.

Yes, the action is make-believe, except they throw each other around, and I am sure it hurts at any given time. Women are very prominent in matches and a significant part of the industry. The show opened with the singing of *America the Beautiful*.

So, as I have mulled this over, here is what happened to me: Long ago, when I was in high school, some friends and I went to the Olympic Auditorium in downtown Los Angeles to see a favorite wrestler, Bobo Brazil. There were, maybe, a few hundred people there - not 80,000 each night like at SoFi. There was no pyrotechnics. There was no music and no fancy walk-in ramp. It was pretty bare bones. The chairs we sat in looked like party rentals. I saw two grandmothers they sure looked like grandmothers - standing up, shouting at the wrestlers, and shaking their fists and purses at the "bad guys ." It was fun, silly, distracting, and, bottom line; I got hooked.





## In *How To Blow Up a Pipeline*, Eco-Activists Take On the Oil Industry

Director Daniel Goldhaber does not shy away from centering his films around controversial subject matters. His sophomore feature film, the ecological thriller *How To Blow Up a Pipeline*, thrusts a group of activists from across the country into a fight against the oil industry.

Adapted from Andreas Malm's book of the same name, it's an ambitious and worthwhile cinematic and political statement for our times.

We first meet the collective, made up of eight young men and women from various backgrounds. They have convened in West Texas, with plans of destruction already in motion. At first, the lack of context for the first 15 minutes feels insufficient and mildly confusing. However, the characters' backstories and how they all came to meet are eventually revealed.

Once we're given more information on who these people are and why they're risking their freedom and lives to make a statement, their reasoning seems justified. Passion and anger fuel their actions, and their message, on the whole, is one worth supporting. There are enough twists in the script to make *How To Blow Up a Pipeline* an enjoyably unpredictable watch. Yet, I fear it lacks the staying power to make it a cinematic political statement of the highest degree.

The film's aesthetic is comforting in its warm and grainy look, similar to Power Ranger films of the mid-90s. The editing is also reminiscent of old-school superhero shows you'd find on TV after school. It gives the film an organic texture that feels rooted in the Earth, almost like we can feel the effects of global warming through the screen.

Composer Gavin Brivik incorporates the sounds of the enemy – oil drums and pipes – into his score by recording samples with distorted and pulsing synth sounds.

There's no doubt that this story is one worth telling. *How To Blow Up a Pipeline* is a commendable effort to bring attention to this crisis. While it may not rank among my favorite ecological thrillers (*Woman at War* and *Night Moves* to name a couple), *How To Blow Up a Pipeline*'s message alone is worth the watch.



This week, I'm pairing one of my favorite new picture books about overcoming fears with a non-fiction favorite that helps kids understand anxiety.




#### Brave Enough by Rob Justus

*Brave Enough* by Rob Justus opens with studious Little Brother, who is afraid of monsters due to all the books he's read about the scary topic, hiding under the covers of his bed. But his brash, brave big sister is determined to prove they don't exist and drags Little Brother down the block, through fields and into forest. When they fall down a hole due to sister's impulsivity and run into an actual monster, Little Brother comes to the rescue with facts from one of his monster books. Readers will relate to the polar sibling viewpoints, each with their complementing strengths and weaknesses, and how experience can debunk unfounded anxieties.

For suffers of anxiety, like Little Brother, the world can be a scary, confusing place. A little bit can be good but a lot can be debilitating. And for kids, who might struggle to put into words what they are feeling and why, books like *All About Anxiety* by Carrie Lewis, can be helpful.

The book breaks down questions kids might have about anxiety such as what causes it, what can they do about it, and who can they ask for help. Included are colorful illustrations that help convey emotions, visualize parts of the body that are involved with anxiety and normalize the experience.

# The City Holds a Ribbon Cutting Ceremony for the New Bridge of Hope Community Housing




This housing community will provide interim shelter for unhoused individuals in the community. The 3800 sqft City-owned lot is located at 131st St. and Simms Ave, offers (12) 64 sq. Ft. insulated shelter units. The units have locked doors and windows, secure ventilation, a folding bed with a custom fit mattress, a folding desk, electricity, wall-mounted heater, air conditioner, fire extinguisher, smoke detector, carbon monoxide detector, slip resistant floors and storage. Eligible Hawthorne individuals suffering from homelessness is the City's target population. The ideal length of stay is between 90-180 days. A service provider who will bring onsite case management, job training, three daily meals and connection to additional services will operate the site. The City will leverage CDBG CARES Act dollars, the American Rescue Plan Act awards, PLHA grants and an HOME ARP allocation to build and operate this project. This is a temporary site that will initially run for 3 years or until all available funds have been exhausted. Thank you City of Hawthorne for helping our residents in need. ## **Kidney Stones: Recurring Symptoms Could Signal an Inherited Disease**

(BPT) - Throughout her life, Kim had no explanation for the recurrent, painful kidney stones she experienced. Growing up she and her doctors dismissed these stones and associated pain for other conditions like menstrual cramps and irritable bowel syndrome (IBS). It wasn't until her sister Joy passed away from the same disease that Kim received answers in the form of an official diagnosis - Kim's kidney stones were the result of an inherited disease called primary hyperoxaluria type 1 (PH1). Kidney stones are a hallmark symptom of PH1. However, many people who experience recurrent stones in adulthood or even one kidney stone as a child do not consider or investigate a root cause, which can lead to delayed diagnoses and further complications. After watching her sister's progressive PH1 symptoms, Kim is determined to ensure her sister's memory lives on by sharing PH1 education and her own disease journey. Here's some information to know about PH1, including signs and symptoms, to better understand what to look for and when to potentially suspect this rare disease.

PH1 causes an overproduction of oxalate - an unneeded waste product that cannot be



broken down further - in the liver. Normally, oxalate is present only in small amounts, is not used by the body for anything and needs to be eliminated by the kidneys. The overproduction of oxalate can lead to the formation of painful and recurrent kidney stones as well as progressive damage - meaning it can get worse over time and cause permanent damage.

As a rare disease, PH1 affects approximately 1 to 3 individuals per million in the United States and Europe, with an estimated 1,300 to 2,100 diagnosed cases across geographies. In some regions, such as the Middle East and North Africa, the genetic prevalence of PH1 is estimated to be higher.

After getting diagnosed with PH1, Kim took a genealogy test that showed she is, in part, of Middle Eastern descent, giving her a higher likelihood of having PH1. Knowing this helped fuel her vigorous research to learn about disease management options, especially since she and her See Seniors, page 7

This event was Wrestlemania, number 39. The first was back in 1985. As noted, SoFi is said to have had 80,000 in attendance, 80,000, mind you, each night.





siblings are more likely to have PH1 due to their ancestry.


Most people with PH1 have their first symptoms as children or teens, but some people don't have signs until they're adults. Kidney stones are the most common symptom of PH1, which may include pain in the side of the body, painful and/or bloody urination and urinary tract infections. However, not everyone with PH1 may have kidney stones. Other symptoms of PH1 include, but are not limited to, nephrocalcinosis (crystal deposits in kidney tissue), failure to thrive in babies and end-stage kidney disease (kidney failure).

Kim was not the first person in her family to experience kidney stones. In fact, this seemingly common symptom ran in her family. Her brother passed away at birth due to crystallization in his kidneys, and her sister also experienced kidney stones, among other PH1 symptoms, throughout her life. Their symptoms were undiagnosed by doctors for years until they received a formal diagnosis later in life - which unfortunately, was too late in her sister's battle with PH1.

PH1 can be diagnosed by a doctor measuring oxalate levels in the urine or blood, and/or with a genetic test. While managing PH1 is life long, there are various ways to address the symptoms. For many patients, like Kim, PH1 is not diagnosed immediately. Half of people living with PH1 may be undiagnosed. Unfortunately, Kim's sister was also diagnosed later in life and, due to the delayed diagnosis, developed severe oxalosis throughout her body, including in her legs and heart before passing away.

Today, Kim is passionate about telling her story, so she was happy to be sponsored to share her story with Alnylam. She also advocates for herself and others with PH1.
