Don't Let that Short Agenda Fool You

The Hawthorne City Council typically meets at 6:00 pm every other Tuesday. The meetings often are cordial, but two weeks ago, the atmosphere took a tense and unpleasant turn regarding whether voters should once again consider having Hawthorne become a Charter City. This potentially contentious issue does not quite seem to be going away, but, with a sigh of relief, cordiality resumed at the meeting this past Tuesday, April 23. The Agenda was shorter than usual, which led Mayor Vargas to say it may be a very brief meeting; however, with the care and time Council takes on matters, the number of persons who spoke, combined with several presentations, the meeting was (as is common) full of detail and consideration. Hence, the title of today's column.

Hawthorne has a new Mayor Pro Tem, Councilwoman Katrina Manning. She replaces Angie Reves English. Ms. Manning will serve when the elected Mayor (Alex Vargas) is unavailable. Kudos to her, having been elected to the Council in November 2022.

Guy Hocker, a long-term Hawthorne resident and a stalwart figure in the city's development led to the Pledge of Allegiance. Mr. Hocker became Hawthorne's first directly elected Mayor in the 1970s.

Dulce Medina spoke on behalf of the City of Hawthorne's Homeless Services, whose office is located at the Memorial Center. Team members include two outreach coordinators, a receptionist, a case coordinator (starting April 29), and supervisor Medina. Homelessness is a sad situation indeed and problematic for the community, but Hawthorne's efforts, thankfully, are having an impact. For 2023, the caseload involved 140 to 152 persons; street outreach provided services to over 3,000 people; case management, which includes housing navigation, health care, and counseling, was provided to over 3,400 individuals; and 24 people were permanently housed. The challenging work on homelessness continues. Councilman Alex Monteiro expressed heartfelt appreciation for the effort, which includes the Bridge of Hope housing facility.

Oral communications, during which members of the public are entitled to come forward for three minutes, was even more attended than usual. Topics ranged from support for Hawthorne to become a Charter City to opposition (like I said, this issue is not going away); the need for speed humps in certain locations; an unhappy resident who feels he is being unfairly ticketed; and issues with homeless persons. Also, Daniel Granados, who runs the excellent Hawthorne Library, shared upbeat news about available programs, including free internet access.

Hawthorne's Kimberly Mack spoke about the draft 2024-2025 Action Plan for the Community Development Block Grant and Home

Investment Partnerships Programs. Kimberly handles several tasks for the city, such as Section 8 rental assistance, rent mediation, and the building rehabilitation loan program.

The Consent Calendar listed nine items, two of which emphasize that Hawthorne remains at the forefront of some very important and unique programs. Specifically, Hawthorne provides supplemental law enforcement jail services to El Segundo and assists (if not instructs) the Gardena police department with medical services. Lives have been saved as a result of the rapid response time of Hawthorne police officers.

At this juncture, Mayor Vargas expressed pride that "Hawthorne is a trendsetter in so many ways... using its state-of-the-art services!" (which includes helicopters). Further, Hawthorne has been at the head of the table regarding "Coffee with a Cop," and Hawthorne initiated the admirable and effective

Film Review


In The Idea of You, Anne Hathaway Navigates Love, Art, and Complicated Relationships

Imagine the lead singer of the hottest British boy band dedicating a love song to you while he's on stage performing for tens of thousands of fans at Coachella. It's pretty much every teen girl's dream and in Michael Showalter's romantic drama The Idea of You, this fairytale is lived out by the most unexpected person: a middle-aged single mom from Silverlake. Part escapist fantasy, part grounded love story that transcends conventional dating taboos, The Idea of You strikes all the right chords in its portrayal of two people living life on their terms. The Idea of You opens at The Culver Theater this weekend before coming to Prime Video on May 2nd.

Anne Hathaway takes command as Solène, an art gallery owner navigating through a complicated relationship with her recently divorced ex-husband, Daniel (Reid Scott), and his much younger girlfriend. Solène and Daniel share custody of their teenage daughter Izzy (Ella Rubin) and she is in the adolescent stage where she'd rather hang out with friends than her parents. Still, Izzy is ecstatic when Solène agrees to accompany her and her friends to Coachella.

Making it a point to stay out of her daughter's way, Solène stumbles into the presence of Hayes (Nicholas Galitzine), the lead singer of the UK pop group August Moon. Almost immediately, Hayes is mesmerized by Solène's maturity, confidence, and ignorance of his fame. Solène, on the other hand, meets his flirty advances with politeness but it isn't



until Hayes subtly dedicates a love song to her during their set that she unexpectedly begins to form a crush.

What follows is a rush of young love that spans continents, high highs and low lows. Despite their age difference and very different life circumstances, their connection is electric and undeniably authentic. However, Solène can't help but feel out of her element when she is constantly faced with Hayes' youth and mischievous behavior, especially in the form of past girlfriends and hookups. This is the most alive Solène has felt in a long time but still, she questions whether this spark is worth the personal and psychological strain that the relationship is putting on her daughter and, if she's being honest, also herself.

There is a lot to love in this Michael Showalter-directed film, especially the strong casting choices. Anne Hathaway effortlessly slips into the role of Solène, her cool-girl style and graceful aging give off icon status. The only moments I couldn't get behind were the few times she insecurely compares her body to the teenage girls she is surrounded by, because in reality, Hathaway looks better than most supermodels. Nicholas Galitzine, who plays the heartthrob Hayes, nails the Harry Styles vibe. Not only does he give a compelling performance as an infatuated young man who may or may not have mommy issues, but his musical talent is equally impressive. Singing and dancing the way he does, it's no wonder Solène fell under his spell.

Based on the acclaimed novel of the same name by Robinne Lee, The Idea of You is an irresistible story about love, art, and complicated relationships. The film premiered on the Closing Night of SXSW and was nominated for an Audience Award in the Headliner category. •

Here in Avalon by Tara Isabella Burton

If you're looking for a great diversion to being stuck inside by April showers, give Here in Avalon a try.

The author of this book is Tara Isabella Burton. She also wrote Social Creature, The World Cannot Give, Strange Rites and Self Made. She has a doctorate in theology from Oxford and her works have appeared in The New York Times, The Washington Post, The Wall Street Journal and more.

The story introduces the reader to two sisters, Rose and Cecilia. The New York City streets and a few other characters raised the girls since their mother was never there to do so. She provided them with an apartment, but that is about it. Rose, when reaching adulthood, gave up her bohemian artistic lifestyle and built the life she always wanted - safe, reliable, stable, and secure. She is engaged to a man who also has these qualities. Cecilia,

her sister, is a talented musician and is still trying to find her happily ever after which leads to grandiose ideas that never quite pan out and a chaotic, impulsive lifestyle that Rose ends up fixing.

After Cecilia comes back to New York City after impulsively marrying a man, Rose believes and tries to convince her fiancé, that Cecilia has changed for good. But after a short time, Cecilia disappears.

Rose is convinced that Cecilia has boarded a magic, cultlike vessel called the Avalon and she is desperate to save her sister. But as Rose uncovers more information about the Avalon, she begins to question herself, her decisions and if leaving her safe world in exchange for magic and beauty is a sacrifice she is willing to make.

This story is a gritty, dark adult fairytale that kept me wanting to know what happens to the two sisters until the very end.

If you enjoyed the Ten Thousand Doors of January by Alix E. Harrow this might be a good fit.

How to Manage Your Anger Toward Your Loved One with Dementia

I've been facilitating support groups for families who care for loved ones with dementia for sixteen years. Together, we work to unlock the many doors of dementia. One of those doors is a frequent topic: anger. Family members, particularly those who assume the role of primary caregiver, are often angry at the disease, its symptoms, their loved ones, and even themselves. These feelings serve no useful purpose and make it more challenging to focus on proactive approaches to caregiving.

If you haven't been affected by dementia, you might have a hard time understanding this anger. We know our loved one didn't choose the affliction, and failing memory isn't anyone's fault, so compassion and empathy are the emotions we expect. However, dementia often comes with challenging behaviors that range from mildly annoying to potentially severe. Most families are unprepared for these behaviors, so negative emotions like frustration or irritation readily appear. Anger is just one step away, and frustrated people have difficulty separating their rage at the behavior and the person exhibiting it.

In addition to challenging behaviors, most families are also unprepared for the progression of the disease, which may advance quickly or slowly. Over time, a tolerable behavior becomes intolerable as it wears on us at a subconscious level. Many families don't recognize these ongoing changes after diagnosis until a visiting relative arrives to point them out.

The diagnosis is the beginning of a journey for families, which is why I call dementia

"the family disease." Lives and relationships are forever changed, and often, roles reverse as children assume responsibility for their parents. The challenge for families is learning to let go of the frustration, irritation, and anger so we can continue life as we want.

A caregiver's best tools are education and talking with others in similar situations. I highly recommend anyone caring for a loved one with dementia join a support group regularly. I also recommend following the advice in my book, Unlocking the Doors of Dementia, which specifically addresses many of the behaviors of dementia as well as many uncomfortable situations faced by families.

Many people who become frustrated or angry about their situation stop caring for themselves, which fuels negative emotions. Make yourself a priority, taking breaks during the day or week to enjoy time with friends, doing activities you want, or even taking walks. If you don't care for yourself, you can't take good care of your loved one.

Learning and using positive communication techniques can help reduce stressful situations. Effective communication is essential when caring for someone with dementia and can minimize frustration while improving your loved one's understanding. Speak slowly and use simple language, avoiding negative language or correcting your loved one's mistakes. Remember to use a calm and reassuring tone and practice direct eye contact.

Finally, practice empathy and acceptance. By accepting the disease, you will have an easier time with your loved one. Step into their reality. If your loved one no longer knows your reality, validate their feelings.

Anger should not consume your energy.





The story continues with Miles Morales (Shameik Moore) as he figures out his life as New York's newest Spidey. Zipping through cityscapes with the greatest of ease, his biggest struggle is balancing his teenage life: honoring his commitments to his mother (Luna Lauren Vélez) and soon-to-be-police chief father (Brian Tyree Henry), looking ahead to college and oh yeah, trying to save the world-all while keeping his identity a secret from those he loves. The only ones who know Miles' true identity are the league of Spider-Men who helped teach him the ropes (webs?) after crash-landing into his universe in the previous film. All of the Spider-Men, including punky introvert Gwen Stacy (Hailee Steinfeld), are spread across different worlds.

The film opens with Gwen's origin story (shown over an incredible drum-solo montage that also illustrates each world's specific visual style-Gwen's being a watercolor one, while Miles' ink-blotted world more readily resembles comics). After Gwen is attacked in her world by the universe-hopping villain Vulture (Jorma Taccone), she unexpectedly meets a few more Spider-Men and women (Oscar Isaac and Issa Rae). These heroes are part of a "Spider-Society" that protects the multi-verses from "canon disruptions." Wishing to leave her world behind, she pleads to join theirs. Against better judgment, she decides to pop over to Miles' world for a quick visit.

While Miles has matured since the first film, although still wise-cracking and perhaps a bit too cocky in his Spidey role, he underestimates the arrival of a clumsy new villain, Spot (Jason Schwartzman). Spot warns Miles that he is his new nemesis and holds him responsible for his genetic mutation; being covered in spots that he can use to travel through space




Check It Out


