# A Day to Encourage and Share Wisdom

Steve Rappaport is a longstanding South Bay resident and the CEO and Co-Founder of the National High School Career Day Network. He emailed me an invitation to attend the Career Day Event at Hawthorne High School.

The language of the invite caught my attention: "Our mission is that every student who graduates from the Centinela Valley Union High School District is academically and emotionally prepared for post-secondary endeavors. The more exposure students have to career possibilities, the more informed choices they can make."

But wait a second. I am going to give a career talk? What do I know? What guidance could I possibly provide?

Well, let's consider the following: I have been a lawyer for over 40 years, taught for a while, and have written newspaper columns for the last 30 years. Maybe I could have some useful information. Maybe I could be of some value after all...

The list of careers for which speakers were sought was impressive and diverse, including persons involved with architecture, aviation, mechanical engineering, fashion, journalism, law, music, physical therapy, psychology, real estate, registered nursing, sports business/management, and web design/ development. This is not the full panoply of professions.

Many signed up. Indeed, a very impressive array of people. On March 27th, just past, we were provided a continental breakfast. Grace Yang, the dedicated Principal of Hawthorne High, welcomed all of us (this is the first Career Day there). She said, "We strive to help prepare our students for college, a career, and life itself."

Student ambassadors guided us to our respective rooms. Each of us gave up to three presentations over the morning to three separate groups of students. Specifically, we shared our experiences, lessons learned, and any useful wisdom we could provide to these young minds, these potential future leaders. We fielded questions and sought to both encourage and inspire.

Some utilized PowerPoint, some hands-on, and some engaged the students in question and answer. As an attorney, I divided the students into a make-believe courtroom, with one side arguing an issue, the other side arguing in opposition, and a jury to decide the outcome. I also discussed the real enjoyment, gratitude, and learning that comes from writing newspaper columns, including, of course, this one.

When our presentations were completed, we were provided lunch and given a nice satchel from the Centinela Valley Union School District (which included, among other items, a superb pen and a writing booklet). Career Day was (and is) quite an experience, for all concerned, and well worth the time. But how did this all come to pass?

The Career Day Network is a certified nonprofit organization. Its focus is to help high schools organize student-centered career day events. Quoting once more from the Network's literature, the objective is to "provide resources to inspire students to find their passion, pursue further education, and set a direction for their

#### **City of Hawthorne Continues to Provide Vital Support for Unhoused Individuals**

The City of Hawthorne is proud to report on the continual expansion of its efforts to address homelessness. The City's Bridge of Hope Community Housing project reached a significant milestone: Hawthorne's housing services department maintained successful occupancy of all 12 pallet homes during its first year in operation

Bridge of Hope officially opened with a ribbon-cutting ceremony on April 11, 2023. Situated on a 3800-square-foot City-owned lot at 131st St. and Simms Ave., the project offers interim shelter with a targeted stay of 90 to 180 days.

"We've created a 5-year plan to combat homelessness in Hawthorne, and one of our key aims was to create more housing for those unhoused," said City Manager

Vontray Norris. "I am proud of the resources offered by Bridge of Hope and am intent on expanding this assistance."

Each of the 64-square-foot pallet homes is outfitted with essential amenities, including lockable doors and windows, secure ventilation, a folding bed with a custom-fit mattress, a folding desk, electricity, a wallmounted heater, an air conditioner, a fire extinguisher, a smoke detector, a carbon monoxide detector, slip-resistant floors, and storage. Additionally, the community provides access to a kitchen, ingredient pantry, and laundry room.

Residents of Bridge of Hope are partnered with service providers upon moving in, receiving assistance with job training,

### <u>Film Review</u>

#### Everything We Saw At This Year's TCM Classic Film Festival

The 15th Annual TCM Classic Film Festival took place this month and my sister Morgan and I were there to savor every minute of it. Running April 18-21 in the heart of Hollywood mainly at the TCL Chinese Theater and newly remodeled Egyptian Theater, the festival once again brought thousands of cinephiles and Turner Classic Movie fans from all over the world to enjoy films of all kinds: from black-and-white to modern classics and everything in-between. Beyond watching classic films on the big screen, TCM Classic Film Fest is a premiere event for bringing out stars to celebrate their films, including this year's reunion of the cast of Pulp Fiction for the opening night film. Over three days, Morgan and I saw seven films, a few of which we've listed below. To read about all of the films we saw, head to Cinemacy.com.

#### **Steven Spielberg Recounted** Close Encounters of the Third Kind

The first film I saw that Friday afternoon, 1977's Close Encounters of the Third Kind, was among the weekend's top highlights. While I was excited to see it on the big screen (I'd seen it before), the real draw was the conversation that preceded it, held by TCM's Ben Mankiewicz and the film's writer and director, the legendary Steven Spielberg. After a rousing standing ovation, Spielberg recounted memories of his third feature film (which famously followed the seminal blockbuster that changed Hollywood forever, Jaws). Spielberg shared a story about how one night as a child, his dad woke him up just to drive out to see a sky full of stars, instilling in him a sense of hope and wonder about life and the beyond that colored all of his films, including this one (one of his most personal films). The story of a man (Richard Dreyfuss) who becomes obsessed after experiencing extraterrestrial life, Close Encounters is nearly a stand-in for the director himself, being overtaken by the incredible powers of cinema. The film's climactic ending between humans and aliens set to a sweeping score by John Williams is a must-watch for cinephiles everywhere.

#### **Footloose Kicked Off** a Poolside Dance Party

Another highlight was attending a poolside screening, one of the fest's most special events (and our first time seeing one!). After watching North By Northwest earlier that day and with time to kill, we sauntered over to the Hollywood Roosevelt to lounge for a bit before our next movie. Making our way to the hotel's outdoor pool to take in the last of the sun, we realized how incredible an evening it was and how much fun it would be to take in a film we hadn't seen before, 1984's Footloose! It was the right choice. The film was preceded by a conversation with TCM's Dave Karger who talked with Dean Pitchford, the composer and songwriter of the film. Sitting comfortably on a shared deck chair close up to the screen (and being able to luxuriously order dinner and a cocktail), we couldn't have asked for a better setting to hear the iconic hits, such as "Footloose," "I'm Holding Out For a Hero," and "Let's Hear It for the Boy". By the film's iconic finale in which Kevin Bacon's small town-dance crazed rebel runs up to the camera





### SBWIB and Holds Blueprint for Workplace Success Job Fair in Partnership with El Camino College

More than 1,000 young adult job seekers and employer hiring representatives participated in the 24th Annual Blueprint for Workplace Success Youth Job Fair presented by the South Bay Workforce Investment Board (SBWIB) in partnership with host El Camino College April 25th.

High school students and young adults from over 30 high schools, colleges, and adult/continuation schools were represented with many districts provided bus transportation to attend the event. SBWIB Executive Director Jan Vogel, along with El Camino College President Dr. Brenda Thames, and City of Torrance Mayor George Chen welcomed the job seekers and participating employers.

"You have this great opportunity to meet with all these employers and find out how you can qualify to meet their hiring needs and hopefully take the necessary steps to enter rewarding careers," Mayor Chen noted. Dr. Thames welcomed the students and urged them to take campus tours and see what the college has to offer as they seek higher education and prepare for career pathways.

Mr. Vogel praised the students for showing the initiative to attend the event and meet face to face with representatives from public and private businesses who are looking to build their future work force. "We have assembled this gathering of companies representing high tech, manufacturing, public service and many other agencies for one purpose and that is to expose you to the unlimited career fields that await you," he noted.

During the day-long event, 235 hiring representatives from 95 private and public employers provided information and leads for more than a thousand available jobs. Over 200 students were interviewed on the spot, receiving potential job offers or scheduled for additional interviews and meetings with the employers.

High school seniors in attendance participated in campus tours and were able to be preliminarily processed by the college's student services staff to enroll in the Fall. Workshops were also presented by recruiters from DreamWorks, who discussed career pathways into animation and production fields. Additionally, Construct Reach, a non-profit in collaboration with Target, facilitated sessions aimed at fostering diversity and inclusivity within construction project workforces.



access to three daily meals, housing navigation, medical care, and connection to additional services offered by Hawthorne's housing and homelessness staff.

Funding for the Bridge of Hope Community Housing project is made possible through various sources, including CDBG CARES Act dollars, the American Rescue Plan Act awards, Permanent Local Housing Allocation (PLHA) grants, and a HOME American Rescue Plan (ARP) allocation.

Outside of Bridge of Hope, the City of Hawthorne is expanding housing opportunities through use of emergency housing vouchers and its participation in the Pathway Home Program. The Los Angeles County initiative provides interim housing in hotel rooms, alongside a permanent housing match and the City's wrap-around support services. These services include case management, housing navigation, health and medical referrals, and mental health referrals.

The City connects with individuals experiencing homelessness through dedicated daily outreach efforts and relationship building. Then, staff act as a bridge between individuals and a variety of resources, including Hawthorne programs like Bridge of Hope, or organizations like the Los Angeles Center for Alcohol and Drug use (LACADA) that

provide specialized services. City staff also work to ensure community access to healthcare through the Venice Medical Mobile Clinic, telehealth appointments, and therapy sessions.

Housing and Homelessness Resources Program staff also work one-on-one with unhoused community members to secure necessary documents for housing placement and program participation, which include a California ID, social security number, and birth certificate. "I am very proud to say that 80 to 90% of our clients have those three important documents, or are in the process of getting them," said Program Manager Dulce Medina.

Medina expressed pride about the City's success with both permanent and interim housing placement and the continual expansion of her department. "I don't think I've ever worked with the city that is so forward-thinking in its pursuit of change," she said. "Hawthorne doesn't just wait around for a third party to come in and try and assist us with the housing crisis. We're very proactive in putting our heads together and saying, 'OK, what can we do?""
