## So Special, So Beloved, and So Dogged

The 42nd Annual K9 Community Fundraising Dinner will be held at Hawthorne's Memorial Center on May 16 at 5 p.m. Tickets for kids 12 and under are \$3.50, and for adults, they are \$7.00. The spaghetti dinner is delicious.

It is a fun, good, and emotional time with several from the Police Department, including dogs and now a unique member of the fold: a bloodhound!

Dogs are a big part of so many families today. They are indeed family members for many of us. As you may know, the Hawthorne Police Department initiated a "facility dog program" over ten years ago, becoming a true leader in the field. Over the years, the Hawthorne Police Department's K9 program has been a major inspiration to many other locales. Dogs filling important roles are no longer strangers to law enforcement facilities.

The first dog in Hawthorne's K9 program, the trailblazer, "the one," was named Scottie. The word "sweet" applies to him, followed by handsome, strong, mischievous, loving, tender, and, finally, irreplaceable.

I reached out to Scottie's wonderful trainer at the Hawthorne Police Department, Lameka Bell. Her colleague Kasey Muraya (also part of the Hawthorne Police Department, Community Affairs) shared a touching eulogy, as Scottie passed a little while ago. With her permission, the following tribute is being presented to you here.

Folks, Scottie was (and remains) so cherished and so truly awesome.

**Eulogy for the** One and Only, Scottie

Today, we gather to bid farewell to K9 Scottie, a loyal companion and beloved by nearly everyone he met. His presence brought immense joy and comfort to all those who crossed his path. From the moment he joined the Hawthorne Police Department, Scottie dedicated his life to service, offering companionship and understanding that transcended the need for words. Scottie's legacy continues to live on in the countless lives he touched.

Scottie was born on March 9, 2010. He spent the first two years of his life learning the necessary skills to function as a facility canine. K9 Scottie served as a police facility dog at the Hawthorne Police Department from March 2012 to March 2024. Even after retiring in 2023, Scottie was a constant presence at the department. Scottie always had a knack for knowing where and when he was needed, whether that be at someone's side after a traumatic event or at the end of a buffet line. It didn't matter how he was going to do it, but Scottie was always determined to make your day just a little bit better. His handler, Lameka Bell, clocked thousands of hours working with K9 Scottie over his 10+ year career. As a part of the peer support team for the Hawthorne Police Department, K9 Scottie and Officer Bell made several visits to law enforcement agencies, funerals, schools, hospitals, and even home visits to ensure no one ever felt alone during some of the worst days of their lives. Not surprisingly, in retirement, it was difficult

K9 Scottie's notable success led several other police departments to invest the same effort to acquire their own facility dogs for their departments. Officer Bell and K9 Scottie made it a personal mission to ensure neighboring facility dogs got to learn the ropes from the "OG" himself. New facility dogs spent hours with the duo, both learning how they fit into the law enforcement arena and how to create their own imprint on the police profession. Scottie paved the way for several new facility dogs and created new opportunities for facility dogs in the law enforcement realm.

One of Scottie's key accomplishments was his inspiration for the creation of the nonprofit International Police Facility Dog

### <u>Film Review</u>

#### The Contestant Shows a Darker, More Depraved, Real-Life Truman Show



Before The Truman Show became an Oscar-nominated film with undeniable cultural relevance, there was a real-life series that started it all. The year was 1998, and over 15 million people tuned in every week to watch Denpa Shonen: A Life in Prizes. This real-life Japanese reality TV show pushed the boundaries of physical and mental endurance of its single, unwitting participant. In The Contestant, now streaming on Hulu, the unethical practices that went on during this show are exposed in fascinating detail, as well as the ramifications of being tortured for entertainment.

Tomoaki Hamatsu had a difficult childhood. His family was constantly on the move and schoolyard bullies were extremely unkind, specifically pointing out his physical appearance. They called him Nasubi-which translates to "eggplant"-and poked fun at his oblongshaped head. The name stuck, as soon Tomoaki embraced the name Nasubi, which he still goes by today. Embracing the name was both empowering and comedic, and soon Nasubi realized that comedy was a great deflection to the teasing. He decided to dedicate his life to making people laugh. However, he didn't expect to get recruited to participate in a new reality show that would have people laughing all right... for all the wrong reasons.

Trapped in a tiny apartment, naked and with nothing but stacks of magazines and hundreds of postcards, Denpa Shonen: A Life in Prizes is a human experiment that forces the contestant to survive only on the prizes he wins from magazine sweepstakes. This includes food, clothing, and entertainment. To win the game and end the experiment, the prizes must equal more than one million yen.

A Life in Prizes coverage consisted of 24 hours of filming, 7 days a week, with two



cameras, and eventually, a round-the-clock live stream was available online. Nasubi, who understandably started to lose his grip on reality from isolation and starvation, was in a constant struggle between sanity and madness. If he didn't win a sweepstake prize that day, he would go to bed hungry. On occasion, producers had to sneak into his room in the middle of the night to give him crackers so he wouldn't die from malnutrition. Audiences were obsessed with Nasubi's journey and cheered him on from the sidelines, but Nasubi had no idea he was gaining any notoriety. In fact, he didn't know he was being broadcast at all. Nasubi became the most famous television personality in Japan without even knowing it.

Through exclusive interviews with Nasubi and people close to the show, The Contestant exposes so many cracks in its foundation. For starters, Nasubi never signed a contract. The show's producer, Toshio Tsuchiya, initially persuaded Nasubi to strip naked by claiming that most of what he did wouldn't be aired. This overt manipulation tactic lowered Nasubi's initial hesitation, therefore making it easier for Toshio to control Nasubi. When all was said and done, he spent 1 year and 3 months competing in A Life in Prizes.

Nowadays, it's not uncommon to look back on various forms of entertainment of the past and see how poorly it has aged with time. Britney Spears talks about it in her memoir, specifically how cruel the press and industry were to her as she was coming of age in the spotlight. Denpa Shonen: A Life in Prizes is another one of those moments in the cultural zeitgeist that would not exist if it were pitched today, based on the sheer torment and manipulation that Nasubi was put through. The Contestant reveals, in stunning detail, how Nasubi not only survived fame and famine, but everything in between. •




#### Buffalo Fluffalo by Bess Kalb Grumpy Monkey Spring Fever by Suzanne Lang


Author Bess Kalb is funny. She has been nominated for an Emmy for her work on Jimmy Kimmel Live. She has teamed up with illustrator Erin Kraan, who is a favorite of mine. When this book appeared in our collection, I had to review it.

The illustrations are bright and happy and contrast nicely against the cranky Buffalo who has had enuffalo. On this particularly cranky day, our fluffy character is approached by multiple wide-eyed animals who just want to be friends and have fun. Each time the Buffalo responds to them in a huffy manner and makes sure the animals understand there is no time for fun. While these short conversations are transpiring, the reader witnesses the illustrations becoming gloomier building up to a torrential downpour that drenches the Buffalo.

When the sun breaks through the storm clouds, the friendly animals find a surprise

waiting for them. Buffalo Fluffalo and the friendly creatures end the story on a sweet note with vibrant colors to match the mood of newfound friendship.

The second book, Grumpy Monkey Spring Fever by Suzane Lang, is perfect for this time of year. The illustrator for all the Grumpy Monkey books is Max Lang.

Our story starts with Jim Panzee (yes, that is Grumpy Monkey's name) feeling silly and just throwing himself, literally, into the day. When he is diagnosed by Norman, his next door neighbor, as possibly having Spring fever, Jim freaks out and goes from feeling silly to anxious in a nanosecond. All the animals give Jim a ton of advice and possibly helpful hints to calm down, but all this unsolicited advice only makes Jim very angry. Norman, the ever helpful and wise next-door neighbor, encourages Jim to embrace his Spring fever, enjoy it! The other animals chime in with Spring fever hints and end up catching the bug as well. The illustrations are fun, upbeat and colorful. There is also a bonus seek and find feature to this book.

Both books left me with a sense of friendship and embracing uniqueness. Just nice, light hearted, fun reads that hopefully will bring some sunshine into your day.

#### Secrets to Getting a Good Night's Rest

(BPT) - A survey conducted by One Poll on behalf of Herbalife examined sleep habits of 5,000 Americans, split evenly by state, to reveal who's getting the best sleep, how many hours per night they're sleeping, plus typical habits around this often-overlooked aspect of health and well-being.

Discoveries from the survey include the fact that respondents in California appear to get the best sleep, South Carolina coming in second and New York coming in third, with Maryland and New Jersey tied at fourth place. However, while experts recommend adults sleep for 7-9 hours per night, respondents in California report getting just over 6 1/2 hours of sleep per night.

Regardless of where they live, over half of respondents (55%) can't remember the last time they had a "perfect night" of sleep, and 78% can't recall when they last had a "perfect week" of sleep. While "perfect" sleep might be unattainable, less than half (48%) said yes when asked whether they know how to get a good night's sleep - and 66% of respondents admit that within two hours before bed, they watch TV or scroll through their phone for extended periods of time, which are not recommended as activities conducive to good sleep.

"Getting good quality sleep is essential for everyone," said John Heiss, Ph.D., and vice president of Global Product Innovation, Herbalife. "Sleep supports important functions including metabolism and brain health and can have an impact on conditions including heart disease, obesity and depression."

To help you sleep longer and more deeply, try incorporating these habits into your daily

Don't overeat near bedtime: Eating lighter, low-fat meals at dinner eases digestion, and healthy carbohydrates (think whole grains, fruits, vegetables and legumes) help stimulate production of brain chemicals that can help you relax and get to sleep. Experts also advise limiting food intake within three hours of bedtime.

Lessen caffeine and alcohol intake: Both caffeine and alcohol can disrupt your normal sleep patterns. You may be able to fall asleep, but it could be harder to stay asleep, preventing you from reaching the deepest and most restful stage of sleep.
