## I Choose to Be Here Full Time

On Friday, April 26th, I traveled to City Hall to interview Hawthorne's City Clerk Dayna Williams-Hunter. The sun was out, and the sky was very blue. I went inside. Dayna and I sat in a comfortable interior room. Over the next hour, I felt like the sun and blue sky also joined us. Let me try

Dayna ran for Hawthorne City Clerk and won the election in 2022. Although divorced from her husband - with whom she has wonderful adult kids (and grandkids) - they remained quite close. He passed away during the election cycle. Dayna had been going door-to-door in Hawthorne to introduce herself, to ask for people's support in her bid to become City Clerk. "When he died, I realized that I just have to keep going. Otherwise, it would be too sad..."

You may not be aware that the Hawthorne City Clerk position has been treated for years as essentially "ceremonial"; the Clerk attends the City Council meetings, oversees various official records, prepares and certifies minutes for the Council, and that's pretty much it, folks. After all, the pay has been \$800 a month for 20 years. It can be challenging to get by on that amount nowadays.

Well, be that as it may, Dayna works full-time Monday through Friday. She has an office at City Hall. I have included a photograph of her desk with this column. Do you get the impression she is quite busy? Dayna currently has one full-time and one part-time staff member. She might get a raise to \$1,200 a month, but it is not quite certain. Dayna makes less than the City Council

members, who also ran for and were elected to their positions.

So it goes. Oh, by the way, Dayne is an FAA 107 licensed drone pilot (she describes as "part of my techy side"). She also is the first African American elected City Clerk of Hawthorne. My impression is she is having a substantial impact on what the Hawthorne City Clerk does.

"I love this City where I live. I want to see Hawthorne be the best it possibly can be. I signed up for this, to be City Clerk. I did not plan to just pump my chest, that am the City Clerk. I choose to be here. I choose to work full-time. I am one piece of a bigger puzzle."

Dayna, aside from being dedicated, is clearly bright, tenacious, and capable. She has significant work experience. For example, she lived in Cleveland, Ohio, for some time. She went to college there and got a B.A. in Communications and a Master's in Education. She worked in sports management with no less than the Lebron James- Cleveland Cavaliers.

Dayna also has two businesses, which she tends to after her workday as City Clerk for Hawthorne. One enterprise is Concierge Nail Care, which you can find online. The other is social media assistance she provides to certain specific clients through D Will-Hunt Public Relations.

Concierge Nail Care came about in part because when Dayna was younger, out of high school, she earned money "doing nails." Her mother, who thankfully is still with us, owned a beauty salon. Dayne grew up in Los Angeles, and when she came back to this area, to Hawthorne in particular, a friend

reached out, they talked, and Concierge Nail Care has blossomed since. So, would you like some pampering at home? Or a nice gift for a friend?

It baffles me, though, that Dayna would put in the significant time and effort she does for all of \$800 a month. She told me: "It is never not busy. I get to the office on a typical day, and there are 20 to 30 emails. People request records, call for information, and need help with claims. A tree falls over and there are damages. There are requests for proposals involving construction. I wind up working with Von, our City Manager, as well as the Police Department and City Attorney, among others, and follow-up may be needed. I get in around nine or 9:30 and put in a full day. Then... I can tend to my

Pause. I notice she is smiling. She likes the choice she has made. As she said, "I choose to be here full time."




## The Caretaker by Ron Rash

This novel left me flabbergasted. As soon as I finished, I threw it down and sat there stunned. I picked it up to read the last chapter over again because I was so overwhelmed. However, it isn't just the last chapter. From the beginning this book grabs you by the throat and leaves you breathless. It may not be a real mystery where this story is headed, but the journey to the end is so taut with tension that one really can't adequately guess the ending.

This tale full of lies, deceit, and betrayal as well as love, friendship, and loyalty is set in the 1950's during the Korean War. Nestled in the rural town of Blowing Rock, North Carolina Jacob Hampton and Blackburn Gant grew up together. Jacob is the beloved only child, his parents having lost two daughters before he came along much later. His parents own the lumber mill and general store and are well re-

spected as leaders of the community. Blackburn is disfigured from having polio as a youth and at sixteen was left by his family to work as the caretaker of the local cemetery. Loneliness was their bond, and it cemented their friendship.

As young men, the two remain friends. When Jacob is conscripted into the service, he pleads with Blackburn to help his very young wife through her pregnancy during his absence. Jacob's parents have disowned him and the townsfolk have no respect for the poor farmers daughter who snatched up the town prince. Blackburn's loyalty to Jacob is sorely tested throughout the novel, but he remains steadfast in his own integrity.

With uncomplicated yet gripping prose, the author immerses the reader into the lives of his characters. Jacob's parents will stop at nothing to get their son back. All this is done in the name of love, as evil often is.

Ron Rash is the author of twenty books of fiction and poetry. Two of his books have been made into movies - Serena and The World Made Straight, and yet another is in development for a TV show. •

## The Last Stop in Yuma County Review: A Slow Burnin' Shoot 'Em Up

The Last Stop in Yuma County may be the final rest stop before passing into the next county, but it's also the end of the line for an unlucky bunch of diner guests who get trapped with trigger-happy bank robbers. This slow-burn neo-western crime thriller is a throwback to single-location standoffs where the fun comes from colorful characters, patiently building tension, fun jukebox needle drops, and not knowing what's going to happen next.

The movie opens on a silent desert highway, basking under the hot sun of an early morning, and awakened by the arrival of a traveling Knife Salesman (Jim Cummings) who pulls into a rest stop to fill up his car. Immediately, there is a problem, the Diner Waitress (Jocelin Donahue) points out. The rest stop is out of gas, and the gasoline truck that refuels the station is delayed. However, a larger problem presents itself when more shifty-eyed travelers arrive at the rest stop, and their car perfectly matches the description of the getaway vehicle used to hold up a bank hours earlier.

Just their luck-it's indeed the bank robbers (Richard Brake, Nichola Logan). The Knife Salesman grows increasingly uncomfortable after realizing this fact. As more travelers shuffle in and fill the diner, the slow-boiling setup reaches its climax. The bank robbers brandish their weapons and hold the powerless diner dwellers hostage. With all that stolen money in their car and ample opportunities to flee, what will happen next under this hot desert sun?

The Last Stop in Yuma County is a throwback film that evokes a more old-school western. Specifically, it feels inspired by Quentin Tarantino, whose standoff Shoot 'Em Up scenes feel particularly indebted to Pulp Fiction, Reservoir Dogs, or The Hateful Eight. There are also enough needledrop moments of old jukebox hits that feel particularly Tarnantino-esque. Written and

Would it be too much for me to encourage the City of Hawthorne to build a statue of Dayna and put it in a suitable place (maybe in front of City Hall)?



## How to Build, Maintain and Improve Your Credit

(BPT) - At first glance, building credit can seem like a challenge. How can you get the credit you need when you have little or negative credit history to start with? Don't get discouraged, though; there are many ways you can build, rebuild or improve your credit.

### **Best Ways to Build Credit**

• Apply for a secured credit card. A secured credit card works just like an unsecured card, but it's guaranteed upfront by a cash deposit.

Making on-time payments and keeping a low credit card balance helps your credit-building.

• Ask a family member to add you as an authorized user on their own credit card. You'll get your own card, but the primary card holder sets the limit on how much you can charge. It can be good for both of you: You'll learn how to manage a credit line, and the account holder can earn rewards on what you buy. Just keep in mind that if the main

cardholder misses or makes late payments, it could end up on your credit report.

• Manage loans soundly. A history of ontime payments shows you can responsibly manage your line of credit. Consider having a cosigner on a loan if you aren't able to qualify on your own.

## Maintaining Good Credit Habits

- Make payments on time, all the time. Pay credit card companies, utility bills and other accounts on time and always for at least the minimum payment. Consider using calendar reminders and tools like automatic payments and money transfers. Missed payments will lower your credit score quickly, but on-time payments show that you use credit carefully.
- Use different types of accounts. Your credit score improves when you responsibly use more than one type of credit account, including personal loans and installment loans, like a car loan. Be mindful of how many new credit accounts you apply for as too many hard inquiries into your credit file can negatively affect your credit score.
- Use your credit card regularly but keep your utilization low. Your credit utilization ratio is the percentage of your available credit that you actually use. Try not to use more than 30 percent of your available credit. For example, if you have a \$1,000 credit limit, try to keep

your balance under \$300.

• Keep current credit card accounts open. Unless you have a reason to close an account, consider keeping it open even if you don't use it. Keeping an unused account open increases available credit, improving your use ratio.

## Get Your Credit Back on Track

- Check your credit report for errors and know your credit score. Your credit score is a snapshot of your credit history and shows lenders how responsible you may be as a borrower. Your credit report outlines your credit activity, your credit history and the status of your accounts. It's important to check your credit report every year and dispute any errors. Also consider using a tool like Navy Federal Credit Union's credit score simulator to see how you can affect your score, for good or bad.
- Create a budget or use a budget worksheet comparing your income and expenses. The best way to live within your budget and avoid bad credit is to catch problems early. With a realistic budget and a close eye on your bank account, you can see where you need to change course to get back on track quickly.

The more you practice good credit habits, the more your credit history will improve - helping prepare you for the future financing you may need. Navy Federal Credit Union is federally insured by NCUA. •
