This is a Historic Person

Many people admire Maxine Waters. Some are less favorable. Is she a lightning rod? At almost 86 years of age, she would be described as thunder and lightning.

I talked with Maxine recently. She was warm, energetic, eloquent, and positive in her attitude. So, I am going to try here to simply provide a brief word portrait.

Maxine Moore Waters is the fifth of thirteen children born in St. Louis, Missouri. Dad left the family when she was two years of age; mom was the parent for all thirteen kids, with some help in time from a stepfather.

Maxine has a basic condo in Washington D.C., where she spends many weekdays, but typically comes home to Southern California to be with her family on weekends. She also comes here to attend many events in the District and Church services at various locations during the year. As you undoubtedly know, she has a full-time job. She is a proud member of the United States Congress. In fact, she has been a member of Congress for twenty-three years. Her District includes much of southern Los Angeles, portions of Gardena, Inglewood and Torrance. Before becoming a Congresswoman, she was a member of the California State Assembly for seven terms. Over that course of time as an elected official - if my math is correct, some forty-eight years - she has never lost an election. In fact, she garners 70% or more of the vote nowadays.

Let me say a couple of things again, just for a reality check: She is going to be 86. Her voice is strong, her will is fierce, and

she is articulate, energetic, and engaging.

"I have a very active life and fly into Southern California every weekend from D.C. unless, that is, I have to go to some other state for a particular reason. There is no magic, as far as I can tell. You either have a gene and last longer and live one hundred years, but it can help to take care of yourself and exercise. In either event, what drives me, the energy I have, is to see fairness, justice, and equality. This is what inspires me and energizes me. I want to try to ensure people have a decent quality of life."

Given what Maxine said, I did a bit of research. I learned there is a respected learning facility in South Central Los Angeles, which is part of the Los Angeles Unified School District, known as The Maxine Water Employment Preparation Center. Recently, some 200 persons graduated. Curricula include adult secondary and primary education and career and technical classes. The focus is career-driven (one example only, the nursing profession). There are financial aid options and help with job placement. Classes are available during the day and evening, and the campus offers an on-site daycare center.

I learned further that Ms. Waters is the first woman and first African American Chair of the House Financial Services Committee. She is today the ranking Democrat (with Republicans in the majority now in Congress). The Committee is significant, with jurisdiction over economic issues, the banking system, housing, insurance, and securities exchanges. In addition, the Committee has jurisdiction over monetary policy, international finance,

international monetary organization, and efforts to combat terrorist financing. She is also Co-Chair of the bipartisan Congressional Task Force on Alzheimer's Disease.

Thus, going back in time, I have tried to piece together at least some of the history. Maxine moved to Los Angeles in 1961 and worked in a garment factory and as a telephone operator before being hired in 1966 as an assistant teacher with the Head Start program in Watts. She was interested in becoming a social worker, enrolled in Los Angeles State College (now California State University, Los Angeles), and obtained a bachelor's degree in 1971. Reality check again: One of thirteen kids raised by a single mom.

"When I first ran for office, we were talking about gardens, and we went out and bought garden seeds. These were things we cook a lot in the community. We actually filled up envelopes. Our motto: A penny saved is a

Rebellious Irish Rap Comedy Kneecap Is Bold, Brash, And Unforgettable



There's a brash, in-your-face cockiness that the new dark comedy and music-packed film Kneecap carries itself with. The lawbreaking, drug-snorting antics from the Irish rap group at the center of the film—played by the real-life hip-hop trio "Kneecap" that the movie takes its name from-are downright anarchic.

Further, the film doesn't even care at times if you literally understand what's going on, as multiple rap numbers are delivered in their native Irish Gaelic language, requiring subtitles that the film sometimes, defiantly, does not provide. Despite this attitude, or perhaps because of it, *Kneecap* is a rebellious crowd-pleaser with a worthwhile message about preserving Indigenous identity.

The film fictionalizes the rise of the reallife Irish hip-hop group "Kneecap" in their proud hometown of Belfast. Naoise (Móglaí Bap) and Liam Óg (Mo Chara) are Northern Ireland hooligans who grow up selling club drugs and running from the cops. When Liam gets caught one night, a disillusioned music teacher, JJ (DJ Próvai), is tasked with translating Liam's Irish Gaelic into English. We learn that Liam's defiant use of his native Irish language was instilled in him by his father, a small-town crook now on the run (played by Michael Fassbender).

JJ realizes that Liam's commitment to his mother tongue, along with his original, cocky lyrics, aligns with his own values and inspires him to record the band. The trio-Liam, Naoise, and JJ, now known as

DJ Próvai-begin recording songs that defiantly speak out against the country's harsh laws, drawing unwanted attention and catapulting them into the spotlight.

Kneecap is anarchic, foul-mouthed, and ungovernable. And also, it's entertaining as hell. It's also more of a crowd-pleaser than I expected. Written by Rich Peppiatt along with Kneecap stars Móglaí Bap and Mo Chara, the film brings a unique story and style. Director Rich Peppiatt, in his first credited feature film after a Kneecap music video, injects electric energy and style, making for a visually captivating experience.

Director of Photography Ryan Kernaghan (Ted Lasso, Belfast) delivers sensational camerawork, with a full-on music-video approach, featuring hand-scribbled lyrics that bring the songs to life. Editors Chris Gill (American Animals) and Julian Ulrichs (Sing Street) create a kinetic, wild energy that the movie thrives on.

And of course, the music is massive fun. Electronic club beats underscore *Kneecap*'s in-your-face raps sensationally. Even if you can't understand the lyrics (or find it hard to read the onscreen translations), you don't necessarily need to, as emotion and energy are the most important.

Kneecap is a riotously fun movie that captures the spirit of rebellion and cultural pride. As Michael Fassbender's wise, countryloving character says to the Kneecap lads, "Every word of Irish spoken is a bullet fired for Irish freedom," a sentiment that resonates deeply throughout the film.



Worn Out or Worn Down? How to Tell the Difference Between Tiredness and Fatigue

(BPT) - Have you ever felt like no amount of coffee or rest can shake off your lingering exhaustion? Do you wake up from a full night's sleep and still find yourself dragging? If so, you might be dealing with more than just tiredness; you could be experiencing fatigue. Fatigue is not just a fleeting feeling of sleepiness - it's a deep-seated exhaustion that can impact your daily life and point to more serious health conditions. However, these feelings are often dismissed as simply needing more sleep or seen as a normal part of a busy lifestyle. According to recent research by MD Live, an Evernorth company and leading virtual care provider, many aren't aware of what fatigue is despite experiencing symptoms and 35% rarely think about the reasons behind their tiredness.

"While we often use words like 'tired' and 'exhausted' interchangeably, there are distinct and clinical differences between tiredness and fatigue," explains Dr. Maggie Williams, medical director for MD Live Primary Care. 1. Scrutinize Your Sleep

First, look at your sleep patterns. Tiredness generally improves with a good night's sleep or a short nap, whereas fatigue persists even after adequate rest. Try keeping a sleep diary

for a week, noting when you go to bed, when you wake up, and how you feel upon waking and throughout the day. If you consistently wake up feeling unrefreshed or have difficulty staying asleep, it might indicate something more serious.

2. Track Your Tiredness

Consider how long and how often you feel exhausted. Tiredness is typically temporary and linked to specific activities or lack of sleep, such as staying up late to finish a project or getting a poor night's sleep. Fatigue is long-lasting and occurs frequently, often without a clear cause. Ask yourself whether exhaustion is a constant presence in your life, lingering for weeks or months. If symptoms persist and you cannot pinpoint a specific reason, it's more likely to be fatigue.

3. Be on the Lookout for Other Symptoms

Fatigue often accompanies broader and more severe symptoms, such as muscle weakness, joint pain, headaches, and a lack of motivation. Mentally, fatigue can lead to prolonged mood swings, depression, anxiety, and severe cognitive impairment, making it difficult to concentrate or remember things.

4. Gauge the Impact on Daily Life

Reflect on how your tiredness affects your daily activities. Tiredness might cause a temporary decrease in productivity and social interactions. Fatigue has a significant and prolonged impact on your ability to perform daily tasks, work, and maintain social relationships. For example, you may See Seniors, page 4

penny earned... we promoted fresh food! We ran against a well-organized opposition and thankfully won."

Seeds? Well, she wanted to help people develop gardens. Now it is all these years later.

Not surprisingly, one of Maxine's priorities, as for so many, is addressing homelessness.

"We have to help build affordable housing so people can live the American dream, so everyone can have a decent quality of life and a safe place to live."

There is consistency in what drives her, what keeps her going and what keeps her thriving. The seeds analogy comes back to mind.

Bottom line, it is challenging, if not

impossible, to capsulize Maxine Waters and to paint a portrait of her in a relatively brief newspaper column. This is a historic person. I have tried to do this well because

Mushroom Maderia Casserole

Directions

- **Step 1:** Place the bread and olive oil into a food processor. Cover and process until the mixture resembles coarse crumbs.
- Step 2: Heat half the butter in a 12-inch skillet over medium-high heat. Add the mushrooms, shallots and garlic and cook for 5 minutes or until the mushrooms and shallot are tender, stirring occasionally.
- Step 3: Increase the heat to high. Stir in the wine and heat to a boil. Cook until the wine is reduced by half. Add the broth and green beans and heat to a boil. Cook for 10 minutes or until the beans are tender, stirring occasionally. Stir in the mascarpone and cook until melted
- **Step 4:** Stir the flour and remaining butter in a small bowl until smooth. Stir the flour mixture in the skillet. Spoon the bean mixture into a shallow 2 1/2-quart casserole. Sprinkle with the bread crumb mixture.
- **Step5:** Heat the broiler to low. Broil 4 inches from the heat for 4 minutes or until the bread crumb mixture is golden brown.
