She Loves Walking Down the Hallways

"One book, one pen, one child, and one teacher can change the world."

Grace Yang may not be a name you know, at least yet. I did not know of her, even though I live in the South Bay and try to write informative columns about people and places of significance in our community.

I first met Grace when she spoke at the Hawthorne Kiwanis Club (of which I am a member). She has been the Principal of Hawthorne High School, home of the Cougars, since the 2021-2022 year. The new school year is just about to begin. First, are you thinking what I'm thinking? She started as Principal of Hawthorne High right about when the Pandemic took root. Talk about a challenge!

A little bit about Grace's background: She is from Taiwan. She speaks English, Mandarin and Spanish. She has a notably "glass halffull" demeanor. Since she visited the Kiwanis Club, I have spent time talking with her, touring the campus, and exchanging emails. After utilizing my "great skill" of judging character, I can report the following: Grace is calm but very determined. She tends towards smiling, but is full of empathy.

Grace also is, in my mostly humble estimation, an outstanding asset for Hawthorne High School, the Centinela Valley School District, our community, and above all the students. "I love walking down the hallways. There is learning – happening right there. I go into the classrooms. Kids are asking questions, engaged with the activities at hand.

There is never a dull moment. Today, teachers are trained to have different learning activities to teach kids education technology. Our science lab is fully equipped. The students participate in such really

interesting tasks. We also have art rooms that, no pun intended, are state of the art! Kids are learning, having fun, and getting feedback from teachers.

You know about our Academies, right? Go into the engineering lab, and students work directly with remarkable machines, including 3-D printers. Young people are creating and making amazing projects in the wood craft program. It's just that I see the kids engaged. So, I love walking down the hallways."

The mission statement of Hawthorne High School is that it "will provide students with a safe and healthy learning environment, rigorous curriculum, and quality education to help students prepare for their future."

I asked Grace point blank - "What are your lofty goals?" She did not miss a beat. "It goes back to the mission statement. The simplest way to put it is that we want to do everything we can at Hawthorne High School to prepare our students for a successful college career and life."

Grace's parents are immigrants from Taiwan. Her mom was involved with physics and worked as a computer engineer. Her dad, already a dentist in Taiwan, nonetheless, had to go back to school here (at USC, no less) to obtain a license as a dentist in the good old USA. Perhaps part of the DNA that Grace inherited is explained by the tenacity of her mom and dad.

She graduated from UCLA with a Bachelor of Science in Applied Mathematics, a minor in Applied Linguistics (which includes teaching English), and obtained her Master's Degree in Education, all in five years. In time she would also earn her Teaching Credential.

Grace found her way to Leuzinger High School while still at UCLA. Starting with an internship, she became a math teacher. While

working at Leuzinger, she learned Spanish and often taught in that adopted language. She will teach AP Calculus, along with the basics. She had, and has, a real passion for math, but after six years, she also became the Coach of the Tennis team (the first tennis team they had in decades). At ten years, Grace became associate principal of Leuzinger High. "It was just such a blessing to stay at the very school I knew."

Fourteen years in, Grace was talking with the then-Superintendent of the Centinela Valley Union School District and learned of an opening at Hawthorne High. It was bittersweet because Graced remained so dedicated to Leuzinger, but she and her then-Principal moved over to Hawthorne as a team. "I was glad to be at least able to stay in the same District, but I will always have a very soft spot for Leuzinger!"

When her colleague moved to a new position as Principal at Hawthorne High, Grace was in line. I think it happened much quicker than she expected, but Grace Yang is ready for challenges.




Film Review

The Inspiring Story of a Pop Star-Turned-Politician is Documented in Bobi Wine: The People's President

If there's one documentary you seek out this year, make it this one. Equal parts inspiring, educational, entertaining, and emotionally activating, the story of Ugandan musician turned politician Bobi Wine is an incredible exposé of the hypocrisy of political elections and the hero who was willing to sacrifice his life to defend the oppressed. Documented over five years by filmmakers Christopher Sharp and Moses Bwayo, Bobi Wine: The People's President charts the fascinating trajectory of one man's selfless dedication to his people in true David vs Goliath fashion. Now playing in select theaters.

Bobi was born in the slums of Kampala, which shaped his identity as he grew into a young man. His awareness of the lack of equality within his country's political system struck a nerve with the budding social activist who, at that time, was expressing his frustration through music. With colorful vocals and infectious beats, Bobi's catchy tunes held a deeper meaning than just entertainment value, these songs were calls for freedom. Robert adopted the stage name Bobi Wine and then, a star was born. As his musical career turned him into a national superstar, Bobi remained a man of the people and returned to the slums often to encourage future generations to persevere through the tough times.

Bobi's dreams extended beyond the recording studio – his eyes were set on Parliament. He secured a seat within the government and quickly realized that behind the facade was corruption, illegal activity, and anti-republic intentions. Since 1986, Uganda had been under a ruthless regime led by power-hungry Yoweri Museveni, and the opposition wanted him gone. With a Presidential election upcoming, Museveni was determined to take another five-year term after he unethically changed the country's constitution to make him eligible to run again. As a result, Bobi decides to gear up for the biggest battle of his life and run against the most powerful man in Uganda.

Bobi's campaign journey is documented in harrowing detail throughout the film's 2-hour runtime. Caravanning from town to town in an effort to connect with the voiceless people in remote Ugandan towns, Bobi and his team of supporters continuously risk persecution, intimidation, and even death from Museveni's military. Told through intimate conversations with filmmakers Christopher Sharp and Moses Bwayo, Bobi gives audiences a glimpse into his secret life at home with his wife, Barbie, and their three children, revealing the sacrifices he makes to keep them safe.

The music that drives the film is a compilation of Bobi's own recordings. Similar to the way Rodriguez came into the musical zeitgeist after the debut of the documentary Searching for Sugar Man – which also happened to also be produced by Bobi Wine's John Battsek -Bobi's music has the potential to find its way to a mainstream audience. Inspiring activism through music, Bobi sings about denouncing the dictatorial regime and fighting for freedom. It's a universally resonating message that you'll be eager to sing along to.

The target on Bobi Wine's head is never out of sight, even today, and the very act of making this documentary is already an act of defiance. If there's one takeaway from the film, it's that nobody can stop Bobi Wine from carrying on. Getting his message out into the Western world would be a huge victory for all the Ugandan people who feel oppressed at the hands of their own government. We owe it to Bobi, the filmmakers, and our fellow world citizens to listen to their stories and then act in a way that allows for liberty and freedom to prevail. •


Check It Out

The Wishing Game by Meg Shaffer

I was sad to come to the end of Meg Shaffer's The Wishing Game. The book was full of smart and witty conversation between the very realistically drawn characters mixed with touching (no, I'm not crying!) scenes that would melt anyone's heart.

Lucy Hart is a teacher's aide for a kindergarten class in Northern California. She lives in a rented house with roommates, shops at local thrift stores and uses public transportation. And she knits scarves she sells on

Etsy. She's saving every cent to accomplish her heart's desire: Being able to be selfsupporting so she can adopt Christopher, a seven-year-old orphan in foster care. Lucy bonded with Christopher by sharing her love for a beloved series of "Clock Island" books by the mysterious Jack Masterson.

Just when obstacles look impossible to overcome, Lucy receives an invitation to compete in a contest orchestrated by the author himself! There is actually a Clock Island in New England and the winner of the contest receives the new manuscript from the Clock Island series.

This story truly is as adventurous as those books from our childhoods starring Nancy

Drew, the Hardy Boys and Encyclopedia Brown, but told in a unique adult voice. What happened in Lucy's childhood to estrange her from her family? What shadowy figure from her past may come back to haunt her? And most importantly, why was Lucy selected out of the blue? Or maybe Lucy knows exactly why she was selected. These questions are answered in tantalizing segments played out over time. Characters are so human it seems they will jump off the page and interact with the reader. Revealing too much of the intricate plot(s) may spoil the fun!

As I was reading, I often thought how successful Ms. Shaffer was in building a fantastical world that would have relevance to adults. She explained in an interview with the Los Angeles Public Library:

"My life changed when I read A Wrinkle in Time [by] Madeleine L' Engle in the 5th grade. Something about that book captured my imagination like no other book had before ... That book combined everything I was fascinated with into one beautiful story—magic and fantasy, science, religion, philosophy, romance, hope..." (I would definitely agree, since that book is also high on my list.) In another article in Writer's Digest, she answers a question about what she hopes readers will get out of her book: "Just some happiness. Maybe a lot of happiness. A little optimism. A slice of old-fashioned nostalgia for the books you read as a kid and still love as an

Maximize Your Road Trip Experience With Proper Auto Maintenance

(BPT) - As summer approaches, many people are planning road trips to take that long-awaited vacation or visit friends and family. Before you take to the open road, however, it's important to make sure your vehicle is in top condition. Proper vehicle maintenance is important for the safety of you and your passengers as well as others. It also prevents unexpected breakdowns, which can ruin your trip.

"Before heading out, make sure your vehicle is in good working order and have any necessary maintenance completed," said Kevin Quinn, Vice President of Auto Claims at Mercury Insurance. "Create a checklist of maintenance tasks and have them taken care of to ensure that your vehicle is road-ready. Remember to review your auto coverage as well and be sure to have the right amount of protection in case of an accident or unexpected event."

Maintenance requirements vary depending on the age of your car, mileage and how it's been driven; however, it's still important to conduct the following checks no matter the age of the vehicle you drive. "The average age of a vehicle on the road today has increased to more than 12 years old, making maintenance a must," said Quinn.

Fluids: To keep your vehicle in top condition, have your oil, coolant, brake, transmission fluid and other fluids checked on a regular basis to make sure that they are at the recommended levels and not contaminated. Follow your vehicle owner's manual for recommendations on how frequently these fluids need to be changed.

Tires: Maintaining proper tire pressure is an essential part of car care. Worn-out tires can lead to poor handling and reduced fuel efficiency, as well as blowouts. Refer to the sticker that indicates your tires' recommended

tire pressure for your specific vehicle. If you see significant signs of wear, replace your tires as soon as possible.

Belts and hoses: Have your car's belts and hoses checked for any signs of wear, cracks or leaks. Older vehicles may require more frequent maintenance and replacement of these components since rubber weakens with age and repeated exposure to heat.

Brakes: It's always important to know that your brakes are in good working condition before getting behind the wheel but even more so before embarking on a long drive. Brakes that aren't operating properly could cause longer stopping, reduced braking power and brake failure which can lead to accidents and injuries. Have your brakes inspected thoroughly to make certain you can safely stop your vehicle during your journey.

Battery: Check your battery to make sure it's in proper working order. A battery that is slow to start or has difficulty holding a charge can quickly become a dead battery, leaving you stranded on the side of the road, requiring a tow and becoming a costly inconvenience.

Filters: The air cabin filter of your car is responsible for filtering out pollutants such as dust, pollen and exhaust. It is important to keep the filter of your car's heating and cooling system clean because a dirty filter reduces the effectiveness of the HVAC system, forcing the vehicle's heating and cooling system to work harder than necessary, leading to increased fuel consumption and potentially costly repairs.

Roadside emergency kit: No matter how ready your vehicle may be for the long journey, it's best to be prepared for any type of road emergency, and having a roadside emergency kit can prove invaluable in helping
