## Trash Talking, Technology, and the Beach Boys

It was "debate night" in America, September 10, but the Hawthorne City Council meeting went forward and went well. Pastor Greg Guich of Hawthorne's Centinela Bible Church gave a warm and thoughtful invocation. He expressed gratitude for the City, for the sunshine, and for the beach. He asked the good Lord to guide our officials and City personnel in determining what is best for our community.

David Kincaid came forward and made a spirited presentation about, did you say "waste"? Mr. Kincaid was there on behalf of Republic Services, a leader in trash pickup (and recycling) for Hawthorne. He noted there has been a change at the top, provided the name of the new "go to" person (I think it is Miguel), and, when several employees were off work for family leave, Republic opened 18 full and 16 temporary positions. Republic wants to get the job done, and for customers to be happy. Republic offers, among other services, commercial and residential pick-up, bulk collection, battery recycling, temporary container rental, and online bill pay. The phone number is 1-800 299-4898. Some trucks now coming forward are electric, quite impressive, and part of the effort to promote sustainability.

From trash to technology, the following presentation was by the Internal Support Department (ISD). These intrepid folks are "behind the scenes", and quite important. ISD seeks to support internet connectivity, email, hardware, printing, software hosting

and users. Its equipment includes 80 servers, 800 desktops/laptops, 95 printers, 480 desk phones, 420 camera equipment, 200 network devices, 15 microwave links, and 140 wifi access points. Cybersecurity remains one of ISD's priorities, and not surprisingly can be challenging.

The public communications portion of this City Council meeting included a representative of the Lions Club who shared the good news about the Club's vision screening last month. Then Richard Huhn came forward. If you do not know this fine person, he is one of the stalwarts of Hawthorne, a member of the Hawthorne Hall of Fame, who has

been involved in community service since 1960 (yes, for 64 years and going strong), including with the Parks and Rec Commission. Richard has been instrumental in the maintenance of the Beach Boys Memorial. All the bricks have now been sold! This wonderful landmark dates back to 2004. The effort to sell bricks began in 2005. Twentyeight remaining blank bricks are going to be covered this upcoming week. The Memorial to the Beach Boys draws visitors from all over and is indeed one of Hawthorne's treasures.

The discussion then focused on the fees of the Hawthorne Planning Department.

## Check It Out


#### Lilith by Eric Rickstad

This is not an easy read, but it should be read by everyone. The first four pages are filled with foreboding. The reader is immediately invested in the story. We know something terrible is coming. And of course, it does. An elementary school shooting.

When teacher Elizabeth Ross realizes what is happening, she foregoes protocol and tells her students to run, run as fast as they can, out of the classroom, out of the school. She should be with them, but she can't leave her son in another classroom facing certain death. It is horrifying to read this from a first-person viewpoint. It is horrifying to read it at all, but school shootings are now so commonplace that we must. Eric Rickstad captures the fear, the dread, the anger, and anguish pumping through Elizabeth Ross as she searches for her son. This is how the novel begins.

Stuck in the hospital, Elizabeth and her son

Lyden recover from the injuries they have suffered. Elizabeth stays at Lyden's bedside, sleeping in a chair. As she wakes one morning, she listens to one of the country's largest gun suppliers announce his bid for president in the wake of the shooting to protect the second amendment rights of all citizens to bear arms whenever and wherever they wish. Gleefully, he suggests that it may all have been a hoax, an excuse to increase gun control. Next, she is frantically called into a meeting with the school superintendent and principal and her union representative to discuss disciplinary action for her breach of procedure, despite being hailed as a hero for having saved those children. Elizabeth seethes with anger at the men in power. If they won't do something, she will. Thus, Lilith is born.

This is a gut-wrenching novel. Every page is filled with mounting tension, an exercise in perseverance. I reiterate this is not an easy read, but this thriller is a masterpiece in addictive prose. One simply cannot turn away. Gripping in its reflection of the real world tragedy of gun violence, it stays with the reader long after it has been read. Retaliatory justice is morally ambiguous at best, but the concept of an "eye for an eye" is provocatively seductive here. •

## <u>Film Review</u>

#### Seeking Mavis Beacon: On Being Lost & Found in the Digital Age

If you were born in the early 80s, there's a good chance you're familiar with the name Mavis Beacon. Her beautiful smile graced the cover of "Mavis Beacon Teaches Typing", a software game used to assist middle schoolaged children in becoming fluent in computer literacy. Many remember her as an icon and a symbol of excellence, with Oprah, Obama, and Wendy Williams singing her praises. But the shocking truth we come to learn in the hybrid documentary, Seeking Mavis Beacon, is that this legendary figure never actually existed. Now playing in select Los Angeles theaters.

Avid Mavis Beacon fangirl and filmmaker Jazmin Jones enlists her friend, Olivia Ross, a cyber security wunderkind and self-described "cyber doula", to investigate the disappearance of the woman they affectionately call the "The Aunt Jemima of Technology". Working out of a shared warehouse space in West Oakland, the young women embark on a years-long investigation to locate the most recognizable woman in technology, who had been out of the public eye for 26 years. After thorough "e-detective" work, they are stunned to discover that their beloved hero is a result of collective misremembering, better known as the Mandela Effect.

Upon further discovery, they confirm that Mavis Beacon was never a real person. Three middle-aged white men created the character, and

the woman behind the facade is a Caribbeanborn former high fashion model named Renee L'esperance. This bombshell throws Jazmin and Olivia for a loop, and they quickly pivot their search toward Renee. Who was she? Where is she now? And most importantly, does she want to be found?

Seeking Mavis Beacon starts as an engaging investigative documentary but slowly morphs into a cultural examination of ethical journalism, digital privacy, and the right to have one's story told on one's own terms. Renee L'esperance never makes an appearance in the documentary, which is a disappointing conclusion for audiences and I'm sure even more so for the filmmaker. However, her unwillingness to participate in the film and protect her privacy serves as a fitting reminder that you can't always control the narrative.

Another perspective that Seeking Mavis Beacon takes is the cultural impact Mavis Beacon continues to have in the tech world today. Her creation predates Apple's Siri and Amazon's Alexa, leading us to question why all tech caregivers seem to be female. Further still, the film questions why Mavis was written as a Black woman. Was it an effort to address cultural inclusion, or was it the result of the coded gaze? It's an important observation, especially given the fact that most coders and programmers continue to be white men.

It's obvious that Seeking Mavis Beacon is a passion project through and through. While it doesn't have the most satisfying "Hollywood" ending, Seeking Mavis Beacon is a fascinating journey and conversation starter about privacy in the digital age. •

#### **City Council**

Gregg McClain, the Department's Director, indicated that most fees have decreased; they have shifted a lot of the application processing to less expensive staff. Some fees have increased, but the bottom line is that there is an effort to keep fees reasonable (and lower if possible) to benefit construction. Mayor Vargas expressed hope that the economy will also improve, so materials and costs-to-build will be reduced.

The Council then addressed the Consolidated Annual Performance and Evaluation

Report related to the Community Development Block Grant and Home Investment Partnerships (you got all that?). Bottom line, how have things gone since 2020, and what projects have been funded? Council member Reyes English (ever vigilant) inquired about the number of applications, how much money has been spent to assist with housing, and who has been helped.

Council member Patterson led inquiry into the laws related to placement of campaign signs and banners, and appointment procedures for commissions.

City Attorney Robert Kim, who is very steady and articulate, explained that campaign signs and banners do not require permits and that commission members serve for a finite period of time (four years) but may stay on until replaced.

As the meeting went into its final stages, we heard about the recent successful and fun Car Show at City Hall, as well as the "tear in the eye", groundbreaking at Jim Thorpe Park (that very day, September 10)

Then crane your neck back down upon the blank sheet of paper in front of you and have a go at the NASA Space Place Art Challenge. We're beseeching all burgeoning citizen scientists to flex that imagination and those creative medulla muscles together.

Let's click the latch on that imaginary vacuum-sealed space helmet and feel yourself transported to the inky-black aether above. For a mere five-hundred million miles away from our Earth is a world crawling with our curiosity. A world completely undulating with an outsized ocean and topped by a frigid icy crust like some kind of Arctic crème brulée. This mysterious ocean planet is Europa and is just one of Jupiter's many fascinating moons.



Europa entices and compels scientists to further study its enigmatic topographical properties as historically, since the beginning of time, wherever we find water there's a high likelihood that early signs of life aren't too far behind. The question that propels NASA's upcoming Europa Clipper mission? Might ocean-coated Europa have just the right pelagic conditions and inimitable ingredients to sustain life forms? 

#### **Cauliflower Gratin**

#### Fitness Guru Finds Cancer through New Screening Test

(BPT) - Gym owner and avid fitness enthusiast, Rich, has always prioritized his health. He prides himself on being health conscious, taking steps to maintain his health and keeping up with his annual exams. 
