Hawthorne Council Objects to Possible Housing Unit Mandates

As it moves towards updating its housing element, the City of Hawthorne could find itself in a bit of a jam in the future. A presentation from Interim Planning Director Sherri Repp-Loadsman at the most recent City Council meeting outlined the potentially huge number of additional local housing units the State of California may require in Hawthorne down the line. "Scary times might be coming forward," she warned.

The Southern California Council of Governments (SCAG) is in the process of developing the 6th cycle Regional Housing Needs Assessment (RHNA) covering the period of October 2021 through October 2029, with adoption of the plan scheduled for October 2020. The RHNA, according to SCAG, "quantifies the need for housing within each jurisdiction during specified planning periods."

SCAG's initial overall regional estimate for the 6th cycle was 675,000 housing units, but the California Departing of Housing and Community Development (HCD) blew that out of the water when it announced its target of the substantially higher 1,344,740. "Everyone is still in shock," Repp-Loadsman

said, adding that if SCAG mandates this number, "you're going to ruin many cities" that simply don't have the capacity to add this many units.

Under the HCD methodology formula, Hawthorne's share of the 6th cycle RHNA has three potential options with 5,509, 7,251 and 1,422 housing units respectively. Repp-Loadsman thought it likely the third and lowest option would be rejected. The methodology includes considerations for share of population, share of population within high-quality transit areas, share of regional undersupply of building permits issued, and local input/ future vacancy/replacement need. Hawthorne's proposed allocations are mostly in line with those of other neighboring cities, with the exception of Manhattan Beach's (which Repp-Loadsman referred to as the "outlier" of the group) markedly lower numbers.

For the 5th cycle still in progress, Hawthorne's mandate was 683 housing units These break down into very low, low, moderate and above moderate income brackets. Hawthorne has already exceeded its total quota, with 821 units provided. But while it has more than satisfied its goals for the final three categories, it lags markedly in the area of

"very low" – with only nine units out of the 170 target. Repp-Loadsman pointed out that there is "not a lot of vacant space" available in town for very low income residential. The majority of the total units consist of new construction, but also includes some repurposing/renovation in the mix.

Repp-Loadsman expressed concern that if Hawthorne challenges the RHNA, it may not be successful...and that challenges by other cities may result in increases to Hawthorne's numbers since subtracting from one city inevitably adds to another. The Council ultimately voted unanimously to reject the HCD numbers -- and in a second action, directed staff to send a letter to SCAG recommending that the latter appeal the HCD methodology. Repp-Loadsman indicated that SCAG is indeed expected to file an objection. Meanwhile, the City must have its new housing element update in place by October 2021 or face potentially heavy fines.

During the oral communications portion of the meeting, local Ramona Tract resident Lucy Ravitch asked the Council to consider an ordinance change that will allow shortterm rental operations in Hawthorne - at

Film Review

Monos Mixes the Beautiful With Barbarism

In only his third feature film to date, budding independent filmmaker Alejandro Landes has proven himself a talent for creating uniquely realized visions to the big screen, filled with a dazzling display of mesmerizing visuals that bring an arresting and honestly observed look at humanity to life. His latest film, Monos, now playing at ArcLight Hollywood and the Landmark, depicts a group of young guerrilla soldiers as they fracture and spiral into chaotic barbarism, evoking the thrills of Lord of the Led by powerhouse performances from the film's younger cast, including a combination of both amateur as well as professional actors (Moises Arias and Nicholson), the ensemble's on-screen chemistry is as authentic and disturbingly beautiful as the world in which they live. Bringing this all to life is cinematographer Jasper Wolf, whose stunning camerawork gives Monos a surreal, fairytale-like aura.

Otherworldly visuals aside, the score and its Oscar-nominated composer are what initially attracted me to this movie. Mica Levi, whose

Flies but pushing new cinematic boundaries. Set high atop remote Latin American hills (filled with incredibly photographed sequences), unsupervised Colombian rebel fighters belonging to a terror group known as "The Organization" pass the time the only way they know how to: horsing around, making out with each other and recklessly firing their machine guns (blame this on their immaturity as well as isolation). The young band's sole purpose is to keep watch over their American hostage, Doctora (Julianne Nicholson), who their higher-ups harbor as a bargaining chip in their favor. The "Monos," as they call themselves, receive periodic check-ins from a senior rebel leader, but for the most part are left alone to fend for and govern themselves. When an unexpected ambush forces the Monos and Doctora down from their hideout in the sky and into the jungle, their desperation ramps up, as childish recklessness quickly turns into primal, physical and psychological warfare.

It's a slow burn of a film that raises more questions than answers (especially in the first act), but that doesn't mean there is a shortage of emotional strings that won't pull the viewer into this beautifully captured world.

genius can be heard in films Jackie and Under the Skin, creates a sort of sound bathmeets-trance composition as opposed to a traditional orchestral score, making for a haunting, erratic and pitch-perfect experience. While devoid of a more traditional narrative context, instead opting for an organically captured and impressionistically felt story, the payoff in *Monos* comes tenfold for those who are willing to give themselves over to Landes and his uncompromising vision. •

Wiseburn Board Hears a STEM Update, Approves Promotions

Last Thursday evening, the members of the Wiseburn School Board witnessed a presentation from R.H. Dana Middle School tech guru Andy de Seriere regarding the strides made with the STEM program. They also awarded a promotion to long-time Wiseburn Unified School District employee Wendy Tsubaki.

De Seriere started his presentation noting "that we are at the epicenter of [technological] innovation" and mentioning the District's proximity to Northrop Grumman and SpaceX. "Crazy innovators,' he called them, "but they are getting things done. It is essential that we provide opportunities for our students to work with engineers so that the kids can see that pathway and go right into those jobs... It is an exciting time to live and work in the Wiseburn [Unified] School District."

Student presenters Maya Walker and Winston Bird shared their thoughts about their participation in a recent tech event, dubbed Future U, that was sponsored and hosted by Boeing, Millennium Space Systems and Discovery Education. Sixteen Wiseburn students took part in the Sept. 6 event, which was part of an effort to inspire and develop the next generation of Science, Technology, Engineering and Mathematics (STEM) professionals in aerospace. The presenters spoke of how they were able to learn from and interface with engineers as well as other professionals.

"We are excited about where our STEM education is going," Superintendent Dr. Blake Silvers said. "Andy has been a treasure to the District, making kids excited about STEM, about problem-solving. Andy is doing what he loves to do and bringing out the love of it in kids."

Board President JoAnne Kaneda, long-time Boeing employee, helped facilitate the District's participation in the Future U event. She said she was "blessed to work with a great company" and pointed out how Millennium and Boeing

O. To ensure that the general fund reserve balance (exclusive of any amounts reserved for capital projects) does not fall below three months of average operating expenditures. This floor amount shall be calculated by dividing the budgeted total operating expenditures for the current fiscal year by 4. If, for any reason, the general fund reserve balance falls below this floor (or the general fund reserve balance, if below this floor, has a further reduction in balance), the City Manager shall immediately notify the City Council of this fact by placing a discussion of the general fund reserve bal-ance on the agenda for the next City Council meeting and by producing, and distributing to each council member, a report on the reason for the reduced reserve balance and a plan. The City Manager shall produce a new report to the City Council regarding the general fund reserve balance at least once a month until the reserve balance has been restored. Each such report shall be agendized as a discussion item at a meeting of the City Council unless the City Council adopts a resolution that (i) sets a goal for the schedule on which the reserve fund will be replenished and (ii) explicitly suspends this agendization and discussion requirement until a specific date. If, following the adoption of such a resolution (i) the reserve balance does not meet a goal set in the resolution or (ii) the reserve balance further decreases, the City Manager shall immediately report such fact to the City Council and shall no longer be excused, by virtue of the resolution, from agendizing a discussion of each report produced pursuant to this subdivision.

SECTION3. If any provision, clause, sentence or paragraph of this Ordinance or the application thereof to any person or circumstance shall be other provisions of this Ordinance which can be given effect without the invalid provisions or application, and to this end the provision of this Ordinance are declared to be severable. SECTION 4. The City Clerk shall certify to the passage and adoption of this Ordinance and shall cause the same to be published once in an adjudicated newspaper in the City

have gone out of their way to mentor students. "The engineers were really impressed with the students," Kaneda said, adding that the event provided "a lot of learning and a lot of fun." Board Vice President/Clerk Roger Banuelos thanked de Seriere for his work and commended the students for "capitalizing on the opportunities made available to them.

Peter Burnett Elementary Principal Hugo Rios then spoke briefly, mentioning a recent professional development workshop opportunity for Wiseburn's elementary principals that focused on enhancing collaborative strategies that teachers can implement daily.

Action and consent items passed during the 55-minute meeting included funding for three school crossing guards, which Silvers said "is a great investment in the safety of our kids." He mentioned the contentious situations that can arise on District streets at school drop-off and pick-up times.

Also, acting co-administrators Maria Garcia and Ted Okasinski were approved at Dana Middle School to fill the void in the absence of Principal Kiana Clark, who is out on maternity leave.

Meanwhile, Tsubaki had her promotion to Senior Executive Assistant to the Superintendent ratified. "A long, long overdue promotion," Silvers said. "Wendy is a great employee who understands the Wiseburn community and is able to facilitate teamwork and implement the District's vision and articulate that. She has a unique skill set. Silvers also touted Tsubaki's "patience, hard work, perseverance and dedication."

The Board additionally approved Annie Aung to take over as Coordinator of Facilities and Educational Services. Aung was a main cog in the construction of Wiseburn High School and will continue oversight of the building on Douglas Street, as well as help in the Superintendent's office with instructional support.

During his comments, Silvers reported a "good liftoff to the school year," citing the positive comments he received on the kick-off motivational talk that renowned speaker Dr. Luis Cruz made prior to the first day of classroom instruction. Cruz spoke about the need to educate all students, and how collaboration and professional development among educators are cornerstones of success. Silvers reported that the District's opening day barbecue was also a success, and he congratulated all involved in the school-site back-to-school nights, lauding the "passion" of the teachers and calling Wiseburn "a community that supports each other."

In her remarks, Kaneda reiterated that she was "delighted to be able, through my employer, to collaborate with the District" and touted her Boeing co-workers who were, she said, already looking for future opportunities to mentor students. Kaneda also mentioned that the District is on firm financial footing. "Yes, we are in the business of education," she said, "but we have to be fiscally responsible, with budgets to meet, to offer the best education that we can." She added that the Board has had "hard decisions that we had to make, but everything turned out okay."

Board members welcomed all to another school year and praised Cruz's presentation. Banuelos spoke about the opportunity to make classroom visits and noted how this the first time in 10 years he has not had a child attending Peter Burnett. Member Dr. Neil Goldman thanked the teachers and administrators for making the back-to-school nights successful, saying it has been a "good start to the year."

The next Wiseburn School Board meeting is on the docket for Thursday, Sept. 26. •

least under certain conditions. A local triplex owner, she explained that she began renting her one-bedroom, one-bathroom apartment as a vacation property in 2014, has paid an annual business license, and remitted a 12 percent transient occupancy tax (TOT) totaling about \$18,000 to the City over that period. But she recently heard from the Planning Department that she will not be allowed to renew her business license because she was told short-term rentals are prohibited by Hawthorne's municipal code. In her research, she learned the code states that accessory dwelling units cannot be used as short-term rentals. Planning further elaborated that dwelling doesn't include the transient public.

Ravitch now has only until the end of the year to operate and asked the Council allow the handful of responsible short-term rental business owners to continue as long as they pay their TOT and business licenses. She suggested that to avoid the potential problems short-term rentals elsewhere can pose, that the ordinance could require the owner to be on the premises.

Realtor Amie Shepard supported Ravitch, noting that Hawthorne does not have the airbnb issues of other area beach cities and that this model provides travelers a "creative way" to get a "feel of the environment" and what the local neighborhoods look like. Later during his report, Councilmember Mike Talleda expressed his support for Ravitch. "If we were going to approve airbnbs – and we should – it should be the model you [Ravitch] represent," he said, adding that she is "serious, on the premises and has a track record." Councilmember Alex Monteiro then confirmed that he wants to look into a short-term rental ordinance.

The meeting reports also included an an-

nouncement from City Clerk Dr. Paul Jimenez of mock elections at the Ainsworth Center on Sept. 28/29 to test out the new voting cycle and format before the next election in 2020. He invited neighborhood associations to contact his department if interested in 45-minute Q & As. Jimenez as well as several of the Council members praised last month's successful and very well-attended (500-600 people) North Hawthorne Community Picnic.

Mayor Pro Tem Olivia Valentine singled out the Hawthorne Arts Complex where artists recently opened their studios to the public to showcase live/work space. She described it as "one of those events that puts Hawthorne on the map."

Monteiro spoke of various upcoming events, including a free vision screening at the Hawthorne Senior Center on Sept. 21, the Oct. 17 Holiday Assistance Program at the Hawthorne Memorial Center, and Oct. 26 Health Fair & 5K at Hawthorne High. He also mentioned his role as a delegate on the South Bay Cities Council of Governments Homeless Services Task Force. Speaking of Hawthorne's inroads made in the area of homelessness, Mayor Alex Vargas suggested, "We should invite [Los Angeles Mayor Eric] Garcetti to see what we're doing" and how the task force is complete with police resources and psychological personnel.

Earlier in the meeting during a special presentation that included a video recap, both Vargas and Valentine lauded the success of last month's National Night Out and how the event brought all of Hawthorne's different communities together in seamless and united fashion. More than 200 residents attended the Hawthorne Police Department-hosted festivities. •

Summary of Ordinance 2190 Amending Chapter 2.17.070 (Purpose & Duties of Youth Commission) to the Hawthorne Municipal Code.

Pursuant to Government Code section 36933(c). the following constitutes a summary of Ordinance No. 2190 which will be considered for adoption by the City Council at its regular meeting on September 24, 2019 at 6:00 p.m. Pursuant to California Government Code section 36933(c) (1), the City Council has directed the City Attorney to prepare and publish a summary of Ordinance Nos. 2189 which seeks to update the duties and responsibilities of the Youth Commission.

The purpose of the Youth Commission was to coordinate and direct the resources of the city to abate to the extent possible graffiti and gangs. Ordinance 2190 is an amendment to the Hawthome Municipal Code (HMC) which updates the purpose of the Youth Commission to coordinate and direct the resources of the city in conjunction with the 4 pillars: 1) education;

2) community service; 3) civic engagement;

and 4) leadership. The City Council finds and determines that there is no possibility that the adoption of this Ordinance will have a significant effect on the environment.
