Our kids loved the television series Thomas the Tank Engine. They watched the stories narrated by Ringo Starr, and eventually, we bought several of the toys. Their favorite train car was named Toby. So, when we decided to bring home a dog, from an animal shelter, the name had already been selected: Toby.

After visiting several places, we found a young, appealing, and sweet boy. It was very hard to visit shelters and leave empty-handed. We wrote his name, Toby, on the adoption application. The nice woman at the counter asked me, "Oh, sir, did we give you his name?" I said, "No, that's what our sons have wanted to call him..." She looked at me, quite surprised and perplexed, "Well, that sure is interesting. That is his name! Toby is what we have called him since he got here over a month ago..." The rest is history. Toby was with us for many years and, like so many dogs, became an endearing (everlasting) part of the family.

That said, bringing a pet into your household is a significant decision. One choice is to rescue an animal from a shelter. Statistics are staggering about just how many dogs (not to mention cats, rabbits, and other animals) are available for adoption.

Here, then, are just a few of the places you may consider, visit personally, or check out online, if you decide to be a rescuer to seek to create a "forever home":

The SpcaLA South Bay Adoption Center, on Yukon in Hawthorne; phone 310) 676 1149. There are many choices which you can view online. Incidentally, this newspaper frequently

includes photos of available pets there.

The Carson/Gardena Animal Care Center is on Victoria in Gardena; the phone number is (310) 523 9566. The website provides helpful details, and the price is reasonable.

Harbor Animal Care on North Gaffey in San Pedro; phone (888) 452 7381. You can send a note online about the kind of dog you are looking for.

Pet Orphans of Southern California, on Gloria Avenue in Van Nuys; phone (818) 901 0190, in business for fifty years.

In addition, breeds of dogs have rescue organizations as well, such as:

California Doodle Rescue, https://www. californiadoodlerescue.org/, as with a number of these organizations, you can foster a dog.

If you do not adopt, you can make helpful donations to an animal shelter. Volunteers are welcome as well. This is a nice way to give back, and give of yourself, which can make a genuine difference.

But: Why adopt a dog? The truth is, you do not know its history. The dog did not start with you as a pup. And, there is cost, See Rescuer, page 4


#### The Substance: Vanity Fares Poorly in this Multi-Sensory Stunner

Youth is a hot commodity in Hollywood. Once you lose it, you can never get it back. Everyone ages, of course, but if you're a fading A-List celebrity, one forehead wrinkle can be the difference between bankable and broke. In the new body horror film, The Substance, French filmmaker Coralie Fargeat explores the toxic repercussions of ageism and body image. Bordering on fetishism when it comes to the film industry's obsession with beauty, Fargeat's film takes a stand against this demoralizing, anti-feminist treatment of women's bodies. In the ultimate power move, The Substance is a graphic and gory cinematic rallying cry that aims to upend the effects of toxic beauty culture. In theaters nationwide on Friday, September 20th.

Demi Moore plays Elizabeth Sparkle, a Jane Fonda-type who has made a career for herself as an actor-turned-fitness personality. Despite having a star on the Hollywood Walk of Fame and her own aerobic morning show, Elizabeth knows her time in the spotlight is running out. She sees her life begin to play out in the past tense, picking up on the notso-subtle cues from her boss, Harvey (Dennis Quaid), with phrases like "you were great". Despite her legendary status in the industry, she can't avoid the inevitable. She will be aged out of Hollywood. If becoming old makes one invisible, regaining youth is the only way to feel desired. Luckily, there's a drug for that.

A chance encounter leads Elizabeth to discover a miracle drug that claims to be



the fountain of youth. One injection of "the substance" is all it takes for her to become reborn as the gorgeous, twenty-something Sue (Margaret Qualley). Blinded by this promise of a younger self, Elizabeth acquires and injects the neon-green liquid into her body. After a demonic exorcism-like process, Sue is born and she is beautiful. Her long limbs, silky hair, and clear porcelain skin stand in stark contrast to Elizabeth's aging body.

Taking the substance comes with a nonnegotiable rule: Remember, you are one. Therefore, the time between Elizabeth and Sue needs to be split equally. For one week, the world gets Elizabeth, the next week they get Sue. While the women take turns as sentient beings, their counterpart lays unconscious on the bathroom floor, being fed through a tube until it's time to wake up. Things go according to plan, in the beginning at least. Both Elizabeth and Sue are respectful of the schedule and Sue quickly becomes Hollywood's budding darling. The divide between Elizabeth's hopelessness and resentment and Sue's optimism and success escalates, eventually reaching a breaking point. What follows is a multi-sensory monstrosity as both women battle to break free from their repression and regain control of their womanhood.

Behind the riotous visual elements of *The* Substance, director Coralie Fargeat crafts a deeply personal message that resonates. Portraying Elizabeth Sparkle is Demi Moore's latest crowning achievement. Her theatrical skills and comedic timing are on full display and are especially mesmerizing toward the film's second half. Margaret Qualley as Sue is another perfect casting choice. Her shift from a Bambi-like demeanor to a greedy it-girl



## Thai Ginger Chicken with Yellow Jasmine Rice

Provided by Campbells Soup Corp.

Originally developed with Thai Flavor Infused Broth, we've updated this recipe to use Swanson® Chicken Broth, coconut milk and ginger for authentic Thai flavor. Chicken broth is pureed with jalapeño peppers and cilantro then stirred into coconut milk for a unique, complex flavor in a smooth velvety sauce. - 1 large onion, cut in half and cut into 1/2-inch-thick slices
- 2 cloves garlic
- 2 tablespoons minced peeled ginger root
- 3/4 cup unsweetened coconut milk
- 1/4 teaspoon cayenne pepper
- 3/4 cup Swanson® Chicken Broth or Swanson® Natural Goodness® Chicken Broth or Swanson® Organic Chicken Broth
- 2 jalapeño pepper, seeded and chopped
- 1 cup fresh whole cilantro leaves

Add the garlic and ginger and cook and stir for 1 minute. Add the coconut milk and cayenne pepper and heat to a boil. Reduce the heat to medium-low. Cook for 2 minutes, stirring occasionally.
- Step 4: Place the broth, jalapeño peppers and cilantro into a blender. Cover and blend until the mixture is smooth.
- Step 5: Stir the broth mixture in the skillet. Return the chicken to the skillet. Cook until
  the chicken is cooked through. Stir in the lemon zest. Season to taste. Serve the
  chicken mixture with the rice.

#### Four considerations as you save for college

There are several savings options as you and your future college student prepare for the costs of college.

WHEN YOU ADD UP THE COSTS of raising a child, education looms large. "Four years at a public in-state college is projected to cost \$47,152 today," says Richard Polimeni, head of Education Savings Programs at Merrill. At a private college, that total could hit nearly \$169,000¹, and at the most elite schools you could spend far more. "You can expect tuition costs to rise by about five percent each year," he adds.
