# Early Morning, Urgent Care, and High Fives

Summer 2024 is just now moving into the rearview mirror. Fall is at hand, and this is an election year. Indeed, it will be of interest to see who is left standing c me November. Hawthorne Mayor Vargas has competition, including from David Patterson, a member of the City Council, and quite a few are running for the two open Council seats (among them the Hawthorne City Clerk and Hawthorne City Treasurer).

But there is work at hand and information to share: The Hawthorne City Council meeting of September 24, 2024, got underway at 6:06 pm. The initial presentation is a bit of a show-stopper. Did you know that five to six days a week, every morning, an "army of people hit the Hawthorne streets" to address the homeless situation? These include mental health personnel, police officers, and landscapers, no less. One of the fundamental ways Hawthorne is seeking to deal with, combat, improve, and address people without housing is to go out to them, to travel to the reported areas, be it encampments or stray persons, and try to get things dealt with right then and there in a constructive manner.

This is an important reminder: My-Hawthorne311, the app you can easily upload onto your phone, is designed to provide Hawthorne residents, businesses, and visitors with the opportunity to report issues, including those involving the unhoused, and to monitor resolutions 24/7, 365 days a week. The speakers emphasized that this is an excellent way to get the word out to your local officials.

So, it is early in the morning that Hawthorne representatives are looking for, and looking

out for, homeless who need services. There is collaboration on this dedicated program, from the using department to parks and rec. Among the efforts are to clean up troubled areas and try to et affected persons help and guidance right then and there. At the same time, military and veteran affairs have wraparound services and food to seek to support displaced veterans (who are among the unhoused).

Reference was made to the intake center just behind the Senior Center at Hawthorne Memorial Hall. Services include hotel/motel vouchers and medical assistance. In addition, the Council attendees were shown a video that included an unfortunate gentleman receiving emergency treatment literally

Thankfully, the homeless count in Hawthorne is down from what it was a year ago, but the effort will, of course, continue. The telehealth van is one of the assets. Mayor Vargas expressed pride about Hawthorne's Homeless Task Force which has become a beacon for other localities.

Mayor Pro Tem Manning then led a lively discussion about the importance of having urgent care centers in Hawthorne. Emergency rooms typically are overwhelmed, and statistics suggest that some 52% of the issues treated at ERs are not of an emergency nature. Urgent care facilities lessen the burdens on emergency room and can provide much-needed and more economical care for various ailments. Non-life-threatening situations can be well


### A Monster Calls by Patrick Hess inspired by an idea from Siobhan Dowd, Illustrated by Jim Kay

A Monster Calls by Patrick Ness was originally the idea of the author Siobhan Dowd. She died of breast cancer at the age of 47 and Hess decided to finish her book, using the idea and characters that she created to write a compelling story. When I first saw the book, I thought it was going to be a horror book. Talk about not judging a book by it's cover! Instead, the book is about a thirteen year old dealing with his mother's cancer and the feelings it invokes in him.

Conor O'Malley has been having the same nightmare almost every night since his mother was diagnosed with cancer several months ago. He wakes up at the same time, 12:07 a.m. shaken up from the horror of the monster's visit. This isn't a usual nightmare monster, but one that seems to come more and more alive each night. Conor expects a certain type of monster, but this monster is different. It's ancient, something wild and wants the truth from Conor. How can Conor tell the monster the truth when he's so scared that he never says the truth out loud?

Conor's monster was a general monster at first, blending in with the darkness and the wind. As Conor's mother worsens, the monster changes. Now the monster is born from the Yew tree in Conor's front yard, and is tall and menacing. It attacks Conor and leaves tree leaves and branches in his room. He cleans them up because he doesn't want

his mother to know what's going on with him. Conor is also having difficulties at school. He used to have a lot of friends, but now everyone knows his mother is sick and treats him differently. The bullies now pick on him and Conor isolates himself at school, so he doesn't have to talk to anyone. When his dad comes to visit, Conor is thrilled. Conor and his mom live in England. His parents divorced about three years ago and his dad moved to America and started a new family. The dad doesn't talk to Conor very much and doesn't encourage visits. How does Conor handle his dad's reappearance into his life? Read the book to find out!

The monster takes the shape of the Yew tree, but is bigger and larger. Jim Cray does a fantastic job with the illustrations, showing the monster in stark black and white. At first, the monster is scary, but through time becomes Conor's friend. The tree monster tells Conor stories and helps him understand everything in a clearer way. How does Conor handle the tree monster and deal with his grandma and mom? Read the book to find the answer!

I found the book to be very emotional and compelling! The author tells the story of grief, loss and acceptance and makes you think about how you handle the same emotions. This is not a happy book but is one that makes you contemplate your own choices. The illustrations showcase Conor's feelings and let you see how the monster really exists. I highly recommend it!


# Film Review

### Winner: A Story of Political Scandal (Based on Reality)

Over the past two years, a handful of interpretations have told the story of America's most unusual vigilante with the equally unusual name, Reality Winner. In 2023, Sydney Sweeney starred in the hybrid dramadocumentary, Reality, which used actual police transcripts as its script. Later that year, Sonia Kennebeck directed the documentary Reality Winner, which included exclusive access to Reality herself, and was conducted over five years. It would seem like audiences may have gotten their fill of the girl with the remarkable name, but in Winner, Susanna Fogel's more comedic take on the matter is a refreshing and welcomed entry into the Reality Winner cinematic universe.

Reality (Emilia Jones) is a wise-beyondher-years misfit who has never been satisfied with the status quo. She lives in Texas with her mom (Connie Britton), dad (Zach Galifianakis), and sister (Kathryn Newton). Her interests have always extended well beyond her high school classroom, and ultimately as far as the global stage. Upon graduating, the 18-year-old ditches any college plans to enroll in the U.S. Air Force. Reality's passion and expertise in the field of language translation make her a hot commodity for government positions. She quickly excels to a position as an NSA contractor. She spends

her days translating the Afghani language of Pashto into English to detect threats to the US.

One afternoon, triggered by an outburst by former President Donald Trump regarding election fraud, Reality decides this is the moment for her to take matters into her own hands. She knowingly accesses and sends out a set of classified documents to a political journalist that contradicts Trump's rhetoric, hopeful that the steps she took to conceal her identity will be enough. As we now know, it wasn't enough, and Reality is caught and sentenced to years in prison.

Winner's success comes from its light comedy, which garners laughs from many sharp one-liners. Emilia Jones makes for a convincing Reality, her voice-over narration lands perfectly between naive and smart-aleck. The rest of the performances are short but sweet, aiding instead of scene-stealing. As the film's visionary, Susanna Fogel brings a youthfulness and energy to a story we have never seen before. Fogel crafts Winner as an enigma that has yet to be completely figured out. She pays equal attention to the whistleblowing plotline as she does to Reality's personal life, including her family and romantic relationships.

It's true that Winner may not add a lot of new information to the existing conversation. However, Susanna Fogel preserves the themes of morality and justice. Bi-partisan in its agenda, Winner is an offensive, fun, and entertaining film about one of America's infamous whistleblowers. Available to rent on Apple TV. •

### 9 tax tips that could save you money

For ways to potentially reduce your tax bill this year or moving forward, consider these ideas from Bank of America

Taking time to review your financial and tax situation could help you (and your family) keep more of what you have earned. While some strategies apply now, others involve anticipating changes to come. For example, deep cuts in gift and estate tax exemptions, scheduled for the end of 2025, may be a good reason to start planning. #### 1. Review your gift and estate plans

If you regularly give to charity and itemize deductions, consider putting several years' worth of gifts into a donor-advised fund (DAF) for a single year, Navani suggests. "You may earn an immediate deduction, and you can spread out the giving over several years."

Without Congressional action, the federal gift and estate tax exemption will drop significantly in 2026, potentially exposing millions to higher taxes. You may want to consider moving assets out of your estate through gifts now, Navani suggests. Part of the planning may involve the best ways to structure gifts, so speak with your advisor and tax specialist about trust options.

#### 2. Put losses to work

With a process known as tax-loss harvesting,

you could sell underperforming assets that you were planning to sell anyway, invest the proceeds in assets you consider more promising, and use the losses to offset capital gains from elsewhere in your portfolio. To avoid triggering what's known as the wash sale rule, which would disallow the loss, you cannot buy substantially similar assets within 30 days before or after the sale.

#### 3. Keep track of where you work

Do you work remotely? Generally speaking, once you work in a state for 183 days, that state may consider you a resident and tax your income. To help avoid potential penalties, Navani suggests carefully tracking where you work every day and speaking with your tax advisor about the latest rules in the states where you live, where you work remotely and where the business is located.

#### 4. Max out retirement plans


Consider increasing your contributions to your 401(k), IRA or other qualified retirement plan. Not only does this offer the possibility of increasing retirement savings, but it can also potentially lower your taxable income. For 2024, you can contribute up to \$23,000 to a 401(k) and \$7,000 to an IRA. If you will be age 50 or older within the calendar year, you may be able to take advantage of higher "catch-up" contribution amounts.

### 5. Consider converting your traditional IRA to a Roth IRA

You can convert all or a portion of a traditional IRA to a Roth IRA. Unlike with a traditional IRA, qualified distributions of **See Money Sense, page 5**

handled in an urgent care setting, which in turn creates jobs. Keep in mind also that urgent care can handle not just patients who have a medical issue, but provide pragmatic services such as flu shots.

Council member Reyes English discussed the history in Hawthorne with regard to urgent centers, including the purchase of property and the use of then-Robert F. Kennedy Hospital. Sadly, to date, no successful operation has opened. The Council seems focused on changing that and bringing urgent care to the City of Good Neighbors.

During the public comment portion of the meeting, Pat Donaldson came forward. She is the President of the Hawthorne Chamber of Commerce. Among other events, Pat mentioned the October 30 "Halloween trunk" the Commerce is sponsoring to provide food and treats to families and kids. She then introduced Dr. Rochelle McCoy of the Rosecrans Veterinary Clinic, which opened less than a year ago and is ready to provide good care to your beloved dog or cat.

Quite a few matters at this Council meeting, as is often the case, were on the "consent

calendar" (and passed after a summary reading of each). However, one item that was taken up separately involved approving an agreement between Hawthorne and the City of Inglewood for supplemental law enforcement services. Specifically, with Sofi and now the new Clippers basketball stadium, Inglewood has a lot of activity, more than its staff can handle. Police officers from Hawthorne have taken time from their families, and sometimes their weekends, to help Inglewood. It was made very clear that Inglewood, including the overtime, bears the cost of the services

for Hawthorne's assistance.

There was a sense of near elation among the Council about the groundbreaking on this date (September 24) for the new, improved Senior Citizens Center at Memorial Hall. While no one high-fived literally, it would be fair to say the Council high-fived figuratively.

#### ${\bf 6.}\ Look\ for\ tax-aware\ investing\ strategies$

Consider putting a portion of your income into investments that are not generally subject to federal income taxes, such as tax-free municipal bonds. Doing so could potentially ease your tax burden when these investments generate income.

#### 7. Fund a 529 education savings plan

Contributions to a 529 education savings plan can potentially grow tax-free and withdrawals are federal — and usually state — tax-free if used for qualified education expenses. #### 9. Move toward clean energy

The 2022 Inflation Reduction Act included nearly \$400 billion for clean energy tax credits and other climate-related provisions. That includes potential tax credits for buying new or used electric or hybrid clean vehicles and making your home more energy efficient. Restrictions apply, so check with your tax advisor on which credits might be available
