

It was 1959 when my dad took me to the Los Angeles Coliseum to see the Dodgers play in the World Series. We sat in the left-field stands behind the notorious "Moon Wall", so nicknamed because Dodger left-handed hitter, Wally Moon took advantage of the short distance, and would try to hit (and often succeeded at hitting) "Moot shots" there.

My dad loved baseball and passed that great affection to me. The lore of the past, players like Ty Cobb, Babe Ruth, Joe DiMaggio, and more recently Willie Mays, Roberto Clemente, Henry Aaron, Sandy Koufax, Fernando Valenzuela, Nolan Ryan, among many so memorable. Players that seem larger than life. Moments and games, personalities, heartbreak, and glory, all sandwiched in between hot dogs, beer, and peanuts. Vin Scully, if you grew up with that gentleman in your ear, on the transistor radio, there is nothing that I have to say. Superlatives are too few when it comes to Vinny. He was indeed lyrical. He called the games, but he also told us about life and so much more, and did so as the Dodgers announcer for sixty-seven consecutive years. Nonetheless, baseball is pretty darn boring, some will tell you. Players are overpaid, some will insist. And, to be clear, baseball is no longer the national pastime, they say. In my little corner of the ballpark, baseball is the best game ever invented. Take a mitt, ball, a bat, and play on the street, in the sandlot, in the backyard, at the beach, in the living room, wherever you can, whenever you can. And dream big: It's a three-two pitch, the bottom of the ninth, final game of the world series - Oh, there it goes - you hit it

out, it's gone, it's gone... you hit the home run to win the World Series, to win it all! The fans are going wild!

At one time, I had a terrific collection of baseball cards, some of which today would be worth quite a tidy sum of money. Sadly my beloved mom tossed them out when I went to college. Oh, I still loved her all those years after, but from time to time had to remind her she should feel a little bit of guilt. And I make it up for that loss today with a whole lot of bobbleheads and more to come.

At ballparks from here to Pittsburg and back, have seen people praying in the stands, kids

# Morgan's Highlights from AFI FEST 2024 Larry is nowhere in sight. Robie is absolutely

A retelling of the horrific events that claimed the lives of eleven Israeli athletes during the 1972 Munich Olympics, September 5 is an adrenaline-inducing thriller that feels eerily relevant given today's political turmoil. Directed by Tim Fehlbaum, September 5 was among the highlighted titles at AFI FEST. The film made its World Premiere at the Venice Film Festival where it was nominated for, but ultimately lost, the Audience Award. September 5 is being distributed by Paramount with a limited release date scheduled for November 27, before a nationwide release later in December.

Starring Peter Sarsgaard and John Magaro, September 5 takes audiences into the control room of ABC studios on the fateful day that changed live broadcasting forever. It was supposed to be just a typical morning for the ABC sports crew who were gearing up for another 12+ hours of covering the Olympics. However, everything changed when the newly hired German interpreter, Gladys Deist (Georgina Rich), deciphers through chaotic messages, that several Israeli athletes and coaches were taken hostage.

Eight members of the Palestinian militant organization, Black September, infiltrated the Olympic Village in a highly orchestrated attack targeted toward Israeli athletes. In the blink of an eye, the ABC crew abandoned their typical sports broadcasting routine and

transformed into an impromptu breaking news station, led by Geoffrey Mason (Magaro) and Roone Arledge (Sarsgaard).

September 5 relies heavily on incorporating archival footage from the station's actual 1972 broadcast. It is both stunning and heartbreaking to relive these moments, knowing full well that these events changed the course of history. To that end, part of me believes that September 5 would have been even stronger as a documentary film, as opposed to a "Hollywood-ified" historical thriller. Director Tim Fehlbaum's controlroom drama feels a bit too slick at times, with characters effortlessly getting from point A to point B without much struggle (I highly doubt the individuals who actually worked the newsroom that day had a similar experience). However, September 5 keeps an energetic pace throughout and is an easy film to get caught up in for an hour and a half.

### **On Becoming a Guinea Fowl (A24)**

Filmmaker Rungano Nyoni's sophomore feature, On Becoming a Guinea Fowl, earns the title of most unusual film I screened at AFI FEST. Her first film, the BAFTA-winning I Am Not a Witch, premiered in 2018 to critical acclaim and quickly solidified itself as an indie darling. Nyoni stays true to her roots and dips viewers back into the colorful and rousing Zambian culture in On Becoming a Guinea Fowl, which won the Best Director See Film Review, page 7

### Holidays 2024: Are Shoppers and Retailers in Sync?

The holiday season is a time most retailers, and people who love celebrating and gift-giving, look forward to above all. While making predictions may seem risky, a number of indicators point to a jolly holiday season for shoppers and retailers alike this year. To get our finger on the pulse of 2024 shoppers, Coveo conducted an annual holiday shopping outlook report, "Gift or Grinch? Unwrapping This Season's Shopper Spending Plans," based on a survey of 4,000 consumers in the U.S. and U.K., in partnership with Arlington Research. Going a step further, we compared those shoppers' views with retailer perceptions from last year's holiday report surveying retail executives from 92 U.S.-based Retailers say they approach the shopping peak as a coordinated effort to create brand excitement, and shoppers agree.

Electronic stores (37%) and fashion/ apparel (36%) were the top two shopping choices for Black Friday or Cyber Monday.



The Coveo 2024 Holiday Shopping Report found digital shopping continuing its upward trend, with 80% of shoppers finding special offers purely through digital channels (email, social media, online search and online marketplaces). Shoppers appreciate shopping assistance, with 61% of consumers saying that pre-set search categories like "gifts for dad" or "gifts under \$50" are helpful. Nearly one in three shoppers (31%) also say having generative AI provide specific holiday gifting recommendations would be useful - rising to nearly half (44%) for millennials.

Shoppers expect personalized and relevant experiences, similar to what they would get

The upshot? Many approaches top retailers are pursuing to improve retail sales - optimizing Black Friday/Cyber Week events, using AI to offer shoppers personalized recommendations and maximizing promotions to improve shopper loyalty - also create what shoppers want: opportunities to find the perfect gifts for everyone on their list while scoring great deals.

### 2024 Consumer Shopping Outlook

Over three-fourths of surveyed shoppers (76%) say they plan to maintain or increase gift purchases this year, which retailers will be happy to hear. In fact, 59% of shoppers say they plan to cut down on everyday purchases to prioritize their gifting budgets. While the 2023 retailer survey found that most retailers (84%) feel consumers can get deals anytime, the majority of retailers (58%) believe holiday events remain a powerful source of revenue, with 76% of the above-average retail performers supporting this idea.

Baseball... please sit down a little bit. Let me tell you a few stories, ok? •






