Then, a little later in the nineteenth century, English author Charles Dickens came forward with the well-known A Christmas Carol, which emphasizes the importance of charity and goodwill.

As to Santa Claus, he can be traced back to St. Nicholas, a monk born in 280 A.D. He gave away his inherited wealth, and traveled the countryside helping the sick and the poor. But, what about Christmas ornaments?

It's the most wonderful time of the year! Under the circumstances, it is fair to ask: How in the world did this holiday thing come to pass? There are quite a few celebrations, including Kwanzaa, Hanukkah, and Nochebuena. Next month will be the Lunar New Year, Omisoka (the Japanese New Year), not to mention New Year's Eve here, as well as Mardi Gras, which begins January 6.

For purposes of this column the focus will be on Christmas, but indeed all of the festivities, all the celebrations and worship, truly add to the spirit of the season.

In 1870, Christmas was declared a federal holiday. The South Bay has a lot of Christmas and holiday celebrations, from parades to tree lighting, Santa Claus visits, holiday

For centuries, when the worst of the winter had passed, the winter solstice arrived. A time of celebration thus arose. Days were (the days are) longer, and there was more sunlight. Food became plentiful, and in time, rituals were established. For example, in Scandinavia, fathers and sons brought home large logs that would be set on fire, and a feast would go forward until the log burned out. This could last as much as twelve days (hmmm, is that related to the song "Twelve Days of Christmas?")

In the fourth century, church officials decided to make Jesus Christ's birth date a holiday. It was not certain, however, what the actual date of birth was. Pope Julius 1 selected December 25, and in time, Christmas, as it came to be known, was celebrated at the same time as the traditional winter solstice.

Washington Irving played a role here in America. His The Sketchbook of Geoffrey Crayon, Gent told stories about the celebration of Christmas in an English manor house. It was 1819, and Christmas was presented as Where did they come from?

The first trees were decorated with apples, white candy canes, and pastries in varying shapes (stars, flowers, and hearts). Glass baubles originated in Germany by the midnineteenth century, which could also be hung on the tree. While the original ornaments were in the form of fruits and nuts, glass figures were soon produced by highly skilled artisans, with clay molds. No less than F. W. Woolworth discovered baubles during a visit to Germany in the 1880s and did very well importing them here. Edward Hibberd Johnson, Vice President of the Edison Electric Light Company, is reputed to have introduced electric lights to Christmas trees in 1882.

Finally, then, what about poinsettias? Why are they a part of Christmas? Is it because they are red and green? The poinsettia is actually native to Mexico. When the Spanish conquered Mexico all those years ago, the poinsettia became known as "la flor de Nochebuena," or Holy Night flower. Today, **See Wonderful Time, page 4**



A24's *The Brutalist* is a Profound Cinematic Achievement, a "Must-See in Theaters" Experience



In 2018, actor-turned-filmmaker Brady Corbet turned heads with his sophomore feature, *Vox Lux*. The Natalie Portman-led dark musical harnessed an uncompromising vision that, at the time, felt exciting and fresh. It was a bold introduction to his aesthetic and unique visual style as an artist. In his latest film, *The Brutalist*, Corbet doesn't so much turn heads as he does command the room. A larger-than-life story about an architect who immigrates to America with nothing more than a dream, *The Brutalist* is a defiant, fiery magnum opus whose enduring appeal will withstand the test of time.

Adrien Brody plays the fictional character László Toth, a visionary Hungarian-Jewish architect who finds refuge in America from his war-torn homeland in Eastern Europe. Famed for his stunning brutalist structures in his native Budapest, the ongoing political struggle has forced him to flee and temporarily leave his wife Erzébet (Felicity Jones) and niece Zsófia (Raffey Cassidy) behind.

Once in America, Pennsylvania to be exact, László is greeted warmly by his cousin who eagerly gives him a job at his modest furniture shop. While there, he meets the bullish and egotistical Harry Lee (Joe Alwyn) and his wealthy aristocratic and industrialist father Harrison Lee Van Buren Sr. (Guy Pearce). Harrison is transfixed by László's constructions, and he presents the talented designer with a life-changing opportunity. Harrison commissions László to build a dynamic modernist monument that will forever be etched

into the fabric of the American landscape.

This is László's golden ticket. Steady work guarantees he can bring his wife and niece to America and give them a better life. He begins construction on the large-scale structure and it all seems to be going according to plan. However, with mounting pressure from Harrison and the weight of isolation finally starting to crack László's tough exterior, he begins to spiral. Even with his wife and niece by his side, László realizes how quickly the American dream can turn into a nightmare.

There is an ongoing theme throughout *The Brutalist* which shows an artist's sacrifice to execute their vision. No doubt the parallels between László and Corbet are strong, as the filmmaker spent seven years crafting and perfecting his vision. His patience has more than paid off. *The Brutalist* won five awards during its World Premiere at the Venice Film Festival, including the Silver Lion honor of Best Director.

For its humble budget of \$10 million, Corbet & company easily made *The Brutalist* look and feel like it had a \$40-\$50 million budget. It's worth noting that, according to online statistics, A24's average production budget for films in 2023 was \$15.36 million. The scope of this film is monumental, from the expansive sets to the period costumes and the actual story itself. Corbet further accentuates László's world by capturing the film in VistaVision, a high-res, widescreen variant of the 35 mm format.

The handheld opening sequence immerses the viewer into feeling like they were in László's shoes. This intimate and personal experience is jarringly effective, amplified by the dissonant score from composer Daniel Blumberg. The film offers a mix of hand-See Film Review, page 4



City of Hawthorne 2024 Year in Review: Progress, Community Engagement and Strategic Initiatives

The City of Hawthorne reflects on a year of growth, community involvement and strategic developments in 2024.

"From enhanced communication tools to public service improvements, new branding and ongoing community support, the City of Hawthorne has made significant strides," said City Manager Vontray Norris. "These efforts reflect our continued commitment to serving our residents and building a stronger, more budget includes a 13% increase in revenue and focuses on investments in public safety, personnel benefits, pension stabilization and the Civic Center project.

Finance Director Felice Lopez led the City's success in growing reserves from \$30 million to nearly \$100 million over the past six years, demonstrating the City's commitment to conservative spending and long-term fiscal stability.

Expanding Homeless Services

has continued several economic initiatives to drive growth and strengthen the local business community. Notably, the City hosted the 2024 Business Expo and Job Fair, an event that brought together businesses, job seekers and community leaders to foster connections and explore economic opportunities.

In addition, the City offered programs such as Hawthorne Business Connect and the Commercial Facade Program to empower local community growth.

Local Events Bolster Community Spirit

The City of Hawthorne hosted a vibrant array of events throughout 2024, showcasing its commitment to fostering community engagement and celebrating local culture. Highlights included the Earth Day Celebration in April, where residents connected with local service providers, participated in sustainable activities and enjoyed eco-friendly goodies. In June, the Juneteenth Celebration at Memorial Park brought the community together to honor emancipation through live music, cultural performances and family-friendly activities. Summer events like the Shakespeare in the Park series, the Hot August Night Car Show and Dodger Day continued to strengthen ties among residents while celebrating the City's diversity. As the year progressed, Hawthorne's fall lineup offered even more opportunities for residents to connect. The annual Fiesta in the Park in September honored Hispanic heritage with music and live performances, while the Touch a Truck event in October delighted families with hands-on experiences exploring City vehicles. The Halloween Spooktacular carnival capped off October with festive fun for all ages. Additionally, the Senior Resource Fair and ongoing Senior Center Community Day showcased the City's dedication to supporting its older residents through valuable resources and facility upgrades. A recent homeless count showed a reduction in the number of homeless individuals in Hawthorne, from 277 in 2020 to 180 in 2024.

As 2024 concludes, the City of Hawthorne remains focused on strengthening community ties, improving services and ensuring financial stability. With continued investment in public safety and community engagement, the City is ready for another year of growth and progress in 2025.




