# **Bluff Street Runoff Improvements Added to Capital Budget Plan**

During its January 14 meeting, the Torrance City Council decided to address the unsightly and slippery runoff affecting the residents of Bluff Street, while choosing to delay adding measures to alleviate issues in the Del Amo Boulevard and Madrona Avenue areas to the 2013-2018 capital budget plan. Residents of Bluff Street have been contacting the Council seeking to find a solution to a slippery mess that was leaking onto streets and driveways. In addition to being visually unappealing, Bluff Street resident Norm Segel said the runoff posed a danger to the those living on the street, especially the elderly. "Please consider it from a health and safety aspect," said Segel. "There is a [risk] of a slip and fall accident because of the slippery material on an incline. Falls with older people have worse outcomes... and there's a lot of older people in this neighborhood." To address the issues on Bluff Street, the Council decided to install a new gutter inlet and storm drain to connect to the LA County storm drain system. The cost of this plan is \$200,000 with an additional \$1,000 in cleaning and maintenance. The Council did not state which currently budgeted projects would be defered to fund this project. City staff did come up with a cheaper, temporary fix for the issue, but Councilmember Bill Sutherland believed the best course of action was to fund fully fixing the problem instead of constantly half-fixing it. "I think if we're going to do this project, we should do it right," said Sutherland. While the Council approved the Bluff Street improvements, it also pushed off two other projects also actively sought after by residents, with the first being improvements to the Del

Amo Boulevard median landscaping between Crenshaw and Van Ness Avenues that come with a \$950,000 price tag. Lee Ybarra lives in the neighborhood and said it has been ignored for years and could use some aesthetic improvements. "It's been such a long time since our street has had something done to it to improve it. Sometime in our lifetime we want something new," said Ybarra. "Price is not the issue here—it's the community. We are a good community. A long time ago they branded us 'Little Tijuana' and different names, but we're all American citizens and part of Torrance. We're not going away... we're not stopping."

While sympathetic to Ybarra's plight, the Council decided to explore adding the landscaping to other maintenance planned for that section of Del Amo Boulevard just outside of the five years covered in this budget in order to more cost-effectively improve the neighborhood.

The other project not added to the budget involved proposed improvements to a vacant lot south of Sepulveda Boulevard past where Madrona Avenue ends. City staff came up with four plans to address the issue: install a seven-foot asphalt walking path (with a cost of \$50,000 and \$500 in annual maintenance), See City Council, page 2

### **The First Torrance Police Department Awards & Appreciation Luncheon**

Torrance has always prided itself with its state-of-the-art police department complete with its own forensic lab (Torrance Tribune May 9, 2013). And it is no secret that many cities look to Torrance as a model of how to structure a community-supported police force.

Last week I spoke with Donna Duperron, President and CEO of the Torrance Area Chamber of Commerce, and she told me, "The Torrance Police Department has always been one that is very involved in the community." Donna explained to me that several years ago, the Chamber of Commerce partnered with the Torrance Police Department and developed the Business Watch Program that assisted in increasing the knowledge to business owners about the benefits of the program. Donna told me she was aware that other chambers hosted a police appreciation luncheon in Southern California and she thought it would be a great idea for Torrance to have the same sort of event. "I contacted Chief John Neu and explained the concept of the program and he and his staff did research of other cities who partnered with chambers to do the luncheon and he agreed. leave the spot as is (with no additional costs), install ornamental grass and a new concrete walking path (with a cost of \$450,000 and \$27,000 in annual maintenance), or develop a private partnership to solve the problem. Sarada Nilakantan lives near the lot and to clarify the particulars of a City charter amendment to extend the time the Council has to decide how to fill vacant Council seats. The issue has come up twice this year with former Council members Susan Rhilinger and Cliff Numark resigning and Herbers

imagines it transforming from an eyesore to a place people of all ages can enjoy. "We have in our neighborhood a lot of children who are under 10 years of age ... it takes a long time to take those kids to any park close by and it would be so nice if we had something like that right here," said Nilakantan. "We also have a lot of elderly and they would benefit from having a walking path right there. Right now it doesn't look like much, but we look at the possibility of how nice and bright it could look...how much we could enjoy it." While the Council did not add this project to the budget, Mayor Frank Scotto strongly hinted that he believes a private partner could fund improvements to the lot that the community might find acceptable.

Also during the meeting, City Clerk Sue Herbers took time to clear up a misconception regarding the June 2014 election. She wanted has asked the Council to examine a charter amendment, but so far that is as far as the issue has progressed. "I will succinctly say right now that a charter amendment is not proposed for the 2014 General Municipal Election," said Herbers. "It was mainly to address the issue of filling vacancies. [On] each of these occasions, comments have come from the Council and from the public about the short period of time to make an appointment or take action."

In addition to addressing concerns about the quick appointment timetable, Herbers said she believes the changes would be cost effective and would be aligned to the most recent version of the California Elections Code (which as of 2012 has allowed a 60day window to appoint or elect as opposed to Torrance's 30-day deadline.) Despite the positive outlook on the change, Herbers believes this election is too big and too soon to fully examine the topic.

"Due to the nature of the election this year with the number of candidates seeking offices and the need to focus on current issues, there would not be sufficient time to allow a full and transparent study of this matter as warranted," said Herbers. "In my professional opinion as the City Clerk, the discussion can and should be left for a dialogue with the soon-to-be-elected Mayor and new Council members and the City of Torrance in a manner of their choice." •

# Finance **10 Simple Ways to Instantly Improve Your Finances in 2014**

(BPT) - Do you wonder how you could better manage finances? You're not alone. When it comes to money, most people are far from perfect. Whether you make \$20,000 a year or \$200,000, some simple steps can start you on the right financial path, and some of them only take a few minutes to complete.

You can use the workbook alone or pair with the free online video lessons. Topics covered include money management, savings, investing and more.

McAuliffe suggests 10 simple ways for you to start improving your finances immediately:

1. Stop, think, save - When out shopping, don't mindlessly pile things in the cart. Take a moment to stop, think what you really need, and save by not buying extras. Cutting unnecessary spending is easy when you make a habit of briefly pausing to analyze what you really need.

2. Cut 5 percent - If your employer cut your paycheck by 5 percent, you'd be unhappy, but you'd still be able to survive. Why not make that cut now? Reduce the extras like your daily latte or weekly visit to the salon and the savings will mount quickly.

3. Save - Every little bit counts when it comes to savings. If you save just \$5 a day - the cost of a fast food lunch - you'll have \$1,800 in a year. It's OK to start slow and build momentum. The ultimate goal should be to save at least 10 percent of your net income (income after taxes and other deductions).

4. Budget - It sounds simple, but most people don't have a solid budget. Create a spending plan now and stick to it. List all expenses and see where adjustments can be made. Refer back to your budget regularly to stay on track. 5. Keep multiple

savings accounts - The less accessible your money is, the easier it is to reduce spending. Keep multiple savings accounts and pay yourself first. One savings account could be designated for an emergency fund, another for a new car or a future vacation.

6. Make it visual - Discourage overspending by reminding yourself why you are trying to save. A photo of your vacation destination, for example, illustrates what you're saving for; put it everywhere you spend money - wallet, computer monitor, vehicle, etc.

7. Make your money work for you - Consistent contributions add up over time, and thanks to the power of compound interest, the longer you leave your money untouched in a savings account or other investment, the more it can grow.

8. Home savings - If you own a home, you know it can cost a lot of money. Cut costs by doing home improvements and maintenance jobs yourself rather than hire out. Call your insurance agent and see if there is a lower rate for homeowner's insurance. Check into refinancing while rates are still low.

9. Manage checking accounts - You need a checking account, but are you really keeping track of your money? Online banking makes it easier than ever to balance your checkbook, track your spending and set up alerts when your balance goes under a certain amount.

10. Review your credit report - From mortgages and car loans to employment and renting eligibility, your credit report and score affect many aspects of life. You can review your credit report for free annually by going to www.annualcreditreport.com. Make sure you know what's on it and make corrections as necessary. •



# Lady Warriors Make **Splash vs. Tartars**

Perhaps it took such an enormous win to get everyone's attention. Maybe it's just that time of the year when the elite teams separate themselves from the rest of the field. Whatever the reason may be, however, the Lady Warriors' rout of the Tartars last Friday night at Torrance High opened up eyes everywhere. Not only did West win by a final score of 72-37, beating the Tartars by almost as many points as the home team scored in the entire game, but with the win, the Lady Warriors moved their record to 17-2 on the season. The cross-town rivalry game against the Tartars prepared West for its Bay League opener against Mira Costa that took place this week. The Warriors have their hands full in a perennially tough Bay League division that this year features the likes of Costa and Palos Verdes Peninsula, but the dominating victory has head coach Mike Caporaso and his girls believing that they can compete with anybody this season.

The Lady Warriors got out to a fast start against the Tartars and never looked back from there. West outscored the Tartars by nine points in the first quarter, but it was the final minutes of that period combined with the entire second quarter that really broke the game wide open. The Warriors began a 16-0 run towards the end of the first quarter and used it to dominate the second quarter on their way to a 40-16 halftime lead. "We have practiced hard and we had a lot of energy coming in," explained West's Kayla Sato. That energy was evident not only in the first half, but continued on throughout the rest of the game as well. With another 16 points in the third quarter, the Warriors extended their lead to 56-24. The Tartars had their best offensive quarter of the game in the fourth, but eventually found themselves down by 27 points with the game well out of reach by that point.

Kylie Fujioka led the way for the Lady Warriors on offense, posting 19 points and 10 rebounds. "We're ready," Fujioka said. "We still have a lot to work on for league, but we're getting better." Jasmine Jones assisted Fujioka on offense, racking up 10 points and 12 rebounds while Sato posted 10 points of her own. Ashley Sasaki took the lead for the Torrance, as she and Carah Fukumoto posted eight points each to lead the Tartars. While the game was somewhat of a letdown for Torrance, head coach Rick Momohara chose to see things optimistically instead. "For us, this was something we needed," he said.

"We're very young and we need experience playing against better teams, and West is one of the elite teams in our division." The Tartars will have another tough matchup as they take on North High this Friday night in the Pioneer League opener. West has an early week matchup against Mira Costa, followed by a game with Palos Verdes on Friday night.

### South High

The Lady Spartans of South High began their league play season a week earlier than most other teams in the Pioneer League as they took on the Centennial Apaches last Friday night at home. Centennial has been an above average team this year and came into the game against South as winners of two out of their last three games. South has been much better, though. Aside from a loss to West High, the Lady Warriors had won seven out of their last eight to move to a 12-4 record and into first place in the Pioneer League standings. Those facts held true last Friday night as South was able to pull out a 46-35 victory.

Kasey Takahashi was the main catalyst on offense for the Spartans on the night, putting up 16 points and six rebounds to help South hold on to the lead throughout. Alexis Henry had a great all-around game with eight points, nine rebounds and four steals, while Jaryn Fajardo put up seven points, seven rebounds and five assists to attain the victory for South. The Lady Spartans will take on El Segundo this Friday night in another division matchup as they look to hold onto first place in the Pioneer League.

### North High

The Lady Saxons are another team holding their own in a stacked Pioneer League this year, as they have jumped out to an impressive 9-4 start, but suffered a setback in their last game against Cerritos two weeks ago. North started hot and held an 11-point lead going into the second quarter, but their defense was compromised in the second and third quarters as North gave up a total of 42 points in just those two quarters of play to go down by seven points leading into the fourth quarter. The Lady Saxons won the quarter, holding Cerritos to only seven points as they scored 11, but it was not enough as they were still left three points short and took the 59-56 loss. North will look to get back on the right track this week as they open league play against Centennial on Wednesday night before participating in a cross-town rivalry game in their second league game of the season against Torrance.

At the beginning of the year, anyone would have thought that a matchup between the San Francisco 49ers and the Carolina Panthers in the second round of the playoffs would have been just that for San Francisco: easy. These Carolina Panthers weren't the same Panthers that we've seen before or even at the beginning of this year, though. After a rough 1-3 start to the season, the Panthers rallied off eight wins in a row and 11 of 13 to take a bye

in the first round of this year's playoffs and show the world that they had actually become a team to be reckoned with in the NFL. That didn't matter to the 49ers, though. A relatively close game through the first half turned into a dominant second half performance by the San Francisco defense as it rallied toward its 30th postseason win in a 23-10 victory, advancing the team to an NFC championship matchup with the Seattle Seahawks.

At the end of the first half, the 49ers went on an 80-yard drive resulting in a touchdown to take the lead going into the break. Coming out of the intermission, San Francisco's defense began to assert its power with a quick threeand-out, allowing the 49ers to go on another 70-yard drive for a touchdown to steal all of the momentum from the game and give the team a distinct advantage. "We had to get settled down," 49ers starting quarterback Colin Kaepernick explained. "We came out--they did some unorthodox things against us. We settled down, we got into our rhythm, we started making plays." Once the 49ers got settled down, it was all downhill for the Panthers from there and San Francisco's superiority over Carolina really began to show. The 13-point victory over Carolina marked the third consecutive season that the 49ers would make it to the NFC title game--three years straight under head coach Jim Harbaugh, including one Super Bowl appearance last year. San Francisco had the experience and that was evident on the football field. The 49ers have been there and done that before, and now will be looking to do what they couldn't last year: win on the last day of the season.

If the 49ers are going to do that, though, they are going to first have to get past a Seattle team that statistically has the best defense in the league, the loudest crowd in the league, and has lost only one game at home in the two years that starting quarterback Russell Wilson has been at the helm. If you thought the Niners/ Panthers game was intense, just wait until you see the display of emotion that takes place on beginning," Kaepernick said. "It's going to be a knockdown, drag-out game."

The 49ers may have all of the momentum on their side. Having won eight games in a row, they are the hottest team in the NFL right now and are coming off of two straight road victories in the playoffs. If that doesn't say tough to beat, then what does? Seattle had a pass on wild card weekend because its record gave it a first-round bye. Either that means the Seahawks are more well-rested than San Francisco or it means they are at more of a disadvantage. The past three Super Bowl champions have had to play on wild card weekend and San Francisco is the only team left standing that did not have a first-round bye this year. Perhaps that bodes well for the team from the Bay, but if the 49ers are going to even make it as far as the Super Bowl, they'll have to learn quickly how to play in the stadium that literally generates earthquakes because of its noise level. San Francisco may enjoy playing on the road, judging from its first two playoff victories, but there is no venue in the NFL that is more difficult to play in than Seattle's CenturyLink Field.

The Seahawks and the 49ers have met twice this season already, splitting the regular season series at a game apiece. This time isn't like the others, though. This time, it's do-or-die, win or go home, and someone's season will end on Sunday night. For the two teams on the field, it will definitely be intense and impassioned in what has truly become a heated rivalry. For all of those watching, it will be fun to view, to say the least. For the San Francisco 49ers though, they have experience on their side. If there is one thing that can take down the Seattle Seahawks, it is experience in big time games like this one. The 49ers have been there and done that before and are now back to gain the one thing that has eluded them throughout their success in these last three seasons. A Super Bowl victory is the only accomplishment left for San Francisco and the only way to get to that is through the Seahawks this Sunday night. •





# <u>Lookina Up</u>

Inhabitants of Minneapolis, Chicago and St. Louis may be thinking that the American Midwest is the coldest place in the Universe. Well almost, but not quite.

At a cosmologically crisp one degree Kelvin (minus 458 degrees Fahrenheit), the Boomerang Nebula in the constellation Centaurus is actually the coldest known object in the Universe-colder, in fact, than the faint afterglow of the Big Bang, which at minus 455 degrees Fahrenheit, is the natural background temperature of space.

Astronomers using the Atacama Large Millimeter/submillimeter Array (ALMA) telescope in Chile have taken a new look at this intriguing object to learn more about its frigid properties and determine its true shape, which has an eerily ghost-like appearance. The ALMA telescope array observes the Universe in a relatively unexplored region of the spectrum between infrared light and radio waves.

As originally observed with ground-based telescopes, this nebula appeared lopsided, which is how it got its name. Later observations with the Hubble Space Telescope revealed a

The Coldest Place in the Universe bow-tie-like structure. The new ALMA data, however, reveal that the Hubble image tells only part of the story, and the twin lobes seen in that image may actually be a trick of the light as seen at visible wavelengths.

"This ultra-cold object is extremely intriguing and we're learning much more about its true nature with ALMA," said Raghvendra Sahai, a researcher and principal scientist at NASA's Jet Propulsion Laboratory in Pasadena, California, and lead author of a paper published in the Astrophysical Journal. "What seemed like a double lobe, or 'boomerang' shape, from Earth-based optical telescopes, is actually a much broader structure that is expanding rapidly into space."

The Boomerang Nebula, located about 5,000 light-years away, is a relatively young example of an object known as a planetary nebula. Planetary nebulae, contrary to their name, are actually the end-of-life phases of stars like our Sun that have sloughed off their outer layers. What remains at their centers are white dwarf stars, which emit intense ultraviolet radiation that causes the gas in the nebulae to glow and emit light in brilliant colors.

The Boomerang is a pre-planetary nebula, representing the stage in a star's

life immediately preceding the planetary nebula phase, when the central star is not yet hot enough to emit sufficient ultraviolet radiation to produce the characteristic glow.

At this stage, the nebula is seen by starlight reflecting off its dust grains.

The outflow of gas from this particular star is expanding rapidly and cooling itself in the process. This is similar in principle to the way refrigerators use expanding gas to produce cold temperatures. The researchers were able to take the temperature of the gas in the nebula by seeing how it absorbed the cosmic microwave background radiation, which has a very uniform temperature of 2.8 degrees Kelvin (minus 455 degrees Fahrenheit).

ALMA, an international astronomy facility, is a partnership of Europe, North America and East Asia in cooperation with the Republic of Chile. ALMA construction and operations are led on behalf of Europe by the European Southern Observatory (ESO), on behalf of North America by the National Radio Astronomy Observatory (NRAO), and on behalf of East Asia by the National Astronomical Observatory of Japan (NAOJ). The Joint ALMA Observatory (JAO) provides the unified leadership and management of the construction, commissioning and operation of ALMA. •

# Finally, Somebody Steps Up to **Prevent Mass Spying of Citizens**

Due to the repeated admission by federal administrators that there has been a widespread effort to spy on American citizens who are innocent of any wrongdoing, Senators Ted Lieu and Joel Anderson introduced a bill seeking to ban state agencies, officials and corporations that currently provide a service to the state from assisting the federal government in its efforts to spy and collect certain data on Californians.

Sens. Lieu and Anderson are taking a stand, for now symbolic, against such invasive practices.

It is no surprise that the government, on any level, can spy on citizens. However, the steps that the NSA took to collect information on millions of citizens are as ridiculous as they are criminal. One report indicated that the NSA collected phone information on an estimated 317 million Americans. Of those citizens whose privacy was violated for no good reason, about 38 million are Californians. The NSA and President Obama's administration can claim that these actions were taken in the name of national security, but the truth is that such an explanation is simply

a copout. It is difficult for me to believe that 38 million Californians are involved in criminal activity. It is even harder to accept that 317 million Americans are such a threat to national security that we need the NSA to spy on their phone calls.

Conducting secret surveillance on a group of individuals involved with criminal activities is a legitimate security measure. In order to do so, there are several steps that must be followed, such as obtaining warrants and other paperwork that help maintain transparency throughout the process. The bill introduced by Sens. Lieu and Anderson attempts to preserve that process in order to maintain the privacy rights of every law-abiding Californian. Maybe I'm old-fashioned in believing in the Fourth Amendment to the United States Constitution and the right of Americans to not be subjected to "unreasonable searches and seizures."

In California, the NSA would rely on the services provided by the state and private entities to collect and conduct such surveillance. With the bill attempting to ban state agencies, officials and corporations providing any services to the state from giving support, from participating or assisting any federal agency in spying efforts, at least Californians will be more protected than your average American. The first step has been taken with the bill introduced by Sens. Lieu and Anderson. Maybe the rest of our elected officials in Sacramento can pass the bill and enforce it for the well-being of every Californian. •


