# State Education Spending to Rise by \$6.3 Billion

The Torrance School Board heard an update on the state of education funding in California during its January 21 meeting. This year marks a turnaround for school funding, which is surging despite facing massive cuts just over a year ago.

The presentation on the Governor's proposed budget was led by Michael Ricketts, Associate Vice President of California School Services, Inc. that advises the Torrance Unified School District on matters of State finances. Ricketts explained that funding has greatly improved. Just 14 months ago, schools were facing contingent cuts of \$400 per student on top of two years of cuts. He said the increase in funding is due to the approval of the temporary taxes in Proposition 30 and some economic recovery.

"Things have changed dramatically," said Ricketts. "The big thing was Prop 30 did pass, which provided additional money for schools and--as importantly--for the rest of the State budget. On top of that, we had a recovering economy and that economic recovery combined with Proposition 30 has completely transformed funding for the State ...in particular funding for schools and public education."

There is now \$61.6 billion in education funding, an 11.4 percent increase over last year's numbers. This means that on average, districts are receiving an additional \$751 per average daily attendance. "Proposition 98 entitlements have skyrocketed because the economy is doing well," said Ricketts. "It's doing moderately well. It hasn't been a gang-busters recovery, but Proposition 98 because of how that formula works has increased dramatically for this next year, so we're going to see that in the budget."

In addition to increasing school funding,

Ricketts said a priority for the Governor is to end the practice of deferring payments to school districts. While districts receive all their budgeted funding eventually, oftentimes those payments are delayed by months and cause schools to rely on methods like Tax and Revenue Anticipation Notes (TRANS). These deferrals amount to 20 percent of all education spending in the state. Ricketts said the new budget has additional funding to pay off these debts, but he stresses that this isn't additional funding but instead a method to address a cash flow issue and to "finally" allow the State to be current in funding schools. "Governor Brown has made it a priority to

pay off that wall of debt," Ricketts said. "This particular budget takes a really strong run at it and actually completely pays off deferrals."

Another sweeping change included in the budget is Governor Brown's plan to modify the State's funding reserves. The plan would mandate a share of capital gains tax be transferred to a "rainy day" fund, but only in years when revenues from capital gains make high returns. The change would require approval from voters, but would smooth the wild peaks and valleys affecting education funding.

"We've been through a cycle of boom and bust in State revenues. Proposition 98, which **See School Board, page 3** 

# Mayor Frank Scotto Looks Back on Eight Years as Mayor

"Take Back Torrance" was the rallying cry eight years ago of then mayoral candidate Frank Scotto and he was invited back to the Old Torrance Neighborhood Association (OTNA) January 15th meeting to give a recap of his term as mayor. Mayor Scotto is serving his final six months in office before being termed out with several candidates who may be vying for his position by the June 3rd election.

Mayor Scotto started his address by exclaiming, "Being mayor is one of the best jobs you can ever have!" He admitted that he was very concerned about the city's direction when he first took office especially considering the worsening recession, however, he now feels that "the

city is in phenomenal shape" eight years later and contributed this largely to three factors – developing a more transparent government, regaining the public's trust and getting actively involved.

Mayor Scotto cited an emphasis on strategic planning when he was elected which included input from numerous meetings with non-profits, sports, business and other organizations. He continued, "training for city commissioners was also implemented – Torrance was the first city to do this – which focused on education and ethical behavior."

He specifically thanked OTNA as one of the first organizations to embrace the concept of "paying it forward" by getting involved in cleaning up the downtown



ever; a Forensics Lab manned by 7 civilian employees who are experts in DNA sampling. Mayor Scotto specifically congratulated the Torrance Centennial Committee who planned "the spectacular events that other cities are now calling us about." He is also looking forward to the AYSO tournament games which will be held in Torrance bringing an anticipated 10,000 people and a projected \$10 million tourism spending this summer, and praised the 555 Maple Youth Facility construction which will heighten Torrance as a destination for youth sports.

Mayor Scotto quickly cited several national accolades that Torrance has received including a 2013 FBI ranking as the 14<sup>th</sup> safest city in the

"We have set the groundwork and the city needs to continue in the same direction," said Mayor Scotto. He praised the current council but warned that there needs to be a "coalition of people to make things happen" and there will be a lot of individuals being termed out or retiring from the city in the next few years. That is why it is more important than ever for voters to be informed, according to Mayor Scotto.

Former Torrance Councilman Dick Rossberg ended the evening with the following statement about Mayor Scotto: "This guy has done the greatest job for the City of Torrance. And most important – he has a great wife!" •

is really the driver for school funding, has been closely tied to State revenues because of how the formula works, so funding for schools has gone through that same cycle," said Ricketts. "The Governor is proposing a rainy day fund...which will put money in a reserve in good years to smooth out the bumps when the bad years come."

However, not all the news was good. Ricketts said the State hasn't had a school facilities bond in a number of years and funding is nearly exhausted with no new bond on the horizon. "Where the next round of dollars to support these schools and modernization will come from is still unknown," said Ricketts. "It still has to be addressed."

Board member Terry Ragins noticed another missing item from the new budget: funding for regional occupational centers like SoCal ROC. "Another thing that's not in this budget--not even mentioned--is the regional occupational centers or regional occupational programs," said Ragins. Ricketts believes that after the moratorium on redirecting funds from occupational centers expires, it will be up to the State Legislature to solve the problem--not a budgetary fix.

Lastly, due to the new Local Control Funding Formula, Torrance Unified School District will receive less additional funding than the State average. Torrance will see an increase of \$523 per average daily attendance, which is up 7.3 percent. However, the average district will see an increase of \$751, or 10.9 percent. Part of this comes from Torrance having fewer economically disadvantaged students, with only 36 percent in that category. The Local Control Funding Formula provides an equal base grant, but more funding for districts

Overall the Board was pleased with the proposed budget. Board member Michael Wermers said the outlook for the future is brighter compared with last year. "This is much better news than last time we saw you," said Wermers. •





# What's a Super Bowl With No Gold?

It was an uneven battle from the start. The "12th Man" of the Seattle Seahawks provided one more benefit than the San Francisco 49ers were able to acquire and that slight edge wound up costing the Niners the game. In a grudge match that lived up to its billing and more, the two teams battled back and forth at CenturyLink field in Seattle last Sunday night and took turns gaining momentum until something just had to give. In the end, it was the 49ers who did the giving. As San Francisco starting quarterback Colin Kaepernick threw the last interception of the game with 22 seconds remaining on the clock in the fourth quarter, it was clear that the Seahawks were the team that simply made more plays. In games of this magnitude, with the NFC Championship on the line, those are the teams who win. Despite any possible controversy involving missed calls by referees and despite all of the almosts and what ifs, the Seattle Seahawks will be moving on to the Big Apple to take on the Denver Broncos in Super Bowl XLVIII at MetLife Stadium in New York.

The last time that two number one seeds had reached the Super Bowl to face off against one another was in 2009 when the Pittsburgh Steelers met Kurt Warner and the Arizona Cardinals. Now, the top two seeds in the league will meet once again as Peyton Manning and his Broncos' top-ranked offense in the league will face off against Pete Carroll, Russell Wilson and the number one defense in the league as they lock horns on February 2 in New York. Seattle's victory didn't come easily, however. Before last Sunday, many believed that San Francisco, winners of eight straight going into the game, was the best team in the entire league. The Niners have already shown their ability to beat good teams on the road, as evidenced by their victories over Green Bay and the Carolina Panthers earlier in the playoffs--but alas, neither Green Bay nor Carolina compare to the 12th Man in Seattle. That fact became certain as San Francisco relinquished a 10-point lead and ultimately lost to the Seahawks 23-17.

San Francisco fans everywhere will complain that the game was lost due to the referees. A botched roughing the kicker call eventually led to seven points for the Seahawks and an incorrect ruling on a fumble near the end zone in which NaVorro Bowman stripped and maintained possession of the ball gave the Seahawks another chance at the end zone. In the end, however, those are only excuses and the Seahawks made the plays necessary to win a game of this level of importance. Wilson pranced around the field, improvising to his heart's content en route to 20

second half points after putting up just three in the entire first half. Marshawn Lynch got going with a 40-yard touchdown run, Doug Baldwin helped inspire the special teams with a 69-yard kickoff return, and then there was the defense--the number one-ranked defense in the league. It was the defense led by Richard Sherman, who had the game-saving and game-ending pass deflection that led to an interception in the end zone with just seconds remaining. Or Cliff Avril, who seemingly sacked Kaepernick at will. Kam Chancellor came up with a huge interception and the entire Seahawks' front seven took 49er running backs right out of the game, holding the backfield to a total of 31 rushing yards on the night.

Now, all eyes will be fixed on the last football game of the season as the two best teams in all of football go head to head. Seattle and its top-ranked defense has had the best record in the league all season long and will be headed to the Super Bowl for the first time in 20 seasons. Peyton Manning and his record-setting offense will certainly test that top-ranked defense as the former gets back to the Super Bowl for the first time since 2009 when his Indianapolis Colts lost to the New Orleans Saints. So what will the outcome be?

If Manning wins, he will be put in a class of his own as the greatest quarterback of this generation and maybe of all time. Always having to compete with Tom Brady, Manning not only broke all of Brady's records this season, but also beat him in the AFC championship and in this scenario, will have gone on to win the Super Bowl. The motivation for Manning must be tremendous. Walking off of the field and possibly out of the game a winner is something that almost no player ever gets to do. No player other than, say, John Elway...

Seattle is just about unbeatable at home. Luckily for the Broncos, there is no home field advantage for either team in New York. That means the 12th Man will be nonexistent for Seattle and the only advantage the team will have to roll with is that top-ranked defense. While Wilson has solidified his place as an elite quarterback, his numbers somewhat fail to tell that story. With 215 yards against San Francisco and only 103 against New Orleans, it means that Seattle needs a lot of Marshawn Lynch to win. Manning on the other hand just threw for 400 yards in one game against the Patriots, eclipsing Wilson's entire playoff total. The Seattle Seahawks are a great team and are truly never completely out of any game, but the Broncos win this one for Peyton and solidify his legacy as one of the best quarterbacks to ever play the game.  $\bullet$

# **Torrance, South Headed** in Different Directions

It's always hard to tell just how good any team is before league play actually begins in high school basketball. With multiple tournaments on the schedule and in most cases a team that is still learning about itself, it always takes until about midway through the season for a team to gain its true identity. Last Wednesday night at Torrance High, both the Tartars and the South High Spartans gained a little piece of mind about their own teams and where their respective seasons are heading. With a 61-37 win in the Pioneer League opener for Torrance, the Tartars moved even higher atop the standings while the Spartans continued on their plummet downwards. It's amazing how quickly one year can change the fortunes of an entire team, but after spending most of last season near last place in league standings, Torrance is treasuring its opportunity to set the normally successful Spartans back in the standings for once.

It wasn't long ago that the South High Spartans made it to the CIF Southern Section championship game against Calabasas. Much like that game that took place almost two years ago, however, South High simply ran up against a better team when it lost to the Tartars by 24 points in what was the second game of league play this season. It was almost over before it even started, as the game marked the Tartars' first home appearance all season long. It was obvious that the fans of the beloved basketball team had been waiting on pins and needles to watch their high school kids play, as the environment inside of the gym was raucous, to say the least. "Our guys came out with a lot of energy," explained Tartars head coach Paul Nitake. "It was our first home game, our first league game. It was a fresh start. The crowd was amazing--it was a great atmosphere. We hit a couple of shots and kept going and played off the energy of the crowd." The noise and liveliness sparked the Tartars to what was an almost perfect quarter that led to an easy win over their cross-town and Pioneer League foe.

It wasn't very long after the opening tip of the game that the Tartars broke this one wide open. With a 14-1 run early on in the first quarter to give the team a 16-3 lead, the Tartars led handily seemingly before things even got started. It was Kyle Polk who capped off that run with a three-point shot and led his team in the first half with 10 points to spark that outburst. When halftime rolled around, it was 40-19 in favor of the Tartars as Torrance had already more than doubled up the point output of South High. Whenever it looked as if the Spartans were about to gain momentum, the Tartars stuck together and maintained to push South even further behind them on the scoreboard. With a 50-25 lead in the third quarter, the Tartars kept the game closely in hand and preserved at least a 20-point lead for the entirety of the game. Torrance's 24-point margin of victory was its largest since the middle of December.

The Tartars (11-6, 1-0) now sit in first place in the Pioneer League standings and get set to take on El Segundo and Centennial this week. At this time last year, Torrance was battling to stay out of last place while the Spartans (5-13, 0-2) were fighting to get into the top two seeds of the league. Now the Spartans find themselves in last place, but look to get things turned around as they take on Lawndale and North highs.

# West High

This time of the year marks do-or-die time for the West High Warriors. The high school basketball season up until this point has been filled with random teams from random conferences, as well as tournaments from all around the area to warm the kids up for what is to come. Now as league play has begun, this is the time that the Warriors had been waiting for all along. Unfortunately for West, the first team that it would have to take on was the number three team in CIF's Southern Section Division II-AA--the Mira Costa Mustangs. That same team in the Southern Section isn't even in first place in the Bay League standings, but certainly played like it was last Tuesday at Mira Costa. Behind a 30-point game from Just Strings and another 10 points from Chase Crandall, the Mustangs were able to come away with a 68-54 victory in the Bay League opener. Giovanni Jackson did his part to make sure the Warriors stayed in the game, posting 16 points, six assists and three steals for West and Christian Jackson was able to put up 11 points on the night. The only other two teams in the Bay League better than Mira Costa (15-3, 1-1) are Palos Verdes and Redondo respectively. The Warriors (6-11, 0-1) will take both of those teams on in the next three weeks of play.

# North High

The North High Saxons have enjoyed a great start to the season, but have been on somewhat of a downward slide recently. With three losses in their last four games, the Saxons have found themselves slowly and steadily slipping out of first place to where they now stand after a loss to Centennial in their Pioneer League opener--in fourth place. In a game that got out of hand late, the Saxons fell by a final score of 57-42 to their division rivals and now must look ahead to games against Lawndale (second place) and El Segundo (fifth place) to get their season back on track and make a run at first place once again. •

Everyone sleeps. Last week, I decided to find out how well people in Torrance sleep. Not being a medical doctor or expert on the subject, I was most interested in how long realized what had happened.

Evelyn then revealed that her brother gave her a sleeping mask for Christmas because she has a lot of trouble sleeping. She wants it dark. I asked her if the sleeping mask is working out and she told me, "Yes, I love it. You just have to get used to it 'cuz it feels heavy on your eyes. But it works really good." I thought sleeping masks were only used by movie stars. But I did get a free one on a 13-hour flight once. I didn't use it.

"I sleep eight to nine hours every single night and I may get up one time, but typically I sleep all the way through," said Vickie. Wow! I looked at Vickie and asked her if she dreams or if she remembers her dreams and what she told me was surprising. She said, "I will tell you about a most recent dream. I am kind of a restless sleeper, so in the mornings I am like a taquito. I am all stuck 'cuz I have rolled in my sheets." She went on to tell me that about a month ago she was sleeping, but hanging off of her bed during the night and began dreaming she was going backwards of a cliff. She really was falling off of her bed! Then Vickie confessed, "I cut my elbow so badly that I have an indentation. I cut it on the corner of a cabinet and then boom--I fell out of bed." My eyebrows went up while I was listening to her story, amazed she slept through all this until the morning and then

don't know how many hours. Anytime I can get to sleep, I do. At night I read. Sometimes I wash [clothes], watch TV or shop on television. I do dream. I understand we dream 24 hours a day, even while we are awake." Really? Okay, that is something I have never heard of, but Kathleen assured me we do and she assured me it happens. She told me when we sleep, we see what we have thought about during the day. At this point, I realized Kathleen is a deep thinker. It could be because of all the nights she spends awake while all the rest of us are sleeping.

Gary Johnson chimed in by saying, "[I am] a terrible sleeper--horrible sleeper. I will generally go to sleep at 10 p.m. and usually sleep for three hours and I'll get up. I'll go on the couch and am awake two or three hours. Every night. Terrible sleeper. Active mind. I'll think of ideas. I never watch TV. Or random thoughts like, 'How old was Bing Crosby when he died?' and I'll go on Google and I'll find out information or trivia I want to know the answer to. Or work... I'll think of ideas for

work." At this point, I should point out that Gary is an artist and maybe that is why he has such an active mind. At any rate, I was beginning to suspect many around our town are up all night. Gary told me he does sleep the best from 5 a.m. to 7 a.m., which is just about the time to get up.

"I am not a good sleeper either and it has been many years since I have had a good, sound sleep," said Nadia Krispel. "I don't feel that I am tired the next day, but I can't nap. I have never been a good sleeper. I don't remember most of my dreams."

Then Lisa Johnson told me, "I need eight hours sleep a night. Absolutely don't function well without it because I get up so early. I probably get seven during the week. Usually

I wake up if it is light at all 'cuz I can't sleep during the day--but if I get six hours a night or less, during the day I can barely function. I can't concentrate, I bump into things. My sisters are the same way. I have always needed a lot of sleep." Lisa also told me that she doesn't remember her dreams unless they are upsetting and she never remembers having a good dream. Hmm...

Right then, I realized how differently people sleep. Little did I know that there are so many a.m." Steve told me how he considers himself a bi-coastal caregiver, with the title of Medical Missionary, Californian. He also told me he has dreams of struggle and frustration usually dealing with taking care of people. Because Steve used to fly aircraft, his dreams have to do with taking care of the people onboard a plane. His concern is for the safety of others. The completion of a flight without incident remains the theme of Steve's dreams to this day. "I dream about protecting the people in

people walking around obviously sleep-deprived! Myself? Eight to 10 hours is my ideal, but I do fine with a bit less during the week. Some say you can catch up on your sleep while others tell me once you lose a day's sleep, it is gone forever. One person told me that every hour you sleep before midnight counts for two as compared with every hour after midnight. Interesting. My family sleeps well and not one of us is an insomniac. Hopefully, there are more of us sleeping soundly in Torrance than those

the plane," he explained. "That was the biggest thing that burdened me. I take care of a relative back east who just had a stroke. There was just an arctic vortex that hit back east and it was minus 20 degrees outside and the caregiver was supposed to help out, so I had to work the problem between 2 a.m. and 3

In a large hot sauté pan sauté the shrimp in the olive oil.


Add the onions and cooked for 30 sec.

aisle in order to better serve voters, regardless of party affiliation. Today I am doing something similar, but as a writer. As someone who has been in favor of President Obama's Affordable Care Act and has wanted to see it succeed, I have been disappointed at many of the problems that have been encountered with the new health care law. One of those problems, which is completely unacceptable, is that many Americans who had health coverage prior to the Affordable Care Act lost that coverage when the law took effect.

Last week Assemblyman and senior member of the Assembly Committee on Health Dan Logue--a Republican from Northern California--introduced Assembly Bill 1507 in an effort to solve the problem. AB 1507 will allow Californians who had their health plans canceled as a result of the Affordable Care Act to reclaim those plans at least through December of this year. Back in November, the Covered California Board unanimously voted that any health plans that covered Californians that did not measure up to federal health care guidelines had to be relinquished.

I am not sure who is on this board nor why they decided that this was a good idea, but that body struck out with this decision. The purpose of the Affordable Care Act is to create the market options necessary to provide health coverage to

because they don't meet the guidelines set by the federal government. That logic simply does not register with my simple mind. To be honest, it is embarrassing that a law meant to provide health coverage ends up stripping coverage away from people who were responsible and fortunate enough to afford their own health insurance.

Furthermore, we all heard the promise that people who were already covered and liked their doctors would be allowed to keep what they had in place. I understand that sometimes the things that we plan for don't turn out as we expected. So if the plan was to allow people with health coverage to maintain that insurance and it turns out that such a move would not be possible, at the very least these people should be given a reasonable grace period to find an appropriate solution.
