"The transitioning of mail delivery to five days a week could affect future employment at USPS and this is unacceptable. At a time when our economy has not fully recovered from the recession, this only adds to its ability to not function as well as it could. Eliminating Saturday mail delivery is not the right answer for the American people. I urge USPS to reconsider its decision, and to continue to provide the six-day mail delivery services that our constituents and businesses rely upon," Congresswoman Maxine Waters said in a statement. Famous Athlete Spends Time with Kids, Discusses Overcoming Obstacles

Olympic Gold Medalist Carmelita Jeter spent a day with the Hub TV Network during the My Little Pony Coronation Concert on February 9 to talk to kids about overcoming challenges and making dreams come true. The coronation concert, hosted by the newly crowned Miss America 2013 Mallory Hagan with Jeter as a special guest, aired as the premiere, all-new coronation episode of the animated hit series *My Little Pony Friendship is Magic* on February 16.

"I love working with the Children's Hospital and I have been working with them on a couple of things, so I love spending my time with them," Jeter said. "Having the Children's Hospital support this event with the Hub Network was one of the reasons that I decided I should get on board and be a part of it. Twilight Sparkles is somewhat like myself since it is about a little pony that has to overcome some things to get her wings. It was the same with me. I missed the 2008 Olympic team and I had to try really hard for the 2012 Olympic team. I finally made it and I got my medal, so I feel like I also play a big role in this."

In the episode, Twilight Sparkle becomes a princess, which results in a wide range of special events including a nine-episode My Little Pony Princess Coronation Marathon showcasing the character's journey to her crowning moment which took place on February 16. "I feel like I am blessed--I am blessed to be in the spotlight that I guess you could say that I am in," Jeter said. "Being a part of the My Little Pony Friendship is Magic is a great experience for me also. Other people will also get to watch how I interact with children and how I talk to them about my failures and how I overcame my trials and tribulations. You always have to give back so that you can help someone else get to a better place."

The coronation concert was also in support of Children's Hospital Los Angeles, a nonprofit, academic, pediatric medical center that provides healthcare to more than 97,000 children and families every year and which has been named the best children's hospital in California and is ranked among the top five in the nation by *U.S. News & World Report*. "I usually come out to the hospital and spend time with the children. However, this is my first actual event outside of the hospital," Jeter

said. "I am a part of it because it explains a lot about me and I will be able to sit and talk with the kids from Children's Hospital."

Jeter, who graduated high school in 1998 and went on to win the gold medal in the 2012 London Olympics in the 4x100 relay, silver in the 100m and bronze in the 200m, enjoys giving back to the community especially when she remembers the people who were in her life growing up. "I will definitely say

Local Band "Smiles" Starts Sharing Its Album

Fresh off winning the John Lennon Songwriting Contest and playing the National Association of Music Merchants (NAMM) convention in Anaheim, Smiles--a South Bay-based five-piece indie-rock group--is releasing its first album, Sharing. Band members Devin Jimenez, Lauren Jimenez, Jonnathan Romero, Austin Anderson and Jesus Lopez have been working on the record for six years. Unlike bigger rock acts, Smiles had to schedule studio time in between working day jobs and playing shows together. "The album has been in the works for a long time--since 2007," said Lopez. "We spent most of 2010 to 2012 recording it, in between tours and in between jobs."

The album debuted on February 10 and is available on the website www. smilesmusic.com. The band is currently working on getting the album added to

iTunes's library. The members describe their sound as part traditional rock, drawing inspiration from performers like the Beatles and Jeff Buckley, and part drum-oriented experimental pop music. "It's part rock, but it's part Animal Collective-style harmonies and drum beats," said Lopez. "It started very experimenal and [the final product] still is."

In addition to releasing the album, one of the biggest highlights for the band this year was taking grand prize in the John Lennon Songwriting Contest. While Smiles' primary focus has been writing more mainstream-friendly music, the contest allowed the group to flex its creative muscles and record music that would show off its talents in song craft. "We spent a few days recording new songs for that specifically," said Lopez, "It's a songwriting contest--not a pop contest or a rock contest. Fortunately, we won out and won it."





Preparing to Take Your Computer in For Repair

Computers and cars are pretty similar: both require regular maintenance, fail unpredictably, and disrupt your life when they do. Computer technicians live in a world where their (often desperate) clients know very little about the work they'll be performing. Sometimes this lack of

knowledge is taken advantage of and at some major computer repair retailers, doing so is actually a required part of the job. Here's a few tips for next time your computer breaks.

1. Get Ready to Talk to a Technician

Before you pick up the phone, come up with a list of symptoms and problems. Has your computer been restarting randomly or giving you any specific error messages? When did this start? Did you install any new hardware or software right before it did? Not only will answering these questions make you less likely to be taken advantage of by the technician, you'll also get you a more accurate quote on the repair.

2. Do Your Research

Before taking your computer to just any shop, do a quick search online to find some

Many shops, especially those with quick turnarounds, don't take the time to backup your data. This means that if your hard drive fails during repair or a technician makes a mistake, you could lose

important information.

4. Protect Your Data

Find that information and email it to yourself, put it on a flash drive, or use an free online backup service like spideroak.com.

5. Sanitize Your Computer

During the normal course of a repair, a technician will have to see some of your files. It's too often we see news stories about how technicians were going through people's files when they didn't need to – usually looking for private pictures, credit card information, or passwords to online accounts. There is a problem in our industry that unfortunately many technicians don't respect their client's privacy, which is why I suggest deleting anything sensitive off your computer. If you're dealing with a particularly motivated technician, they might use data recovery tools to "un-delete" your files so you'll have to wipe them instead. I'd suggest using a

reviews. Sites like Yelp and Google are an excellent resource for this. Ask your friends and family if they know anybody – finding a good, honest repair technician isn't easy so if you know somebody who has already done it, why re-invent the wheel?

3. Get Quotes from Shops

If you get a quote that seems a little high, shop around! Some shops charge flat-rates while others bill by the hour. Most places will give you a quote by phone but if you need to bring in your computer, ask if the shop charges a diagnostic fee. Remember that the cheapest service does not always

6. Don't Be Afraid to Ask Questions

After your machine is repaired, ask the technician what you can do to maintain your computer's health. If you are confused about what was done with your machine or why it failed, ask!

In ancient Greece, a cadre of self-proclaimed intellectuals named themselves "Sophists," translated as "I am wise." Wikipedia said "these intellectuals had one thing in common: They typically had a great understanding of what words would entertain or impress or persuade an audience. Hence today, Sophists use specious arguments for purposes of deceiving someone. They use rhetorical sleight of hand and ambiguities of language increase of 49 percent from January 2009 to November 2012. New enrollees are joining the ranks of those that cannot feed themselves at the rate of 11,000 people per day!


in order to deceive or to support fallacious reasoning. In this view, the Sophist is not concerned with truth or justice, but instead he seeks power."

Chairman Ridley-Thomas responded:

Supervisor Knabe said:

Each and every city and community within the South Bay faces its own unique challenges and opportunities in 2013. Los Angeles County stands ready to assist its residents with all available resources to meet those moments together in the coming year.

Warriors Too Hot to Handle

With two weeks left to go in the season, the West High Warriors were left for dead. Sitting at the bottom of the Bay League standings after a 22-point loss to Redondo Union, the outlook was bleak, to say the least, for head coach Paul Nitake and his squad. After beating Leuzinger and Palos Verdes Peninsula, however, the Warriors received a glimmer of hope to end the season. In almost the blink of an eye, West moved up from sixth place in the standings to fourth place and received an at-large bid to enter the CIF Southern Section Division 3AAA playoffs. From then on, it has seemingly been uphill for the Warriors. Now they are streaking, winning games when it means the most and looking to make a name for themselves in this year's playoffs.

The Warriors started off their playoff push with a game on the road against Colton last Wednesday night. The game plan was to get big man Terrell Carter the ball, as he had a distinct size advantage over Colton coming into the game. Carter capitalized on his opportunity by racking up 22 points, 17 rebounds and two blocks as West took the 62-44 victory in the first round of the playoffs. "Carter was a workhorse tonight," Nitake explained. "He did a great job defensively on the glass. Their biggest guy was 6-3, so we went to Carter the entire game."

It wasn't an easy start to the game for the Warriors, who trailed by two points after the first quarter. Once they got Carter into the swing of things, the game opened up on both sides of the ball. The Warriors outscored Colton 16-6 in the second quarter and 14-8 in the third to eventually roll to the 18-point victory and advance to the second round where they would meet the Hart Indians.

West came up with an effective game plan to take down Colton and decided to stick with it in order to gain an advantage over Hart as well. Carter once again put together an amazing performance, finishing the game with 13 points, 12 rebounds and three blocks as the Warriors won a game that no one expected them to--defeating the number three-seeded Hart 64-55 to advance past the second round of the playoffs for the first time in the history of the school.

"We broke the curse," expressed Xavier Basso, who is now a junior on the team. "First time past the second round. It feels good." It looked good too, as the Warriors jumped out to an early six-point lead in the first quarter. Coming out of the half, West maintained its energy, holding Hart to just five points and outscoring the Indians by 12 in the quarter. victory and moved on to face the number six-seeded Royal. It looks as if the Warriors have finally found their identity. Though it won't be a walk in the park, West is running on all cylinders at precisely the right time.

NORTH HIGH

The North High Saxons ended their regular season off in the right way this year. Two key Pioneer League victories against El Segundo and Torrance had the Saxons on a roll and going into the playoffs hot. Unfortunately for them, they ran into the Hart Indians in the first round of the CIF Southern Section Division 3AAA playoffs. Hart ended the season with a record of 25-3 and finished in second place in the Foothill League standings, winning eight games in a row at one point towards the end of the season. Fortunately for the Saxons, however, Hart slipped in its final game of the year against Canyon, suffering a key loss and forcing the Indians to enter the playoffs with a sour taste in their mouths. The Saxons, though, were unable to capitalize on that sour taste and wound up suffering a slim 86-83 loss to end their season in heartbreak in the first round of the playoffs.

North showed up on the offensive side of the ball, getting big games from their top three players. This year, the team did in fact win its last regular season game of the year, but a first round matchup against Bonita was a little bit more than head coach Leo Klemm and company could handle. Bonita, which finished the year in first place in the Hacienda League standings at 25-5, was on a roll coming into the playoffs having won its last 10 games of the season. That win streak didn't stop against the Spartans, as South trailed almost the entire game. Bonita came away with the 54-40 victory to end South's playoff life in the first round this year, leaving West High as the lone Torrance team remaining in the playoffs. The Spartans will lose both Kenichi Hackman and Jake Ly to college next year, but Klemm always finds a way to have the

Basketball Legend Dr. Jerry Buss Passes Away at 80

Dr. Jerry Buss, longtime owner of the Los Angeles Lakers and owner of the Los Angeles D-Fenders, passed away on Monday morning after a long illness. He was 80 years old.

The Buss family and the Lakers organization sent out the following on Monday shortly after the passing of the greatest owner in the history of professional sports:

"We not only have lost our cherished father, but a beloved man of our community and a person respected by the world basketball community," a statement released on behalf of the Buss family said. an era of success unrivaled in the history of Southern California professional sports.

As owner of the Lakers, Dr. Buss oversaw a franchise that won 10 Larry O'Brien championship trophies, reached the NBA Finals on 16 occasions, and missed the playoffs just twice. Furthermore, the Lakers compiled the NBA's best record under his guidance, going 1786-926 overall (.659 winning percentage).

Some 27 years after his journey began with the Lakers, Dr. Buss became the first NBA owner to own and operate an NBA Development League team, starting the D-Fenders franchise in 2006 to help develop NBA talent for the Lakers. Under Dr. Buss' ownership, the D-Fenders produced countless NBA players and, in just

the third Laker to enter the Hall as a contributor (Chick Hearn, Pete Newell).

Dr. Buss was a graduate of the University of Wyoming, earning a Bachelor's degree in Chemistry and later a Ph. D in Physical Chemistry from the University of Southern California. After a brief career in the aerospace industry, Dr. Buss and Frank Mariani, an aerospace engineer, drew upon their scientific training to launch a career in real estate. For Dr. Buss, the real estate firm of Mariani-Buss Associates was originally intended only to provide income, which would allow him to pursue his love for teaching. The expansion of the real estate firm was so fast, though, that it would not allow time for other professions.

Ultimately, Dr. Buss parlayed his original \$1,000 investment in a West Los Angeles apartment building into assets that eventually enabled to him to achieve his second love, ownership of a major league sports team.

A true pioneer and trailblazer in innumerable ways, Dr. Buss initiated many innovative marketing changes (which included a major advertising agreement with Great Western Bank in 1988 to name the team's former arena the Great Western Forum), and as a result, many of his strategies are emulated today by franchises across each of the major North American professional sporting leagues.


In addition to his role with the Lakers, Dr. Buss served two terms as President of the NBA Board of Governors and helped launch Prime Ticket Network (now FS West/Prime Ticket) in 1985. Altering the look of sports television, Prime Ticket televised all of the Lakers home games and shortly became the nation's premier regional sports cable network.

On October 30, 2006, Dr. Buss' inventive spirit empowering fans to never miss a home game earned him a star on Hollywood's Walk of Fame in a ceremony attended by his staff, close friends and family.

Yet for all of his accomplishments in business and sports, Dr. Buss was equally respected for his philanthropic efforts. Among his countless philanthropic endeavors, Buss focused on supporting education along with the needs of disadvantaged youth and the elderly. For his generous efforts he was honored by such organizations as the City of Hope, NAACP, the B'nai B'rith, United Negro College Fund, United Indian Development Associations, American Hebrew University, National Organization of Women, Boys and Girls Clubs of America, Muscular Dystrophy Association, the Los Angeles Human Relations Commission and Heart of Los Angeles Youth, along with many others. Dr. Buss also funded scholarships at his alma maters, Wyoming and USC, and endowed the Magic Johnson Scholarship at Michigan State University.

Dr. Buss is survived by sons Johnny, Jim, Joey and Jesse and daughters Jeanie Buss and Janie Drexel, all of Southern California; eight grandchildren; former wife JoAnn of Las Vegas; half sister Susan Hall of Phoenix; half brother Micky Brown of Scottsdale; and stepbrother Jim Brown of Star Valley, Wyoming.

A memorial service for Dr. Buss will be held on Thursday, February 21st at Nokia Theatre, L.A. LIVE. In lieu of flowers, the family requests that donations be made to the Lakers Youth Foundation or a charity of the donor's choice. • **Photos by NBAE/Getty Images.**




Dr. Buss had been hospitalized much of the past 18 months in a battle which "showed his amazing strength and will to live. It was our father's often stated desire and expectation that the Lakers remain in the Buss family. The Lakers have been our lives as well and we will honor his wish and do everything in our power to continue his unparalleled legacy," the statement concluded.

In 1979, Dr. Buss purchased the Lakers along with the Los Angeles Kings of the NHL, The Great Western Forum and a 13,000-acre Kern County Ranch in June of that year, and so began

six seasons of existence, had already won the Development Champion award, set the regular season record for wins (38-12) and reached the NBA D-League Finals, among other successes. A true pioneer both in the NBA as well as the NBA D-League, now a total of five NBA D-League teams are owned and operated by an NBA team, a number that will likely continue to grow.

As result of his incredible successes, Dr. Buss was enshrined in the Naismith Memorial Basketball Hall of Fame in Springfield, Massachusetts on August 13, 2010, becoming

just once. Chad Billingsley not only dealt with inconsistency once against last year, but also fell victim to the injury bug--something that he hopes to avoid this season. That leaves Aaron Harang and Chris Capuano (who both had nice seasons for the Dodgers last year) available, but out of the mix and most likely available for trade.

On paper, the position players for the Dodgers look as if they are going to do damage all around the league this year. Matt Kemp, Andre Ethier, Hanley Ramirez, Carl Crawford, Adrian Gonzalez... Where is there a hole in that lineup? Well, Ramirez can be seen as a liability at shortstop because of his tendency to commit errors at key moments in ballgames. Though he has the ability to go deep at the plate, he has hit only .243 and .257 the past two years respectively. Crawford is coming off of Tommy John surgery and he and Ethier are both terrible at the plate against lefties. Crawford is batting a career .263 vs. lefties with a .309 on-base percentage, while Ethier is just as bad, batting .276 with a .330 on-base. Kemp is coming off of shoulder surgery to fix a torn labrum and it remains to be seen whether he will return to his MVP form of 2011. Then there's Gonzalez, whose home run totals have consistently dropped from 40 to 31 to 27 to 18 over the last three

seasons and his .806 OPS was the lowest of his career last year in split time between the Red Sox and the Dodgers. It was a far cry from the offensive powerhouse that Dodger fans thought they would be getting when Gonzalez crushed a home run in his first ever at-bat with the Boys in Blue last year.

As expectations remain sky high for these Dodgers, manager Don Mattingly is doing his job to keep his team's hopes on the ground level for the time being. "The expectations, the noise is going to be there," Mattingly said. "Let's make sure we keep the focus on what we have to do to get ready for this year." Should Mattingly and the rest of the

Dodgers do that, there is no doubt that this team should remain successful. But overtaking the world champion Giants? Well, that may indeed be a different story. The Dodgers only won 86 games last season as opposed to San Francisco's 94. But with full seasons from Gonzalez, Beckett, Crawford, Ramirez and Kemp (who only played 106 games last season) and a deeper rotation, that win total should certainly eclipse the mid-90s. Despite all of the potential flaws and barring a catastrophic meltdown of only Laker-sized proportion, Los Angeles fans may indeed be looking at the best baseball team they have seen since 1988. •

Then I began thinking how I rest and asked others around town how they relax. My friend Joycie told me she relaxes when she and her husband watch *Jeopardy* and *Wheel of Fortune* while she plays with her "babies"--meaning her animals--dogs Lulu, Mini, Louie and her cockatoo Angel. That would be relaxing, I suppose, and I am sure lots of people pet their dogs and cats and watch TV to relax. Once in a doctor's office, I noticed a huge aquarium and asked the nurse about it. She explained to me that the motion of the beautiful fish swimming in the tank smack in the middle of the room

Honestly, the entire scene looked like a postcard. Monica Garth told me, "I run. I listen to music with great friends at the beach. Sometimes I come here to just sit and watch the waves." Jennifer Trujillo told me, "Lately I have been meditating and reading the Bible and praying--that is the latest thing--and running at the beach. This is a new thing--like two weeks, not a New Year's resolution. Some

are all the same," explained Viviana.



Thinking about what I heard from others, I agree that a long, hot soak in the tub is relaxing as well as reading a book or petting an animal. But what do children do to rest? The answer was sleep. I asked youngsters and they didn't really answer me. Could it be that is because they don't think about resting? They want to play. Volumes have been written on how to relax, unwind, de-stress and generally chill out in this high-anxiety world we live in but I have found three very practical things I do that seem to help. First, unfurrow your brow, then unclench your jaw--and if you can, let your tongue be loose in your mouth and then finally drop your shoulders. Doing these three things really helps me relax. Challenging as it is for me to relax before I get all my work done, I am going to try taking some time to slow down and enjoy the day as it unfolds.

windows down listening to the waves and the sounds of the seagulls. Our backyard ocean view is truly beautiful and every day the free sunset puts on the best show in town. •



Avoiding Tax Refund Identity Fraud

Many people file their income tax returns as early in the year as possible. Some are eager to claim their tax refund right away, while others are simply following their New Year's resolution not to procrastinate until midnight, April 15.

<u>Finance</u>

Let me add another good reason to file your taxes right away: tax

refund identity fraud. That's where someone uses your Social Security number (SSN), birth date and other private information to file a fraudulent income tax return in your name and then pockets the resulting tax refund. Often, a victim's first clue is a letter from the IRS contesting their legitimate tax return, saying one has already been processed under that name. It can take months - and mounds of paperwork - to unravel the mess.

This scam has proliferated in recent years thanks to a confluence of events: There's a thriving black market in personal information playing whack-a-mole with thieves who dream up new schemes - the IRS is hard-pressed to keep up. In one extreme example, the agency issued more than \$3.3 million in refunds for 2,137 tax returns filed to a single address.

But all is not lost. The IRS has significantly beefed up its fraud-prevention efforts. In 2011,

they intercepted nearly 262,000 fraudulent tax returns seeking almost \$1.5 billion in refunds. And they now issue special personal identification numbers (PINs) to impacted taxpayers to protect their future tax filings.

So what should you do if you've been victimized? Typically, the IRS will send you a notice that: More than one tax return for you was filed; You have a balance due, refund offset or have had collection actions taken against you for a year in which you didn't file a return; or IRS records indicate you received wages from an employer you

stolen from healthcare facilities, nursing homes, schools, insurance companies and

identification.

The IRS is pressured to begin issuing refunds shortly after taxpayers start filing returns in mid-January, even though employers and financial institutions aren't required to submit withholding and income documentation until the end of March. Thus, disparities often aren't caught until months later.

other institutions that require an SSN as

The growing popularity of electronic filing, where hard-copy documentation (like W-2 and 1099 forms) isn't required. Many people receive refunds via direct deposit and prepaid debit cards. Criminals open and close accounts using bogus addresses long before the theft has been detected.

Thanks to severe budget cuts and chronic understaffing - not to mention constantly don't recognize. This could indicate that someone has used your personal information to get a job.

If you receive such a notice, don't ignore it. Complete an Identity Theft Affidavit (IRS Form 14039 at www.irs.gov) and return it with a copy of the notice to the address provided on the notice. If you did not receive a notice but believe you may be at risk, the form contains separate submission instructions.

The IRS's Identity Theft Protection website (www.irs.gov/uac/Identity-Protection) includes tons of helpful information, including ways to tell whether your identity may have been stolen and how to report a breach.

And finally, file your tax return as early as possible to beat potential scammers to the punch. If you owe money, you can always file your return now and mail the payment by the April 15 deadline. •

Expert Answers to Common DMV Questions

Do you have questions about general driving related requirements like registration and insurance? Are you unclear about laws and restrictions related to driving? The California Department of Motor Vehicles has answers. Save Time. Go Online at www.DMV.ca.gov.

Q. I have noticed a lot of license plates that have DMV.CA.GOV on them. What does it stand for?

A. In 2011, the DMV began putting the department's website address on license plates. This is to encourage people to go online to complete their DMV tasks-saving them time! Remember to Save Time! Go Online! At www.DMV.ca.gov

Q. I saw a car the other day with a California license plate on the rear and a foreign license plate attached on the front. Is this legal?

A. When two license plates are issued, it is required that a one license plate be mounted on the rear to display the month and year sticker AND one on the front of

the vehicle. For more information about license plates, visit http://www.DMV. ca.gov/pubs/plates/standardplates.htm. Q. I see that the DMV headquarters building is finally complete. How long did the renovations take?

A. This project has taken 14 years. The renovations began in 1998 in the second floor and continued throughout the building. It was strategically planned so that the building did not need to be vacated during the construction.

The DMV is a department under the Business, Transportation and Housing Agency, which is under the direction of Acting Undersecretary Brian Kelly. The DMV licenses drivers, maintains driving records, registers and tracks official ownership of vehicles and vessels, investigates auto and identity-related fraud, and licenses car dealers, driving schools, and traffic violator schools. 




A basic home office setup can cost you under \$500 if you already have a computer that you can relocate to your new space.
