## Vendors and Businesses Rally Around Downtown Marketplace

During the Tuesday July 9 Torrance City Council meeting, Barbara Lieberman, owner of Seeds of Inspiration and a vendor at the Downtown Marketplace farmers' market, spoke about how the market is progressing after launching a year ago. She reported that despite the humble beginnings, the number of vendors at the market has grown from 10 to 40. "We now have up to 40 vendors and events each week, including local authors, musicians and DJs, free children's crafts and more," said Liberman.

The Downtown Marketplace has a busy schedule of events. Every Thursday from 3 to 8 p.m., there is a different event slated, starting with a Summer Bash on July 11. The following week, ROMP Rescue will be on-hand to find homes for rescued dogs and to raise funds with dog kissing booths and other canine-themed events. After that, Christmas in July is planned for July 25 with the One-Year Anniversary party set for August 8. "Every week at the Marketplace is unique and it's always worth going," said Lieberman. "We would like to see this family-friendly event grow into the thing to do on Thursday nights in Torrance." Michael Shafer, owner of The Depot and Buffalo Fire Department restaurants in downtown Torrance, added that while the market is going on, a group of restaurants in the area will be offering specials under the banner of "2-4-6 We Ate in Downtown Torrance" with menus items costing \$2, \$4 and \$6 in addition to their normal happy hour specials. "To entice you to come down to downtown Torrance and stroll and dine and shop local and shop small," said Shafer. "We hope to see you down there." Meanwhile the Torrance Certified Farmers'

Market, held Tuesdays and Saturdays at Wilson Park, is also getting some attention. Councilmember Gene Barnett mentioned that that the City's Naming of Public Facilities Committee will consider renaming the event in honor of Mary Lou Weiss. Weiss had been a long-time manager of the Farmers' Market and was instrumental in establishing the Saturday date for the event. The meeting is open to the public and will be held on July 17 at 4:00 p.m. in the City Manager's Assembly Room.

Also during the meeting, City Clerk Sue Herbers announced that the Council is still seeking applicants for Susan Rhilinger's former seat. To apply, one must be a registered voter in Torrance and return an applicant packet (available as of this Monday from the City insect repellent with DEET. Clerk's office) by 5:30 p.m. on Wednesday July 17. The Council will appoint one applicant during its July 23 meeting to serve from that day until the results of the June 2014 elections are finalized.

At the start of the meeting, Councilmember Pat Furey warned residents that the warmer summer nights also bring with them mosquitoes potentially carrying West Nile virus. The virus, while typically asymptomatic, can be debilitating or fatal in certain cases--particularly with the elderly. 

## <u>Police Briefs</u> **Major Traffic Collision on PCH**

On July 05, 2013, at approximately 12 noon, officers from the Torrance Police Department responded to a major injury traffic collision at the intersection of Crenshaw Boulevard and Pacific Coast Highway in the City of Torrance.

On arrival, officers discovered that a black Volkswagen Passat traveling eastbound on Pacific Coast Highway had collided with a 33-year-old male pedestrian, who was crossing southbound across Pacific Coast Highway outside of the crosswalk.

The male pedestrian sustained major injuries and was treated by Torrance Fire Department personnel at the scene. The pedestrian was transported to a local hospital where he is listed in critical condition. The driver of the Volkswagen Passat was not injured in the collision.

Last night I went to the annual Sadomasochists Ball, and met once again the most prominent members of the Liberal Establishment. • Thirty-eight percent said Obamacare has caused them to pull back on business growth.

So the evening ended as all sadomasochistic encounters do...with the never-ending search for more government solutions to more governmentally induced crises. •

### **Another Man's Opinion**

The California Assembly's Judiciary Committee passed AB5, the Homeless Bill of Rights, in a 7-2 vote. Unlike current laws and ordinances that tend to criminalize homelessness, AB5 is a significant attempt at helping individuals without shelter rather imposing a punishment. AB5 was authored by Assemblyman Tom Ammiano from San Francisco and it overcame strong opposition through a well-organized grassroots movement of homeless and poor people. AB5 serves a reminder to us that everyone deserves the same protection under law regardless of socioeconomic status.

The National Center on Family Homelessness reports that California ranks second worst in the nation in the number of homeless children. It is estimated that 160,000 men, women and children experience homelessness. With so many people living under the homeless label, it is unreasonable to criminalize everyone. Furthermore, how can our legislators justify the prosecution of individuals so down on their luck, circumstances or whatever you want to call it that we simply label them criminals? Granted, there are homeless people who chose to live on the street--and that presents a problem to the rest of the general population. However, that does not mean you become a sub-par human, let alone citizen of this state entitled to equal protection by the law.

Currently criminalization of homelessness comes in the form of laws that make it illegal to sleep, sit or store personal belongings in public spaces, with enforcement against homeless people for violating laws like loitering (which is very selective), jaywalking or open

container ordinances. Furthermore, the removal of homeless people under such circumstances often results in the destruction of their personal property such as medications and personal documents. There are also laws against begging and panhandling, which also restrict groups from sharing food with homeless people in public areas. These laws are enacted to push the homeless population away from one's city, but it does not eliminate the problem.

Some of the measures proposed in the Homeless Bill of Rights include the establishment of hygiene centers such as bathrooms and showers, allowing individuals to rest or sleep in certain public spaces; access to counsel during civil prosecutions; and protecting people who offer food in public places. All of these amenities will cost taxpayers money. Yet, it is costing us money now to prosecute people and families for not having a place to live. Not only is it costing us money, but criminal prosecution is not resolving the homeless issue in any way, shape or form-and neither is prosecution mitigating the nuisances that are associated with the homeless population.

AB5 is not the ultimate solution to a neverending problem. However, it does decriminalize an issue that should have been humanized many years ago. At the end of the day, these are not 160,000 units or numbers or stats represented in a report. These are 160,000 men, women and children finding it more difficult to get back on their feet because of the tendency for localities to prosecute. Giving such people the amenities necessary to improve their personal existence even in the direst of circumstances will have a more positive effect on their attempt to escape out of homelessness. •

## **Dwight's Decision**

Maybe the one good thing about this decision is that there wasn't a lengthy, drawn-out, onehour-long television special about the whole ordeal. Instead, Dwight Howard did what he said he was going to do and made his decision in a timely fashion. For Los Angeles Lakers' fans, that meant saying goodbye to an athlete that scouts, coaches and players all believe to be the best true center in the NBA today. Yes, the Lakers lost in the Dwight Howard sweepstakes. The franchise that has won 16 NBA championships in its storied tenure isn't very accustomed to losing. By becoming one of the first dominant players to ever walk away from the Lakers' organization, though, Howard, through his very public breakup with Los Angeles, showed the team that it is no longer what it once was and that it may have no one else to blame but itself.

There are two ways to look at the situation that has gone down with Dwight Howard and the purple and gold. The first is that Howard simply could not handle the bright lights of Hollywood. Other NBA analysts and past NBA superstars, like Shaquille O'Neal, seem to think that is precisely the reason why Howard left the big stage of L.A. for a "little town" like Houston. "We've all been in L.A., and not a whole lot of people can handle being under the bright lights," O'Neal said. "Everybody wants to do it, but when you get there, there are certain pressures. I think it was a safe move for him to go to a little town like Houston. That's right, little town. I said it." O'Neal was a player who possessed the exact opposite characteristics during his career. While he was with the Orlando Magic, O'Neal found it difficult to rise above that "little town" and its big star, Hakeem Olajuwon. Olajuwon and the Rockets beat Shaq and his Magic in the 1994-'95 season for the NBA championship. But when Shaq later joined the Lakers, he flourished under the bright lights and the pressure, obtaining titles in back-to-back-to-back seasons, from 2000-'02.

Even if it was the pressure of pleasing everyone in Los Angeles that drove Howard away, he still hopes to have the same success in his career that O'Neal has had when it comes to championships. "My résumé, I've accomplished almost everything that you can accomplish in the NBA but winning a championship and getting an MVP," Howard explained. "I've come close to both of them. So you know, that's my goal right there. That's the reason why I play. I have fun, but that's my goal...I might have fun, I might joke a lot, but I'm serious about winning a championship." For that reason, Howard has chosen to leave Kobe Bryant, Steve Nash and Pau Gasol to team up with James Harden and the Rockets.

The second way to look at Howard's situation

is to not think that the pressure of L.A. got to him, but that the ownership did. With no real intention of tweaking the roster and by stubbornly sticking with Mike D'Antoni over other coaches like Phil Jackson, Jim Buss, Mitch Kupchak and the rest of the Lakers' front office drove Howard away. The Rockets have a younger nucleus of players and a coach who is willing to play towards Howard's strengths in the low post-and clearly, Howard prefers that. "I just looked at both teams and I felt like Houston was going in one direction--they got a lot of young players, they got a good coach in Kevin McHale, and I just felt like having him as a coach, he could really help me in the post and help me develop like I want to," Howard continued. "That was mainly the big reason right there, and having the opportunity to grow with a team--a young team--like the Rockets. That's the reason why."

Clearly, Howard is choosing young potential over veteran experience. Harden, the only other star on the Rockets' team, is only 23 years old and coming off of a season in which he averaged nearly 26 points, five rebounds and six assists per game. Kobe, Nash and Gasol, however, are aging, injury-prone players who may never again reach the skill level that they attained in their respective primes. That, combined with a coaching style from D'Antoni that nobody seems to like, may have made Howard's decision a good one.

No matter what the reason, the damage has been done and Howard's 17 points and 12 rebounds per game through 76 injury-plagued games is going to be wearing a different uniform next season. So what does that mean for the Lakers? A lot more of Pau Gasol, first of all... Gasol has been like the Lakers' ex-girlfriend they just keep taking back because they can't find anything better. Though he has won the Lakers multiple championships, the organization just keeps trying to get rid of him. Now, it seems as if he is here to stay--at least for one more year. Even without Howard, the Lakers have over \$70 million in salary committed to the 2013-'14 season. The salary cap is \$58 million next season, meaning that the Lakers, with many roster spots still to fill, will already be penalized for going over the cap. Those roster spots will now be filled with minimum salary players, making the outlook for next season not so bright for the Lakers.

Any team with Bryant, Gasol and Nash should still be at least in contention for the playoffs when it comes down to it. After all, Gasol is one of the most skilled true centers in the league and has been playing out of position since the emergence of Andrew Bynum. But with Bryant's Achilles injury and Gasol and Nash's shaky bones, Laker fans could be in for one of the most disappointing seasons they have seen

## **Torrance Schools Go Swimming**

With the heat wave that has been beating down upon the South Bay, there probably isn't one person in the city of Torrance who wouldn't mind jumping in the pool to take a few laps through the water. Fortunately for the kids of North, South, West and Torrance highs, they have had the opportunity to do that on a daily basis all year long for their respective schools. The only difference is that they do it in competition rather than for leisure. These athletes might be relaxing and swimming in the oceans and beaches of the city for different reasons now, but some of the brightest local stars also shined with the sun this past year to not only represent their schools, but also put their own names on the map as well.

Perhaps the school that is most adapted to the aquatic life is West High. The Lady Warriors' swimmers have had a number of athletes take home first and second team honors this year, most notably headed by Tiffany Liu. Liu is only a sophomore at West and has already taken the swim team by storm. This year, she took on the 100 freestyle and finished in seventh place with a time of 52.39 in the CIF Southern Section Division II finals. Liu wasn't only good at the 100 meters, though. The talented youngster also placed 13th in the 200 freestyle with a time of 1:54.47 in the same CIF Division II finals. To get to the finals, Liu first dominated her opponents as she took her team to the Bay League finals and won the 100 freestyle outright with a time of 53.25. She also took the 200 freestyle outright with a time of 1:55.01.

Liu's teammates backed her up with successful seasons as well. Cindy Ngo made the CIF preliminaries in the 50 freestyle and took 18th place in the 100 freestyle with a time of 54.49 in the CIF Southern Section Division II finals. Ngo is only a freshman and has much time to improve upon her already stellar standings. Also a freshman, Ksenia Afonicheva set meet records in the Bay League finals by posting times of 2:06.86 in the 200 IM and 57.34 in the 100 butterfly. In the CIF finals, Afonicheva took 10th place in the 200 IM and 10th in the 100 butterfly. Lastly, sophomore Christina Ngo took sixth place in the CIF SS Division II finals, placing a time of 1:07.03 in the 100 breaststroke. Ngo had a time of 1:08.31 in the Bay League finals to win it and advance to the CIF Finals.

South High also had a big showing for its lady swimmers this year, starting with Yining Chen. Chen reached the CIF Southern Section prelims in the 50 freestyle and 100 backstroke. The junior helped her relay team capture this year's Ocean League title. Tiana Pugliese also came up huge for the Spartans in her last year with the team. Pugliese took first place in the Ocean League finals in the 50 freestyle and in the 100 freestyle while taking 13th in the 50 freestyle in the CIF SS Division II finals. Junior Samantha Sannes took second place in the 100 butterfly division finals and reached the CIF Division II prelims in the 50 freestyle, doing her part to help her team to the league title.

Perhaps the most dynamic swimmer of all didn't come from West or South. North High's Jasmine Margetts received the Swimmer of the Year award for her work in Torrance. Margetts finished above every other South Bay swimmer this year in the CIF Southern Section Division II Finals with her marks of 2:4.47 in the 200 individual medley and 56.62 in the 100 backstroke--both of which were personal records for the sophomore. "It's fun to be on the team at North," Margetts explained. "It's like a family. Maybe more will join and get into it here. Maybe we can qualify for CIF as a team soon." Margetts' team-first attitude translated during the regular season this year as well. She won every individual event that she entered, including the 200 IM at the division finals with a time of 2:08.67 to break a record that has stood since 2009. She also set a record in the 100 backstroke with a time of 57.75 to dominate this year's South Bay swimming scene.

The boys weren't as fast in the water as the girls this season in Torrance, as the latter clearly amassed many more awards. One male athlete who did go above and beyond for his See Up and Adam, page 6





### **Finance** Don't Get 'Spoofed' by Rogue Callers


When caller ID first arrived on the scene it seemed like a godsend to many people: Now you could easily identify who was on the line and ignore unwanted calls, whether from telemarketers, an ex-boyfriend or an unfriendly collection agency.

But as often happens, unscrupulous individuals soon began manipulating the technology to defraud people by pretending to be someone else. Their scheme is called "caller ID spoofing" and disturbingly, it's perfectly legal in many cases.

Here's how caller ID spoofing works and what precautions you should take to avoid being victimized:

For a very low cost, businesses and individuals can use widely available caller ID spoofing software to generate calls that alter the telephone number and/or name which appear on the recipient's caller ID screen.

Police, private investigators and collection agencies have used legal spoofing services for many years. Others who might have a legitimate reason to hide their identity when making a call include domestic violence victims and doctors returning patient calls who don't wish to release their private

4. Act your age: Seniors can often get discounts on attractions, events, meals and more by simply showing a photo ID or AARP membership card. 5. Leave time for recovery: A vacation should be fun and relaxing, but intensive driving or time zone changes can leave a traveler feeling exhausted. When outlining your trip itinerary, consider that you may need time initially to rest from your travels or recover from jet lag.

Whether you're embarking on a weekend getaway or taking the trip of a lifetime, spend a little extra time to consider the unique requirements you may have specific to your age, health and capabilities. Follow these five simple tips for a smooth, stress-free vacation experience and turn travel into a revitalizing fountain of youth.

> screen. Under the pretext of warning about an urgent situation (breached

about an urgent situation (breached account, late payment, pending insurance claim, missed jury duty summons, etc.), the spoofer will try to coax you into revealing personal or account information, supposedly to verify their records.

Often these are robocalls, where a recorded voice asks you to stay on the line to speak to a representative or call another number for more information. Do not. If you suspect the call might possibly be genuine, contact the company yourself at the toll-free number found on your card, account statement or the company's website.

You should never reveal your full Social Security number, mother's maiden name, credit card number, passwords or other private information over the phone unlessyou initiated the call yourself. Someone possessing such information could use it to gain access to your existing accounts to withdraw or transfer money, raise credit limits or snoop around your recent activity, among other intrusions.

ID thieves also can use your personal information to open new credit accounts (e.g., credit cards, mortgage or car loan), create a new identity or even obtain a job

Beyond that, the lines of legality begin to blur. The Truth in Caller ID Act of 2009 prohibits anyone from transmitting misleading or inaccurate caller ID information with the intent to defraud, cause harm or wrongfully obtain anything of value. Violators can be penalized up to \$10,000 for each infraction. Unfortunately, such penalties haven't dissuaded many scammers.

One common scam involves spoofers pretending to represent a bank, government agency, insurer, credit card company or other organization with which you do business. They count on you being reassured after recognizing the company's name on your

Often, you won't even realize something's wrong until a collection agency – or the IRS – starts hounding you for unpaid bills or taxes.

Another common caller ID spoof involves hacking into someone's voice mail account. Many cellphone users never bother to set up passwords on their voice mailboxes. And, since many voicemail systems grant access to callers phoning from their own number, a hacker could easily spoof your number and gain access to your messages.

Bottom line: You wouldn't give your personal information to a stranger on the street. Take the same level of precaution with strangers on the phone – or online.

## Mixed Mushroom, Spring Onion and Chardonnay Cream Sauce

DOTS N' PA

<sup>1</sup>/<sub>2</sub> cup sliced spring onions or an onion of your choosing

2 pounds of mixed mushrooms, sliced

- (I use Portobellos, Crimini, Shiitake, and regular white mushrooms)
- <sup>1</sup>/4 cup olive oil
- <sup>1</sup>/<sub>2</sub> cup chardonnay wine
- 1 cup heavy cream
- 2 tablespoons unsalted butter
- Salt and pepper to taste
- 4 fresh basil leaves, coarsely cut up

In a hot large sauté pan, pour olive oil then add the onions. Sauté for about one minute or until onions are translucent.

Add the mushrooms and sauté for another minute or so.

When the mushrooms are soft, add the chardonnay and let it reduce down by half.

Pour in the cream and let the mixture cook for one minute. Continue to stir as it will prevent it from burning or sticking.

Season with salt and pepper, then slowly add the butter while stirring to incorporate butter into the mix. Just before you serve the mix, sprinkle some basil and use the extras to garnish the dish.

# TerriAnn in Torrance Ken Miler – A Remarkable Public Servant By TerriAnn Ferren Melvin Miller...went to work at the Bank real estate license and drove back and forth retired, so I was able to open an office of

that they add to the world. Last week, I had the privilege and honor of speaking with a Torrance treasure. Former Mayor Ken Miller graciously agreed to an interview and I couldn't wait to speak with him.

From the moment Mr. Miller opened the front door of his home in Torrance and escorted me through the living room into his den, I knew I was in for a treat. The walls of his office were lined with plaques, awards and memorabilia. Along one wall was a bookcase with his favorite tomes. This was a working office filled with memories and treasures.

Ken Miller was born in Torrance, California in 1922. He was delivered by Dr. Lancasterone of only two doctors in Torrance at the time. It is interesting to note that *Torrance Memorial Hospital* wasn't built until a year later. "I'll be 91 in August--I look over my shoulder all the time. I don't know why I am still here," said Miller. "I was born in the El Prado Apartments down on Sartori and El Prado. That apartment--it's still there. In Melvin Miller...went to work at the Bank of Italy--now the Bank of America--located right on the corner of Sartori and Marcelina."

As I listened to Miller's story, I imagined how downtown Torrance must have looked and thought back to the old photographs I have seen at the museum. He then told me he graduated from Torrance High School in 1941 and his prospects for going to college were grim. Knowing his father had worked in the steel mill (and had died earlier), young Ken Miller decided to try that line of work. He ended up shoveling dirt at the steel mill for about a year, but when WWII broke out Miller joined the US Army Air Corps and was shipped off to the CBI (China, Burma and India). "I worked the ground crew and at that point, I knew I had the opportunity to go to school [on the GI Bill]," Millers said. "After the war, I went to Compton Junior College and I did two years there and I got into Occidental and graduated with a BA and went to USC to get my secondary. I wanted to be a coach. At six-foot-three at that time, I was one of the tall guys. Six feet now is nothing. I was about 23, 24 years old in college," said Miller.

Former Mayor Ken Miller then smiled broadly and told me about a "pot luck" group of friends he had grown up with who would meet monthly at alternating homes. Miller then explained, "We had no money to go out and socialize, so once a month we would get into somebody's house and have our party there. We did that for over 50 years. And I was the only guy of that group that wasn't married. So I had met Judy and decided to take her to the pot luck. I took her out three times and within two months, we got married [1952]." They have been married 61 years!

I was eager to hear more of the story of Miller's early days in Torrance. It was the summer of 1952 and the newlyweds rented a small place on Amapola Street. Miller needed to borrow \$300 for a stove and refrigerator

fact, my next door neighbor was Sam Levy. Eventually, from the apartment house, we moved down to Gramercy right next door to the Zamperinis. I was a ninth grader when he [Louis] was a senior, so I was a punk. I had an older brother who used to hang around him 'cuz they were on the same age level and I don't know how many times I

and decided to apply for a loan at the old Torrance National Bank. George Post was President of the Torrance National Bank at the time and did grant Miller the loan, but only after a lengthy lecture on the perils of getting married with no money! Miller told me he and George Post (the son) were neighbors for 46 years! from Torrance to Los Angeles to complete a course. A member of the pot luck group offered Miller a job to sell 200 small houses in Stanton going for \$6,900. Honestly, at this point I gasped. Can you imagine a house selling for that price? Then Miller told me an amazing story. "I opened up the office on Beach Boulevard at Chapman and I put some flags out and then next thing I know, it was one o'clock," he said. "I opened up and 15 minutes later, Jose walks in and I was sitting like this with a wall and a map behind me of the subdivision. So he says, 'I want that one.' He had already picked out the house. I said, 'Okay,' and I said, 'Give me \$50 and I'll hold the house for 'ya. You come back next week and I will have your contract ready." There were no credit checks retired, so I was able to open an office on Madrid and Torrance Boulevard where the railroad tracks are."

After that, Miller managed the properties from an office in Garden Grove and learned his profession from the first day he headed to Stanton. In 1953-54, after making some money, the Millers moved to a little threebedroom, one-bathroom house on Marjorie Street off Sepulveda (with the help of the GI Bill) and paid \$12,950.

In 1959, Ken Miller was voted President of the *Torrance/Lomita Board of Realtors* (now the *South Bay Board of Realtors*). It was at that time Torrance Councilman George Bradford asked him if he would like to be on the Planning Commission. "I didn't know what the Planning Commission did," said Miller. But he said yes even though he hadn't ever

at all and after Miller finished with Jose, the next client arrived with their \$50 down and so it went all that day. By the end of the day, Ken Miller had sold 160 homes in one day and had the cash deposits stuffed in all his pants pockets and even under his shirt because he hadn't been prepared for the "fire sale." That night at 11 p.m. when he finally arrived at his home on Amapola Street, he surprised his young bride Judy with the cash tumbling out of his bulging pockets cascading from his shirt. Doesn't this sound like a scene from It's a Wonderful Life? This was the beginning of a real estate career that would overshadow plans to coach at Torrance High School. "I fell in love with what I was doing and I liked to meet people and I had a lot of friends from high school, but I didn't want to have an office in Torrance because

been to a City Council meeting. At this point, former Mayor Ken Miller brought up names from the history of Torrance like Boris Wooley, Dr. Rod Stetson, Dr. Lancaster, Don Wilson, Bill Sharman, Bill Mertz and Bobby Riggs. "I knew Torrance and all I had to do was to fill in the city instructions," Miller said. After serving two years on the Planning Commission (1960-1962), it was during lunch at a local restaurant in downtown Torrance with a group of about nine who were complaining about local politics that Miller was challenged to run for City Council. After lunch he went directly to City Hall, registered to run for City Council and won the third spot on the first try. And that was the beginning of the political career of Ken Miller.

After two terms on the City Council (1962-1970), Miller ran for Mayor and won. He subsequently served two terms as Mayor of the City of Torrance (1970-1978). Following his last term in office, the string of awards and accolades for the former Mayor continue.

He was named Citizen of the Year in 1978, and it was Miller who was instrumental in the acquisition of Charles H. Wilson Park from the Navy and securing 200 acres of Torrance parkland. And then there is the building that bears his name--The *Ken Miller Recreation Center*.

Listening to former Mayor Ken Miller share stories about the history of Torrance from the perspective of a native son who was born literally in downtown Torrance reminded me we are indeed "the biggest small town in America." Together with his lovely wife Judy, they have raised their children Jim, Randy and Kathy with an appreciation for their town and history. Honor and integrity are the very fiber of this remarkable man who to this day keeps active in his beloved city with Judy. •


