

# Council Rejects Fireworks Funding

While nearly all of the Torrance City Council claimed to "love fireworks," a plan to fund a new fireworks display at the Torrance Civic Center was voted down during the Nov. 5 meeting amid concerns about complaints from residents, parking and funding. The deliberations started with Councilmember Tom Brewer expressing the he was pleased to be able to evaluate a plan to return a large fireworks display to the city after a three-year absence. "The community was very anxious to have this [fireworks display] come back," said Brewer. "I'm really encouraged to be able to look at this."

The first stumbling block with the plan was funding. The proposed fireworks display would have been funded using carryover from last year's budget. The carryover is a one-time funding source, as it's tied to the City taking in more revenue than it expends and is typically used for one-time projects and capital improvements. Mayor Frank Scotto said it is approved this year, but the successive year would need to be added to the budget instead of relying on carryover funding. However, Brewer hinted that there were some businesses that were interested in sponsoring the cost of providing fireworks, although he did not mention any willing to fund the required public safety officers to make the celebration safe for attendees. "There are some companies that are willing to come forward and help us with the fireworks part of the show," said Brewer.

City staff did try to make their plan more cost-effective. Prior to 2010, Wilson Park hosted an all-day Fourth of July celebration featuring an arts and crafts boutique, games, food and, of course, fireworks. However, the \$250,000 celebration was canceled due to budget constraints resulting from

the economic slowdown. Since ending the Wilson Park event, the Council has looked into other ways to bring fireworks back to the city at a reduced cost. This current plan would cost between \$70,000 and \$75,000 and only include a fireworks show. While agreeing it is cost-effective, Councilmember Bill Sutherland pointed out that the Torrance Police Department would still need to lend manpower to Redondo Beach for that city's show and the private show that occurs off the coast of Torrance Beach. With these and other L.A.-area fireworks displays, he didn't think it was necessary to spend additional funds on celebrating the Fourth of July. "We're still going to have to provide police and fire to Redondo Beach," said Sutherland. "I love fireworks, but I can always go to the Rose Bowl or go to Redondo Beach."

While the Council was primarily weighing on whether to pursue a fireworks display for between \$70,000 and \$75,000, the topic of location came up frequently. Councilmember

Pat Furey said residents' reactions to the proposed Civic Center location were mixed, with some enthusiastically in favor and others dead set against it. "Picking a site is probably one of the most difficult parts of this," said Furey. "I've heard from citizens saying this is the greatest site ever and others claiming this is the most ridiculous thing we've ever thought of."

The Civic Center location was chosen by City staff due to the ease of securing it (especially since the police department closes off the center in a similar way during the Armed Forces Day parade), the abundance of viewing areas and parking in the vicinity. By choosing an easily managed site, City staff hoped to keep costs down. Assistant City Manager Mary Giordano said that of the myriad locations in the city surveyed, only the Civic Center and Wilson Park were suitable. City Manager LeRoy Jackson said no other location could be secured as cheaply. "We



# Torrance Police to Unveil Forensic Laboratory

On Oct. 30, the Torrance Police Department unveiled its newest addition to the police facility; a forensic laboratory is officially open for business. Construction to the laboratory began in January of this year where several offices and meeting rooms were demolished to make way for what is now a "state- of-the-art" forensic facility.

The new lab will allow Forensic Identification Specialist (FIS) personnel to process evidence more efficiently, either from DNA and/or fingerprint samples collected at crime scenes. The lab will also benefit Torrance investigations as it allows FIS personnel to better prioritize evidence and process each case more efficiently using the latest equipment.

Since the FIS unit was civilianized in Feb. of 2010, they have responded to nearly 4,500 calls for service, collected nearly 1,000 DNA samples and collected latent prints in over 3,000 cases. More than 117,000 latent print comparisons have been completed and more than 4,000 latent prints have been identified. There has been an approximate 400% increase in the submission and identification of evidence and since 2010 there has been more than 500 suspects identified.

It was a picture perfect day. The kind of day where you pick up your camera or cell phone and snap a shot just because everything is so clear that it seems brand new. Special tributes from Claire Rothman, former general manager of the Forum; Bill Bertka, Lakers' scout and longtime friend of Sharmans; Keith Erickson, former player and Olympian; Kobe Bryant, present player, MVP; James Worthy, former player, Hall of Famer; Pau Gasol, current player; Jerry West, former player, GM and Hall of Famer and Pat Riley, former player, GM and Hall of Famer told of their special relationship with Bill Sharman. From the Buss family (who owns the Lakers), Riley Drexel, grandson of Dr. Jerry Buss and Jeanie Buss, Dr. Buss' daughter, spoke from their hearts along with many others who highlighted their memories of the life of Bill Sharman.

The common thread among those who spoke

was the emphasis of Sharman's integrity, desire to win and his kindness and enormous heart. Performers Andy Hill and Renee Safier played "Is" Israel Kamakawiwo'ole's version of *Over the Rainbow* and other beautiful songs during the two-video montage specials that were made for the day. One video montage at the end of the celebration documented Sharman's incredibly impressive career from his days in high school in Porterville, California to the present time with the song *How You Play the Game*.

"Once in a lifetime the stars can align, season after season, time after time. The whole is greater than the sum of its parts...a team is greater than the sum of its hearts...Once in a lifetime someone leads the way, to be an inspiration, play by play. have no other real alternatives available to carry it out at the fund level we've shown," said Jackson.

Between the two locations, Wilson Park was the preferred option by the Council and the residents who spoke during the meeting, although there were no plans for dealing with the additional cost of securing the park. City staff said using Wilson Park would require police to monitor the location all day (which was not the case with the Civic Center), which is part of the reason past Fourth of July celebrations were all-day affairs. Still, Councilmember Gene Barnett believed the park to be a better location than the Civic Center. "I prefer Wilson Park for a variety of reasons," said Barnett. "I think this is a nice proposal in the wrong location."

Two Torrance residents also remarked that the limited viewing angles available at the Civic Center would make the display difficult to watch. Loyd Brown said that unlike the Wilson Park shows of the past, residents living near the Civic Center would be unable to watch the display from their yards. "This is a terrible location," said Brown. "The people who live around here have tall trees. None of them will watch this from their yards."

Ultimately, the Council voted to forgo the plan altogether, with Cliff Numark, Kurt Weideman and Brewer opposing the Council's decision. Scotto said that while enjoyable, the fireworks display isn't necessary to maintain Torrance's charm. "The city of Torrance is no different place without the fireworks display," said Scotto. •

# **Apology Doesn't Solve Problems, Highlights Inefficiency**

As the problems to register for health coverage under the Affordable Health Care Act, Service Administrator for Centers for Medicare and Medicaid Marilyn Tavenner apologized before Congress for the complicated rollout. Unfortunately, an apology four weeks after the rollout and with little having been solved in those four weeks is no more than a reminder of how ill prepared everyone in charge was.

Tavenner's opening statements that they know how eager consumers are to purchase some type of coverage comes across more as an attempt to divert attention from what really matters which is that the majority of people attempting to use HealthCare.gov are struggling to make a purchase. At the core of this issue is that everyone responsible for making sure that this website and that these health care options be made available by now, have failed. The Affordable Care Act was passed back in 2009. That means that those who have championed this law and have fought for giving more Americans access to health care coverage were not able to figure out the logistics of their brainchild in four years. That is flat out embarrassing.

I've said it before and I stand by it now, I am looking forward being able to purchase my own health insurance. I was uninsured throughout my 20s as I worked part-time jobs and made my way through school. Now, as an independent contractor, I am responsible for my own health care coverage and this is

supposed to be a legitimate option for people like myself. Unfortunately, the only way to sign up for coverage has turned out to be a headache and Tavenner's apology is simply a reminder of everyone's failure to properly prepare, in four years, for this moment.

Also disturbing is the fact that it took four weeks for someone to address the issue. It's difficult to determine why it took almost an entire month for anyone to come out and acknowledge the deficiencies of the rollout but it remind me of Washington's inability to be accountable. In any other job having four years to prepare for something like this rollout would result in unemployment. Unfortunately, Tavenner isn't an election official so we can't oust her for her role in this snail-paced rollout and nor do we have any idea who is directly responsible for this failure.

Despite Tavenner's apology and her taking responsibility for the program's failures, there aren't any signs of reprimands for anyone involved with this fiasco [at least for now]. All that is left is waiting to see how long it is going to take the same people who got this wrong the first time, despite an almost four-year head start to get it right the second time around. Apologies mean a lot when they come immediately and in this case should have been accompanied with an explanation as to how this will be fixed. Sadly, the apology comes a month after the initial problems were encountered and with no real solution in sight. Maybe they need four more years to get it right. •



# Pumpkin and **Dried Fruit Pecan Trifle**



1 box of yellow cake mix, bake according to directions and cool (or you can use any kind of sponge cake or biscuit you'd like)

## **Pumpkin Mousse**

(1) 15 oz. can Libby pumpkin meat

- 1 cup brown sugar
- 1 tablespoon vanilla
- 2 cups heavy cream
- ½ cup brown sugar
- 1 teaspoon ground cinnamon
- 1 cup chopped dried fruits (figs, dates, apples cherries or plums)
- 1 cup toasted, salted pecans

Mix the pumpkin, brown sugar and vanilla in a bowl. Set aside. Whip the cream, brown sugar and cinnamon to a stiff peak. Keep chilled.

Assemble in a large glass bowl.

With alternating layers of cream, cake, pumpkin, fruit, nuts. Ending with whip cream on the top final layer.

Keep chilled. You can add your favorite liquor like Kahlua or Grande Manier. •

# **Looking For Gold**

After a thrilling opening night for the Los Angeles Lakers, at which they took out the much-heralded Los Angeles Clippers, who share the same building and are expected to contend for a championship this year, the Lakers let it all slip right out the window by getting routed by the Golden State Warriors 125-94 the next day.

Naturally, the Lakers aren't going to go undefeated or even compete for one of the league's best records this year. Fans must restrain their expectations now. This season is not one that is going to be one of the greatest of all time, especially with Kobe coming off of a horrific injury. These Lakers aren't going to win many second of back-to-backs this year, even if they happen to be against the likes of the Charlotte Bobcats or New Orleans Pelicans, rather than the Warriors. These Lakers, with Kobe, Pau Gasol and Steve Nash, are still an old team and will have to maintain healthy in order to get into the playoffs and make any kind of a dent. Even coach Mike D'Antoni knows that it's going to be a bumpy road, but if the Lakers can find gold in some of the younger players on the roster, a championship may not be as far away as it currently seems.

Credit still must be given to the Lakers for beating the Clippers and handling them in the fourth quarter with only bench players for the entire 12-minute span. Last year, with Kobe, the Lakers lost four of four games against the Clippers, giving a spark to what is now considered an inner-city (or inner-arena) rivalry. The Warriors showed the same type of exuberance and energy in their home opener the very next night that the Lakers did versus the Clippers as they destroyed the purple and gold. Let's face it, though - no one thought that the Lakers would beat the legitimate champion-contending Warriors on that night.

So who are the Lakers? Are they the team that came out with energy and took it to the Clippers, or are they the team that came out and laid down against the Warriors? Possibly both. The remainder of the season will certainly tell, but by looking at just the first two games of the season we can begin to make some assumptions, at least. The Lakers are supposed to be a defensively weak team this year. That's no shock considering D'Antoni is the head coach and dinosaurs like Gasol and Nash must protect the center lanes of the court. That fact certainly reared its ugly head when the Warriors put up 125 points against them. Kurt Rambis was brought in as an assistant coach to shore up the defense and he will certainly have his work cut out for him this year, but don't expect the Lakers to easily beat any teams that are offensively savvy this

Nash will most likely always sit out the second of back-to-backs this year to preserve his health, leaving the team almost directionless in his absence.

Once again, that was the case against the Warriors and the Lakers took an ugly loss. The starters are also old, and like Nash will need a lot of rest in a long 82-game season. It may take some work to keep everyone healthy. That responsibility will belong to D'Antoni again this year, like it did last year when Kobe was overplayed and tore his Achilles.

Despite those weaknesses, the Lakers do, believe it or not, have a few strengths to contrast. One thing that has been overwhelmingly obvious since the tip-off of opening day at Staples Center is that these players have chemistry together. That's right--Dwight Howard is gone and apparently happy in Houston. That means that now, everyone gets along with one another on the Lakers. Chemistry is one thing that can bring a team a long way and the Lakers certainly look to have it early on this year. Youth may have a lot to do with that. Jordan Farmar, Jodie Meeks and the electric Xavier Henry have used their youth and provided a spark from off of the bench that has given the Lakers an aspect that has been absent on the team for a long time now. Those three, plus the likes of Jordan Hill and others, give the Lakers a bench that can run and score and keep the team in the game when the starters must rest. That bench was the same one that scored 76 points against the Clippers last week. An even mix of veteran leadership with Pau and Nash mixed in with the youth described above can possibly make the Lakers a threatening team this year. Any time you add Kobe Bryant to that mix near the middle of the year, it certainly can't hurt either.

It's obviously still early in the year and considering only two games of the season have been discussed, different variables can, of course, change. Coaches and players alike are getting used to each other and the system being run on the floor, so it is not time to panic quite yet because of a 31-point loss in Oakland. One thing remains certain, though -with a whole list of players in their contract years, there are a lot of people with something to prove, including D'Antoni, if he wants to be around to coach the team again next season. This year will certainly be an interesting one in Laker Land where despite their finish this season, the Lakers look for gold out of one or two key players who could possibly help them in their quest to become a championship-caliber team again in the near future •

It was 28-7 in the second quarter and after Ojiyi's 80-yard scamper for a touchdown to start the second half, the game was well out of hand at 35-7 before it ended at 42-12.

Ojiyi was accompanied by his quarterback's strong performance on the night, as Heeger went 12 for 21 for 108 yards and added 113 yards on the ground. It was a great bounceback win for West after falling to Palos Verdes the week before. 





Insist on someone who is in good standing with the Better Business Bureau, holds at least \$1 million in general liability insurance and carries all required state and local licensing. The best contractor for the job will be specifically certified to install the roofing components you've selected and possess both a dedication to outstanding craftsmanship and knowledge of the latest industry standards and technologies.

## 4. Plan for the Future

Replacing a roof can be a significant investment, so make sure it's protected with a strong warranty. If you've installed a roofing system, ask your contractor about adding on a warranty that covers the system of components. Some of these system warranties also include contractor workmanship coverage. Be sure you review and understand the details, limitations and requirements of the warranty before your roof is installed.

## 5. Don't Hesitate to Insulate

While your roof is being replaced, consider adding another layer of protection to the top of your home. Ask your contractor to assess your insulation levels when he's in the attic inspecting the underside of your roof. When installed in an attic, loosefill insulation contributes to energy savings and helps control interior temperatures for a comfortable living environment. This could be a DIY project, but many contractors are specifically certified to install insulation - making it an easy add-on to your roofing project.

With the protection of your home and family at stake, don't wait until it's too late to address roofing issues. •
