Council Approves Contract With Minol Inc. For Utility Billing

Members of the Torrance City Council approved a recommendation from Finance Director Eric E. Tsao to approve a contract with Minol Inc., from Aug. 18-April 30, 2021, with the sole option to renew for an additional five years. The contract is for Minol Inc. to provide utility billing services for Torrance's water, sewer and refuse services and replace the services being provided at the moment by Global Water Management LLC [Global].

"What we are asking or recommending to you tonight is to change our service provider for utility billing. Currently we are under contract with Global Water and we have been under contract with them since September of 2010," Tsao said. "One of the reasons why we are here tonight is because Global Water, we found out late last year, that they were not really content with the current contract and we were hearing rumblings that they wanted to increase the amount that they are charging the city for utility services, even though they remain under contract with us."

The approved contract sets expenses at \$600,000 annually for the first year with an annual escalator of 3 percent, plus postage and a one-time implementation cost of \$200,000. The second year's expenditures are also set at \$600,000 plus the 3 percent escalator and plus postage; however, year three expenses are set to be the second year's annual amount, plus the 3 percent escalator and plus postage. Year four expenses are set at third year annual amount in addition to the 3 percent escalator, plus postage; lastly, year five will be set at the fourth year annual amount in addition to the 3 percent escalator

On Jan. 27 the city council approved the first of two, three-year options that would allow the extension of the contract with Global Water Management LLC [Global] from Feb 1-Jan. 31, 2018 to provide utility billing services to the city. However, due to Global's complaints about the dollar amount of the contract, city staff and Global management had several discussions in which it was revealed that the utility billing provider believes it miscalculated their cost when submitting an RFP in 2010. Despite contractual obligations, Global has started to impose additional fees for many "routine

items that the City expected to receive in order to provide the services its residents and customers are accustomed to receiving" states the staff report.

"Because of the real possibility of Global terminating the contract for convenience, staff began exploring options that included an alternate service provider," continued that staff report.

In addition, some council members have received complaints from residents regarding the service provided by Global, including its lack of customer support.

Davis and DeRosa Physical Therapy Expands Their Presence on Main Street

Davis and DeRosa Physical Therapy, Inc., moved into their current El Segundo location in 2005, doubling their square footage to 2,000 square feet. A few months ago, the practice once again expanded when they took over the adjacent space, previously occupied by Touch Institute. The addition more than doubled their

Troy Davis and Chris DeRosa moved to El Segundo in 2003 when they occupied an office in the 300 block of Richmond Street with their introductory practice of physical therapy. Until Davis and DeRosa Physical Therapy, Inc., there had not been an office dedicated solely to physical therapy (PT).

"Back in 2003 we were just so happy to be in El Segundo," said DeRosa, "and then we moved to Main Street in 2005. We saw an increase in patients as our visibility made people more aware of our practice."

As Chris said during a previous interview, "Moving to Main Street was like moving up to the 'big kids' table!"" Both Davis and DeRosa live in town and Chris can often be seen walking the practice's "watchdog," Jackson, down Main Street. (The practice's previous popular "watchdog," Caffrey, passed away six and a half years ago.)

The PT partnership began after each of them left two separate private PT companies, seeing the need for a practice right here in El Segundo. At the time they opened their practice, the timing



Estate Reduction Options for High-Wealth Individuals

Some high-net worth families still face the challenge of reducing their estate to minimize or eliminate estate taxes, although the federal estate tax exclusion is currently larger than it has ever been. The portability of unused exclusion amounts are at \$5.43 million for individuals and \$10.86 million for couples. But a 40 percent top estate tax rate on amounts above the exemption concerns those with large estates.

High-net worth individuals managing their estates are better off working with an experienced estate planning attorney, The Marietta Daily Journal confirms in a recent article, titled "Estate reduction ensuring wealth transfer to heirs." With the changes in estate and gift tax laws, have an expert on your side to ensure your documentation is drafted properly and work with your financial advisor to plan asset transfers to heirs.

An easy move for wealthy families is gifting. Individuals can gift up to \$14,000 per year, per individual without incurring a gift tax. The amount doubles for spouses.

There's an informational gift tax return to be filed, but there's no tax due if the gift is under the annual exclusion limit.

Another option is paying for medical care, insurance premiums, and education costs. These do not count against the \$14,000 limit, but must be paid directly to the institution or service provider.

You can also "power-fund" a 529 College Savings Plan. The Plans allow you to contribute a lump sum (up to \$70,000 per beneficiary) and then elect to treat the contribution as if it were made over five years for gift tax purposes. Those assets immediately leave your estate.

Older heirs might do well with a Grantor Retained Annuity Trust. You'll need to work with an estate planning attorney to set this up.

A GRAT allows you to transfer rapidly appreciating or income-producing property to heirs while retaining an interest in the property over a set term, from two to 20 years. As the grantor, you are making an irrevocable, taxable gift to the beneficiaries, and the gift's value is discounted by your

An Outlook on Business

The business outlook in Torrance is extremely good.

I know you've probably heard that businesses are leaving Torrance in droves. But, what you may not know is that in the past 18 months more than 2,200 new business licenses were issued by the City of Torrance. And, in that same time, the Torrance Area Chamber of Commerce has signed on more than 500 new members.

I understand that Toyota's decision to relocate to Plano, Texas has spurred a heightened sensitivity by all of us. I hear it all the time!

"Who is leaving next?"

"Is 'XYZ' leaving?"

"I heard that 'ABC' is moving out?"

These are just some of the questions I get from members of our community. Yet when Jim Lentz, Toyota's chief executive said "Geography is the reason not to have our headquarters in California," few paid attention.

New buzzing started with the announced departure of Panasonic and Kubota. However, many are not aware that both companies are relocating for unique reasons that are not tied to the relationship each of them has with the City of Torrance.

Torrance is a business friendly city. It is apparent if you just look at the facts—the actual data.

The fact is companies are coming to Torrance almost every day looking for a potential business location. In addition, many of our current businesses are looking to increase their footprint within our city. And, there are many reasons why - the most obvious are location, safety, school system and climate.

But, there are so many other reasons. Did you know that Torrance is one of the few cities in Los Angeles County without a gross receipts tax? That can mean a lot to an ongoing business or a startup.

And, in May, Los Angeles Magazine published a story on the clusters of microbreweries that have opened in the South Bay and pointed out that "The city of Torrance permitting process for opening a taproom takes 12 weeks and \$3,800" compare that with one of our neighbors where "it can take up to 12 months and costs entrepreneurs a minimum of \$6,500."

Torrance has a robust Economic Development team comprised of staff members from almost every city department. They meet with current businesses and prospective businesses constantly.

Our biggest obstacle is that Torrance is a fully, built-out city. There is very little room to build a new facility. So, creative planning for re-adaptive use is most important. And, the Torrance Community Development team does that.

Nordstrom and more than 100 other new stores will open this fall at the Del Amo Fashion Center on its same footprint. Just across Hawthorne Boulevard, the Financial Center has just been acquired by The Muller Company and it is being rebranded Del Amo Crossing with more than \$35 million in improvements planned.

Costco is just about ready to start construction of its new store on Lomita Boulevard that is almost 25% larger than the existing store.

L'Oreal/NYX cosmetics will be filling the last half of the former Ball site on the property directly across Crenshaw Boulevard from the Torrance Transit Center, which will be starting construction in the next couple months. Right around the corner on Del Amo Boulevard, Ganahl Lumber has acquired 18 acres which will be home to an 86,000-square-foot building supply store, a 40,500-square-foot lumber storage shed and a 12,700-square-foot lumber milling shed.

As for the Toyota site, I can only say that the interest in that property has been overwhelming. Many national and international companies as well as local developers have pitched ideas and concepts to the city and Toyota. As I mentioned, we are a built-out city and the 100 or so acres on that campus spurs the imaginations of many.

There is much more in store for the City of Torrance. The community can expect to see an even brighter future for our business community... stay tuned. •

Film Review

Shaun the Sheep Movie Rivals Inside Out for 2015's Best Animated Feature (Thus Far)

It's August. If summer was just a weekend, this month would obviously be Sunday – everybody was working for the weekend, but now they're scrambling back for the weekdays. The cinema's release slate is merely a reaction to this; the freshness of the summer movie season is becoming stale, and fall awards season that follows is hotly anticipated. August is the in-between that sometimes produces modest hits but also a lot of releases that are forgotten since audiences are preoccupied with societal transitions such as a new school year. While much of the film discussion this past week has been pointing and laughing and opining at what went wrong with Fantastic Four, a worthy film has fallen through the cracks at the U.S. box office despite for compelling solo stories, but not the case with Shaun. He's dastardly, fun, and above all lovable in the vein of Bugs Bunny or Rocky & Bullwinkle. The rest of the flock doesn't really have the same level of personality, except for the adorable youngling.

The new film is a short but sweet delight, and the key to its charm is its absolute simplicity. That's not to say the film is minimalist, per se; Aardman's signature stop-motion animation has never looked better or more detailed. But one example of the skillful straightforwardness is the taciturn sound design, in which the characters only speak gibberish. A bizarre creative choice that somehow works - demonstrating how unnecessary words are in such a medium as inherently visual and ornate as the animated

a wide release. It's a treat from the UK, who are seriously on a roll when it comes to family films recently between this and Paddington.

Shaun the Sheep Movie reminds me of a film school application, namely the one at the establishment I studied at. In it, an applicant must contain a short film that adequately conveys him or her, but without any words whatsoever. Sounds hard, but every student application I saw just made it look easy. So does the cartoon in question, which exists in the absence of any formal spoken language.

The plot involves the titular character and his flock planning a great escape from their farm lifestyle - one they actually enjoy, but nonetheless grow fatigued of. However, while their escape is ultimately successful, it comes as a catch-22: their farmer... and just go with this... is accidentally flung into town, develops amnesia, and becomes a hipster barber. The flock of sheep then adapt to urban life while attempting to recover their old master – all while evading the vicious animal control specialist.

Shaun himself is a classic cartoon character. He originally appeared in the 1995 Wallace and Gromit short A Close Shave, but the film is actually more directly related to the TV series of the same name. The danger of a spinoff is that certain characters sometimes don't make


feature. Furthermore, the humor and jokes are quick and ruthlessly funny - but always good-natured. It's about as hilarious as Trainwreck is, but without resorting to the ribald. It's refreshing to laugh so hearty. So much of what works in Shaun the Sheep could adequately be regressed to "less is more," but that wouldn't do justice to how clever the gags are here.

Also, a special mention goes to Tim Wheeler of the band Ash. His original song "Feels Like Summer" is a much better song than most that get nominated for Globes and Oscars. Not like it will help its chances, but it's an irresistible power pop tune that serves a sweetly diegetic purpose within the story. Just wait until you hear it performed by "The Baa Baa Shop Quintet."

This is a welcome return to form for Aardman Studios, even if the creative visionaries behind the studio's greatest achievements, Peter Lord and Nick Park, are only executive producer here. Co-directors Richard Starzak and Mark Burton have crafted a vivid ride that holds its own against the company's best animated features, Chicken Run and The Curse of the Were Rabbit. Just like with Pixar, Aardman made 2015 a time to put themselves back on the map and make their best contribution to the world in years.

Shaun the Sheep Movie is now playing in theaters. •

Torrance Trying to Transcend Expectations

This month, we've been taking a look at the football teams from around the city of Torrance that are getting ready to make a run at the Pioneer League title. Last year, the West High Warriors were skilled enough to boast the honor of league kings. This year, the Torrance Tartars believe that they have what it takes to dethrone the champs from last season. The Tartars may not have any heavily recruited stars like Mique Juarez of the North High Saxons, but with head coach Rock Hollis back at the helm and some key returning players, Torrance believes that they have what's needed to shock the world and take home the Pioneer league crown.

When initially taking a look at the Torrance High roster, the first thing that anyone who followed the team from last year will notice is that a lot of players have left to attend college. Torrance was a team based on offense last year. If they weren't going to outscore you, they were going to put up touchdowns trying to. One of the key cogs to that offensive output was quarterback Vincent Huey. Huey, a senior last season, threw for a total of 11 touchdowns and had 79 completions on the year. Many of those touchdowns and completions were thrown to starting running back, Tyree Harris. Harris put up incredible numbers last year, proving himself to be one of the best running backs and all-around football players in the area.

At 5-11, 195 pounds, Harris destroyed the stat line on a week-in and week-out basis. On 243 total carries last season, the senior running back averaged 7.3 years per carry while totaling 1,766 yards on the year. He had 10 games of over 100 total yards and when all was said and done, finished the season off with 25 touchdowns to his name.

Huey and Harris were, as a combination, the obvious reasons for the Tartars dynamic offense one season ago. This year, Hollis and the rest of the Torrance football team are going to have a hard time replacing that production. One man that the head coach will look to and rely on, however, is Tyler Maseuli. A junior one year ago, Maseuli stepped in when needed and took his turn at many different positions on offense for the Tartars. He played quarterback, took carries as a running back, and spent most of his time at wide receiver for the football club, ending the year with 159 yards receiving and two touchdowns. Maseuli's best work though, may have come on the defensive side of the ball. With 91 total tackles and two interceptions on the year, he proved himself as a key component of Hollis' defense. This year, Maseuli will be back looking to lead the offense and defense alike, and improve on the team's third place finish of a year ago.

Last season, the Tartars were fortunate enough to make the playoffs despite finishing in third place in their division. An average

Don't Forget **About Baseball**

With everyone so ramped up about football lately, it becomes easy to forget about a sport that has been going on since early April. It's even easier to forget about the game of baseball in Los Angeles when one of the biggest cable providers in the city, Time Warner, refuses to sell the Dodgers channel to any other provider at a decent price. All that aside, however, a 162-game season can sort of have the tendency to drag on. Don't forget about baseball. Not only do the Dodgers remain in first place and have a great shot at a deep playoff drive, but Clayton Kershaw and Zack Greinke are also battling each other for the Cy Young award.

When it comes to the month of August and baseball season, you pretty much know what you're getting. For instance, everyone knows that the St. Louis Cardinals are going to be a playoff team and everyone knows that the Philadelphia Phillies are not. Just like those two things, we also know that the Dodgers and their two aces, Kershaw and Greinke, don't give up many runs.

To this day, Kershaw and Greinke have made 48 combined starts in the regular season. 42 of those starts have been what the baseball world calls "quality starts." Think about that for a second. That's about 90 percent of their starts. No other set of teammates have ever piled up a set of quality starts like that in baseball history. That includes Greg Maddux and Tom Glavine. That includes Curt Schilling and Randy Johnson. That includes

Needless to say, what you're seeing this year (or trying to see) is unprecedented history from these two Dodgers starting pitchers. Greinke, himself, is on pace to have one of the greatest seasons pitched by a pitcher ever. As of today, his 1.58 ERA leads the entire league. His 0.86 WHIP (walks and hits to innings pitched) also leads the league. At 13-2 on the season, he may not have the most wins in the entire league, but having only lost two games in a season is a pretty remarkable feat in itself as that record looks as if it will only get better as the season nears its close. Greinke is unbeaten in his last 11 starts, has 21 quality starts to his name, and his last loss came on June 13 against the San Diego Padres. He has yet to exit a game before the sixth inning and has given up more than two runs in a game just four times all season long. Clearly, a bright and shiny Cy Young trophy (and a hefty pay day next year) is on Greinke's mind.

The only thing that will keep Greinke from that trophy that he's set his eyes on, however, is his very own teammate, Clayton Kershaw. Kershaw's season may not have started off in an absolutely remarkable fashion, but he has a tendency to pick things up as the year goes on. That is precisely what he has been doing. Kershaw is now the Major League leader in strikeouts and the NL leader in innings pitched and strikeouts-per-nineinnings rate. Since the month of may, Kershaw has allowed less hits than Greinke, less runs



start to the season led the Tartars into a three game winning streak before a couple of league opponents got the best of them. A two-point loss to start the season against Banning and a 49-7 loss at the hands of El Segundo had Torrance fearing for the worst early on. Wins against PV Peninsula and league opponents, South and Leuzinger, however, turned the season around quickly for Hollis and company.

Ultimately it was two league-play losses to North High and West High that knocked the Tartars down to third place in the final Pioneer league standings. A loss in the first round of the playoffs to Oxnard ended the season for Torrance and has had the team working hard all offseason to avoid a similar fate this year. If the Tartars would like to do that, though, they are going to have to do it versus a pretty difficult schedule. Before league play even begins, Torrance will have to take on the best of the Bay League. Games against Mira Costa, Peninsula, and El Segundo lead into a league schedule that proves to be a difficult one on a yearly basis.

Should the Tartars make it through their tough start to the year, they will have revenge on their minds for their two league losses of

last year against both North and West High. This year, it will certainly be a tough climb back to the top of the Pioneer League to end the team's first-place-finish drought, but with Hollis at the helm and Maseuli in the fold, anything is possible. Stay tuned this year for another exciting football season and root the Tartars on in their quest for both the Pioneer League title and a CIF championship crown. •

than Greinke, has walked less batters, struck out more, has a lower ERA, a lower WHIP, and has one more complete game. Uh oh, Zack.

While Kershaw is certainly gaining ground on his rotation mate, the question is if there is enough season left to catch him. Before his last start of the season against the Oakland Athletics on Tuesday, Kershaw owned a 0.92 WHIP, a 2.39 ERA, and a 10-6 record. Clearly, those numbers aren't as good as Greinke's, listed above, but the three-time NL Cy Young Award winner and 2014 NL MVP is only getting better and better. With only about 40 games left in the regular season, Kershaw has approximately eight or nine more starts left in him to try to make a case for the award for the fourth time in hi already illustrious career. Don't expect Greinke to just roll over

and let him have it, though.

Yes, football season is just around the corner. But before you fall too deep into the Tom Brady, Peyton Manning hype, make sure you don't forget about baseball. Our very own Los Angeles Dodgers are making a run at the World Series with what is stacking up to be the best 1-2 punch in the starting rotation in the history of the game. The competition for the Cy Young Award is a healthy one between the two pitchers and will only serve to make one another better. When it comes to baseball in October, there are no two guys I'd rather have at the top of my rotation than Zack Greinke and Clayton Kershaw. We'll see if it's enough to finally bring home the first World Series championship to L.A. since the 1988 season. •

Minol and city staff also agreed on an implementation schedule, as well the "go live" date being set for May 1, 2016, at which time the contract with Global is terminated and Minol will begin to get billed. During the agreed upon implementation phase Global will continue to provide utility billing services, with no overlap in billing cost.

"I think that everybody up here has heard the phone calls and gotten emails concerning this; we have been hit with lots of complaints over the life of this contract and we are looking forward to moving on to another company," said Torrance Mayor Patrick Furey. •

was right -- personally, professionally, and economically -- for downtown El Segundo.

Chris DeRosa, a native New Yorker, born and raised in the borough of Queens, holds a degree in exercise physiology from Adelphi University. Initially not sure of a career goal, he took basic courses. Then, he saw the film Regarding Henry, starring Harrison Ford, following the long recovery of Ford's character, a victim of a gunshot wound to the brain who undergoes extensive physical therapies to relearn all the basics of walking, feeding himself, brushing his teeth and hair, etc. "That film really inspired me to go into physical science. I saw how that meant I could work with people, but not in a job that was business-based. I began to volunteer as a PT aide at Jamaica Hospital in Queens, and that was it. I immediately knew my career choice!" recalled DeRosa.

After college, Chris worked in various PT clinics in New York, gaining experience until he was accepted into a PT program at Robert Gordon University in Aberdeen, Scotland, a program accredited by the American Physical Therapy Association, the governing body of all licensed physical therapists in the United States.

Meanwhile, Troy Davis, raised in Long Beach, California, graduated from California State University at Long Beach where he majored in PT. Davis' mom is a nurse, and he was always interested in how the human body works, how it is capable of restoring itself, how muscles function. PT seemed a natural choice for him. Davis enrolled in the PT program at Robert Gordon University in Aberdeen, Scotland.

After graduation in Scotland, their PT careers started in NYC at Faxton Hospital, each gaining experience in both inpatient and outpatient physical therapy. Both of them returned to California following acceptance into the Credentialed Advance Manual Therapy Residency Program at Kaiser Permanente Medical Center, which only accepts two therapists per year. The PT in which they both specialize relies on the manual therapies, with skills honed to exact a better treatment for the patient with hands-on therapies, not just relying on ultrasound and sonic waves for treatment.

Since occupying the larger office and with this new expansion, the staff at Davis and DeRosa has grown to 18, with seven therapists, including Chris and Troy, who each carry a full patient load, and 11 support staff. Their highly trained PT staff gains experience each day, most holding a degree in Kinesiology or Pre-Physical Therapy, until being accepted into PT school. In addition to the manual therapies, all PTs are certified in the Graston Technique, a unique specialized form of soft tissue manipulation.

"Physical Therapy improves the way one moves and we are all trained in Movement Science. Our staff has also been trained in the techniques of Pilates. Our practice is unique on several levels," said DeRosa. "Our patients stay with the same therapist for their treatment cycles, or at least that is the goal. We treat our patients on a 45-minute appointment cycle, and between the seven therapists we see approximately 60 to 75 patients a day.

"With the changes and challenges in medical reimbursement and medical coverage, since we opened our practice, as well as the open policy that exists now, we see a trend of self-referral, instead of PT being recommended by a medical doctor. People are taking control of their own preventative care. Insurance does not require a physician referral, so our patient base has grown. We needed a larger space.

"We encourage our patients to communicate what is going on and we work very closely, physical therapist to patient, to determine together the best course of treatment. People are not used to having that direct access, although it is becoming more the norm now that people are relating to the changes in health care," continued DeRosa.

"We work with our patients on a financial level. Some insurance companies now have a higher co-payment and less reimbursement for PT, but some others are treating PT just like any other treatment and reimbursements

are fair. It all balances out, but we want to

focus on the patient and their treatment, first.

or decreasing or not changing treatment is needed, until the PT has been completed.

"Since we opened in 2003, we have been so blessed to have the community support we get," DeRosa remarked. "In turn, we support El Segundo wherever we can. The Run for Education, the Wellness Fair, Little League,


