## Friends Hope to Preserve Historic *Heralds*

The very first *El Segundo Herald* hit the streets (the few of those that existed at that point) on October 12, 1911. It was during the same year that Standard Oil (now known as Chevron) founded the town, and the refinery and the newspaper are the only two businesses from the beginning still around to this day. Over the years, readers have pored through more than 5,000 weekly editions of the longstanding community paper. Through various ownership changes and the advent of new technologies, the *Herald* continues to thrive more than a century after its debut. And with a little help from the community, the paper's history—and in essence, El Segundo's as well—will soon be preserved in perpetuity.

The Friends of the El Segundo Library recently launched a fundraising campaign as part of an ambitious project to digitize and eventually post online 11 decades of *Herald* issues currently stored on microfilm at the public branch on Mariposa Avenue. The editions represent a veritable history of El Segundo that does not exist anywhere else and can never be recaptured if lost. "From 1916 to 2008, we have roughly 4,628 issues on microfilm and from 2008 to now we have 208 print copies," said El Segundo Library Director Debra Brighton.

The Friends budgeted about \$24,000 of its own funds to foot the bill for the conversion costs, but will need another \$20,000 to acquire software and actually host all those *Heralds* on the library's server. "We'll have to get some extra money or cut some of the things we do for the library such as the annual Author Fair," said Sue Carter, former President of The Friends who remains active with the organization as well as with the library's history committee. "We've known this [converting the papers] was going to happen and have been quite careful saving our money. We decided we've got to do it now or we're going to lose everything entirely."

While later-era rolls are still in decent shape, the earlier microfilm has noticeably deteriorated in recent years. "If you don't do it now, there's no place else that has the *Herald* including the *Herald* office," said Carter. "Some rolls are worse than others, so we thought if we have to fix a few rolls, let's do the whole thing."

Under the supervision of Senior Librarian, Support Services Mark Herbert, microfilm packages farm out to a content management company in Bethesda, Maryland called PTFS. As part of his research, Herbert received

good reviews for similar projects undertaken by public libraries in Whittier and Torrance.

"They [PTFS] converted 24 rolls of microfilm so far and we have 10 rolls out now," said Herbert. The library has a total of 83 rolls, with the first ones going back to 1916. Papers before that year were reportedly destroyed in a fire at the *Herald* offices of the time, while four other complete individual years (from various earlier decades) are also missing. Otherwise, the library has everything else.

## Eagles Fight Hunger Club Donates Food for Thanksgiving

For the second straight year, the El Segundo Eagles Fight Hunger Club was able to rally El Segundo High School students to donate food that will be distributed to the less fortunate during the Thanksgiving holiday. The school-wide effort netted 5,102 cans of food, which more than doubled last year's 2,566 cans collected. Just like last year's food drive, the Westside Food Bank located in Santa Monica picked up the food collected and will distribute it from as far north as Hollywood all the way down south to Carson and Inglewood.

"They help people who are chronically hungry so all of the food goes to food shelters, to malnourished children who just don't get enough food, and it is all distributed by the food bank," Eagles Fight Hunger Club President and Founder Jamie Stewart said. "We just put it [food] together and they come here to pick it up. They [food bank] take it and disperse it to other local food banks, shelters or anywhere where people can come get food. The food is for

the chronically hungry and malnourished people that live all over Los Angeles."

The success of the food drive last year impressed Stewart and his fellow club members. However, the amount of food collected this year went beyond the expectations of any of the individuals involved with the effort.

"I never dreamed that they could pull off such an amazing event. The school has lots of clubs that do lots of things and this is making a huge impact on the community and I am so impressed with the leadership. They have organized well," El Segundo High School teacher and Eagles Fight Hunger Advisor Emily Hirsch said. "They were able to learn how to make it [food drive] better. The other thing is that since this is something for them to be passionate about, they were able to incentivize other students. The student body really pulled it off and it is just very impressive, especially in these times where a lot of people are hurting themselves. It

After an initial test run of four rolls, Herbert sent another 20, which took PTFS two months to return. If all goes well, the entire conversion job will wrap up by the middle of 2013. "I go through the rolls, verify the dates [of the editions] and send them off. After they're done, they [PTSF] send the original rolls back to us as well as PDF and TIF copies on an external hard drive," Herbert explained of the process. It is difficult to determine the exact cost for each roll since there are sometimes duplicate editions, extra images or pages, so Herbert ships out only 10 at a time as a rule. "We want to make sure we stay within budget, so we don't send them all out at once."

Herbert was pleased to report that the microfilm came back intact and the digital images received thus far are "very good quality" overall. "The microfilm is starting to deteriorate and some of the images have tears in them---so on a lot of the older ones you don't have a complete page, but what is on the page is very good," he said.

The additional \$20,000 will help pay for the necessary software to upload and maintain the images on the library's website. Then users will be able to pick a year and access the *Herald* edition of their choice at the click of a mouse. The library will continue to store the old microfilm for as long as the material holds up. "It's very important for the history of El Segundo," Herbert said of the conversion project. "It's something vital to the preservation

of knowledge of El Segundo's past."

As part of a major outreach effort to secure the needed funds to complete the job, Carter mailed donation requests this week to more than 800 citizens and businesses in the community and made a pitch at Tuesday night's City Council meeting to ask individuals in town to contribute to the cause. A few have already stepped up the plate, she reported. "This is the first time The Friends have ever done something like this [asking for money], so we're learning," Carter said. "I'm a person who likes history. It's important to realize your family has a history and also your community has a history made up of individuals and businesses as well as events, ads and so forth."

Between fires, relocations and multiple ownerships, the *El Segundo Herald* itself possesses precious few copies of its old editions. "We are very thankful to The Friends and the El Segundo Public Library for their efforts in helping preserve El Segundo's history and to make sure that history never disappears," said Herald Publications CEO Heidi Maerker, who added that her company plans to kick in \$2,000 of its own money towards the project. "Having close to a century of local news conveniently available for the first time will be a great resource for the community itself and also for local school kids interested in learning about El Segundo's past. It's a nice reminder of why our hometown paper has been and remains such a vital lifeline for us all." •

says a lot about people who are willing to give to those that are less fortunate.”

Part of the club's efforts to motivate fellow classmates to donate was reaching out to local businesses for sponsorship. Through the participation of Domino's Pizza, Ralph's who provided shopping carts, and Lucky's Donuts, the Eagles Fight Hunger Club was able to create friendly competition between classrooms over who could donate the most food.

“I had to incentivize the people so I thought, ‘What better way to get people to bring food than by offering food itself?’” Stewart said. “So for the top three classrooms, we established a prize-based system where they received pizza and soda or doughnuts. We went around

the other classes. Last year our highest class raised 500 cans--so we more than doubled this year, which is great growth.”

Overall, the effort by club members led to the success of the food drive, which last year filled an entire Westside Food Bank delivery truck “It always helps when on Fridays we went around class to class, wearing our jerseys [football],” Eagles Fight Hunger Club Secretary Daniel Zeman said. “It definitely gave the students a little extra incentive. Knowing what past classmates have done with regards to the tradition of helping, it is important that we are setting the precedent for the future classes.”

Continuing these efforts is of importance for the club's members because they want

Club members also recognize the effort and help received from teachers such as Jason Ito, Craig Gast and Vicki Stuken, among others, who played a big part in spreading enthusiasm among the students to donate food. “We got the teachers behind it and then the student body [ASB] as well since they are the leaders of our school per se. They spread the word around and it went really well,” Eagles Fight Hunger Vice President Malcolm Au said. “Special thanks to the teachers who helped create a bit of a rivalry. They created a positive response and their friendly competition helped this even more. We had two classes that raised more than 1,000 cans this year, which is a lot. Mr. Gast's class raised more than 1,000 as did

## D-Fenders Announce 2012-13 Training Camp Roster

The Los Angeles D-Fenders have finalized their 2012-13 training camp roster by acquiring seven players from the 2012 NBA D-League Draft, retaining four players from the 2011-12 season, selecting three players from a local tryout, reacquiring one player whom they held rights to and completing a pre-arranged draft day trade with Fort Wayne.

“We are happy with how we were able to construct our team for training camp,” said Head Coach Reggie Theus. “We believe we have a group of skilled players who are motivated to work hard and prepared to compete to make our opening day roster.”

Coming off of the best season in NBA D-League history, the D-Fenders, who won an NBA D-League record 38 games in 2011-12 and earned the Development Champion award, held the final pick in all six rounds and an additional eighth round pick that was obtained from Iowa last year. The D-Fenders used their draft picks to select Rashad Bishop / Cincinnati in the fourth round (64th overall), Phil Jones / UNC Charlotte in the fifth round (80th overall), Tristan Thompson / North Texas in the sixth round (96th overall), Cecil Brown / UC Santa Barbara in the seventh round (112th overall), Mamadou Diarra / Chaminade in the eighth round (121st overall) and Eniel Polynice / Seton Hall in the eighth round (128th overall).

In addition, the D-Fenders drafted Dairese Gary on behalf of Fort Wayne to complete a previously arranged deal. In the trade, the D-Fenders acquired Jarrid Famous along with Darnell Dodson, a fourth round pick in the

draft, in exchange for Gary.

Famous, a 6-10, 240 pound forward out of South Florida, returns to the NBA D-League after playing for Memphis during the NBA preseason and spending time with Milwaukee (2012 Las Vegas Summer League) and Indiana (2012 AirTran Orlando Summer League) during the NBA Summer League. Prior to signing to an NBA roster, Famous played in 16 games for Fort Wayne and Iowa during the 2011-12 NBA Development League season, averaging 13.9 points (.494 FG percent) and 9.8 rebounds in 29.4 minutes per game.

Selected in the fourth round (60th overall)

of the 2012 NBA D-League Draft by the Mad Ants, Dodson played for Southern Miss during the 2011-12 season after transferring from the University of Kentucky in 2010. A 6-7, 215 pound guard/forward, Dodson averaged 11.2 points and 4.9 rebounds in 11.8 minutes for the Golden Eagles in his final collegiate season.

The D-Fenders also announced four players who are returning from the 2011-12 roster along with three players selected from local tryouts and one player who the team held the rights of to join the aforementioned players in training camp: Gary Flowers (returning) / Southern Miss, Courtney Fortson (returning) / Arkansas, Orien Greene (returning) / Louisiana-Lafayette, Jamario Moon (returning) / Meridian CC, Augustine Okosun / Northwood (local tryout), Renardo Sidney / Mississippi State (local tryout), Anthony Stover / UCLA (local tryout), and Kevin Kruger (player rights). •

I've been pondering the recent public case in El Segundo initially reported on September 11, 2012 as "Girls Soccer Coach Arrested on Lewd Acts with a Minor" While I do know this man, I wrote the following thoughts prior to any contact with him since these dramatic headlines broke out. I am writing this not because my knowing this man leads me to any certainty of the facts...but because it calls forth a basic regard for the facts...a basic regard which strikes at a challenge we all must consider.

What has been presented is that a fifteen year old girl "reported having engaged in sexual acts with him." So the police set up having her contact him by expressing a need for his help and requesting to meet at a public place. He was arrested upon arrival. Within hours the police seemed confident of his guilt and so their investigation was focused on finding "more victims." Based upon the confidence by the police, the headlines broke forth with a public contempt which reflected the same clear sense that this was the discovery of a sexual predator.

After all, the police moved and spoke with clear confidence that this was a case of stopping a man who likely leads a life "manipulating" young girls into sexual relationships. After all, the immediate headlines skipped the words "alleged" often enough to suggest that this is far from a case of simply one teenage girl's personal account. We should assume that corroborating and substantiating evidence is what set such accusations and arrest in motion. After all, the relationship is presented as involving

a girl whose only relationship is participation on a soccer team this man coaches. Therefore it's clear that what is really at hand can best be interpreted as a predatory involvement with coaching, teaching, and church programs. It would seem clear that any private contact itself could only have such inappropriate motives. The discovery of his having so many friends on FaceBook was given as a sounding alarm. After all, the immediate headlines declared "lewd conduct" and "engaging in sexual activity" with him. That is clear enough. Based on such statements, we can only assume this is not about some nuanced exchange... but rather that which can be regarded as clearly sexual in nature. After all, the immediate goal has been declared that of finding "more victims"...not alleged victims... so it has been established that she is a victim. And after all, on the radio I heard what I recall as the police Lieutenant say that this perpetrator "set up this meeting" with this girl. That seems clear enough. It may not always be wrong to meet a troubled youth asking for help...especially in a public place....but this is clearly someone pursuing a youth with no other relational connection, and therefore no other possible relational motive, other than sex.

There seems to be no lack of clarity here. Not by the police. Not in the media. And not in the public mind. This man's professional and public life is over. It was over the first moment that such clarity was presented to the public.

After all...this is the one crime that unites nearly everyone is the deepest disdain. Many have already called this man the worst of filth... the vilest of creatures...and one who should be locked away for life. One website focused on "Tainted Teachers" already posted his eligibility for their "Teachers Hall of Shame."

Do we still share a value for honoring one another as "innocent until proven guilty?" That's a value we seem to feel is best set aside for this type of crime. Apparently we already know these types of predators and can fill in the facts. After all, the police wouldn't allow a man's life to be destroyed by their declarations if they didn't have all the facts ...so neither should we.

As time now allows the truth to unfold...there is one question that might be worth keeping in mind. What if, after all, we were wrong? What if what unfolds is not the discovery of the sexual predator we already judged and sentenced in the court of our social assessment? More importantly, what if the "clarity" that everyone seems to have joined... was never there? Would it matter?

What if, after all, it comes out that in fact this man had no pattern of initiating private contact with this girl ...which would be an enormous and easy enough fact to settle? What if, after all, this man wasn't pursuing any youth... which would be an enormous and easy enough fact to settle? What if, after all, it comes out that there never was anything inappropriate with having a lot of friends on Facebook? What if, after all, the nature of the relationship with this fifteen year old girl was not simply that of his being a soccer coach or any other public relationship? What if, after all, what was described as being "engaged in sexual acts" was actually a single disputed touch? What if, after all, it comes out that he didn't "set up" a meeting with this girl...but rather the police had her do all the initiating and he only agreed to meet after several cries for help...and only at this most public of places? What if, after all, it comes out that nothing else comes forward?

For all our pride in being protectors, would we even care about what happened to this member of our community? Would we care about his loss of livelihood? Would we care about the significance of his service to the community being lost in our momentary pleasure for judgment?

Would we care about his wife...and how she may never again be able to enjoy seeing the eyes of her fellow community members? Would we care about their children...how their inner worlds have been changed forever...and their social worlds have lost trust in the mouths of police and other adults? Would we care enough to actually say we are sorry to these lives for how our public opinion destroyed them? Would we consider whether our rushing ahead of facts had really served to care for a fifteen year old girl's own process of discernment of various matters? Would we care about justice still being related to truth?

I don't raise these questions out of knowing all the facts about this case. I raise them because of something far more general that I believe effects us all. It seems to me that we are more excited by the drama of possibility than we are with the truth. We get more excited by the accusations of initial headlines than the actual facts which later get buried because they are not as exciting after all. We give ourselves to fears more than facts... sensationalism more than substance.

What is the cost? We lose the most basic regard for one another that defines us as a community. Our quality of community depends upon a reasonable trust ...and such trust requires that we will not sell our concerns for facts for the sake of fear. The humorous statement "Don't bother me with the facts"... brings an echo that reverberates within us all. The facts require time and the willingness to live with uncertainty for a season. The facts require suspending the emotional satisfaction of declaring our judgment. Yet what holds us together is our willingness to be bothered by the facts.

I honestly do not presume to know the truth that will unfold in this particular case. But let's not wait to confront our rush to certainty. I do not expect the police to publicly question the nature of their initial judgment. I do not expect the media to publicly question the nature of their headlines. It is we who must check ourselves if we want to enjoy the most basic communal trust. For after all, it is only "after all" that we should presume clarity.... not before it. •

### Eagles KO'd Literally From Football Playoffs

The 2012 football season came to an end for the El Segundo Eagles. It wasn't so much on losing, but how they lost a heartbreaking 14-10 CIF Southern Section Northwest Division quarterfinal game to Centennial.

If this had played out like a *Rocky* movie where the Eagles were Rocky and Centennial represented Clubber Lang, well you get the idea. Centennial trotted onto the field in a classless manner by running down the Eagles' sidelines taunting El Segundo players who were already on the field warming up. The

Centennial players kept up their chanting and taunting Eagle players as the Apaches' coaching staff looked on with a smirk and sneer. Eagle players took offense to the display and some light pushing and shoving between the two teams ensued before order was restored.

These two teams had something to prove to the other and Centennial was attempting to play the intimidation card. The Eagles wanted to prove that they were better than a forfeit win they received. In their Pioneer League matchup just a few weeks ago, the Apaches defeated the Eagles 27-14. The Eagles were later awarded the forfeit win when it was discovered that Centennial used an illegal player.

The Eagles had been on a roll lately, having won five of their last six games. The defense had been phenomenal, especially in the past two games when it gave up a combined 14 points. The offense had found a ground game that was sorely needed to augment the passing game. This would be a statement game in which the winner would move on to the semifinals.

Even with the bush league pre-game antics by Centennial, it was just another piece of the puzzle on a night that didn't go El Segundo's way. There was a lot to overcome, especially with the injuries that the Eagles had to cope with throughout the night.

Eagle head coach Steve Shevlin wouldn't say much on the pre-game skirmish, but he did say his team was not intimidated and the players handled the situation with class. "They're [Centennial] a good team—I'm not sure what they wanted to accomplish, but I thought our guys handled it well," Shevlin said.

Centennial's opening drive went for 65 yards, but the Apaches came away empty-handed. On fourth and 10, the Eagles' defense forced an incomplete pass and El Segundo took over at its own 33 yard line.

Centennial opened the scoring on its next possession, but got plenty of help from the host's defense. On third and five, the Eagles were called for a costly pass interference that gave the Apaches a first down. On fourth and two from the Eagles' 11 yard line, Apache quarterback Travon Hill found a receiver open in the end zone for a 6-0 lead.

Centennial's great field position on its next possession helped contribute to its other score. The Apaches went 57 yards in eight plays capped by a three-yard run. After being penalized for an illegal procedure, the Apaches used some chicanery to successfully convert a two-point conversion to make it 14-0.

The Eagles had a long, sustained drive that culminated in their only touchdown of

the evening. Starting from their own 15 yard line, they went 14 plays and scored on the last play of the first half.

Sophomore quarterback Lars Nootbaar, who was already nursing an injury to his throwing arm, completed four of six passes while Austin Brasher did the running. Brasher picked up 35 yards on four carries to help keep the drive going and the Apaches' defense honest. Nootbaar found tight end Austin Kurke open over the middle for a 34-yard pickup. On third and long, Kaylin Franklin caught a pass good for a first down.

All of a sudden, Centennial looked out of

sorts and the Eagles were marching towards the Apaches' end zone. Brasher pounded his way to the four yard line as time was winding down. The Apaches were penalized for pass interference on the next play with less than 10 seconds remaining. Nootbaar then found Seth McKenna in the end zone on a fade pass and the Eagles trailed at halftime 14-7.

If the Eagles were to win this prize fight like Rocky did, they'd have to do it with mirrors. Nootbaar's injured arm was a concern to start the second half, so Brasher was inserted at quarterback to run the wildcat offense. "We didn't have too many options available. Daniel Zeman was out and the other quarterback [Jason Kehl] is just a freshman and I didn't want him getting overwhelmed," said Shevlin.

During the Eagles' first possession of the second half, Brasher's athletic ability really showed. The senior ended up carrying the ball five times for 20 yards. The problem was Centennial's defense keyed on the run when it was apparent the Eagles wouldn't be passing. Nootbaar would reenter the game during the first possession, but he didn't attempt a pass until the Eagles' second possession.

With the Eagles' defense forcing punt after punt, the offense seemed to be clicking. With their last possession of the game, the Eagles had a time-consuming 15-play drive that ate up just over six minutes of the fourth quarter to score on a 39-yard field goal by Jamie Stewart.

On third and six, Evan Sharp picked up a first down with a 12-yard reception. Then more adversity to the Eagles occurred on the next play when McKenna caught a pass for a 14-yard pickup. On the play McKenna injured his knee, would need assistance to leave the field and was done for the night. El Segundo's drive stalled out near the Centennial 22 yard line and Stewart drilled his 39-yard field goal attempt to close the deficit to 14-10 with 2:49 remaining in the game.

The Eagles attempted an onside kick, but the ball took a favorable Centennial bounce and the Apaches recovered. From there, they ran out the clock and season for the Eagles.

The Eagles played through the misfortune of injuries to key players all year long and it caught up to them. They were knocked out of the playoffs and much of it had to do with injured players being forced from the game.

Coach Shevlin, who celebrated his 100th win against South Torrance a few weeks ago, was stoic and very proud of his team in his postgame speech to his players. "I couldn't be prouder of them and the seniors were leaders

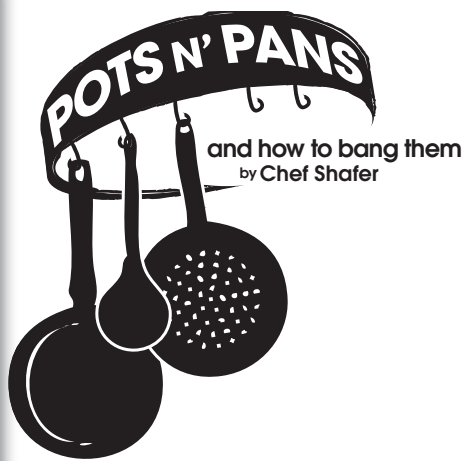

The girls' team recently competed at the CIF Southern Section Division IV finals at Mt. SAC. The Lady Eagles had advanced to the State meet in each of the past two seasons, but failed to qualify with a 12th place finish. Anna Farello's 17:17 was good enough for a fourth place medal and she will compete as an individual at the CIF State meet on Saturday at Woodward Park in Fresno.

It was a bittersweet end for seniors Farello, Jordan Mullins, Megan Freiburger and Macy Vezina who had each run at the State meets. They have, however, helped infuse a program that has been ranked in the top 10 for the past three years. Head coach Marcos Bolanos believes the mentoring of these seniors to the underclassman runners will make the team that much stronger in the future. •

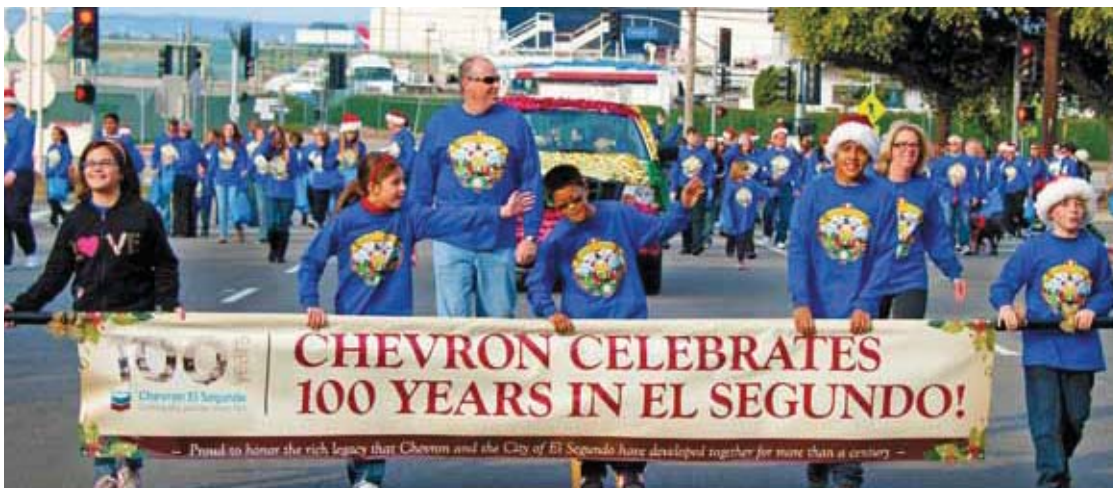
